## Dirt, Noise, Disappointment: Welcome to the Dolphin Cove

*New Residents at CSI Find Poor Planning and Rushed Delivery Problematic*

CSI welcomed new residents and their families into the Dolphin Cove for the first time on August 25 with an elaborate move-in day; chaperoned by Resident Advisors, volunteer students, and members of the Student Housing Department.

The celebration was well received by the college campus, that had been reminded of the opening with jeering signs and advertisements telling the community that, "if you lived here, you'd already be home," or that "you could have slept in."

The signs failed to mention that holes in the ceiling, a lack of hot water, and no internet connection could make the extra time sleeping or being home more of a hassle than anything.

While luggage and amenities were carried and set up in rooms, the joyous event was marred with the realization that the dormitories were not yet completed. While many of these students were responsible for paying for a seat in the Dolphin Cove months before, most found that the Student Housing Department were quick to take checks and even quicker to announce the dorms "complete".

The move-in day became even more of a disaster as several residents were instead checked into hotels, accommodated with shuttle bus service to and from the college and hotel.

"The shower is missing, one of the cabinets is half off, there's a hole in the ceiling, there is paint missing, what else is there?" joked Mayra Pesantez, trying to make light of a serious situation. "No hot water, there's only cold water."

The North and South Building along with the newly constructed handball and basketball courts make up the Dolphin Cove, CSI's new residential community. 442 residents, of which two are professional staff members and eight are Resident Assistants, call the Dolphin Cove home.

A look at the Dolphin Cove's website reveals a virtual tour of the different kinds of living situations offered. The video highlights the beautiful landscape and the fully furnished dorm rooms. It fails to mention that as of the first week of September, the Dolphin Cove barely resembles anything in that video.

The problem is that the virtual rooms are lively with beautiful lighting, wonderful furniture, and exude a feeling of home. The dorms that the residents showed off were empty and bare, pock-marked with lack of paint in some areas or small and invasive holes within the walls and ceiling.

The website and the FAQ page also fail to mention that the Dolphin Cove is still a work in progress, a fact that the residents are not quick to forget. A look outside of one of the rooms reveals a large dirt mound, unplanted trees, and debris from the summer long construction. Construction workers are also present at the Cove, often intermingling with the residents as they hurry to finish their job. This was learned by all residents on the move-in day.

"An email went out to residents advising them that some construction would continue after they moved in," said General Manager of the Dolphin Cove, Nicole Weston. "We understand

that the construction items are an inconvenience to residents and we are feverishly working to complete all outstanding construction items."

However, there were a handful of students who were more than happy with their dorms and their roommates, ecstatic to finally live the college experience.

"I love living here, it's amazing," gushed freshman and resident Nyah Smith. "The dorm experience depends on your roommates."

But the excitement of living on a college campus is not without the recognition that there are problems.

"Except there's no WiFi or hot water," interjected Smith's roommate Irina Heimerlen, class of 2017.

For the first week at the Dolphin Cove, residents in the South Building were informed of the lack of hot running water in the dorms. The residents were then encouraged to venture to the Gym, or The Recreation Center 1R to take warm showers there.

"Students were also advised that hot water would not be available for a couple of days," responded Weston. "But they could use the Sports and Rec Center to shower."

The problem was corrected later that week, but during a follow-up, the residents acknowledged improvement but noted on how the water still was not hot but lukewarm and that it took about five minutes to get that way.

Now that these students have officially paid for their seat

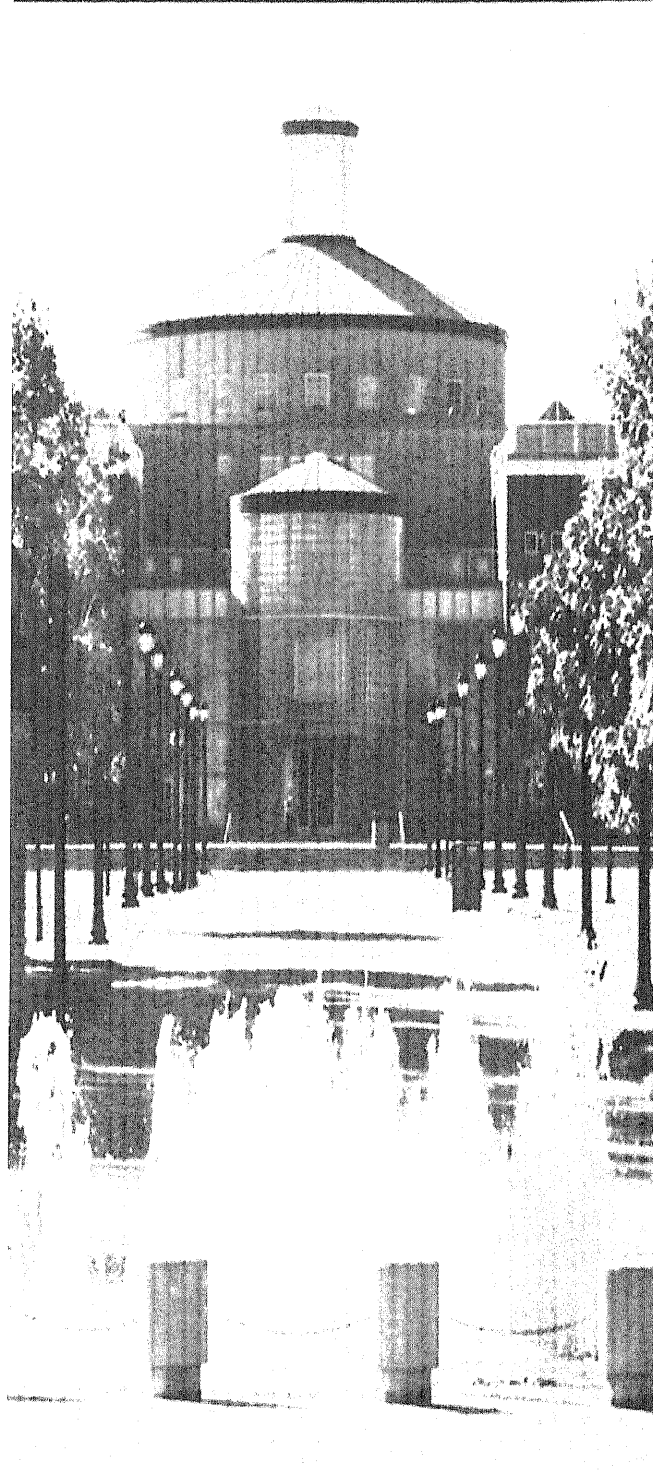

in the Dolphin Cove, many feel trapped and taken advantage of. In addition to the exorbitant fee, complaints from these residents have been filed to supervisors such as Weston and the RAs.

While these complaints are filed, few have been followed up on. Resident Kiana Williams of class 2017 admits to meeting Weston around three times.

One of these meetings with Weston occurred during move-in where Weston was described to be, "really caring and helpful," by Williams.

After that Weston disappeared from Williams and her roommates until a larger problem arose revolving around legal action.

Samantha Wong, a freshman and "little person" diagnosed with skeletal dysplasia, sought CSI as her first choice for college because of its status as the most handicapped accessible campus out of all the CUNYs.

Wong and her family also agreed to give the Dolphin Cove a chance, seeing as she would otherwise face a long and expensive

commute via cab service.

In May, three months before the projected completion of the Dolphin Cove, Wong took the time out to place an order for a fully accessible (Americans with Disabilities Act (ADA) accommodated) four bedroom, two bathroom dorm. When she showed up on August 25, she was not given anything close to what she and her family were promised.

The doors to the North Building are not automated, so Wong has a hard time even getting into her dorm lobby.

The family quickly consulted Director Christopher Cruz of the Student Disabilities Office who promised to remedy the situation. Yet Wong remained in a non-ADA room, North Building 105, until they switched her with Williams, to 103 later on that day.

When the family realized that the room was still not along the lines of the specifications requested in May, they reached out to Cruz, only to find that he was no longer working at CSI.

The switch not only failed to remedy the situation, it also proved to make things

uncomfortable for Williams who had already met and bonded with her roommates from the move-in date.

"They allowed us to get connected with our roommates when they notified us who we'd be living with," said Williams. "After I had gotten close with them, they switched me and Samantha. My room isn't very handicapped accessible either."

Investigation of North Building rooms 103 and 105 reveal small differences, nothing along the lines of the drastic changes Wong and her family had ordered.

While inside of the buildings, the smell of fresh paint was recognized as were the countless pieces of equipment lying around while construction workers entered rooms to fix problems.

With the lack of privacy noted, it was also mentioned that some of the windows throughout the South Building lacked blinds and people were able to see straight into bedrooms.

After the switch, Wong unofficially left the North Building, opting to live at home.

"We spoke to all the office managers we

could but the ADA room is not ready," said Wong's sister Vivian. "The family is spending a lot of money to get Samantha to school every day. Because of her disability, Samantha has to take a cab service which is really expensive."

Vivian also discussed the emotional stress that Wong has suffered because of the dorm situation because of the moving and inability to stay with her friends in the dorms.

Due to private issues and the Family Educational Rights and Privacy Act or FERPA, the managers of the Dolphin Cove and the Office of Student Housing declined to comment on Wong's situation, instead insisting that the Dolphin Cove, "meets ADA compliance."

With these problems at hand, could it be possible that the dorms on campus were rushed thereby forcing CSI residents into problematic and uncomfortable living conditions?

When questioned on the idea Weston repeated, "Outstanding construction items are in the process of being completed."

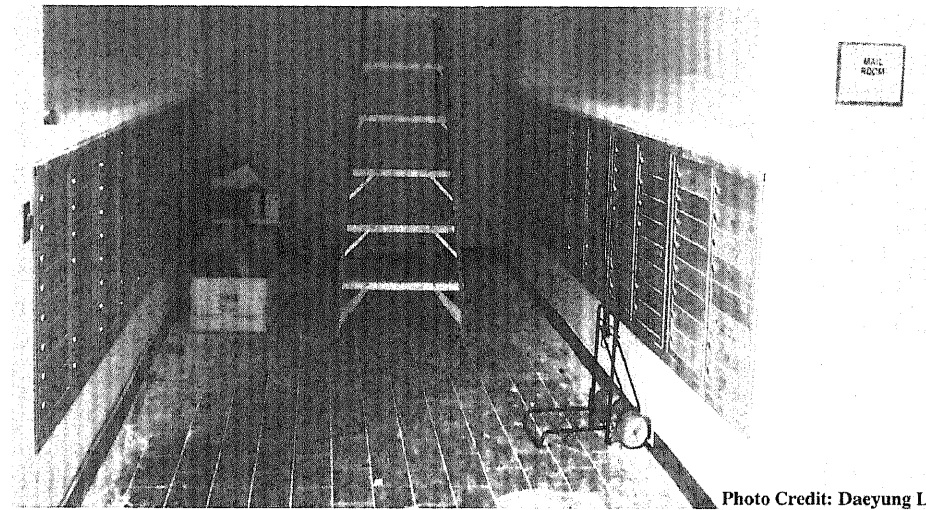

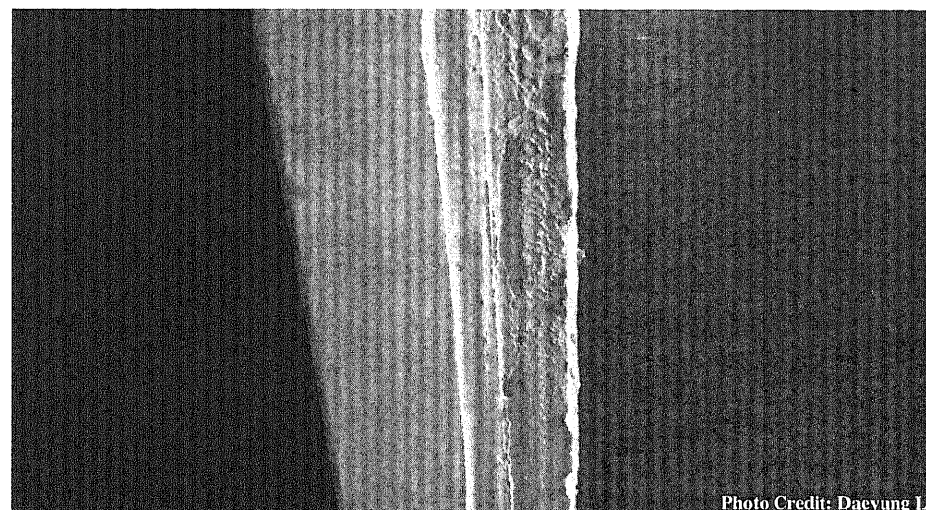

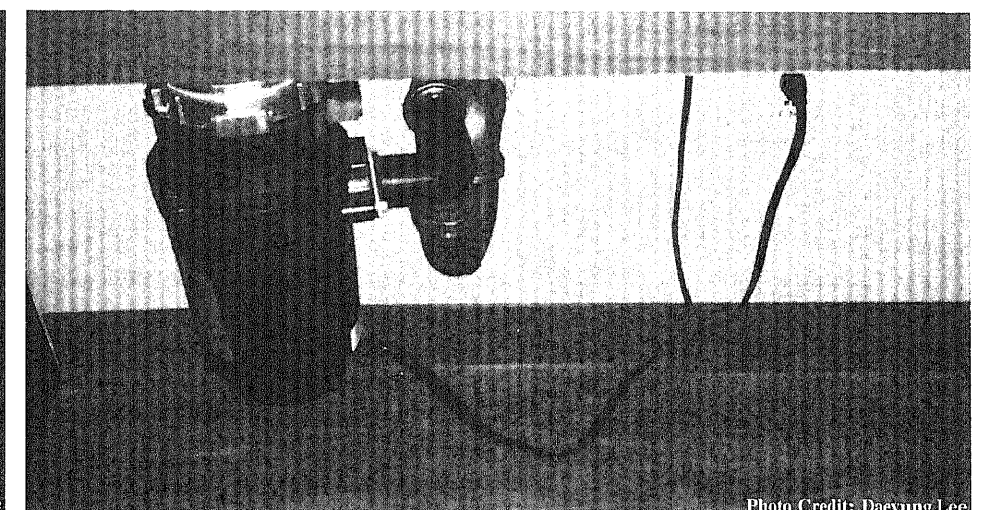

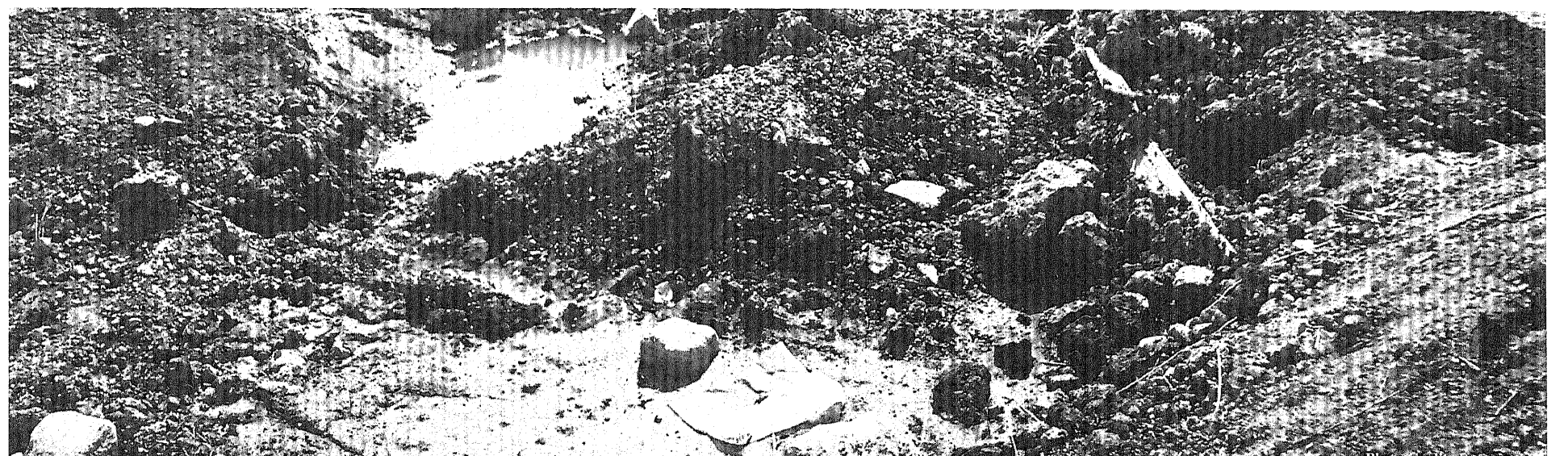

## CSI's New Dorms Are Guaranteed to Change the Campus The Impact of Dolphin Cove On Community Life

Mayra Pesantez, a freshman at the College of Staten Island, starts her mornings off stress free. She wakes up, showers, and makes herself a plate of eggs right before she strolls to her 8am class. This convenience is provided to Pesantez and over 400 CUNY residents by Dolphin Cove, the newly built apartment complexes on the north side of CSI's campus.

CSI was traditionally viewed as a local college but with the construction of Dolphin Cove, CUNY's latest residential complex, students who were initially intimidated by the long commute decided to give the campus another look.

"I figured if I dorm, I'll have more time to study. Because if I commute it'll be three hours, so that's six hours a day commuting so you have more time to study and get settled," said Pesantez.

Dolphin Cove's amenities also aid in providing residents with a proper study space. The spacious apartments include a desk, full kitchen and dining area—benefits that most undergraduates will have to wait till their senior year to obtain.

Beyond studying, some residents believe that Dolphin Cove has the potential to create a tight-knit community seen on traditional college campuses.

"I think there's going to be more commitment to the activities on campus," said Pesantez. "Because now we're living here and some of us want something to commit to, so I'm pretty sure we'll get involved in more activities."

The various banners hanging in the campus are proof of CSI's multitude of clubs. The campus currently has fifty clubs

and organizations on charter for students to join, but some clubs struggle from a lack of participation from the student body.

"I think a lot of that has to do with students not wanting to get involved, so I'm not going to blame that completely on the fact that we're a commuter college," said Student Government President Andrea Curry. "Dolphin Cove would bring more life to campus, specifically weekend events and night events that normally have lower attendance rates. So I'm looking for that to

be an area of increase due to the new dorms."

The Campus Activities Board (CAB) is in charge of providing the student body with social events to entertain and bring together the CSI community. They organize over 100 events every year and on September 3 they presented this year's first outdoor movie night, showcasing "Fast & Furious 6." There was a huge turnout from residents as many crowded the benches and grass surrounding CSI's track field. Moviegoers

wrapped up in complementary blankets and snacking on freshly made popcorn gave sign of cheerful times to come.

With a portion of the CSI community living on campus, enthusiasm for school athletics is primed to grow as well. CSI's men's baseball, basketball, softball and women's soccer programs are playing at a championship level in the CUNYAC (City University of New York Athletic Conference).

CSI's former President, Dr. Tomas D. Morales, was a large supporter of collegiate athletics and the sports programs have seen tremendous growth under his supervision. He was a firm believer that athletics would enhance the CSI experience. And now with the residential building being steps away from the baseball field named after Morales, many are excited for Friday nights on the field to root for their Dolphins.

"I definitely think that housing will increase school spirit. I think there'll be an increase in attendance because the school is no longer just a commuter school, so there's people here 24/7 living and breathing CSI and ready to come to the home games, said student housing resident Joe Tribuzio. "And also commuters can have friends in housing, who would encourage them to come to events."

The excitement and buzz can be felt all over campus as students pour out of the North and South building to go about their day. No longer will CSI's campus be used solely for getting around from one classroom to the next. While for hundreds of students CSI is an institution first, it is just as well a place to be called home.

## New DolphinCard Brings Convenience and Headaches to Students

To Get One or Not to Get One, the Choice is Yours

The beginning of a brand new semester has sent hordes of students to the Office of Parking and DolphinCard services; exactly where you want to be. If you don't access your CSI e-mail account, then chances are you might have missed the subtle introduction of the new DolphinCard.

"My friend worked here over the summer so that's how I found out," said Sophomore Anna Miranda. "If I don't have to get one, I won't because I don't really eat here."

First administered to the new residential students, the card, which acts as both an ID and a debit card, can hold money for purchases at the book store, dining services and parking services. In addition, the DolphinCard allows access to secured areas and gated parking lots, as well as the option to purchase parking decals or pay tickets.

"For the past five years, many of our customers upon payment have presented us with a debit or credit card and we've been unable to accept them," said Director of Dining Services Jodi Merendino. "It's a new world and I think the fact that we're finally able to accommodate them will make many people happy."

Long waits have plagued the crowd of students hoping to get in and out of 3A quickly.

The DolphinCard looks to eliminate congestion and headaches in the cafeteria, the coffee lounge in the library and the bookstore.

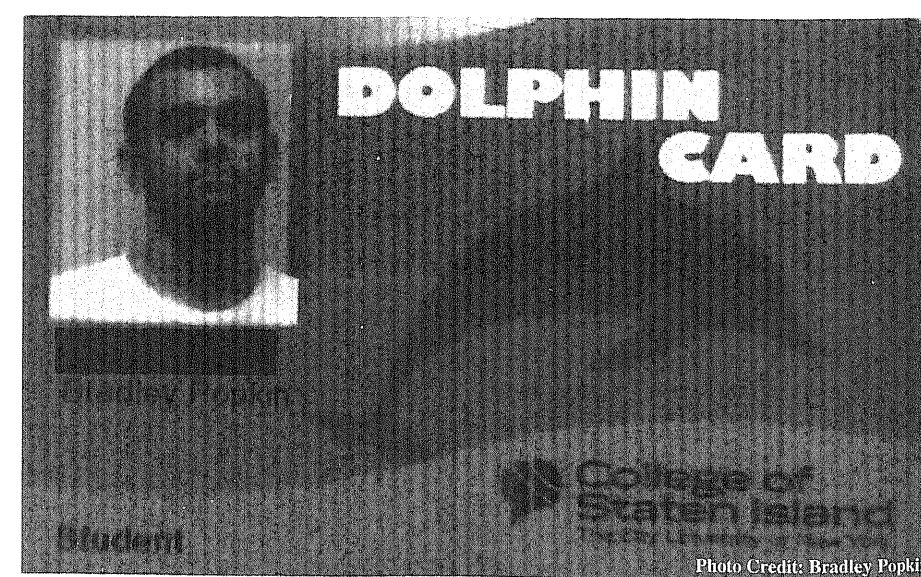
"It definitely takes out the factor of using cash," said Freshman Vincent Crescente. "Or if you can credit or debit card [campus purchases], taking out books or eating would be way quicker."

Make sure you hold on to those DolphinCards for dear life, because replacing a card comes with a fee of \$15 when you lose it the first time, \$20 for the second, and \$25 thereafter.

"I think that's a little ridiculous," said Miranda. "If you want something, carry some extra cash on you. I don't think it's worth it."

The brand new cards can have money added to them in a variety of ways, including, Card Management Centers, at the Office of Parking and DolphinCard Services or online via the DolphinCard page on the CSI website. They have three different account types which are Dining Dollars, Dining Plus Dollars and Dolphin Dollars.

Dining Dollars is the main account which holds funds for a meal plan, if you so choose. And the Dining Plus Dollars are subsequently used after all funds have been drained from the main account. There is a minimum deposit of \$50 for the Dining Plus Dollars account and any

remaining money will be forfeited at the end of the semester. Both of these accounts are exempt from NYS sales tax.

Lastly the Dolphin Dollars, the most flexible account, can be used for purchases all around campus; even in the residential laundry facilities but are not tax exempt. Account balances will roll over from semester to semester.

When CUNY made the switch from E-SIMS to CUNY First, they stopped using the

students social security number as the base line for the ID number and went to another form of ID called an "emplid," informed Merendino. The switch was evidently a huge undertaking because the transition was both delayed in bringing the card to students, especially new residents.

"Now that they have one card that acts as a student ID and (are) able to use it for money; it's super important," said Merendino. "It's one stop shopping."

## Sarin Gas Attacks Brings US to the Brink of Involvement in Syrian Conflict The Fuzzy Facts and Obama's Line In the Sand

In the poker game of international politics, someone in Syria is calling President Obama's bluff.

The big question is exactly who is calling for the President to show his hand.

Syria's current civil war dates back to 2011, and it is a complicated affair, but it basically boils down to what most civil wars boil down to: on one side you have the existing government and military led by President Bashar al-Assad and on the other side you have a newly formed Free Syrian Army (FSA) which wants to bring down the Assad regime. In the middle, you have innocent civilians.

To date, the United States has stayed out of the conflict, but that may soon change. Back in July, the President stated that the use of chemical weapons by the Assad regime, or any of the other players in the war (i.e. the FSA) would be to cross a red line, leading to US involvement in the conflict.

Recently, a proliferation of amateur video has surfaced on the Internet in the wake of what appears to be a Sarin gas attack on innocent civilians. Someone crossed Obama's line. The question is was it Assad's forces or the FSA?

In an address to the nation on Saturday August 31, the President made it clear that he is certain US intelligence has concrete evidence the Assad regime is behind the attacks, but also admitted that not everyone may agree.

"I'm confident in the case our government has made without waiting for U.N. inspectors," said Obama. "I'm comfortable going forward without the approval of a United Nations Security Council that, so far, has been completely paralyzed and unwilling to hold Assad accountable."

Are they paralyzed and unwilling or unsure due to fuzzy or inconclusive evidence?

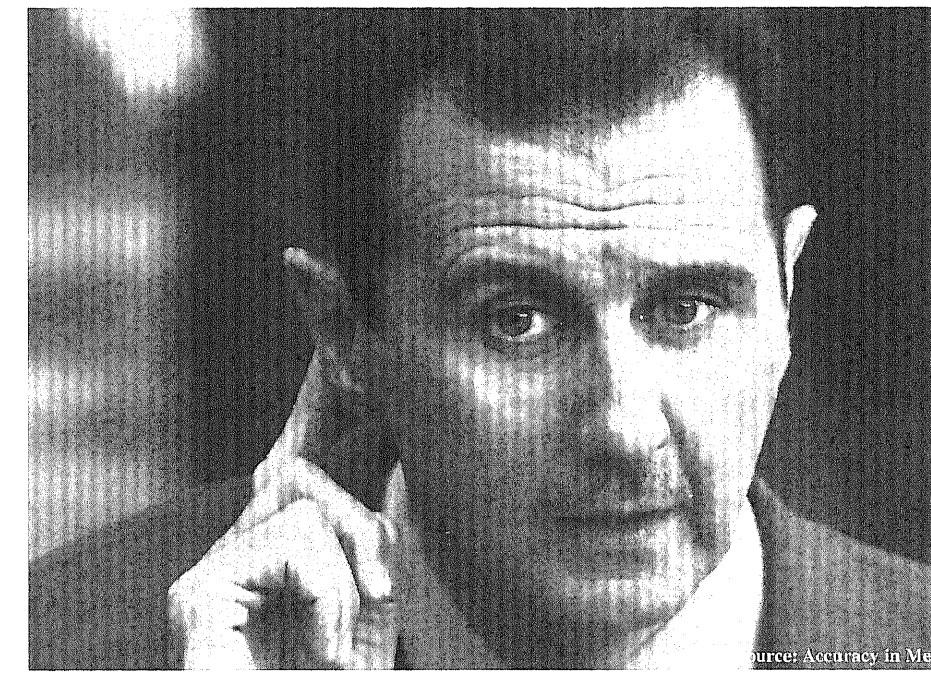
Assad has used forceful language while denying that he ordered the use of chemical weapons, calling Obama weak and claiming that Obama cannot even convince his own people with the evidence that is available.

Obama plans on showing Assad he is wrong by securing Congressional approval for limited military strikes against Syrian government targets.

In order to get the support he needs, the Obama administration must provide answers to the crucial question: was it really Assad, was it the FSA, or was it a third party intent on further destabilizing the situation?

Gathering public support for US involvement in yet another Mid-East conflict may prove more difficult than the President may realize. He would be asking for Americans to back him even though our ally Britain's parliament recently refused to support military intervention in Syria, even though he would not have the backing of the UN, and even though Russian President Vladimir Putin is calling for the Obama administration to provide more evidence to support its claims. As of now, the only other world leader who is backing Obama is the French President Francois Hollande.

Given the amount of international uncertainty surrounding the answer, it does raise some

considerable questions about the firmness of the evidence, which the Obama administration is claiming to have.

situation Obama has likely backed himself and our nation into a corner with no real way out. It doesn't take a military expert to realize that a limited military strike on a few targets will not bring an end to this conflict. So what is the endgame here?

Obama needs to act, or at least attempt to, in order to show that he wasn't bluffing, and this can lead to one of two outcomes.

One, Congress shoots the President down and Obama has to fold his hand whether he was bluffing or not. Whoever executed the Sarin attacks went all-in and won.

Two, Obama gets the approval he seeks and the bombs begin to drop, he wins this hand.

Neither outcome really has an upside. Outcome one virtually destroys President Obama's international credibility- he made a bold claim and couldn't back it up. Outcome two sees us involved in another Mid-east conflict and may tick off some of our allies who want more proof before action is taken.

Let's hope Obama has a few cards up his sleeve.

## What is Sarin Gas?

Sarin gas is not something you want to be exposed to. Odorless, colorless, tasteless, and highly toxic, this man-made chemical warfare agent is a ruthless nerve gas. For a firsthand look at the results of sarin gas exposure, perform a YouTube search for "sarin gas attack Syria." A word of warning though, this footage is not for the faint of heart and contains graphic images of violence and death showing men, women, and children victims.

## A Glass a Day Keeps the Doctor Away The Health Benefits of Red Wine

For thousands of years, red wine has played an integral role in human history. From religious ceremonies to cultural traditions, wine has been the drink of choice among gods, monarchs, and other societal elites.

Apart from its rich lineage and great taste, red wine provides excellent health benefits that Jesus and friends didn't know about.

Everyone knows that wine is the ultimate antidote for a long, stressful day. Recent studies have shown that drinking red wine can help fight depression. According to Spanish research, people who drank a glass of red wine daily had the lowest risk of depression compared to those who didn't drink.

While wine does wonders for your mental health, it can also improve your physical health. A study conducted in France claims that wine can boost cell function and prevent muscle deterioration. Another recent study published in The Journal of Andrology and Cancer Science reveals that a compound in red wine makes prostate tumor cells more susceptible to radiation treatment.

So what exactly is in red wine that gives us all of these health benefits? The answer is resveratrol, a compound found in

grape skin. Resveratrol acts as a preservative and protects the grape's skin from fungi. Its defensive nature makes it powerful against tumor cells, while acting as a preservative for muscle fibers and brain cells.

Another healthy compound found in red wine is piceatannol, which delays the production of fat cells and can also boost your metabolism.

The evidence supporting the health benefits of red wine is staggering, but there can be too much of a good thing. Drinking more than one to two glasses of wine a night can have adverse effects on your mental and physical health.

Thanks to both of these potent antioxidants, a daily dose of vino has been deemed acceptable by researchers worldwide. But not all wines are created equal. According to researchers at Cornell University, pinot noir contains the highest concentration of resveratrol.

Because the grapes used to make pinot have very thin skin, they maintain high levels of resveratrol and react quickly to fungi attacks.

Wines made from humid areas are also more likely to contain more resveratrol, since their grapes are more likely to fight off fungi. When shopping for a bottle, opt for wines from France, Oregon, and of

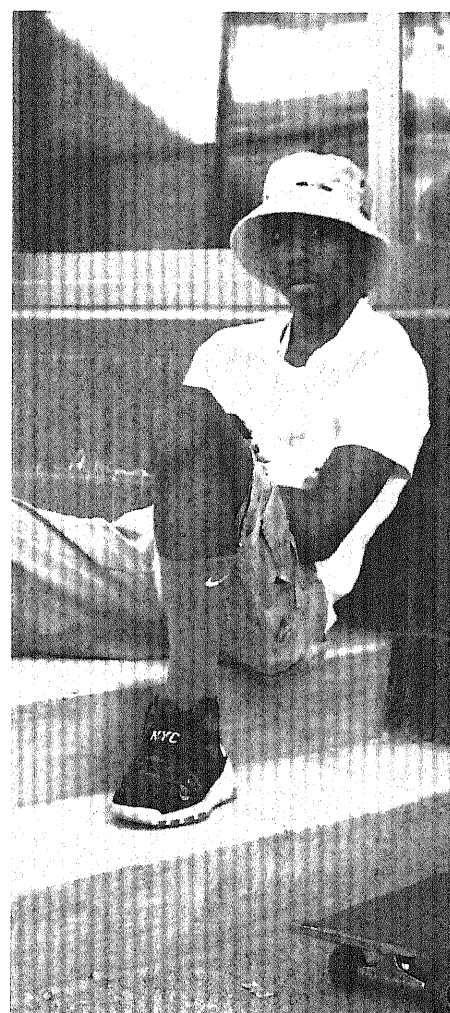

and textures. Emerald green is another popular hue for this season and can be paired with other jewel tones for a regal look.

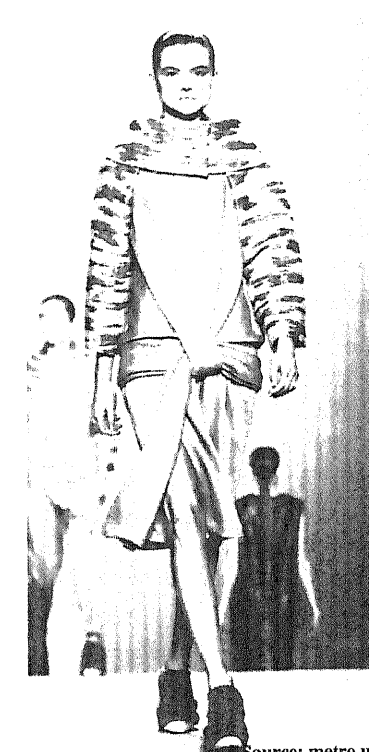

Fortunately for us girls, menswear inspired

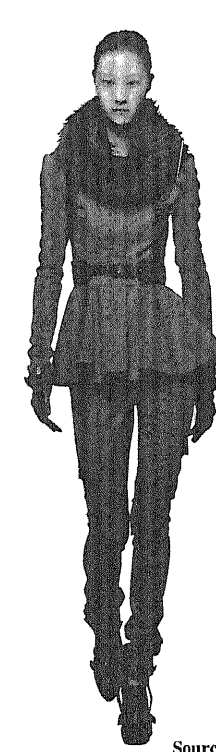

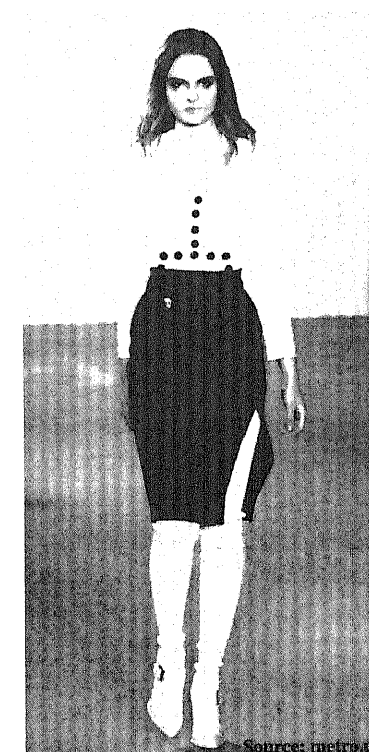

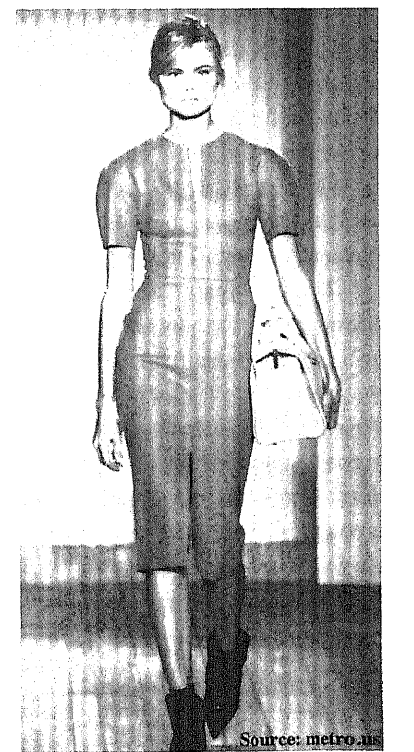

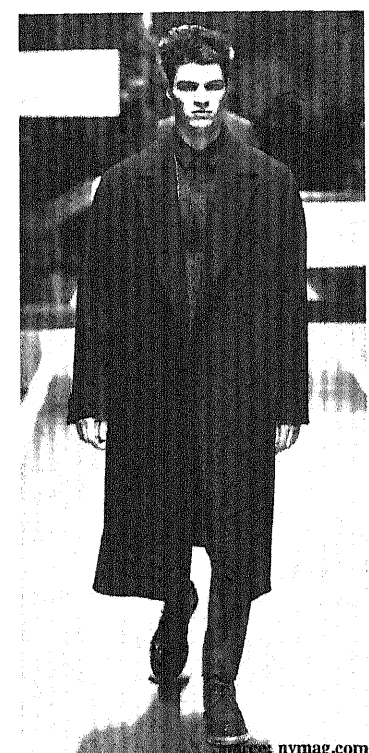

A chaotic, sci-fi comedy, starring Simon Pegg and Nick Frost makes this movie impossible to fail. It really invokes 'Invasion of the Body Snatchers', a classic science-fiction.

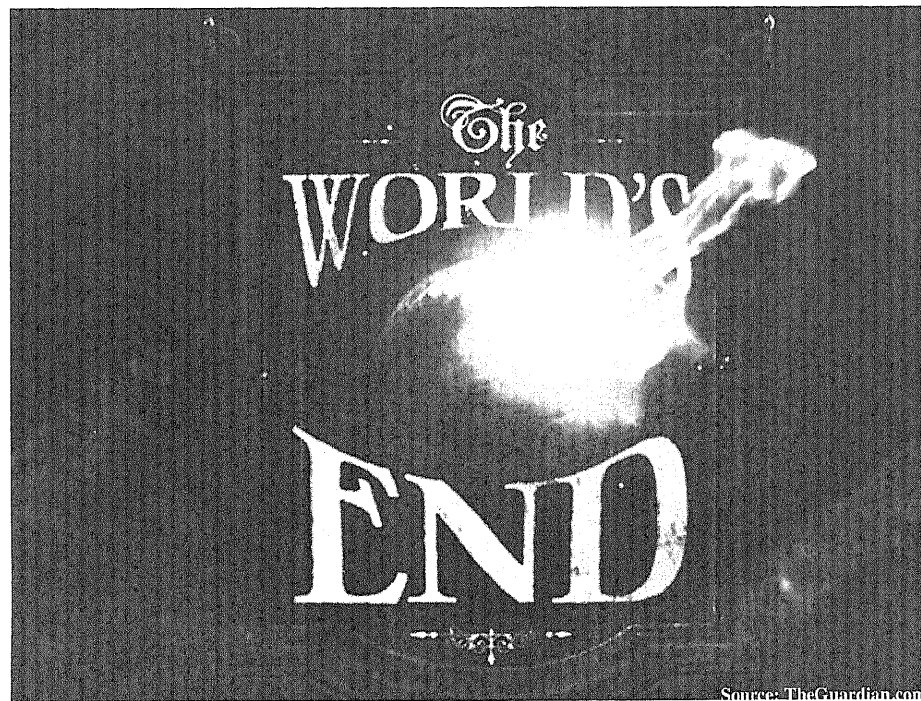

## Saint's Row 5 is as Funny, Addictive, and Fun As Ever

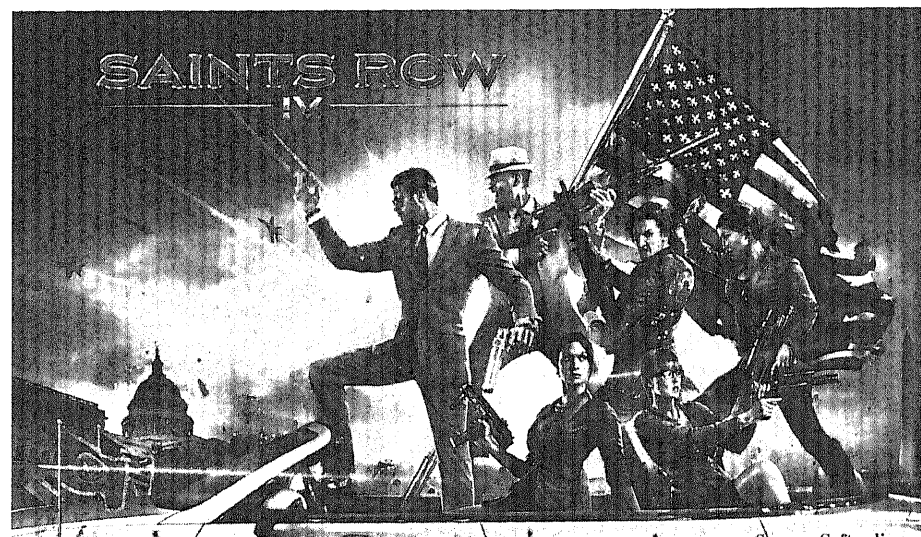
When These Saints Come Marching In You'll Know It

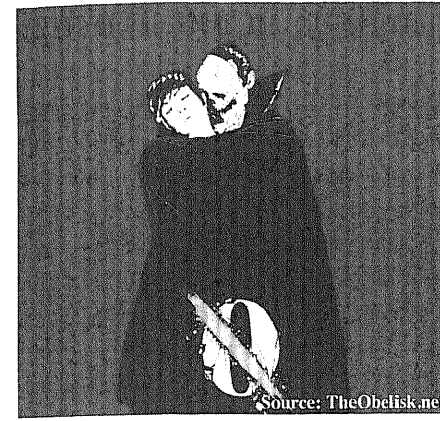

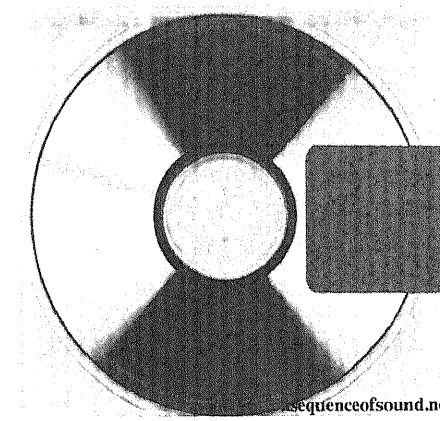


Queens of the Stone Age -

Yeezus

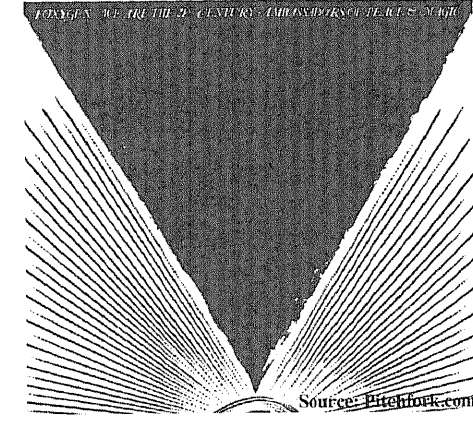

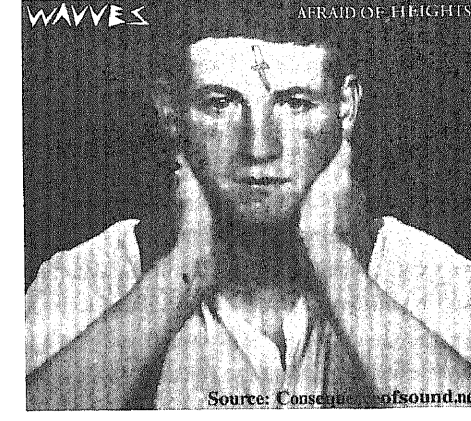

revoked and attacked are shown how they were assaulted horrifically.

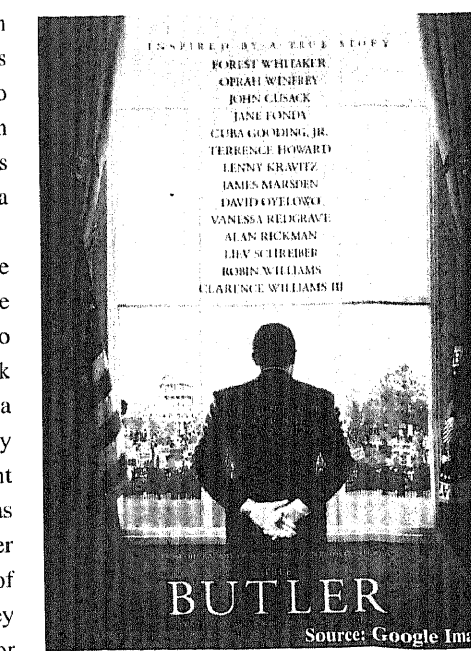

## Students Voice Their Opinions on the Successor to eSIMS

### *An Early Assessment on the CUNYFirst System*

CUNYfirst, the new system designed to simplify the way students can register for classes and review financial aid information, officially introduced to the College of Staten Island on April 1, 2013, evoked mixed reactions in students throughout the campus.

One of the major criticisms of the service amongst students is its difficult navigability. Kaitlin Jardine, a senior at CSI, asserts that "CUNYfirst isn't only not user friendly, it's a labyrinth of unnecessary folders and [gives] the appearance of being easy and friendly when in truth, it isn't."

In June 2010, students at CUNY Queens College and CUNY Queensborough Community College surveyed the system. The results were used to create a team composed of students and faculty who taught training workshops that focused on teaching students and staff how to use the basic features of the system.

From that point forward, the system spread to other CUNY institutions including Brooklyn College, Lehman College, York College, and LaGuardia Community College.

Approximately two years ago, the CUNYfirst reached CSI's Human Resources Department, and grew from there.

The college's website features a CUNYfirst page, where students have access to a range of "How To" tutorials that give a brief overview of the systems basic functions.

I recall one experience I had attempting to pay my tuition, something that, at first glance, appears to be basic. After half an hour of giving myself an unsolicited tour of the Financial Aid tab, I gave in and clicked on the "Help" link, which was hidden underneath the "My Links" dropdown menu in microscopic print to the far right of the page.

Clicking the link opened a new tab in my

browser window entitled "PeopleSoft Enterprise Campus Self Service 9.0 PeopleBook", a twenty-five "chapter" tutorial book that describes how to use the Student Center.

The book features chapters that cover setting up Financial Aid Self-Service to how to use Self-Service Student Admissions.

I discovered an option to show and hide graphics, located in the upper right-hand corner, which basically were screenshots of the different modules including Personal Information and Financial Aid Awards, that I had already spent half an hour staring at before.

Next to the graphics button was an option to show or hide a reference pane, which enabled me to skip to different chapters of the book so that I could skip to the information I needed without wasting time scrolling through the page.

The book does a decent job of organizing and describing the many different categories of the Self-Service page, but if you aren't a fan of reading descriptions of things that are pretty self-explanatory, then prepare for a frustrating experience.

Students find it very difficult to have the aspects of CUNYfirst that they like outweigh its shortcomings.

"I like how easy it is to sign up for classes and how you can view them all in the same window," says Mariah Metzger. "But the weekly view option makes it incredibly difficult for me to view my classes for a general week."

Another displeasure among students is the fact that it was released in the middle of last semester, a crucial period of time during which students are heavily focused on preparing for final projects and examinations, as well as registering for the following semesters' classes.

Although registration was pushed back to May 22, the poorly timed release date added a complicated task to many of students' to-do lists.

English Writing for Adolescent Education major at CSI Anna Tam expresses that she "felt like a freshman again." She was annoyed that she had to "relearn how to register, check grades and everything!"

"It's annoying at first, and I wouldn't say I'm satisfied," said Tam. "But I'd prefer if we stuck with the old system."

The thing about CUNYfirst that nags me the most is that it is incomplete. Following my first use of it, I had to wait three days because of "down time" which is a monthly maintenance period that lasts two to three days in order to update its current features, add new ones.

I likened the experience to my one-month affair with Windows Vista, back in 2007, a beta release that masquerades as an official operating system.

The CUNY website features a two-paragraph description of CUNYfirst, describing it in the first as "a massive upgrade in how we'll do things in the future." The following paragraph, states that it will be "implemented in phases," prioritizing academic structure and adding more features within the next few years.

It is disturbing that this service is out there with a lot of itself missing. Students should not have to deal with glitches and unresponsive links on a consistent basis.

"It could potentially be useful, but it just seems really buggy", says CSI student Alex Caroleo. "I had to wait three hours to register for a class because the website just wasn't processing my prerequisites; eSIMS was much easier and I never had those problems with it."

For nearly a month, there has been a

notification in the "CUNYfirst Alerts and Notices" module that states that the "Financial Aid tab is active only for Queensborough Community College, Hostos Community College, Gutman Community College, Lehman College, and CUNY Law School students."

No date referring to when it will be active for every institution using CUNYfirst has been posted. Accessing Financial Aid information is essential to every college student. Why would, if academic structure was prioritized in this system, the full features of the financial aid tab not be accessible to everybody?

Cynthia Prenelon, a former CSI student who currently attends Brooklyn College expresses her displeasure, "I sure can tell you the service sucks. Whenever there's an update and I have deadlines to meet, the website begins acting up."

"There are way too many glitches in that system," said Prenelon. "Most of the time my financial aid and classes get messed up, it doesn't even show that I've graduated which is ridiculous!"

The signs posted in the grass all over campus last semester as part of the marketing campaign might as well have been picket signs, a physical representation of the frustrations felt by many.

I do not understand why the City University of New York could not wait until all the components of CUNYfirst were ready and running smoothly before it ripped eSIMS out from under everybody.

A number of students will miss eSIMS, but it seems as though CUNYfirst is here to stay. It is normal to have the reactions that students are having now but such things come with change.

I am certain that CUNYfirst will get easier to use with time, so, for now, let's give it a chance.

The Dolphins strong 2012 season ended in disappointment after losing the CUNYAC to City College, 1-0, and then losing in the ECAC a few days later. The team is looking to put the past behind them as they have gotten off to a fast start in 2013.

The Dolphins are 2-0 after shutting out both John Jay and NJ City University. The team's defense has been lights out as they have allowed just six shot attempts against opponents compared to their 63 shots. One of the CSI's most important pieces on the defensive side is goalie, Victoria Donegan, who suffered a season ending injury last year.

## Men's Soccer Team Looks to Put CSI on the Map *A Young Dolphin Team and the Quest for the Title*

The latest CSI Men's Soccer campaign ended at the hands of NYU in the ECAC Metro NY/NJ Tournament and yielded a 11-11-1 record, the third highest win total in team history.

Head Coach John Tardy, now in his second year, is preaching commitment and responsibility which he hopes will result in a more focused team this upcoming season.

"Once you get a set of boys that get that sense of family and are willing to fight for each other; that's kind of what we got last year," said Tardy. "The commitment level is up. The work the guys put in this off-season is remarkable."

One of the biggest victories of the season for the Dolphins came in the postseason. The club, playing the role of spoiler, upset Rutgers-Newark for the win on penalty kicks in the first round of the ECAC Metro NY/NJ Tournament.

For CSI, it marked their first advance in the ECAC postseason since 1990.

Expectations are high around the club despite losing four senior stalwarts like Ahmed El-Ghareib and Giovanni Cortese. Tardy knows that building a good foundation of players to win and grow with takes time but both himself and his young team know that if

they play like they're capable of than they can reach the NCAA Tournament.

"We brought in 15 Freshman. I think we have a little more talent than we did last year," said Tardy. "The new guys we have coming in bring a lot to the table."

Tardy's team consists of hard workers who put the good of the team before their individual stats.

Hard work begins in the off-season which is why Tardy has stressed dieting and conditioning; hoping it will sustain them over the course of the long season.

"They have to pass several fitness tests before they can actually step on the field like the Cooper test, the beep test," said Tardy. "Certain guys are put on diets because they need to lose a little weight."

Returning to the action for the Dolphins this trip are Junior captain Alfonso Castaneda, Sophomore (MF) Brandon Cadmen and Junior (F) Michele Kissi. After not having a full off-season to recruit, Coach Tardy made full use of it this time bringing in names like Sophomore (MF/F) Arlind Nika and Junior (MF) Thomas Vasquez, a former star in Puerto Rico whose new teammates are excited to play with.

"He's a really good, smart player," said Freshman (MF/D) Nobel Habgu. "He sees the game 2 or 3 steps ahead of most other guys."

Defense is a vital part of every sport and soccer is no different. The team gave up double digit shots on goal in five of their eleven losses.

"A lot of the games last season we lost in overtime, the last minute of the game," said Cadmen. "We have a lot of variables in the midfield and a good defense (which) is going to help us in not conceding goals."

Part of the clubs 11-11-1 record is a 4-4 conference record which has to improve in order for them to win their conference and capture a CUNY title. The Dolphin's first test is a home contest versus M.I.T. on Saturday

August 31, at 4pm.

"Four of the first five teams we play were ranked Top 25 during the course of last year," said Tardy. "Four very challenging teams right off of the bat to kind of test ourselves and get our guys playing at a faster speed and a higher level."

A rematch of the ECAC Tournament game at Rutgers-Newark is slated for September 14, at 5pm. The season will culminate in early-November with the CUNYAC Championship which will be played for the first time at Brooklyn College.
