RIVAL SHAMELESS

Says O'Connor Is Exploiting the Mentally III in State

Governor Rockefeller accused Frank D. O'Connor yesterday of "shamelessly exploiting" the misery of mental patients for political gain.

Resuming his personal attacks on the Democratic candidate for Governor, Mr. Rockefeller charged Mr. O'Connor with showing mental patients on Democratic television commercials to dramatize "a thoroughly reprehensible distortion of our record in this field."

Ignoring Mr. O'Connor's charge that he was descending to "gutter politics," Mr. Rockefeller said he would continue in the remaining days of the campaign to stress Mr. O'Connor's "lack of size" for the job. of Governor.

Standing on the curb outside the headquarters of the New York Eoard of Rabbis at 10 East 73d Street, where he had met in closed session with Orthodox, Conservative and Reform Lewish leadors the Covernity of the form Jewish leaders, the Gov-ernor said Mr. O'Connor was using the mentally ill and retarded as "political pawns in the campaign.

Rabbi Defend Covernor

A rabbi on the fringe of the crowd spoke up to say that Mr. Rockefeller had done more than any other Governor to improve conditions at Willowbrook State Hospital for the mentally retarded, on Staten Island. He identified himself as Rabbi Philip Goldberg, Jewish chaplain at Willowbrook.

Ar. O'Connor paid a surprise visit to Brooklyn State Hospital on Oct. 14. He described that mental institution as "horrible" and charged that of more than 89,000 patients in state mental hospitals, 16,000 received "no treatment at all."

The Governor discarded his text, but told newsmen he stood by it. Answering a student's question he said the two higgest disadvantages in his race for re-election were upstate opposition to the sales tax and to the Medicaid program.
