Willowbrook 'Deal': A See-Sawing Row

Councilman Frank Biondolillo, chairman of hearings on conditions at Willowbrook State School, has charged "a deal" has been made by the state with two dismissed employes to reinstate them and oust the school's director, Da Jack Hammond, "within six weeks."

Biondolillo said the deal was agreed upon at a 4hour meeting last Monday between State Commissioner of Mental Hygiene Alan D. Miller and representatives of Dr. Michael Wilkins and Mrs. Elizabeth Lee.

Dr. Wilkins and Mrs. Lee, who had no tenure in their civil service posts at the state school, were released by Hammond last month assertedly because of personality differences.

The hearings presided over by Biondolillo are being conducted by the Society for the Prevention of Cruelty to Chil-

A Pledge Of Help

ployed at the island school.

"deal" to put the ousted pair back in Willowbrook had gone through. He also, insisted that the fate of Dr. Hammond had been sealed.

Miller and several other state officials had met with members of the Benevolent Society Jan. 27 in an effort to effect a reconciliation between them and Hammond.

When it was believed agreement had been reached, the two dismissed employes returned to Willowbrook Jan 28. to be reinstated.

Other employes, however,

vigorously objected to the return of the two ousted pair. This pressure led to a disrpution of care and treatment programs for the residents of the school, Grunberg said.

Miller's letter pointed out that the two employes would not be reinstated at Willowbrook because it "would undermine employe morale and cause disruption of patient care."

The state has offered to permit the two to "consider the possibility of employment elsewhere in the department."
