

# A daring lure in kidnap case

## Minister risked his own family

The accused kidnapper of Jennifer Schweiger lived in the West Brighton home of a storefront preacher for almost a month as police sought evidence to implicate him.

The amazing story came to light yesterday when the Rev. Charles G. Muskett revealed how he and his wife, Carolyn, took the risk of taking Andre Rand in at the behest of the police.

"We have 'special children,' too," he said, "and I felt a sympathy for Jennifer and her parents. I could just feel what it was like."

Mr. Muskett said he rented a spare room in his home at 1062 Castleton Ave. to Rand shortly after the July 9 disappearance of Jennifer, the 12-year-old Westleigh girl who has Down's syndrome.

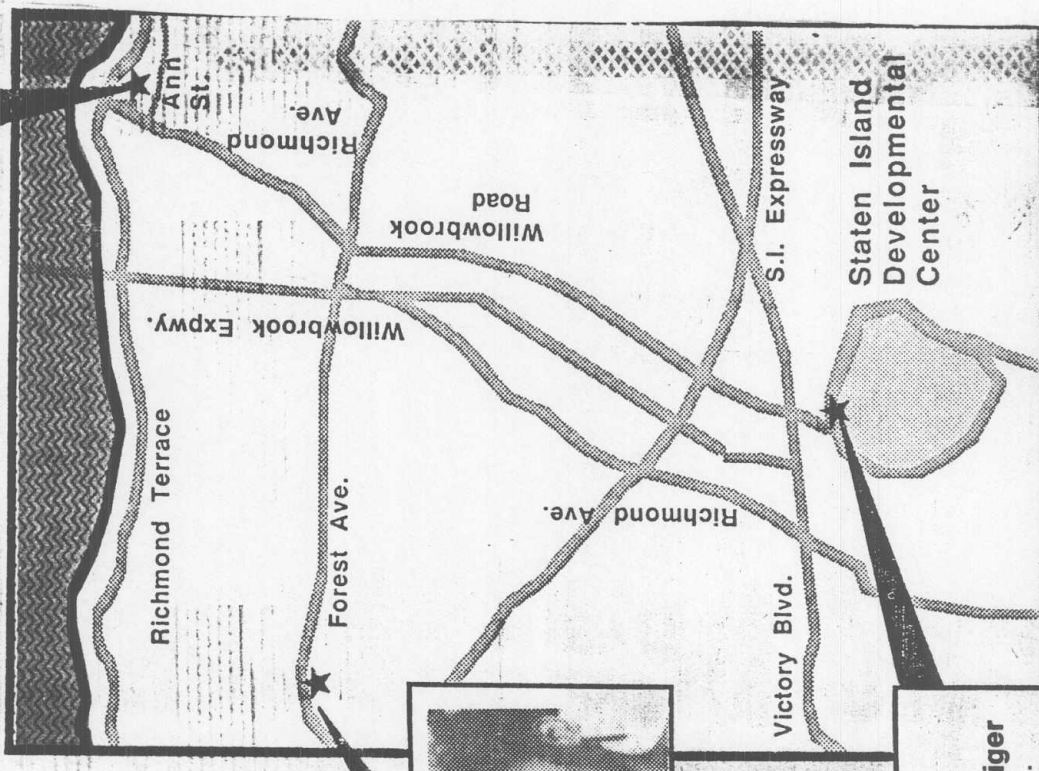
Rand was apparently looking for a room after police discovered his encampment on the grounds of the Staten Island Developmental Center. After Rand approached the Musketts, police also talked with them, requesting them to take him in so he could be placed under surveillance.

Despite his initial fear of what Rand might do to his six children — two of whom are mentally retarded — Mr. Muskett said he allowed detectives to place an electronic listening device in his kitchen table in an effort to get Rand to implicate himself during the month he lived with the family.

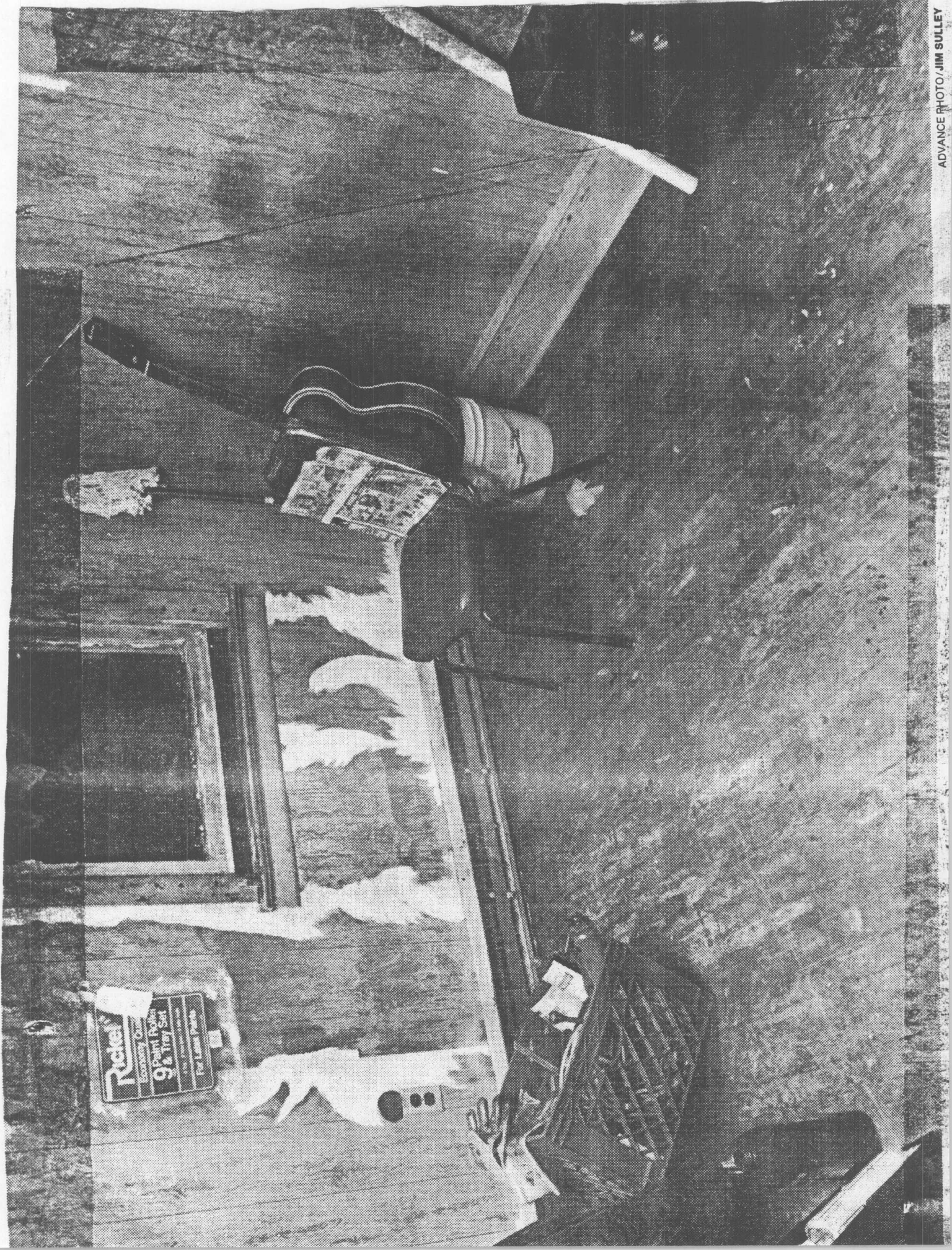

lice were secretly taping Rand when he told the preacher that authorities "were looking in the wrong places. Who says she has to be buried?"

Police yesterday declined to comment on the existence of an electronic bug in the Muskett home. Assistant District Attorney John Loughery, who is handling the case, did not return calls to his office.

Mr. Muskett, 44, said his only regret about exposing his family to Rand is "we haven't found Jennifer."

According to witnesses, on the day Jennifer disappeared, she was last seen walking with Rand on the grounds of the Developmental Center in Willowbrook.

Mr. Muskett, a part-time Pentacostal minister who works full-time for the Postal Service and has his ministry in the building in which he lives, also said two of his sons, David, 14, and Donald, 11, were seen with Rand on his late-night jaunts to the Pathmark Supermarket at 1351 Forest Ave., Port Richmond, in the weeks following Jennifer's disappearance.

David said last night that while in the vicinity of the supermarket, Rand would point to houses and say they reminded him of houses he lived in "on Long Island."

Mr. Muskett said detectives from the Staten Island Crimes Against Property Squad, which investigates missing persons, wanted the two boys to stay with Rand while investigators kept the man under 24-hour surveillance.

"They (Detectives Robert Jensen and Ralph Aquino of the Property Squad) assured me that they would take all safety precautions and (his sons) would be all right."

Mr. Muskett said he told David what was happening but did not tell Donald because he was too young and might accidentally reveal the plan to Rand. David readily agreed to help, his father said.

Mr. Muskett also said: "(Rand) hung around with and liked mentally retarded people. That's why he liked my son Chippy. He could lead people who were not as intelligent as he was."

Charles Muskett Jr., 17, nicknamed Chippy by his family,

was in danger. I have a 10-month-old baby," Mr. Muskett recalled yesterday, pointing to his daughter Susan.

His concerns increased when police told him that in 1969 Rand had been accused of raping a 9-year-old girl in the South Bronx, "but told me not to tell my wife." Mr. Muskett said he did not tell his wife of the alleged rape.

Rand later pleaded guilty to a sexual abuse charge and served a year and four months in jail for the crime, according to police.

However, "a lot of prayer and God" convinced the Musketts to go along with the detectives' plan, and several days after the girl's disappearance Rand moved into their home.

Mr. Muskett said he first met Rand about three months ago in the Pathmark parking lot as the drifter was leaving a Salvation Army soup kitchen. They became friendly and often talked about the Bible.

"He was very friendly, very intelligent," Mr. Muskett said. "I believe he has a high IQ."

"He seemed religious of a sort. He most liked to hear about (the book of) Revelations, about God's vengeance upon man for being evil."

Rand "seemed familiar with Revelations," but not the rest of the Bible, the clergyman said. "When I tried to steer him into other parts of the Bible, he only wanted to talk about Revelations."

Eventually, Mr. Muskett learned from Rand that he was "living in the woods," and the preacher offered to rent him a room in his home because "you felt sorry for him living out in the woods."

However, Mr. Muskett changed his mind about renting to Rand because the homeless man didn't get along with his youngest son Donald. "They fought all the time, like kids."

Despite his trepidations, Mr. Muskett cooperated with police, even missing a day at work to let them into his home so they could place the electronic listening device, he said. He was docked a day's pay for missing work, despite police explanations to the Postal Service, he said, adding that he is still trying to recover the money.

Mr. Muskett said that in trying to get Rand to talk about the Jennifer disappearance, the suspect told bizarre stories in which he claimed he had seen a lot of brutal action as a Green Beret in Vietnam.

"He said he killed women and little children," Muskett said.

However, Lt. Louis Fiore of the Crimes Against Property Squad said that although police knew Rand was in the military, he had not been in the Green Berets and had never been in Vietnam.

Mr. Muskett admitted that when police first approached him and his wife a few days after Jennifer disappeared, they were leery about cooperating with the detectives.
