Schweiger, already sweat-soaked from hours of searching, breezed in with his wife, Karen, and Cardinal O'Connor.

Embracing a new battle plan, the entire volunteer

search effort was focused on SIDC.

Donna Cutugno, co-ordinator of a group called the Friends of Jennifer, called on the searchers to keep an eye out for fox holes and dry wells, along with any garbage bags, traces of clothing, and freshly dug earth.

Creeks, sheds, and Andre's former campsite on the SIDC grounds were also targeted. Tips from psychics, children who would regularly see Rand in the community, and former SIDC employees were all being followed up on.

Searchers yesterday were eagerly following up on witnesses reports that they saw Rand with what appeared to be Jennifer's purse. The witnesses said they saw Rand driving a brown car and carrying

Jennifer's purse after her disappearance.

Whistles were handed out to help people keep track of each other in the woods. Stacks of thousands of missing persons posters bearing Jennifer's picture were quickly scooped up by volunteers who would be pinning them up and handing them out during the day.

"You are looking for the family's real treasure," Cardinal O'Connor told the determined group. "If you can help return that gift, you're making a

tremendous contribution."

As the cardinal turned to embrace Mrs. Schweiger, volunteers filed into the parking lot and prepared to march on SIDC. Soda, ice, flashlights, and shovels were loaded into cars and trucks, supplies for the day's mission.

"We'll do what we call a sweep," Bianco said, referring to a criss-cross search pattern employed

by soldiers in Vietnam.

James Donohue, Martin Merjave, and Tim Goldbach, all veterans with the New York POW MIA Public Awareness Coalition, helped review maps of the area as the group assembled in the church parking lot.

Volunteers without military training, but seasoned by weeks of trodding through the Island's woodlands, themselves took on the look of commandos. Hiking boots, caps, canteens, and walking sticks were stan-

dard gear.

The troop swept into SIDC, setting up a rest station which included a Red Cross mobile kitchen. On previous days, an Emergency Medical Service technician had been tending to the cuts, insect bites and poison sumac. Yesterday Dr. David Pfaff of Dongan Hills volunteered to tend to the wounded "I was a little surprised," said Richard Carisinacting supervisor of SIDC's security force yesterday. "We are behind what they (searchers) want to do, we just wish we knew they were coming."

Colunteers fanned out through the woods, while Ken Schweiger, himself a veteran, led a team of the former jungle fighters to Rand's former campsite tome.

"We've got to find something," Schweiger said

resolutely.

Mrs. Schweiger, accompanied by a tightly knit group of family members and friends, helped track the search effort and direct some of the volunteers. "They (the Schweigers) are tremendously courageous people with a deep faith," Cardinal O'Connor

said yesterday, "a truly inspiring couple."

A specialized team of police officers trained to search rugged terrain were out earlier in the day, searching through sections of the Greenbelt in Sea View, and portions of William H. Pouch Boy Scout Camp, according to Sgt. Norris Hollomon, a police spokesman. The police search is scheduled to be in the same areas today, the sergeant said.

Police are also checking into three notes found parlier in the search in the woodlands near Rockland Avenue and Manor Road in Sea View. Pieces of paper with the words "Jen" and "Jeni" were found

taped to trees in the area, according to Mary Reilly, who was among the volunteers who made the discovery.

Volunteers will continue to gather at the Holy Family Church daily at noon and 7 p.m., and a special mass in honor of Jennifer will be held in the

church Thursday.

Searchers yesterday, undaunted by the heat andstorm clouds, continued to search into the night.

"It's not the heat," Dennis Wonica said wiping sweat from his brow during the search. "We're running out of time. Who's taking care of Jennifer?"
