CSI's Education Department Up For Crucial Review

CSI will undergo a secondary review of its Education department by the Washington D.C. based National Council for Accreditation of Teacher Education (NCATE) this December. If the department does not fulfill what it previously lacked in the recent testing, it will have three years to get up to par or face possible shut down.

NCATE only granted CSI's school of education provisional accreditation in October of 2005. Among the six categories of criteria that needed to be met for full accreditation, the department fell short in one category, "assessment system and unit evaluation." In a recent letter to the editor to the Staten Island Advance, CSI President Marlene Springer clarified that "assessment system and evaluation focuses on the analysis of student performance and not the performance itself." The other standards CSI passed were faculty qualifications, candidates' knowledge and skills, field experiences, clinical practices, resources, and diversity.

It is a New York State requirement that the state board of regents or an external bureau such as NCATE must accredit all schools that teach education. When full accreditation is acquired it is in effect for seven years. When only a provisional accreditation is granted it must be reviewed after two years.

Robert Huber, a CSI spokesman, is confident the department will not have an issue gaining full accreditation in December. "We're well in the process of remedying the situation, it's a matter of collecting data and applying it," said Huber.

The Education Department will only be re-tested on the area that it fell short; if it should pass, it will immediately be granted full accreditation. Failing, however, does not necessarily mean a department shut down. CSI can submit a "corrective action plan" which will state its plans for improvement. This plan will have to be submitted to the state commissioner of education, and if approved, the school will have three years to actualize it. According to the State Education Department no other suspensions would be implemented, meaning that CSI could continue to render degrees as usual.

CUNY Capital Project Gets CSI \$17 Million

A \$17 million project to trench up and fix the inadequate underground lighting conduit system, which has caused frequent electrical shortages, will not begin for three years.

When the campus was given to CSI, almost twenty years ago, the builders installed faulty PVC pipes, unable to sustain weathering. Not only did the builders cheap out on the pipes, but they also failed to bury them deep enough.

The cheaper, plastic PVP pipes, as opposed to the metal pipes that they should have used, have cracked and let water seep inside. According to an email from Tom Tyburczy, "Water freezes during the winter and

thaws this time of year creating the shorts."

The campus has no history of violent attacks at night, but students feel that the campus should still be well lit. "I get outa my music class at class 9:35," said Norma Chia, "sometimes the whole strip is dark."

The strip that Chia referred to stretches from the library to the campus center, and can seem eerie late at night with no lights. "I'm not scared," Chia said, "I usually walk with friends and classmates, but just because it's a safe campus doesn't mean we should have to walk around in the dark."

"The lighting situation on campus is terrible," said Alex Proto, the vice

Cafeteria Guilty of Health Violations



There were no reports of spoiled food or mold and the administration assures all students that cafeteria food is safe for consumption.

The Staten Island Project (SIP), whose Associate Director is CSI Political Science Professor Richard Flanagan, created The Staten Island Social Capital Community Benchmark Study to investigate how Staten Islanders felt about their community such as their neighbors, friends, political organizations, and other factors that shape their society. Their findings were presented at the conference "Building Community on Staten Island in the 21st Century" on April 13, 2007, in the Recital Hall in the Center for the Arts.

President Springer welcomed those in attendance saying that holding this conference is, "one of the many ways the college can make a contribution to the community." She also broke news that CSI would be acquiring a supercomputer within the next week that will be a, "major resource not only for New York City, but the whole region."

The survey uncovered that 18-34 year old college students are more dis-

n March 1st New York City passed a symbolic law banning the use of the N-Word unless used in a historical significance. The ban is purely figurative and there aren't any official efforts to enforce or police the ban. Apparently the measure began because of an L.A. Nightclub incident where Michael Richards (Cosmo Kramer) used the n-word a multitude of times during his act; unbeknownst to him, a camera phone was filming.

The public definition of the n-word used today can have slight variations, but is generally reserved as a physical, social, and cultural identification tool. Depending on one's connotation and complexion the word can convey completely different meanings from anywhere in the emotional spectrum. Unwritten social norms govern the word "nigger" and incorrectly assign it's social identification to those that have "a noticeable drop of black blood;" a double standard is created and disallows those outside of the nigger identification from using the word. Thus for the first time in American histo ry, white middle class begins to feel ostracized.

In a literal sense, the word nigger suffers from a lack of widespread definition and understanding. The word incorrectly gains an assigned skin tone from similar words such as Negroid and Negro, both correct scientific identifications for persons of noticeable African descent. Negroid originates from a human classification method separating homo-sapiens into categories based on skull design; the Negroid, Mongoloid, and Caucasoid respectably represent persons of descent from Sub-Saharan Africa, North-Eastern Asia, and finally European/Middle Eastern descent. Innocently enough, the word Negro is a Spanish adjective that seeks to define a subject as "black in color." Of course, this subject doesn't have to be a living being and can be used to describe anything, much like how we would define our shoes, car, or pen as black.

One could infer that if the n-word only rooted from a neutral classification of skin tone, then the massive controversy regarding the usage wouldn't even be a factor. Though, over the evolution of language, the negative connotation of the n-word stems from a like word: "Niggard." According to Oxford's English Dictionary "The [n-]word was initially used as a neutral term, and only began to acquire a derogatory connotation from the mid 18th century onwards [...] for coincidence of the word in some dialects with Niggard."

Unlike the words Negroid and Negro, Niggard isn't attached to any specific skin tone, race, gender, handicap, sexual affiliation or otherwise; instead the word can

summoned by a radical cleric Moktada al-Sadr, arrived at the Shilte holy city of Najaf on the fourth anniversary of the U.S. occupation

"No, no to America, yes, yes to Moktada," thousands of protesting Iraqi men and youths, marching through Najaf, shouted. The public disorder forced the government to drop the national holiday on April 9 and to rule out the automobile traffic for 24 hours.

A group of Sunni clerics accepted the invitation from the Shiites to take part in the demonstration. If Sunnis and Shiites unite in their resistance against the invaders, the U.S. military will be in a big trouble. Sadr seems to be the right person to piece together such a unified front. The U.S. officials claim that Sadr,

who accuses the U.S. of responsibility for the neverending spiral of violence in Iraq, left for Iran, but Sadr's people and Teheran deny it.




Guatemala Hosts IDB Conference



goes on," indicated Director of Marketing and Public Relations, Robert Huber. "We always strive for excellence and perfection. This is an opportunity for us to improve. Very few people get 100% on every test they take."

According to Huber, the violations included: loose ceiling and wall tiles, a small leak in a sink pipe, absence of a thermometer in a reachin refrigerator, the presence of fruit flies, a broken soap dispenser, absence of a shatterproof casing for a single light bulb, carbon dioxide tanks not properly secured, upside down storage of the plasticware, and slicing of some food at 8 degrees warmer than mandated by city regulations.

"I buy my lunch almost every day from the cafeteria in the Campus Center," said Vice President for Student Affairs, Carol Jackson. "Both the food and its preparation are of high quality. Though I haven't tried it myself, I hear the pizza's great."

Many students do not share the administration's enthusiasm for the cafeteria cuisine. "I've eaten cafeteria food on multiple occasions and found it to be of a somewhat lousy quality," said Education major, Michael Gualtieri, 22. "I understand that the violations weren't too extreme but they should keep it up to the health code standards all the time."

Student, Ashley Hurwitz, 19, says she's not surprised about the violations. "It doesn't seem like the cleanest place," she said. "The sandwiches and pizza aren't bad, but I've tried food from the dinner menu that was so disgusting, I wouldn't feed it to my dog."

The Department of Health became interested in investigating the cafeteria conditions at CSI after they received an anonymous complaint that a worker had been handling food while wearing only one protective glove. Inspectors did not find evidence of this practice during their investigation.

On April 11, inspectors returned to CSI and discovered additional violations. According to Huber, these included: the absence of test kit to determine if a proper amount of sanitizing agent was being released into the dishwashing cycle, and the preparation of some food at temperatures that did not meet city regulations. The administration indicated that these problems have also been rectified.

"I think the cafeteria food is very good," said Huber. "We are very proud of the service. I eat there almost everyday. CSI places the highest value on the health of its students, staff and faculty and value the high-quality of its food service."

and it just came to me naturally."

After a recent match, Seshadri reflected on his time with the team. "The tennis team is a very friendly thing," he said. "It's a really friendly environment. People pump up each other and support you. I'm gonna miss it when I graduate."

The winter weather took a toll on the tennis player's game and he spoke about the problems playing in bad weather. "The cold was annoying because it slows down your reflexes and slows down your actual movement," he said. "You get really rusty and you have to learn to play with the cold."

Windy conditions affect the outcome of a match and can frustrate a player. "The wind is annoying because it throws

the ball around so when the ball is coming at you if the wind is blowing against it, it stops the ball," he said. "So if you're expecting the ball to come over here, it lands over there."

"You're not there playing your best obviously so when you're not playing your best and you see that you're losing. It's frustrating thinking you could have done a lot better."

Seshadri and the rest of the men's tennis team look forward to the CUNY Tournament at the end of April. They have three games remaining before they head to the National Tennis Center in Queens, NY in search of CSI's 11th CUNY Championship. They have Conference matches against City College on April 17 in Manhattan and return to CSI on April 20 at 3:30 p.m. to take on second place Baruch College.

connected from the community compared to other age groups. Also, they tend to be more distrustful of society, and individuals born after 1976 tend to reject public political service, but are open to volunteerism.

Professor Flanagan presented the findings of the SIP, which he hoped would, "spark dialogue about the meaning of community on Staten Island. Blood things flow from a vibrant community." He also stated that Staten Island is "lagging behind" the nation when it comes to issues of community engagement. However, the borough is unique in the fact that its population has, "more diverse friendships than most Americans."

Reasons for Staten Islanders lack of social involvement include obligations to work and family, lack of information provided, problems with transportation, and a feeling that they lack efficacy.

Marchi noted that remedies for this lack of civic participation must take into account the size and population of the borough in order for them to be feasible. In addition, he stressed the need for bipartisan support in the endeavor.

On hand to hear the results of the survey were CSI President Marlene Springer, Senior Vice President for Academic Affairs/Provost David Podell, Mce President for College Advancement Richard Truitt, and Associate Dean for Student Affairs Michael Daniels, along with numerous other individuals from the faculty and administration. Notable guests included Council Member Michael McMahon and former New York State Senator John J. Marchi, for whom one of CSI's buildings is named.

president of student government. "The path between 3S and 6S is pitch black," said Proto, "It can get so dark that I can barely see several feet in front of me. I'm not scared but some of my female friends have told me that they are afraid to walk alone. We definitely need some major improvements with the lighting on campus."

Major improvements are coming but not soon and the solution has not come easily. Structural guru and CSI professor, Ralph Giordano once walked around the entire campus and made a report of specific problem areas. Like most faculty, Giordano has been aware of the recurring lighting problems for years. Unlike most faculty, Giordano took action. He reported his analysis of the problematic light posts and "low bid construction", but like a piano player in a whorehouse, no one paid much atten-

"It's spaghetti down there,"
Giordano said, referring to all the underground wiring on campus. "You can't just stick a backhoe in the ground and dig. It's an expensive project and there are a lot of complexities to the issue."

"A couple of years ago we addressed the issue," said Bob Huber CSI's public relations representative. "There was a time in which if one light went out it was like a string of Christmas light bulbs, a whole line of lights would go out. We've corrected that now so that if there is a short only one light goes out."

After waiting years to fix the out-door campus lighting, CSI only has to wait three more years. "The budgeting process happens in an organized organic and prioritized fashion," said Huber, "\$17 million has been set aside to dig up the conduit system and install new lighting throughout the campus."

The Banner Responds to WSIA

WSIA is pleased with the FCC's decision to grant our application for renewal of our broadcast license, but we were disappointed with the Banner's coverage of this notable event. In particular, the headline and final sentence declaring the station's reaction to the decision to be "screw you" to those who challenged the renewal was both inaccurate and damaging. Nowhere in this piece was this phrase attributed to any member of WSIA; the implication is that this is the sentiment of the entire station. "Screw you" is not the official position of WSIA. Likewise, the assertion that the "staff of the radio station believes it was a personal vendetta from a former member" is inaccurate, and the lack of attribution suggests this position to be official. Had the Banner approached me for comment for this story, I would have made these points clear.

Later, the story states Chief Engineer John Ladley mailed files to Samantha Zito. This is also inaccurate. In truth, Mr. Ladley was not present when Ms. Zito visited the station, nor was he involved in any discussions regarding providing her with documents. Again, the Banner did not follow up with Mr. Ladley to confirm this statement.

Officially, WSIA is pleased with the FCC's decision, and has taken steps to address the sole point the FCC found to be substantial — access to the station's Public File. WSIA disagrees with the remaining claims presented by the petitioners, but recognizes the right of any community member to voice concerns regarding the station.

WSIA is licensed by the FCC to serve the public interest, and responds to criticism it receives from the public with the utmost seriousness. The Banner's suggestion to the contrary does a great disservice to WSIA and its members.

In response to the letter from Mr. Masciantonio, The Banner would like to comment on his disappointment with the use of "screw you" on the deck and in the kicker. The Banner did not imply, or intend to imply, that the statement was made by WSIA collectively. In fact, the unattributed kicker quote, "Screw you David Sheer and Carl Sabantino," was made by a student/WSIA trainee. The Deck was meant to imply the opinion of this person as a future part of WSIA and not a present member.

As for the comment that the "staff of the radio station believes it was a personal vendetta from a former member," being inaccurate, The Banner reported on November 13, 2006 that in the official response to the original petition, CSI claimed "[t]he Petition to Deny is frivolous, insubstantial, premised on irrelevant and/or false allegations of fact, and the petition was filed in bad faith, as part of an attempt by the Petitioner to wrest control of WSIA from the College for the private benefit of the organization of the Petitioner, one Carl Sabatino." This indeed implies that the comment is not only the stance of WSIA. but of the entire college.

As for the last concern regarding Chief Engineer John Ladley's involvement with mailing Samantha Zito the public files, The Banner never stated that he was present when Mrs. Zito visited. Ms. Zito, who has no ties with CSI or WSIA, asked for files from students who did not know the proper procedures for access to public files. The FCC judgment stated that CSI Vice President Carol Jackson told John Ladley to mail Ms. Zito the files.

The information in the article was not negative towards WSIA. We are proud that WSIA's license was renewed and look forward to working with them to expand their news department.

FREEDOM OF SPEECH THREATENED AT CSI

On March 30, 2007 several dozen copies of Third Rail, the political-arts journal of the College of Staten Island (CSI) were stolen from their rack and dumped in a nearby garbage can less than thirty minutes after they had been distributed. This was the first of at least two such incidents. Since then, approximately 550 copies of the issue have been dumped or destroyed at a cost of \$1.49 per copy totaling in an \$819.50 loss in the CSI Student Activity Fee. Copies have disappeared from several places in the Campus Center (1C) as well as the Performing Arts Pavilion (1P), the South Administration Building (1A) and the North Administration Building (2A). It was made clear that the copies were being dumped, and in effect stolen, when approximately seventy-five copies were discovered in a trashcan just outside the entrance to the Campus Center near the Green Dolphin Lounge by Illya Geller, the former Vice President of Student Government. The editor-in-chief of the publication, P. Melissa Fisher, notified Associate Director of Student Life, Gregory Brown, immediately following the discovery of the theft of the first distribution. The losses have taken place during spring break when the student population on campus is particularly

low but the full staff and administration are still present. The known incidents occurred between 12:00 pm and 5:00 pm on business days between March 30, 2007 and April 5, 2007, and might have been caught on security cameras, but the footage has not yet been reviewed at this time. Gene Martinez, CSI Director of Public Safety, has promised to review the footage.


Fisher said of the incident, "Third Rail prides itself on being a champion of the First Amendment, and the entire staff is deeply saddened by this violation of our right to free speech. We look forward to the day that we can see those responsible for this prosecuted to the full extent of the law."

The Student Press Law Center (SPLC) indicates that the actions of dumping copies of a student publication, even if it is free to the college community, is a crime; some of the "possible charges include: larceny, petty theft, criminal mischief or destruction of property," (SPLC). If convicted, those involved are subject to the all legal ramifications of those infractions. Third Rail intends to contact the SPLC for support within the week.

ly every school on Staten Island and in hundreds across the country. "Our board pass rate is higher than that of Columbia's," said Huber. "The most recent board pass statistics were 99% on the Liberal Arts section and 100% on the Teacher Education section."

The general student body seemed surprised by the decision and some were even unaware of it. "It's a pretty thorough department, I'm really surprised that it was criticized at all, I had no idea," said English Writing major/Education minor, Rachael Albanese. English majors with a minor in education are generally training for secondary education.

CSI granted 150 baccalaureate degrees in education and 235 master's degrees in education last year alone. "From what I heard even before I came here, if you' are going to study education you should do it at CSI," said Writing major, Education minor Jenny Zajac.





Shangri Las, and even Elvis Presley.



"A little bit of anorexia, a little bit of bulimia," she said, "I'm not totally OK now but I don't think any woman is."

Back to Black is a fun and interesting album, but does have its low points. The ballads "Love is a Losing Game" and "Just Friends," are boring, sappy and cliché. In this case, however, the good outweighs the bad and Back to Black is worth a listen.

A Short Guide to the Killswitch Engage Record Collection

illswitch Engage isn't your typical metal band and this unique difference is what sets the band apart from everyone else. Since 1998 Boston's Killswitch Engage have become one of the most recognizable bands in the metal scene. After ripping their name from an X-Files episode, the band formed in 1998 with frontman Jesse Leach. The band has combined screaming vocals and metal riffs with a barrage of melodic, emotional choruses. The musical arsenal is guitarists Adam Dutkiewicz, Joel Stroetzel, bassist Mike D'Antonio and drummer Justin Foley. Leach's lyrics stray from the metal norm and are filled with hope and the belief that there is always an answer. "The Element of One" off their first album, 2002's Alive or Just Breathing seems like a prayer in song. Its lyrics are laced with religious overtones and the belief that in God there is rejuvenation. Leach sings the lyrics, "Breathe me in, I am eternal." Metal bands never had the audacity to sing about God over such heavy music, but Killswitch Engage masterfully succeed at this

All of their records are produced solidly by lead guitarist Adam Dutkiewicz. Adam D, the backbone of the band, has produced albums from the likes of Unearth to Underoath. He is a musical genius and his ear for music is uncanny. Every band that hires him suddenly releases a breakthrough record. The music isn't very difficult, but the way Adam constructs and arranges the parts is what gives the music the trademark Killswitch sound. The Killswitch song formula is a slow introduction, followed by the moshy breakdown to the inevitable chugging guitar fade out. Sonically, the band excels and the guitarists fill all their songs with guitar squeals and harmonics. The sounds are amazing and it almost sounds like they're slaughtering pigs. The perfect execution of these sounds will make any headbanger smile and enjoy the band

Killswitch is currently fronted by Howard Jones, formerly of Blood Has Been Shed. His voice is a lot more powerful than Leach's, but they each have their positives and negatives. Jones joined the band prior to the

release of 2004's The End of Heartache. A powerhouse of breakdowns, soaring melodies, and the gospel-like voice of Howard Jones, The End of Heartache propelled Killswitch even further into metal success. The title track was even released on the soundtrack to the zombie-flick Resident Evil. Killswitch was soon appearing all over television with their video for their first single, "Rose of Sharyn." A vein-popping, guitar driven, straight-forward metal song with power-ballad lyrics. Jones has continued with Leach's lyrical quest for metal with a heart and "Rose of Sharyn" is the pinnacle of this method. The song is about the loss of a loved one and the opposing forces of heavy music and soft lyrics are what make this song so beautiful. Jones sings, "It won't be long, we'll meet again. The rising sun will always speak your name." The visuals of the video also parallel the theme of the

Currently, Killswitch Engage is on tour promoting their newest album As Daylight Dies. An album screaming to end the war and all the unnecessary violence that presently invades our world. The title track, "Daylight Dies" is filled with an abundance of allusions to death and destruction. Jones' sings, "How much blood must be shed? Hear their cries, don't wait till daylight dies." And the only prescription is more baseball.


