

Faculty, Staff, and Tutors Talk About Family, Culture, and Technology

One of the perks of being a CSI student is access to the free tutoring available on campus. However, attending tutoring has a negative stigma.

"I just didn't need it," admitted Freshman Ariana Xhelili. "But I would go if I did."

Other students share Xhelili's opinion on tutoring. But this is the sentiment that Director of the Modern Languages Media Center (MLMC), Valeria Belmonti, foresaw.

"Tutoring presents not only an opportunity to review grammar structures and vocabulary, but it

also gives a chance for students to interact with native speakers, learn about those cultures and practice speaking skills," said Belmonti. "It is important that they are aware of the wonderful resources available to them if necessary."

But the MLMC tutoring lab is a different breed altogether when compared to ones in the Library, 1L, or the math department in 1S.

Upon entering the lab in 2S, students are met with opportunities to attend local events on campus, to join a foreign language club such as the Italian or Spanish club, and the opportunity to sit down with a tutor for a quick lesson in Spanish,

Italian, French, Arabic, Mandarin, and American Sign Language (ASL).

Yet these tutors are different than the ones experienced in other labs. Sitting down with an MLMC tutor is akin to sitting down with an engaging professor, one who is knowledgeable on the basics of the language such as grammar and conjugation of irregular verbs, but is also familiar with the culture.

A trip to the MLMC is like a trip to a foreign country. The room is decorated with popular magazines from around the world. Tutors gather and

Staten Island Continues to Suffer in Drug Epidemic

From Opioids to Pills, Teens Enroll in High School

On March 31 in the Center of the Arts Executive Director of Camelot Counseling Luke Nasta the delivered an emotional speech to students and faculty on the topic of opioid abuse on Staten Island. Also in attendance, and speakers of the afternoon, were Professor David Goode of Sociology, Assistant District Attorney Jennifer Cilia, and patients of Camelot.

"I started out as high school dropout from Port Richmond. I've lived this and I've studied this," said Nasta, who has been the director of Camelot for 38 years.

Nasta has battled addiction with heroin and has seen the landscape of the borough change. He has been at the forefront of the battle against this epidemic and has been recognized for his efforts on multiple occasions.

"Five years ago, I wrote a letter to the opinions section of the [Staten Island] advance, to parents," said Nasta. "I said, there's a new way of getting high and it's with prescription medication."

Often misconceived, many teenagers and parents underestimate the highly addictive, powerful qualities of opioids. Essentially heroin in powdered form, youth are taking these drugs and are facing the same risk as if they used a bag of heroin, claims Nasta. The main difference between the two drugs are the after-effects. Because pills take time to absorb into the body, the process of them wearing off is also gradual. He points to lack of concern as detrimental to their children's well-being. Throughout his

speech, Nasta emphasized the importance of owning the problem.

"If you don't do anything about it, then don't call me to attend the funeral," said Nasta. "If you can't get above this thing, then you will have earned your pains of conscience. In many cases, it will never get better but certainly you have no chance if you don't intervene."

The number of overdose deaths have risen and in comparison with other boroughs, Staten Island ranks three times higher in deaths by prescription pills. Between 2005-2011, the island saw a 261% increase in overdose deaths from prescription painkillers.

Nasta brought two patients, Nick and Matt who are 22 and 18 respectively, who gave

Men's Basketball Coach Tony Petosa Leads by Example

Doing it the Right Way by Bradley Popkin

In the award-laden office of CSI men's basket-ball coach, Tony Petosa stares at his computer screen concentrating on apparel he plans on purchasing for his team's upcoming season. For Petosa, there is no off-season. The day following their loss against York College in the 2014 CUN-YAC Championship game, he had wanted to scout but fortunately was able to have an assistant make the trip.

"My season began the day after we won [the ECAC Championship]," said Petosa. "It absolutely kills my personal life. I'm easily here from September through the end of March."

Behind the storied coach sits a Staten Island Advance clipping of one of his former coaches, the late Thomas Keenan. Keenan coached Petosa during his Junior and Senior campaigns at CSI.

"He was so far away," said Petosa. "Every six months or so I'd give him a call. He was a good person."

Petosa is fresh off of a record setting 28-3 season that concluded with an ECAC Championship victory over Kean University and will be inducted into the Staten Island Hall of Fame in May. Before his head coaching career at CSI, where he has racked up five CUNYAC Championships and 400 wins, Petosa forged an award-winning basketball career at the school that began in his teenage years.

The future CSI great began playing basketball at the age of eleven where he began his career playing at Our Lady Queen of Peace.

"Things were different, they had intramural leagues at my grammar school," said Petosa. "They had CYO and stuff like that."

Petosa, a self called late bloomer, entered Monsignor Farrell High School where began to take the sport seriously. Petosa honed his skills under Tony Rafaniello who is the winningest coach in Staten Island high school basketball history with 511 games.

"I was very well coached as a high school player," said Petosa. "He has a great knowledge of the game and brings a lot of intensity."

Before there was a Tom Keenan, Petosa played his first two years of college basketball under head coach Evan Pickman. Pickman, a former scout for the LA Clippers, coached the Dolphins for six years compiling a 127-42 record. Petosa was a starter for all four years at the school.

"Pick made me hungry to become a better player," said Petosa. "By the time I had left, I felt I



"Keenan was really laid back and Pick was very fiery," said Petosa. "I'm kind of in the middle between the two of them."

Pickman, whom Petosa calls Pick, is now head coach of the varsity program at the Abraham Joshua Heschel School in Manhattan, and had nothing but praise when recalling times when he coached the big man.

"I recruited him out of Farrell High School where he was a good player. [In] my last two years at CSI he started every game and was sort of a role player. He rebounded, he fit in. After I left, he became a great player," said Pickman. "He wanted to be a shooter [laughs]. When he left, he was outstanding. He learned to incorporate a presence inside. He became a complete power forward."

In a sit-down with these tutors the first thing that is notable is how close-knit everyone seems to be. Despite the various ethnicities and cultures they align to, they sit amongst each other as friends and colleagues. Each belts out the MLMC mantra towards tutoring: "repetition, patience, critical thinking."

Talking amongst themselves, they reveal a common interest toward helping students. Further than that, they show their interest toward promoting the MLMC as a safe place. They assure everyone that the lab is a family, and they are committed to introducing students as members.

"I was born in the Dominican Republic, I came to the States six years ago," said MLMC tutor Holdaliz Brito. "I've been back every semester since I was 16."

Every tutor in the lab shares a story like Brito. on their background and why they dedicate their time to tutoring.

"A professor recommended me after they found out I used to work with kids in the afterschool program. I'm a native speaker that needed work on grammar. I started tutoring and it gave me an explanation behind everything," admitted

Roa Harizi, a tutor for French and Arabic, recollected on her immigration to the US over four years ago.

"I wanted to use something from my country, I saw students failing, discouraged, and needing help," added Harizi, "I felt that my help would lead them to finish the semester very well."

"You can learn so much from tutoring," admitted Susca, "You learn how to be patient and how to have a one-on-one conversation. Working here as a tutor gives you insight. After repeating these lessons with students over so many years I've learned exactly where students are having difficulties in learning Italian.

"The tutoring lab is a place where students come for a relaxed environment" added White. "It's difficult because there are different relationships. Tutoring isn't the same thing as being in the

"WeSpeke and DuoLingo are two free technologies that anyone can access from any smartphone or computer with internet access. They are becoming popular names in Computer-Assisted Language Learning, which is the field that the media center assists with," explained Belmonti.

DuoLingo is an app available for free on Apple and Android platforms. At first glance it seems to be a Rosetta Stone-based learning program. But constant use of the app shows that it feels like a video-game and quickly becomes addictive as you make your way through lessons in prepositional phrases, verbs, and basic sentences. Available for those who wish to learn French, German, Spanish, Portuguese, English, and Italian, DuoLingo was nominated as the best NYC and there are people from all over the world. "For example, if you have an assignment on a current news or world event, or you are researching a foreign book or artist, and you are interested in French too, then WeSpeke can find a French person interested in practicing English that also would like to talk about those subjects and share views with you."



Supreme Court Unleashes the 1% for Campaign Funds

Political Donations Now Considered "Free Speech"

On Wednesday April 2 the Supreme Court made a final decision in the controversial McCutcheon v. Federal Election Commission case. The court ruled in a split 5-to-4 vote to expand the maximum amount an individual can directly donate to political candidates and com-

Previously, federal laws capped the amount of money any one person can donate during a the First Amendment protects flag burning, two-year election cycle at 123,200 dollars. The final decision now allows a single person to donate \$3.6 million dollars in an election cycle.

The decision was made on the grounds that limiting the amount of campaign donations one can give out is equivalent to limiting an individual's First Amendment rights.

Chief Justice John G. Roberts Jr. argued for the controlling opinion, stating that, "there is no right more basic in our democracy than the right to participate in electing our political leaders. Citizens can exercise that right in a variety of ways. They can run for office themselves, vote. urge others to vote for a particular candidate, vola candidate's campaign. This case is about the last of those options."

The conservatives of the court disagreed that a possibility in the increase of influence in the political process, spurred by massive campaign

donations, does not trump limiting an individual's First Amendment right.

"Many people might find those latter objectives attractive. They would be delighted to see fewer television commercials touting a candidate's accomplishments or disparaging an opponent's character. Money in politics may at times seem repugnant to some, but so too does much of what the First Amendment vigorously protects. If funeral protests, and Nazi parades -despite the profound offense such spectacles cause- it surely protects political campaign speech despite popular opposition," Roberts continued.

In an extremely rare occurrence, which hinted at the polarized state of the Supreme Court. Justice Stephen Brever was joined by Elena Kagan and Sonia Sotomayor as he read his 30page dissent from the bench.

"[The majority's] conclusion rests upon its own, not a record-based, view of the facts. Its legal analysis is faulty: It misconstrues the nature of the competing constitutional interests at stake It understates the importance of protecting the unteer to work on a campaign, and contribute to political integrity of our governmental institutions. It creates a loophole that will allow a single individual to contribute millions of dollars to a political party or to a candidate's campaign. Taken together with Citizens United v. American foreign policy in the post-Cold War era has been the defining tightrope act in today's global politics. There have been calls from both "doves" and "hawks" on this issue, with President Obama's administration treading a fine line between the two extremes.

However, in a dynamic and polarizing arena such as international diplomacy, staying in a "middle ground" can be worse than taking a side.

As we've seen, military intervention can be quite a tricky situation: intervene in one situation another you'll be criticized, not to mention the economic costs of either choice.

For instance, the Ugandan government signed into law on February 24 anti-gay legislation, the Ugandan Anti-Homosexuality Act. which effectively outlaws any kind of same sex relationships or behavior and brings down harsh penalties which have included life imprisonment and even the death penalty.

President Obama, among other world leaders, has denounced the new bill, According to Al-Jazeera, "The United States is Uganda's largest donor, sending more than \$400 million in aid annually in recent years. If Museveni signs the bill, the U.S. could find ways to register disappointment over the law.'

In other words, aid money can be used or withdrawn depending on a country's ideological or government policies. Nonetheless, in the circumstances of Uganda, the United States will not be so eager to rush to pull funding. As, according to Al-Jazeera, "Uganda depends on donors for about 20 percent of its budget", there would probably be hesitation due to the consequences involved in pulling millions of dollars in development aid from the country.


Conversely, not every foreign aid situation is as straight-forward as the Ugandan dilemma. Take for instance the situation in Pakistan. According to the USAID Foreign Assistance Database, economic assistance to Pakistan in the fiscal year year 2012, this economic assistance increased to ignored.

Yet, Pakistan's initiatives to take on the Taliban and terrorist cells in the region, as well as support other United States initiatives have been less than forthright. Our modern relationship with Pakistan started in response to India's alignment with the Soviet Union during the Cold War, in order to gain a stronger foothold in the region. Now that the Cold War is over, part of the aid money that goes to Pakistan is to avert conflict between India and Pakistan, according to BBC

With Operation Neptune Spear, the NATO-U.S. operation that successfully killed Osama Bin Laden, relations between Washington and Islamabad have diminished greatly as some in the United States speculated that the Pakistani government may have knew about Bin Laden's hiding in Abbottabad, Pakistan and may have even

Naturally this has also created a conflict of interest in the foreign aid department. While we do have a humanitarian outreach to Pakistan through foreign aid, we still have strategic reasons for giving aid as the United States tries to hold on to as many allies in the region as possible.

In 2012, according to USAID, Russia has received approximately \$293 million in economic assistance and China has received \$49 million. This just highlights how far the \$48.4 billion in foreign aid reaches across the world. Whether this is seen as a waste or a strategic necessity. 2001 was approximately \$92 million. Pillow Fight for Vengeance and A Worthy Cause





Federal Election Commission in which on April 2 2014 the court decided to remove aggregate individual spending on elections meaning limits imposed on wealthy donors have now been dis-

The problem: this decision essentially boils down to the more money you have, the more sway you hold over the electoral process. Our democratic system has been turned into a subscription system. Our free package comes with one vote but you can go for the super platinum electoral donor plan and that gets you a lot of benefits - hell, spend your way to office. In the majority opinion written by Chief Justice John Roberts he stated " we have made clear that Congress may not regulate contributions sim-



ply to reduce the amount of money in politics, breaks. The whole concept of "corporate welor to restrict the political participation of some in order to enhance the relative influence of

Of course Justice Roberts, if certain candidates didn't have the large amounts of cash to throw at television ads, flyers and posters, door to door electioneering, and attack ads I'm sure their "relative influence" would decrease, but wouldn't you agree that's due to their fundamentally awful political platform?

It seems the court has decided that "political participation," which is blatant corruption, is fine as long as you do a good job of hiding it and Congress doesn't catch you.

No, I'm sorry Republicans, free speech and first amendment rights for corporations and wealthy individuals aren't the problem here, it's that everyone else's vote in this country is now devalued that much more by the inflation party of campaign finance and nothing is stopping

Personhood in regard to corporations has long been a focus of contention between the two ideological points on the spectrum. If corporations are "people" and money equals peech," then the law should apply equally to mega-corporations as much as any other individual. Most recently, General Motors recalled 2.6 million cars due to faulty emission switches and has been blamed for at least 13 deaths. This flaw has been known by GM since 200 and was studied by their internal review department for four years. Repairs were reported to cost only 57 cents. And they did nothing.

So far all GM has received in punishment is a slap on the wrist in the form of a Congressional hearing. I predict at most a fine. And that's the real travesty, that people's lives can be put at risk without their knowledge and GM, which is a "person," will not face criminal charges. Just like in the aftermath of the 2008-

Irony also has a part to play in this absurdity when various groups advocate on behalf of these large corporations. Take straight-forward journalistic reporters Sean Hannity and Rush Limbaugh, who espouse the troubles of the barely-working class. High earning CEO's and corporations who are just are being persecuted unfairly by socialist policies.

When a false pretense makes its way to Capitol Hill it manifests into subsidies and tax CO2 and toxic emissions can do to affect

fare" serves as a slap in the face for people who can't even gain access to real healthcare. How can anyone talk about the lack of availability to social services, such as "Keep your government hands off my Medicare," when they advocate giving millions of dollars of subsidies or tax breaks to billion dollar companies who quite frankly don't need the lift from Uncle

This especially doesn't make sense when many of these companies create unregulated externality - which in the socioeconomic definition means negative side effects inflicted on others as byproduct of business. In the case of GM, the externality would be the deaths caused by a bad business decision, a decision made outside the power of those who died but a decision that ultimately proved fatal to the said

One prevalent externality which especially in recent time has become ever more poignant is pollution. According to the U.S. Energy Information Administration, in 2013 the four largest energy sources the United States its energy from are Liquid Fuels/Petroleum at 35.97 quadrillion BTUs or British Thermal Units, Natural Gas at 26.22 quadrillion BTUs, Coal at 18.31 quadrillion BTUs, and Nuclear/ Uranium sources at 7.93

Not a clean fuel industry in sight unsurprisingly. The oil, gas, and coal industries are the biggest companies, get the biggest subsidies, have the CEOs with the biggest paychecks, and retain the biggest grip on America's energy

Also relatively banal yet distressing is the fact that these industries are without a doubt the biggest polluters in the United States. According to Mother Jones, the top ten polluting sources in the United States are all coal power plants. Close behind, according to Forbes, are oil giants Exxon and BP, and Dow Chemical/Industrial.

Between air pollution, fracking, and water pollution caused by runoff wastewater chemicals, the externality of pollution has been hard hitting. One only has to look at the great environmental damage occurring in China, due to a rapid increase in their manufacturing and energy supply sectors, to see what potential threat

Nevertheless, the most dangerous thing facing the United States on this matter is not the emissions or even the polluters. It's the deniers. Like the abolition of slavery and the adoption of publicly funded healthcare, America is once again behind the rest of Western industrialized countries when it comes

The pollution and the bad policies are only side effects of the disease of ignorance that has plagued this country for far too long. The mere fact that in the year 2014, a whole 44 years after the founding of the Environmental Protection Agency, the President has to stand in front of the American people during his State of The Union address and affirm the validity of climate change as a signal that change needs to occur and quickly.

The disease of climate change denial comes in many forms, all equally toxic to the objective of combating issues facing our envionment. First up, the lobbyist; usually an employee of an oil or coal company pushing legislators to keep a blind eye to externalities while hustling for that extra subsidy to go on exploratory surveys in foreign countries that aren't exactly friendly to the United States.

Next, the Fox News watcher/climate denial apologist who uses common phrases such as, 'How can there be global warming if it's snowing right now?" or "There has ALWAYS been global warming!" These climate experts, often marketers trying to pitch climate denial or just ignorant people, religiously cite that there "hasn't been a consensus in the scientific com-



Dolphins Destroy Vaughn College in Double Header

On Sunday April 6, the College of Staten Island played Vaughn College in a non-conference doubleheader at Tomas D. Morales Field. The Dolphins swept the Warriors in tremendous fashion with a score of 24-0 in game one and 20-0 in game two.

Freshmen pitcher, Josh Bernstein, made the start for the Dolphins. Bernstein fanned out the first three batters in the first to bring it to the bottom of the inning. The Dolphins would start off the scoring immediately after Vaughn College's shortstop, Adrian Zamora, bobbled what should've been a routine out.

Instead, CSI's Phil Ciprello dashed to first and catcher, Josh Palmeri, scored the first run of the game. The flood gates were opened and the Dolphins talent greatly overshadowed the inexperienced Warriors. Ciprello advanced to third base and eventually scored due to several wild

pitches by Vaughn College starter, Zamora. Nick Delperte, Will DiFede, Chris Falcone, Greg Manassa and Chris Ramanaukas, all scored easily to make it 7-0 after the first inning.

Junior right fielder, DIfede, showed tremendous power, knocking a deep double into center field. He'd be driven home right after by Manassa's single. Manassa was quickly able to put himself into scoring position by racing to second base after another wild pitch by Zamora. Falcone singled, bringing Manassa home. Delperte stepped up to the plate and swung the bat confidently, as he drilled a triple to bring Falcone back to home plate. The Dolphins tacked on four more runs after the second inning, leaving the score 11-0.

The Dolphins continued to rip through the Warriors as they had another big inning in the third as they were able to score seven runs on four walks and RBI doubles on the back of fresh-

men second basemen, Anthony Mauro, and first basemen, Francis Munoz.

The scoring continued in the fourth inning as the Warriors continued to be plagued by their errors. Freshmen centerfielder, Anderson Acosta, and freshmen catcher, Mike Allocco, both advanced into scoring positions off of errors. Both ended up scoring unearned runs to help the Dolphins to a phenomenal 21-0 lead. CSI finally slowed down, scoring one run in the fifth and two in the sixth to win the match 24-0.

In game two, the Dolphins started out modestly by only scoring one run in the first inning. The game quickly broke open in the second inning, with CSI scoring eight runs. together a 19-game win streak, capturing a CUN-YAC Championship win over Medgar Evers, en route to a berth in the NCAA tournament. The highly touted Dolphins that year were filled with talented names. The team also received help from the mid-season acquisition of Lameik Black. Black averaged 8 points and 5 rebounds over 17 games.

"2012 was a phenomenal group, a tight knit group of kids," said Assistant Coach Chris Peterson. "They worked their asses off in practice. Some practices were even more competitive than games."

The following season history repeated itself. After a 19-5 regular season record, Petosa's team defeated John Jay to win the championship and would continue their run of dominance in the CUNYAC in 2014, despite missing Seniors guards Jonathan Chadwick-Myers and Magloire for the first 8 games.

"It was entirely my fault. I slipped up in the classroom and had to deal with the consequences," said Magloire. "He was 100% honest with me. [He's the] best coach I've had [and] developed my game into what it is now."

After starting 1-2, the team won 24 consecutive games including lopsided victories over Baruch and Medgar Evers. The team would falter in the CUNYAC Champion versus York losing 87-

84. To the dismay of Petosa and many supporters, the team was not given a bid to the NCAA Tournament.

"I just think it was a bad decision by the NCAA, the selection committee was very unfair to our program based upon our conference," said Petosa. "Our season shouldn't have hinged on us winning that tournament. Once we got to 23-2 or 24-2 we should've been an automatic [bid].

Despite the disappoint, Petosa and his club moved onto the ECAC tournament where they conquered NJCU, Stevens IT and Kean to win the championship.

"We didn't play great throughout the ECAC's," said Petosa. "We played good enough to win."

As the team moves on and players graduate and new roles open up, Petosa is tasked with meddling with a roster where Javon Cox, Will Fonseca and Frankie Schettino return and have added experience under their belt.

"This year [2014] we really pushed the ball because we had a point guard who could push the ball and we had guys he throw it to on his wings," said Petosa. "If we don't have that next year, we have to walk it up and try to keep games close."

With Seniors like Chadwick Myers, Dylan Bulger and Magloire graduating; there are voids that need to be filled. One spot Petosa is comfortable with is Point Guard. The Freshman sensation Schettino snagged D-III All-Freshman Team honors and helped lead the Dolphins to a 23-2 regular

season record with 9 points, 7 assists, 4 rebounds and 2 steals per game.

"We're not going to be deep next year. We're not going to bring in six kids with the ability of the ones we're losing," said Petosa. "I'm going to do the best I can to bring in good kids, high-quality kids. I need to bring in a number of them; one or two possibly, three and four is not easy."

Petosa added, "It's hard to recruit public school kids because they don't have the academic grades to get into the school. Our standards for the baccalaureate program are very high."

Petosa will be entering his 25th season as head coach of the men's basketball program at the college this November. The full-time teacher has a 10 month old daughter Alexa and wife Dalia at home.

"I call this a labor of love, I love doing it but at the same time it impacts my personal life immensely," said Petosa. "I don't have holidays off, I don't have Christmas off. I get to go to my sisters house for Christmas and while I'm there I'm watching videos of games that we have in two days or making phone calls to recruits on Christmas Eve."

According to a 2011 CUNYAC benchmarking study, the average yearly salary for head coaches of men's teams at CSI is \$8,267.

"This was as a difficult year as I've ever had coaching wise," said Petosa. "I feel that if I wanted to I could coach another 15 years easily. There's no question I still have the desire."
