





A little over two dozen protesters, many from CSI, demonstrating against Trump's rally in Staten Island BY MARCUS DEL VALLE

A CSI club and activist group received push back from Staten Islanders and, allegedly, police officers on April 17 as the group protested a fundraiser for presidential candidate Donald Trump held in the borough's Hilton Hotel.

Staten Islanders Against Racism and Police Brutality (SIARAPB) members were greeted by Trump supporters who organized

an opposition protest. The demonstrators held signs and chanted "White Lives Matter." The Pro-Trump advocates organized after the Staten Island Advance published that the student organization was planning a demonstration.

"We need a wall, we need a secure border," said one Trump supporter. "I lock my door at night at my home, this is my home so I want my door locked."

SIARAPB posted their plans on Facebook. A day later, on April 13, the group started to receive hateful comments from Staten Islanders.

SIARAPB President Krystal Sanchez said that the group was not deterred and felt that it was important to voice opposition to the Trump phenomenon.

### Something Goes Bump in the Night at CSI

It's been 23 years since the College of Staten Island set itself on the land where the notorious Willowbrook State School once stood. A facility that once held 6,000 residents which was originally designed to house 4,000 with mental disabilities.

A place Robert F. Kennedy called a "snake pit" because of the conditions. Of course now it's closed largely because of the cases of child abuse, overcrowding, sexual abuse, beating, and even strangulations revealed due to the work of Geraldo Rivera. Today, some buildings still stand, if you didn't know, so far known they are the ad-

ministration buildings: 1A, 2A, and 3A (formerly a morgue). Also on the Great Lawn is where the hospital itself once resided.

There are people who believe in hauntings and there are droves of students who don't.

Here are some lighthearted first-hand accounts of abnormalities from people who work and/or live on campus.

#### Voices in 5N

This anecdote was taken from a Public Safety officer, whose name has been changed to Thomas, has offered his experience of what happened to him and his witness almost 17 years ago during winter.

Thomas story starts off with him and his friend patrolling in the basement of 5N, the Physical Therapy building. In the basement, his buddy and him find small doors that looks as if they were openings to tunnels. He describes even the smell that hit his senses during this time in there as being "concrete and musty." It was oh so quiet and empty but what happens next is nothing short of creepy.

The public safety officer recalls hearing voices of people singing terrifying words. Although he just assumed it was his partner; that was not the case as his partner denied **Continued on Page 4** 



Warriors Are Living History

### At 'My Story,' Students Share Their Struggles and Accomplishments **BY SONIA MARTINEZ**

Throughout CSI's campus, accommodations are made for students with physical disabilities. Every building used for academic purposes are equipped with a ramp, elevator and automatic buttons that will open doors for individuals. But there are some students who suffer from disabilities others cannot see.

"My disability is invisible," said Shanelle Scott. "You would never know I had a brain tumor because I'm so full of energy."

Scott suffered from astrocytoma, a brain tumor that kept her from pursuing her education at CSI. After battling cancer--both its side effects of treatment, and the stress of school work--Scott is now cancer free and will be graduating this June.

Scott was one of seven students who shared their personal stories at CSI's 6th annual "My Story" event on April 16. The event was sponsored by the Center for Student Accessibility who serves about 600 students with disabilities.

The students who spoke at this event shared their academic accomplishments and how others can learn from the hardships they had to overcome.

Their disabilities ranged from learning disabilities like Autism Spectrum Disorder, ADHD, and Asperger syndrome. Some had been diagnosed with physical disabilities like dwarfism and blindness.

Silverstein struggles with everyday challenges, as many students with disabilities do.

"When you have something that possesses your mind," said Silverstein. "It's invisible to the naked eye"

There is a strong sense of community when it comes to students with disabilities. Many of the students talked about their involvement with many different clubs on and off campus and how they were able to find their voice through these programs.

"It doesn't matter the physical or mental differences, the challenges or realities," said Silverstein. "What I have doesn't define who I am."



## **BANNER POLITICS** The Dream Act, Explained

### An Exploration of America's Most Hot Button Issue

One of the most controversial topics, immigration, arose in political campaigns this year and the Dream Act is no doubt one of the most debated policies which Democrats and Republicans cannot seem to agree on.

documented immigrants to attend college and apply for financial aid, was rejected from last tween Democrats and Republicans.

Despite this setback, the New York Times reported that Governor Andrew Cuomo would continue his push for the Dream Act. The Dream Act, supporters claim, can elevate enrollment rates for universities and promote immigrants to invest in the state economy after they receive higher paid jobs with their respective degrees through opening bank accounts, purchasing homes and starting their own businesses.

Undocumented immigrants who decide to attend college increases the amount of revenue their schools receive, which helps colleges provide more services and better equipment for classes.

The Washington Post reported that Washington state passed a version of the Dream Act in 2014, providing \$5 million to the State Need Grant Program, which covers tuition aid for 1,100 at state universities.

The Dream Act, which would allow un- 2012 called the Deferred Action for Childhood Arrivals (DACA).

If immigrants meet the qualifications for year's state budget due to a disagreement be- DACA, they can apply and, after acceptance, can work and attend college.

> The passage of the Dream Act is still necessary because DACA is not a guarantee for citizenship and can be revoked at any time.

> Undocumented immigrants can also apply for financial aid and the Tuition Assistance Program.

> CSI Sophomore Maria Vazquez is one particular student who applied for DACA during her senior year of high school and currently works part time.

"It's not the fault of children that were brought here because our parents wanted a better life for us," she said. "We want to study and go far in our lives. That's why I jumped on the wagon when I got the opportunity to get DACA."

According to the Pew Research Center, 750,000 people in New York are illegal immigrants, that's about four percent of the state population

Illegal immigrants also contributed over A policy passed Congress on June 15, \$1 billion in state and local taxes unpaid and, if given legal residence in the state, would pay over \$1.3 billion in state and local taxes, including \$622.8 million in sales taxes, \$345.8 million in personal income taxes, and \$375.8 million in property taxes, the American Immigration Council wrote on ImmigrationPolicy.org.

> Senior Researcher at the American Immigration Council, Walter Ewing, said "It (The Dream Act) would resolve the legal status of millions of unauthorized young people in a way that is consistent with core American values

And it would empower these young people to become better-educated, higher-earning workers and taxpavers."

Advocates of the Dream Act continue their fight for undocumented immigrants while the opposition maintain their position on why the act should not be passed


"Like most New Yorkers, he doesn't be-

lieve taxpayers should cover the cost of free college tuition for illegal immigrants while hardworking, middle-class families here legally take out student loans that will take them years to repay," a spokesman for Senate majority leader Dean G. Skelos, Scott Reif, said to the New York Times.

Executive Director of the Center for Immigration Studies, Mark Krikorian, further expressed the reasoning behind why the Dream Act cannot be passed and offers points on how to improve it.

"Rather than limiting amnesty to those brought here as infants and toddlers, it applies to illegal immigrants who arrived before their 16th birthday," Krikorian said. "If the argument is that their very identity was formed here, age 7 would be a more sensible cutoff.

"That is recognized as a turning point in a child's psychological development. Such a lower-age cutoff, combined with a requirement of at least 10 years' residence here, would make a hypothetical DREAM Act 2.0 much more defensible," he continued.

### The Late Night Workers


Custodians around campus working late night shifts volunteered information as well. I asked five custodians on separate occasions if they noticed anything off about the buildings and they all agreed on one thing.


From prior knowledge, buildings are made to shift and move especially with the wind so that they do not collapse on themselves


So at night when the buildings are empty and are shifting, it is common to hear creak-

"Hate is growing because of Donald Trump," said Sanchez. "It only took one day for us to receive bigoted and racist comments all over our event posting."

There was a significant police presence comment on the scene.

The streets leading to the entrance of the event were blocked off on both sides. Protesters and supporters were kept a safe distance apart via guard rails.

One protester named Maribel, a Mexican woman attending the anti-Trump rally with her daughter, said that police offered her misinformation.

According to Maribel, NYPD officers told her that she should demonstrate next to the entrance of the Hilton and hold her signs up there.

This raised questions about police motivations within the group as the Hilton is private property and a protest of this sort would be cause for arrest.

Members of SIARAPB identified the policeman's action as a form of entrapment. An NYPD spokesman didn't immedi-

ately respond to the Banner for a request for

Police presence was spread out a few blocks away from the protest location, with officers at all corners of the streets.

Several protesters accused police of giving them incorrect directions.

On the scene, members from both sides were chanting rally calls for their cause, some more aggressive than others.

When several Hispanic protesters joined in with SIARAPB, the pro-Trump rally goers chimed in: "America's full! Go home!"

Pro-Trump advocates followed this by rallying together shouting in unison, repeatedly "Build that wall! Build that wall!"

SIARAP shot back with chants such

as "Stop racist deportation," followed by "Working people have no nation!"

Over the course of the protest, agitations grew when a pro-Trump supporter mooned the crowd of protesters.

Police did not catch this, so complaints of the action did not go far.

Members of SIARAPB began to call towards the group, "Build the wall around Bigots! Make them pay for it!"

The Staten Island Advance published an article on April 13th, just days before the protest, where they quoted City Councilman Joe Borelli, a co-chair of Trump's New York campaign

"This just adds to the narrative that the extreme left no longer stands for free speech and only seeks to disrupt, denounce, and intimidate," Borrelli told the Advance.

Response from the community of Staten Island accelerated when the article was posted, accusing the group of being racist themselves and ignorant themselves.


Sanchez did say that club members were on the fence of attending or not due to the online attacks.

"Many members were scared to attend. A Biker Gang and another group threatened to hurt us if we showed up," said Sanchez. "Others were scared to show up because of bad press but we still came out strong."

The anti-Trump rally drew larger numbers than the pro-Trump camp.

When asked what she took away from the experience Sanchez stated, "The other side made a lot of assumptions about us and I learned that it's not good to do that. As a largely student and teacher group we hope to use knowledge and passion to fight against hate and make a difference."

Question: Have you ever had to take an alternate form of transportation at night instead of the S93 because you got out of class too late and the S93 was no longer running?



56 students took part in this poll.

79% of students had to take an alternate form of transportation because they got out of class early.

Only 9% of students have always been able to take the S93 at night, while more than 12% of students had an experience where they did not fit on the bus.

"Instead of a 40 minute commute home for me it's an hour and a half," said Destiny Rosario, a junior at CSI. "Instead of one bus and a train its two buses and a train."

"If I don't get out of class early enough for the S93 I call a relative," said Patricia Zorbas. "They bring me to the S53 on Clove Road, but it still takes longer."

### **Searching for S93 Solutions** CSI Student Government Wants MTA to Extend Bus Service

At 9:36pm, CSI senior Jasmine Smith walked to the Victory Blvd entrance bus stop just as the last S93 pulled away. She went straight into the bus shelter, sat on the bench, and took out her phone knowing her commute home to Brooklyn just got twice as long.

CSI Student Government senator Maxime Muller, who frequently uses the S93 to commute home, presented the Student Government board with the draft of a letter to the M.T.A. aiming to expand service of the S93 and help students like Smith.

"I feel that there is a lack of service," said Muller. "We need buses to come at 9:45pm and 10:30pm which can help the students be able to get on the bus and go home to Brooklyn."

The last S93 bus leaves CSI at 9:30pm. This forces many students who cannot fit onto the last bus or take night classes ending at 9:30pm or later to take the S61 to St. George Terminal and then transfer to the S53 in order to get to Bay Ridge in Brooklyn.

The alternate commute takes at least an extra half hour for students to get home.

Muller feels confident that the letter will result in the M.T.A. providing additional services like it did two years ago when S93 buses began making stops in the middle of CSI's campus.

In his letter he makes a subtle threat to the M.T.A., stating that student government will contact legal representatives to look into the safety of students with disabilities who may not be able to access or receive proper seating on the overcrowded 9:30pm bus if services aren't extended.

Muller feels confident that the proposal will be effective.

"I really think it will happen," said

Muller. "We are presenting them the letter in James Oddo, and he will continue to go higha way showing that they can have more students on this bus paying the fare."

Student Government President RJ Mohammad does not share Muller's optimism. He believes that the MTA will not be so quick to accommodate students, and that more than a letter will be needed to result in change.

"Change does not happen overnight or with a piece of paper demanding anything to happen," said Mohammad. "It happens over time and needs constant effort, and what we are doing is laying a foundation for something that will result in change."

Mohammad has already put consideration into the next steps that student government will need to take in order to push for extended bus services to become a reality. He will be sending this letter out to Staten Island's elected officials and plans to start scheduling meeting with them.





### New Live-Action Disney Film was a Roaring Hit

Jon Favreau (the director of "Iron Man," "Elf," and my personal favorite "Chef,") has created, by far the best depiction of Kipling's novel and the 1967 animated film with his adaptation of "The Jungle Book."

In the world of Disney, where live action remakes of their classic animated films are becoming more and more common, many have considered these new films to be underwhelming and largely disappointing. However, I believe they have finally taken a step in the right direction with this entry.

The Jungle Book follows the story of Mowgli (Neel Sethi), an orphaned boy who was adopted by a black panther named Bagheera (Sir Ben Kingsley) and raised by his surrogate wolf-mother Raksha (Lupita Nyong'o)

Mowgli, who is known in the forest as a "man cub" who struggles to fit in with the rest of the wolf pack

His problems become compounded when Shere Khan (Idris Elba) finds out the wolves have been harboring a human which is forbidden by jungle law, and Shere Khan vows to end his life at any cost.

Bagheera and Baloo become the odd couple in order to save Mowgli from King Louie, which drives the narrative to the third act of the decisive showdown between Shere Khan and Mowgli.

Jon Favreau almost flawlessly blends elements of the original source material and the beloved animated film into a cohesively fluid story that all ages can enjoy.

The visual effects alone are reason enough to see this movie. I cannot remember an animated movie looking this good since

The job that Neel Sethi did with Mowgli astonishes me constantly when I think about this kid acting in a destination location, but he's on a soundstage in LA. 





### Where's the Empathy for Disenfranchised Children?

It is time for the government to start putting the interest of people, especially disenbig businesses and their lobbies.

The government urgently needs to find ways to ensure that all children working in farms are working under fair and safe conditions

While switching through channels, I stopped at an episode of Al Jazeera America's Fault Lines series called "America's Hidden Harvest," intrigued by a girl named Anabella, a fourteen year old seventh grader who is one year behind in school and works with her mother on a farm.

Her mother talked about how Anabella had been in the farms with her since she was 40 days old.

It was noted that they work on a field sprayed with pesticides. When asked about them, she explained that she has often felt sick because of the pesticides, but continues picking onions anyway.

According to Human Rights Watch there are approximately 300,000 to 400,000 minors working in farms under very tough conditions on a daily basis.

But, it is hard to provide an accurate statistic for children working in farms as franchised children, in front of the interest of employers rarely keep records of underage workers in order to avoid possible government penalties.

> Under the Fair Labor Standards Act of 1938, the United States government created regulations relating to the employment of children.

The law set the minimum working age at fourteen, but does not apply to children working in agriculture, allowing children as young as ten to work in farms, with other exceptions that allow for even younger children to work on smaller farms.

Not only are children working in farms allowed to work at a younger age than other children, they are also allowed to take part in tasks that are considered hazardous

Children are exposed to dangerous chemicals found in pesticides, tools such as circular saws, and harsh working conditions such as being under the sun for 72 hours a weel

According to the Labor Department, child farm laborers are subject to a workplace

Exploring the Dangers and Consequences Farm Children Face mortality rate roughly four times higher than that of children who work in other industries.

> The problem with the existing regulations is not that children are working, but rather the detrimental effects that working has on their education.

Since farming requires workers to move wherever the harvest is, child workers are often forced to move often.

This mobility poses a challenge to these children's education as they have to frequently change schools, which causes them to fall behind in their studies.

This fragmented education causes these children to lose interest in school and, out of frustration, drop out. Migrant children have a dropout rate four times greater than the national average

Leaving school impairs their ability to pursue better jobs and only serves to facilitate the perpetuation of poverty among migrant workers in the farming industry.

By allowing this to continue happening, as a nation we are turning our backs on a

large part of the U.S. population. We are not even giving them a chance at

achieving their dreams.

In 2011 the Obama administration attempted to create laws that would have prevented minors from performing hazardous work and would have created regulations regarding the age and hours of employment for child farm laborers.

The American Farm Bureau and other powerful lobbies quickly acted against this bill, arguing that it would have negative effects on family farms, and that it was a overstep of the government.

As a result when it was sent to a committee, it was quickly struck down. Laws that set a minimum working age and minimum wage along with time restrictions need to be created

Children should be allowed to work, but only under conditions that are safe and guarantee a fulfilling education. These laws need to be enforced by the Labor Department. Employees who do not abide by these regulations must be held responsible.

Child laborers are not visible to most of us on a daily basis, but it does not mean that their lives are not important.

We as a nation need to ensure that all children have a fair opportunity to succeed.

In their third meeting of the season The Dolphins jumped to an early 3-0 lead after one inning. Juan Rodriguez who was making his first start of the season for the Dolphins was able to pitch himself out of a jam in the top of the 2nd inning.

With two outs and the bases loaded Rodriguez struck out Joe Jacobsen to end the inning.
