stop on the "A" train you will find the Community Development Day Care Center of Brooklyn, Inc. When you enter the first thing that will strike you is the very plain, almost austere atmosphere. Then you will see the quotation above tacked on the wall. If you're aware of the plight of the cities of America; if you are aware of the critically poor conditions of the schools our children are miseducated in; if

At 1310 Atlantic Avenue, two you know that throughout the blocks from the Nostrand Avenue cities, mothers who need to work to break the cycle of poverty in which they have been trapped for generations are forced to stay at home because they have no place to leave their children; if you have witnessed the lack of community involvement in the educational process, and you have been frustrated by a sense of powerlessness; if you are aware of the lack of concern for our children in the public educational system; if you're tired of wating for an unresponsive government to act in your best interests go to the Community Day Care

Center of Brooklyn, Inc. You will see 175 children, ranging in age from three (3) months to six (6) years. These children are here from 7 a.m.-7 p.m. and are fed three meals a day which are prepared in the manner in which they would be prepared in their homes.

You will see children learning to be proud of themselves as African Americans. You will see children expressing themselves and developing strong personalities within a group where respect for others is emphasized. Missing is the hostility and belligerence you find int he public school setting. You will see discipline here, although the shouting you find in public schools is absent.

There is a warm feeling in the atmosphere. In addition, in a time when public schools are producing high school graduates who read on a ninth grade level. the 4 and 5 year olds at this Center can read and write. To a person who knows what goes on every day in agencies which are supposed to serve the same needs, you cannot fail to be thrilled.

For too many years, poor children, particularly Black children have been exposed to the hostility of their teachers, or the indifferences or the condescension of their teachers. For too many years the future of our children and the hope of our people has been left to the untender mercies of the clinical approach of one sociologist after another, as though we were a race of people on a microscopic

Today, we are no longer satisfied with the definitions previously imposed on our lives and the character of our existence by strangers to our communities. Today, we strive for self determination and control over the institu-

The Day Care Center is a community supported and parrent controlled organization. This independent organization was begun in 1967. Initially, there was an attempt at a cooperative venture, including a gas station and a drug store to finance the operation of the Center. This venture did not prove to be a successful and stable means of raising the necessary expenses for the operations of the Center. It was then necessary to find other means of .. maintaining the Center. Funds

were obtained from a private source and the Center gives Dances and Raffles to raise money for its expenses which include staff's salaries that go no higher than \$6,000 a year and a \$30,000 rental a year for the 20,000 square feet of space that the Center encompasses.

The Center presently has a "tax-free status" which permits contributions to write off their donations as income tax deduc-

The Center was conceived as a practical means of meeting a specific needs of the Black community in which it is based which government had already shown its inability or unwillingness to do. In the writer's opinion, this Center has become e model of the type of institution that all communities could use to their interests; institutions which are controlled by the community itself, which are responsive to the needs of the community and which function through the dedication of individuals who have found a practical significance in their daily lives in working for their communities in their com-

Law and Order?

As civilization, as we know it, spreads across the continent, millions of Indians were slaughtered, and driven from their land to slowly die from poverty, Millions of Black souls were taken from their motherland and redeposited in the "new world." These Black souls were stripped of their language and of their identity. To safeguard and to sanction this manifest destiny, white men resorted to "law and order."-

The Red man and the Black man were stripped of their cuttures under the guise of "law and order"-White man's "law andorder": 'Luke the Indian's land and take the Black man's body, and make it all legal in the eyes of man and God.' Law and order meant to take from the masses, the rightful owners, and to claim their land and their bodies.

Law and order has always been a means by which the few control the many-by force, by power, by money, and by God, but never has it been by what is right. Law and order has always been the means by which the ruling class has controlled the working class, the means by which the property owner withholds "his" property from the masses; the means by which the oppressor classes have oppressed the masses. Law and order is the siaughter of millions of men. women, and children; and law and order is the power to wage a genecidal war in the name of peace. A law designed to keep the power out of the hands of the people is designed to keep the order of the society that makes the laws.

Law and order is the Watts riot and the Chicago convention and Berkeley's Peopels Park, Low and order is malnutrition and starvation, police brutality and poor housing, suppression and exploitation, and the right to die for an unjust country which deprives you of the right to make

the wrong laws right, Law and order is the right, the manifest destiny, of the wealthy, the ruling class, the enemy of the people. The people being the workers, the housewives, the students, and the children. The children of today are the workers, the house wives, and the students of tomorrow, the children of today are the oppressed of tomorrow. Laws are made to keep the sun-the power out of the hands of Indians and slaves, and laws are made to keep niggers, spicks, kikes, chinks, wops, and micks from sitting in the wrong "public waiting" room, or drinking from the wrong "public" drinking fountain, or applying for the "right" jobs. There are jails for those who take what they believe belongs to them and there are concentration camps for those who stand up and demand that law and order allow them to have what rightfully belongs to them. There is the loneliness and coldness of graves for those who are capable of showing the masses what law and order really represents.

that controls the news media, and convinces the public that the true power of control rests in the hands of the public. Law and order is a government controlled by the rich and the super-rich, but is capable of convincing the masses that the true power of government rests in the hands of the public. Law and order is a government that controls and regulates the actions of all its citizens, and is capable of convincing its citizens that they are free to speak and to move as they please. Law and order is a government that promises its citizens the right to a speedy and a fair trial, and is capable of convincing the public that it is legal to imprison-and even to kill-anyone who is opposed to injustices. Law and order is not in the in-

terest of pustice, but rather it is

Law and order is the suppression of any and all attempts to create any realistic movement to eliminate hunger and poverty; genecide and war; ghetto's and unemployment; hate and racism. A careful investigation of the charges, and of the bails set for incarcerated Panthers is bound to enlighten even the most conservative minded American.

It is absurd to think that a band of militants, aware of local and lederal infiltration, is going to plan murder, or is going to plan to blow up the Botanical gardens. The Black Panther Party has been, ever since the inception of the party, a legal target for every "law enforcement" gun in the country. Ernest Dow

Mr. Ernest Dow has been active on Staten Island in a variety of ways related to education, economic and social needs of the community as a whole, but specifically with the Island's Black and Spanish segments and with

Mr. Dow states, "I believe than an educational system should be relevant, innovative and reflect the importance of the widest spectrum of the community. This can only be accomplished if a board reflects a valid cross-section of the community's desires and goals through dedicated representatives. He also consulted with parents on various community problems, thereby becoming knowledgeable of community needs in education and social turmoils from the grass root

As a candidate, Mr. Routte feels that his experiences will prove to be an asset, enabling him to relate the educational needs of the community to the local school board.

Mr. Routte is presently serving as the director of the West Brighton Senior Citizens Center, which is located at 230 Broadway, Staten Island. He was president of the West Brighton Community Council, which sponsored the first anti-poverty program on Staten Island.

Edna Prince

Mrs. Edna Prince has been actively and diligently fighting for the needs of Staten Island for many years. Her involvement extends into almost every problem area, highlighting on education, housing, mental health, social services and legal aid.

Mrs. Prince is the organizer and presently vice president of the New Brighton Civic Association. Some of the accomplishments of this association are street light and sewage repairs, plus numerous improvements in poor housing conditions.

Mrs. Prince also serves on the advisory boards of many resourceful agencies such as the Mental Health Head-Start Program, New York Legal Aid Society, New Brighton Civic Association and the Board of Education's title I program. She holds membership in the Civic Congress of Staten Island and the Mayor's Task Force.

Mrs. Prince states, "I would like to be the voice off the community's needs, but also cooperate and recognize the needs of children in all communities as far as education is concerned. The future of our community and our children depends on the decisions we make today."

In America, the most technologically advanced civilization ever to exist, the people are kept ignorant to world and local events. The news is distorted and redistorted prior to being passed to the public via the media. Common gossip and rumors are often far more reliable than the misrepresentations that we read and hear via the media. The information is there for those who seek it, but the odds are with the establishment, because people are all to willing to accept what they are told as the truth. So is the case against the B.P.P. received by Americans, if it is in the media, it must be gospei. The American public has re-

fused to become curious as to why Black's are being gunned down, arrested, and harrassed. The same Americans that condemn Huey P. Newton, Bobby Scale, Eldridge Cleaver, David Hilliard, and hundreds of other Panthers: the very same Americons say that a public official, such as Alioto, Adonjzio, (Adonizio, the mayor of Newark, is under Federal indictment, slong with several individuals from his administration, for tax evasion and mafia connections. Alloto, San Franciscos Mayor, is under investigation for fee splitting, and is involved in suing a well known publication that publically accused Alloto of having maffa ties; are innocent until proven dimination of the Panther Party? The democratic government as reserveed in this country seems to play favorites. The Panther Party realizes that Newark is not the only city controlled by the mafia, and the party realizes that any fight against poverty and wag slavery is a fight against the mails. The man on the street has the same realizations, it then stands to reason that the "very surprised" investigators were and are aware of exactly what is happening.

Several magazines (All American, thereafter reliable, in their readers opinions) have exposed the extent of maria control in industry, the military and most means that the government i important, the political structure of city, state, and federal agency's, The mafin controls gambling, prostitution, dope; and the movie industry, the recording industry, the construction industry, and food and marketing industries are utilized as fronts for mofia operations.

It makes one wonder why the ed an intensification of investigations involving suspected mafia figures and maffa front organizations. It makes one wonder why the American public has not demanded an immediate, all out. investigation, an all out war on crime in America. Why have Americans not demanded that dope traffic be stopped, instead of demanding that dope users, and small fry dope pushers rereive stiffer jail sentences? Why did Nixon refuse to monetarilly erm his army to fight his war against crime? A request for approximately \$60 million was met with a drop in the bucket—\$2

million, Nixon declared war, yet he has shown a reluctance to fi nancially enable the job to be done properly. There is something wrong there that needs an immediate investigation.

It is not my desire to convince anyone of anything. The facts are a matter of record, available for anyone who cares to do the search. Information without factual documentation is food for curiosity. The established political structure of America is starving all of us.

The established political structure of America is not serving the needs of the people. It is not even meeting the minimum standards, set by itself, to guarantee an end to hunger and malautrition. The educational arenas are mismanaged, and the politicians are corrupt. (The local sheeriis, at least on Jersey Street, can be seen collecting their graft atmost any day of the week).

America-love it or leave it? Why not find out why and how to make it "loveable" for everyone? leaving it won't change it. You see, love of country is not lacking among the dissenters; love of country, love of justice, and love of humanity is exactly what dissent is all about. The bigot's and the racists that cheat the poor, exploit the workers. and who make deliberate mistakes on their income tax(in their own favor over that of the government that they love so well) are the people that should leave. Their concept of "America-love it or leave it" is what they can get for themselves at the expense of others. They are the people who scream like raped ages when welfare recipients are given a raise in the budget, and say very calmly, when the U.S. Navy over-pays 96 million dollars for a 151 million dollar destroyer, "We goefed."

The average American doe's not know that the U.S. government pays 60% of every dollar spent by private industry for rescarch, and that the other 40% is tacked on to the final contract should the government deelde to purchase from the company in question, this 40%, strangely enough, is worked into the price to cover for the rising cost of material and labor. To those who think you have to be a member of the Black Panther Party or any other "Black Activist" or "Revolutionary" group to be the target of racist attacks:

Miss Doreen Dow, the daughter of Mr. Ernest A. Dow. was the victim of a physical beating while attending Curtis High School here on Staten Island on February

As Miss Dow related, she was climbing the stairs to the fourth floor of Curtis High School when she was conscious of a voice from her rear. "Did you write an article in the "Cats?" (referring to an article that Miss Dow had written in her school newspaper). "Yes." "Are you Doreen Dow?" "Yes." Immediately following her affirmative response to this query Miss Dow was struck in the abdomen. Miss Dow then fell to the floor. Her assailant, a dark complected caucasian dressed in a black imitation leather jacket and dark nants, then fled the scene.

Miss Dow continued on her way to class, where she reported the incident to her instructor and asked to be excused to see the dean. Denying her request the instructor told her to be seated and begin taking an examination along with the rest of her clas. After threatening to leave without permission, Miss Dow was finally allowed to go to the Dean's

The Dean's immediate reaction to her story was to attempt to locate her assailant and to notify Mr. and Mrs. Dow of the inci-

Upon returning to the Principal's office, after an unsuccessful "search", for the assailant, the Dean and Miss Dow found that Doreen's mother had arrived and was awaiting them in the Principal's office. Mrs Dow insisted that she accompany her daughter on an independent search of the school-his request was initially denied, but after rigorous demands on the part of Mrs. Dow. the school authorities consented to her request.

At 12:50 Mr. Dow arrived at the school and informed the Principal for the first time of the incident. Up to this time, the Principal was completely unaware of what had taken place. Mr. Dow's personal appraisal of the case was that there as an "indifference" on the part of the administration, and an ignorance as to the possible consequences of an attack upon a Black girl by a white student after that girl as written an article in support of what is known as "Black Militancy". The total sum of administrative actions at Curtis High School to locate Doreen's assailant and to insure that incidents such as this do not recur were two conferences. One of these conferences was attended by concerned students of Staten Island Community College and certain community members. The 60's and Black America

The sixties, in America, was the scene of many changes for the Black man. It was the age of the "Long Hot Summer" or better known as the time when the Black Community took their dividends from the people who had been robbing them for years in their communities throughout the nation. This burst of Black energy into a strong external force of violence brought foth a counteraction throughout the nation. New Federal, State and City Programs sprang up in most of the major cities, to remove Black youth from the streets; drawing them into the system and dulling the pangs of frustration and powerlessness that had driven them into the streets in the first place. These programs were accompanied by an increase in the Police Arsenal, Special Tactical Forces, Anti-riot training and Pig pressure served as America's answer to the race riot.

A big challenge came along,

following this period, that must have done wonders for locksmiths and gun manufacturers. Black Power became a part of the nation's vocabulary. The mere combination of Black with the word Power brought fear to the guilt-ridden soul of America. What would power mean to a people who had been oppressed for so long? What would this mean to a people who had killed, and raped and humiliated these people for so long? White America turned to the long established Civil Rights organizations and leaders to define the term Black Power. These leaders perceived Black Power as "Green Power," "Vote Power," "Brain Power," but were very careful to stay away from "Gun Power." White America breathed a deep sigh of relief. Black Power was defined as economical and political in thrust and therefore under the control of the established economic and political powers in the nation. Political power was kicked around and debated, while economic power became Black Capitalism-adding black to the world capitalism makes about as much difference as adding water to water, all you get is more. America began to welcome and encourage Black Capitalism and why not? What easier way to eliminate the problems than to make the Black man identify with and ascribe to the very system that has suppressed him so long. How can you speak of Brothers and Sisters and believe in an economic system which is dependent on the success of the individual by defeating and depriving others to achieve your goals. There is no unity, no common goals for the benefit of the whole, only the goal of the individuals, succeeding through deft competition and the defeat of others. Of course American capitalism as very moralistic and beneficial goals, economic growth, full employment, price stability, econom-

ic freedom, equitable distribution of income, economic security—but how many of these can a Black man or any man believe in as true goals.

The endorsement of Black Capitalism quickly found roots in the Black Bourgeoisie; who found it as a new status vehicle and gained more recognition from White and Black America, but it actually offers little or no advantage to them or anyone else. A few token Blacks were placed in some new position and seen more often, but the power remained as stable and exclusive as

The American cry of Black Capitalism came too late to halt the Black movement that had begun however. It may have served to soothe the people for the present, like many Federal Aid Programs do, but the true struggle for "human dignity" goes further than the osmosis of the American way of life. It is no longer only a matter of becoming an American, of wanting to belong, to fit in; not just a battle for Black rights but a struggle against an oppressive system which is strangling the white American in the Appalachian mountains just as certainly as it is destroying the American Indian children on barren reservations and black tenant farmers in Mississippi, and Vietnamese and Loatian peasants in Asia.

As people become more aware of the hideous trick that has been played upon their minds and souls by a rather small group of individuals in power and as people begin to flex their muscles and attempt to deal with their conditions of life the struggle will become more bitter and will encompass many more people. If we are ever to stem the tide of inhumanity in our nation and the world the struggle must go on. The struggle will go on.

As we all know, pawns do not have feelings; unless the pawns are human. Presently, it appears that the pawns here at S.I.C.C. (students) have been manipulated between two separate factions in a struggle which seems to have at stake certain Faculty and Administration powers and prerogatives.

Regardless of the personalities, involved, the student body will apparently end up in the same position it presently is in, that is, powerless to determine curriculum changes and without effective control over the bulk of finances which come into this institution; and relatively no say in Administrative procedures such as Registration.

As matters stand now the students are sharply divided on whether or not to stand with the Faculty in its struggle to curb the Executive powers of the President of Staten Island Community College or whether to support the Executive and Administrative Branch.

This is not a simple matter. In the Administrative Branch there are a greater number of Black people than has ever been at Staten Island at one time since its inception. To a great many Black students these individuals represent hope for a future life which the student will have an opportunity to use the skills developed in the college tot he benefit of themselves and hopefully their communities. For many even this "image" of hope was not afforded the Black high school or college student. Every Black student in the past spent many agonizing hourse of frustration and worry as to whether or not the skills developed in College will ever be used; as opposed to the general student concern of how well these skills will be used.

For this reason, there is a natural inclination on the part of Black students to think of the Administration with a favorable bias.

On the other hand, we are aware of the dangers inherent in following a path laid out for us by friend or foe.

A realistic and intelligent direction for all students to take is to attempt to gain some real student power, so that our interests can be protected by ourselves.

The housing situation in Brownsville is the worst in the city of New York. The area looks like the aftermath of World War II. The avaricious landlords can never be found. They don't show up to collect their rentals for fear of being suppensed. They persist in refusing the minimal services for the tenants who are forced to live in these conditions because of the current housing shortage in New York City, because of poverty and because of racial discrimination in the real estate industry.

When the people on welfare refuse to pay their rental because of the conditions, these housing pimps make deals with the welfare so that the checks will be sent directly to them. The corcupt housing officials and welfare officials are quickly swayed to report that there are no violations on the landlord's buildings. usually through the use of bribes.
