South Africa 2010: World Cup Winners and Losers off the Pitch

In 2004, an aging Nelson Mandela pitched South Africa as a World Cup host to FIFA, soccer's international organizing body, as a story of hope and overcoming. Sixteen years after the end of apartheid, South Africa is poised to become the first African nation to host the world's second largest sporting event.

South Africa has widened its roads, upgraded its hotels, increased security and built state of the art stadiums in anticipation of the World Cup. The question now is will it see a return on its investment?

Most signs suggest that the World Cup's impact on South Africa's economy will be muted at best. A recent study published by Jean Francois Mercier of Citigroup-Johannesburg predicts that the World Cup will boost GDP by only 0.5%. Other academics have put the number closer to 0.2%. Grant Thornton, a multinational accounting firm, believes that 330,000 foreigners will visit this summer, down from its original projection of 480,000 in 2008. The economic slump, it thinks, will discourage soccer fans from making the trip to the most southern African nation.

In December, the British Telegraph Travel suggested that price-gouging hoteliers might also be to blame. Taking advantage of the foreigner influx, 65% of hotels in Johannesburg were charging more than 50% of normal peak season rates for accommodation between June 31 and July 31, the period of time when the World Cup will be played. The four-star Cape Town Lodge Hotel even raised its rates from 68 Pounds per night to 395.

Other entrepreneurial locals have not been so lucky. Food and drink peddlers looking to sell the native steak and pap at matches have been turned away by FIFA and its multinational sponsors who include McDonald's and Coca-Cola.

The biggest beneficiary of the World

Cup, it turns out, is FIFA. The organizing body is only responsible for paying teams' travel expenses and prize monies. In return, it gets to keep TV and marketing revenues. For the 2006 World Cup hosted in Germany, FIFA incurred costs of 222 million Euros while receiving revenues of 1.4 billion Euros, a nice return on investment.

But South Africans remain hopeful that in the long run they will come out ahead. The tourism industry sees the event as an opportunity to showcase South Africa to the world. It anticipates tourism to grow past the 10 million mark and to hit 14 million per year by 2014.

Bloomberg Says a Soda Tax 'Makes Sense'

As the battle over the state budget and the looming multibillion-dollar gap becomes more intense, Mayor Michael R. Bloomberg has stepped up his call for the Legislature to pass a penny-perounce tax on soda to stave off major service cuts to education and health care.

During his weekly radio address on Sunday - a day before a symposium on the topic - Mr. Bloomberg noted research suggesting that such a tax would reduce consumption of the sugary drinks, driving down obesity rates and the accompanying medical costs. Yet his main thrust was on finding a quick source of revenue for a city in serious need of one.

"In these tough economic times, easy fixes to our problems are hard to come by," he said. "But the soda tax is a

fix that just makes sense. It would save lives. It would cut rising health care costs. And it would keep thousands of teachers and nurses where they belong: in the classrooms and clinics."

The city's health commissioner, Dr. Thomas A. Farley, and his predecessor, Dr. Thomas R. Frieden, have advocated such a move, but the comments reinforce the mayor's newly public support of the controversial tax.

Last year, after Gov. David A. Paterson encountered such strong opposition that he eventually dropped the proposal, Mr. Bloomberg expressed support for it but noted the "enormous outcry" and said the idea was "just not one that we're going to be pursuing."

This year, Mr. Bloomberg is throwing his weight behind the proposed tax at a time when the governor has been weakened and distracted by scandal. During testimony about the budget before the

6.0 earthquake hits eastern Turkey, kills 57

A strong earthquake with a preliminary magnitude of 6 struck eastern Turkey on Monday, killing 57 people as it knocked down stone or mud-brick houses and minarets in at least six villages, the government said.

The government's crisis center said about 100 other people were injured in the quake, which hit at 4:32 a.m. (0232 GMT, 9 p.m. EST Sunday) in Elazig province, about 340 miles (550 kilometers) east of Ankara, the capital.

The earthquake, which caught many people as they slept, was centered near the village of Basyurt and followed by more than 30 aftershocks, the strongest measuring 5.5 and 5.1, the Kandilli seismology center said.

The worst-hit area was the village of Okcular, where some 17 people were killed and homes crumbled into piles of dirt. Another 13 people were killed in the village of Yukari Demirci, Gov. Muammer Erol said.

By noon, everyone had been removed from the rubble and there was no one left buried inside the debris, Erol said.

"Everything has been knocked down, there is not a stone in place," said Yadin Apaydin, administrator for the village of Yukari Kanatli, where he said at least three villagers died.

Authorities blocked access to Okcular so ambulances and rescue teams could maneuver on the village's narrow roads. Relatives rushed to the village for news of their loved ones.

"The village is totally flattened," village administrator Hasan Demirdag told private NTV television.

Ali Riza Ferhat, an Okcular resident, said he was woken up by the jolt.

"I tried to get out of the door but it wouldn't open. I came out of the window and started helping my neighbors," he told NTV television. "We removed six bodies."

Court Upholds "One Nation, Under God" in Pledge

Phrase Ruled Constitutional After Trial

According to a new ruling by the U.S. 9th District Circuit Court of Appeals, the phrase, "one nation, under God" will be kept in the Pledge of Allegiance. This reverses the court's previous decision that the inclusion of this expression was unconstitutional. A Californian man and atheist, Michael Newdow presented this case previously in 2002, as well as in 2004. He stated to The Los Angeles Times, "This is not a politically popular cause and those who would disenfranchise a majority have the power to do it." Newdow has also argued against the axiom "In God We Trust" being printed on the U.S. dollar, "citing a Supreme Court ruling that the phrase constitutes a national motto."

Some argue against removing the saying, citing tradition as favoring its inclusion. One can note, however, that the expression "one nation, under God" did not exist within the Pledge of Allegiance until 1954, under the



Eisenhower administration. Many campaigns to include the phrase within the Pledge failed, U.S. District Judge Lawrence K. Karlton believes that "under God" was embraced because of the atmosphere that resulted from the Cold War, in a "gesture against the godless communism of the Soviet Union." Karlton ruled in favor of Newdow's proposal

Many Potential Successors if **Rangel Retires**

Representative Charles B. Rangel's decision to relinquish the coveted chairmanship of the House Ways and Means Committee has raised a once-unthinkable possibility: that after 39 years in Congress, he will not seek re-election this vear

Even as Mr. Rangel insisted on Wednesday that he would run, a person who has spoken with the congressman about his political future over the past few days said that if he did not regain control of the committee, an unlikely prospect in a tough election year for Congressional Democrats, he would consider dropping out of the race.

"He would have to take a really hard look at the race," said the person, who spoke on the condition of anonymity so as not to offend Mr. Rangel by discussing a private conversation.

In an interview, Mr. Rangel rejected the speculation and said, "There is no way that I can foresee anything that would stop me from running for re-election.'

If he decided not to run, it would touch off an intense battle for what has been. for the past 20 Congressional elections, the safest of safe House seats. The last time that Mr. Rangel faced a serious Democratic challenger was 1994, when he defeated his primary opponent by nearly two to one.

In interviews, his potential successors carefully parsed their words out of deference to Mr. Rangel, the dean of the New York Congressional delegation. But they left little doubt about their interest in his job.

Privately, many said that Mr. Rangel's brand had been damaged by a series of House ethics investigations and that the loss of his powerful perch on the committee would diminish his ability to deliver crucial funding for his district, which includes Harlem.

Some of the injuries occurred during the panic, when people jumped from windows or balconies. Video from the Dogan news agency showed residents bringing the injured to hospitals by cars and taxis.

Turkey's Red Crescent organization sent tents and blankets to the region. Erdogan said ambulance helicopters, prefabricated homes and mobile kitchens were also being sent.

Earthquakes are frequent in Turkey, much of which lies on top of the North Anatolian fault. In 1999, two powerful earthquakes struck northwestern Turkey, killing about 18,000 people.

In 2007, an earthquake measuring 5.7 damaged buildings in Elazig, briefly trapping a woman under debris. In 2003, an earthquake measuring 6.4 magnitude collapsed a school dormitory in the neighboring province of Bingol, killing 83 children. The collapse was blamed on poor construction.

LETTER FROM THE EDITOR If You Don't Like the Courses at CSI Then Leave

Being a student at CSI means that you will eventually come across a course that is required that you don't like. If you really don't want to take a particular course that is required what are your options? You could try figuring out how many of your credits will transfer over if you decide to leave CSI. You could try delaying taking the course or attempt to get a waiver, but chances are that it'll be more work than its worth. So is there a better option? Actually there is... get an e-permit.

What exactly is an e-permit? CUNY's e-permit website states that an "e-permit facilitates the process of CUNY students obtaining permission to register for courses offered at other CUNY colleges."

Meaning that if you are willing to travel outside of CSI to any one of the other 22 CUNY colleges located throughout the five boroughs of New York you can find a course that is right for you.

However you need to concider a couple of things. First is the course you want to take a required course for your general education requirements or a Major requirement? Or is the course an elective? In any of the cases mentioned you need to understand that, "prior to taking courses at another institution a student should inquire at the Host College for registration dates and procedures governing permit/transient students."

Second you need to make sure that you are eligible to apply for an e-permit. According to the e-permit website you must meet the following requirements:

* A matriculated student currently in attendance at a CUNY college (Home college);

* Undergraduate students with a minimum cumulative GPA of at least 2.00;

* Graduate students with a minimum cumulative GPA of at least 3.00;

* A student cannot have any stops on his/her record:

* A student must meet all Home college registration requirements, such as completed immunization;

* Newly admitted and continuing Macaulay Honors College and CUNY BA students with advisor approval.

If you fall into either one of the following categories you can not apply for an e-permit:

* A non-degree student

* A newly admitted undergraduate or graduate student prior to completing their first term at the Home college.

Once you meet the requirments to register for an e-permit and you know how the course you want to take will be counted towards your degree there are a few things you need to do to make sure that things go smoothly. Always check with your 'home' college for an equivalent course. So an example would be if you want to take a language course that is already offered at CSI, but at another CUNY college. What you have to do is make sure that there is an equivalent course. So let's say you took Basic Spanish I and want to take the next level at Kingsborough. The course there would be Elementary Spanish 2, confused yet? Each college has their own set of classes at different levels of study so the best way to make sure you're not taking the wrong course is to do a little research.

Thankfully you don't have to do too much work because an e-permit goes through an approval process, which Registrar, Academic involves Advisement, and the respective department the course you want to take falls under. In our example it would be the Modern Languages Department.

While all of this seems like a lot of work it can be a very rewarding experience. Not only do you get to learn something new you get to learn it outside of CSI. Then you can see if CSI is really as bad or as good as you feel it is. Also you can use this experience to gauge if the academic path you chose is the right one for you.

Legislature in January, Mr. Bloomberg - whose history of using his office to tackle public health issues includes an anti-soda advertisement campaign and banning smoking in bars - called the proposal "far-sighted."

Dr. Richard F. Daines, the state health commissioner, said he had noticed a difference.

"What I think you're seeing is really a momentum shift in favor of doing it," he said.

Dr. Daines added that the new tax differed from the one proposed last year in that it would be levied directly on soda producers and the estimated \$1 billion in annual revenue would be dedicated to the health care budget, rather than to the general fund. Mr. Bloomberg said the tax would also benefit education.

CUNY Energy Institute Awarded \$350K Grant For Developing Potentially Groundbreaking Technology

New York State's energy research agency has awarded \$350,000 to the CUNY Energy Institute, supporting two projects underway at the Institute to develop innovative and inexpensive methods of storing energy-including one that could have a major impact on the growth of hybrid electric vehicles.

The grant, announced Wednesday by the New York State Energy Research and Development Authority (NYSERDA), is part of an \$8 million package awarded to 19 universities and companies around the state to help develop or commercialize cutting-edge energy storage projects. NYSERDA said it chose projects with both economic and environmental advantages-those "that will strengthen New York's standing as a national leader in the energy storage industry and help build New York's clean energy economy for the

The state funds will support the CUNY Energy Institute's development of a potentially revolutionary version of nickel-zinc battery technology-a project that could provide the hybrid electric vehicle industry with a rechargeable battery that is less expensive, more eco-friendly and safer than those now in use.

"The problem with nickel-zinc in hybrid electric vehicle applications is that it requires frequent recharging, which degrades battery life," said the institute's director, Dr. Sanjoy Banerjee. By developing a method of controlling the flow and composition of the battery fluid, Institute researchers have already observed much higher lifetimes in accelerated testing than any other nickel-zinc batteries now on the market. "To date, we have obtained more than 1,300 deep discharge cycles in laboratory test cells, with little capacity decay," Banerjee said. "That is an improvement of more than 400 per cent over what has been previously demonstrated for nickel-zinc, and even better than lithium ion batteries. which last threer or 4 times longer."

Baneriee said that the implications of a successful "flow-assisted" nickel-zinc battery are enormous. "The main roadblock to widespread adoption of hybrid technology is the lack of an acceptable battery," he said.

The other Energy Institute project included in the NYSERDA grant is a

capacitor system that could be used to improve power management in conventional energy sources ranging from coalfired boilers to nuclear plants-as well as in converting and storing energy from renewable sources such as wind and solar power.

The state grants support the New York Battery and Energy Storage Technology Consortium (NY-BEST), an industry-focused coalition working to further the development of an advanced battery and energy storage sector in New York State's economy.

"Creating more advanced energy storage technologies is essential for us to achieve substantial reductions in our greenhouse gas emissions and energy use," said

Francis J. Murray, Jr., NYSERDA president and CEO: "The proposals we are funding will not only help meet our energy needs, but will demonstrate New York's leadership in energy technology, stimulate world-class research and development, and commercialize products that will help build a clean energy economy and create jobs for the future."

These predictions are not without precedent. In the three years after its World Cup, Germany saw tourism revenues increase by 1.5 billion Euros as 88% of WC-goers said that they would recommend a visit to the country.

South Africa may not be able to rely on the same positive feedback. In a country where crime is rife, roughly 30% of the workforce is unemployed, 40% live below the poverty line and ethnic tensions are still palpable, it is easy to imagine how a string of unfavorable events could dampen the experience and damage the country's brand.

To prevent such events from occurring, South Africa has invested 600 million Rand (the South African currency), into its police force, purchasing helicopters and other equipment. The South African Navy has even committed to enforcing a 50 kilometer match day "no-fly" zone around three out of the nine World Cup stadiums located in coastal cities.

Yet for a nation whose ability to host the tournament was in doubt as late as 2008, being on the verge of doing so is already a victory. The GDP growth, increased prestige and political clout are just icing on the cake.







It Came from Planet Mars



Asteroid Listed As Official Cause of Death

It's been a mystery over 65 million years in the making and so far everything from the Ice Age to disease and even global warming has been attributed to the death of the dinosaurs. However the journal "Science" reports that on Thursday, a team of 41 scientists including paleontologists, geochemists and climatetologists met in London to finally help settle this age old debate. And after having reviewed the countless findings and documentations that were made over the course of the past two decades, scientists are now pretty certain they have found a likely cause of death for the dinosaurs.

"We now have great confidence that an asteroid was the cause of the K-T extinction" says Joanna Morgan, one of the co-authors of the review. She later goes on to describe what kind of impact the K-T asteroid had when it crash-landed in Chicxulub Mexico 65 million years ago. The 9 mile wide asteroid is believed to have had created what scientists called a "hellish environment". which ultimately blanketed the planet in darkness and created a shift in climate. And as numerous terrestrial and marine habitats were destroyed, many of the creatures that inhabited them could simply not adapt. "It's the only plausible explanation" the team concluded after having reviewed the geologic records.

Currently the final crater is estimated at an earth shattering 95.4 miles and believed to have hit the planet at a force a billion times more powerful than the atomic bomb

The K-T extinction to this day is still regarded as one of the most influential and epic events in the Earth's 4 billion year history. For it not only put an end to the dinosaur's 160 million year reign, but also allowed for the rise of our mammalian ancestors

Furthermore, according to the same Bloomberg article, "If you're a money center bank and you engage in global businesses, you need proprietary trading to offset the risk that you're exposing yourself to when you're serving your clients," said Peter Sorrentino, a senior portfolio manager at Cincinnati-based Huntington Asset Advisors, which oversees \$13.8 billion. The Most Powerful of All Banks - The **Federal Reserve**

means is the notion of the federal funds rate, also known as the rate that banks charge each other for overnight loans.

Having a direct impact on interest rates, the Fed decided to lower the federal funds rate in response to the financial crisis that began in the summer of 2007 Since 2007 the rate which was 5 _ percent was drastically brought down to a near zero percent in hopes of improving the economy

Lowering the federal funds rate would ease the credit obligations for households and businesses that borrow money and therefore create an incentive for these entities to borrow funds from banks. The low consumer spending and high unemployment rates are still in need for bottomed out interest rates. In fact according to The Wall Street Journal, the Fed is not going to tighten its monetary policy until it sees an above-average economic growth along with job creation and loan growth to consumers and businesses.

Statements released at the Federal Open Market Committee (FOMC) meeting, states the target range for the federal funds rate will continue at 0 to 1/4 for an extending period of time until growth expectations are met. The Committee also announced that it will be purchasing up to \$1.25 trillion of mortgage-backed securities and approximately \$175 billion of agency debt in order to support mortgage lending and housing markets.

Another method that the Federal Reserve has significant impact on the global economy is the discount rate, or the rate with the Fed charges banks for emergency loans. This rate, normally a full percent more than the federal funds rate had been brought down to a mere 3/4 percent. In addition The Fed lengthened the typical maturity from overnight to 90 days. These changes were made so that banks may have a greater incentive to take loans from The Fed, and therefore loan to other entities in hopes of improving the economy. Other notions included creating credit programs like the Term Auction Facility (TAF) which auctions term funds to depository institutions in hopes of improving funding markets.

The recent improving conditions in funding markets have brought several reverse changes to the primary credit rate policy. The rate would rise for the first time since the financial crisis began in 2007. This decision was made by the FOMC and was effective February 19th Also, maturity times for primary credit loans were reduced to 28 days on January 14, 2010.

According to Reuters, the rise in the rate hopes to act as an encouragement for banks to borrow funds from private funding markets and use The Federal Reserve only as a backup source for funds. Also reductions were made to credit programs that were created due to the crisis, including TAF which will hold its last auction on March 8, 2010. It has been credit programs like these which have acted as an essential element of the economic recovery the last few months. Consequently, the Federal Reserve holds a staggering amount of power over the financial markets. This power has influenced the economic cycle of financial events around the world since its creation and will most likely continue to do so going forward. Q

A Look Down the Rabbit Hole: A Review of Tim Burton's Alice in Wonderland


