## Panel Informs First Time Voters For November

Event Covers Relevant Issues of the General Election

CSI hosted an election panel to connect first-time voters with political experts as the 2012 General Election approaches. The panel was an open discussion for all but fell short of attracting the attention of students.

"This is exactly the kind of event we should be hosting," said President Fritz in his opening statement. "It really connects the faculty expertise we have on campus with community inter-

The panel covered a wide variety of topics. Tax reform, healthcare, voter identification, voter suppression, and the importance of staying informed were all covered on the night of October 2nd.

Fannie Conner of the League of Women Voters opened the discussion. She reminded attendees the last day for registration is October 12 and that people who change their place of residence need to fill out new registration forms. Conner also reminded attendees that voting will take place from 6AM to 9PM on Election Day.

Each panelist was then given ten to twenty minutes to discuss their topic. Professor Calvin Holder of the History Department was the opening panelist.

"Democracy is not a spectator sport," said Conner. "This election will arguably be one of the most important this country has had since perhaps 1936."

Professor Conner followed with a discussion a history of lynchings and voter suppression in the African-American community during in the early 1900's as the context to compare contemporary voter suppression with government issued I.D.'s.

"Democrats have argued that there is an effort to implement voter suppression, directed primarily at minorities. The Republicans have argued that their intent is to prevent voter fraud," said Holder. "I'd like to put in historical context what voter suppression has meant for a minority group in the United States before, specifically blacks.3

Professor Holder went on to explain tax reform, an issue that both presidential candidates have arguing over since the conclusion of the Republican Primaries.

"The tax system really is a window into the soul of our nation," said Holder. "It is becoming increasingly evident that an oligarchy is emerging in the United States, and an oligarchy is a direct threat to any democratic system, such as

## The United States Economic Meltdown

CSI Experts Point The Finger At The Banks





President Obama and Presidential Nominee Mitt Romney have two competing views for fixing U.S. economic woes

Political Scientists and Economy Professors at CSI place blame on the banks for the worst financial meltdown in over 75 years.

"Good solutions are hard because banks are really good at evading them," said Political Science Professor Roshen Hendrickson. "If they're doing things behind the scenes they're more likely to take risks."

Capitalism works when people, businesses and governments have easy access to salary, credit, or investments. Money flowing towards markets that create jobs and distribute

resources is more important than the total money available within an economy.

Sustaining markets involve the purchase of resources between connecting industries, such as when timber, cement, steel industries integrate with the construction labor industry. When one builds a home from scratch it helps the economy more than purchasing a home already built.

"The real price of everything...is the toil and trouble of acquiring it," wrote the credited inventor of Capitalism, Adam Smith.

When a person qualifies for a loan, and

then purchases a home from a previous owner, money is only moving from one bank to another. That is a non-sustaining market. Before the recession, the majority of the world's income was channeled through housing mortgages. These transactions create meager ripples in the economy, as they are a non-sustaining market.

These transactions occurred thousands of times artificially inflating them in value, along with homes of similar value that weren't on the market. The systemic rise in artificial values created a conflated economy. This happens


## **Voter ID Laws Under Fire**

#### Solution to a Problem that Does Not Exist

The attempts at passing new voter ID laws in Pennsylvania, Mississippi, and South Carolina to prevent voting fraud drew criticism from Democrats and the American Civil Liberties Union for being unconstitutional. The laws would require a voter to possess valid identification to be able to register or vote in the 2012 General Election.

"It is an open secret that the express purpose of Voter ID laws is to discourage or prevent people from casting a ballot. Numerous studies show that voter fraud is statistically nonexistent in the United States," said Political Science Professor Cary Karacas. "Given that relatively few votes can determine which candidate emerges victorious in an election, a law that effectively suppresses the vote of minority and low income groups makes

strategic sense for Republicans. It does not bode well, however, for our democracy."

If the laws are passed students, minorities, veterans, and senior citizens would find themselves able to register but unable to vote in the election because they lack a certain form of ID. These groups do not have the same access for acquiring proper identification before an election or lack the money.

"More than 10 million eligible voters live more than 10 miles from their nearest ID-issuing office," reported The Brennan Center for Justice at New York School of Law, "Many of the offices maintain limited hours.'

Congressional Republicans have defended these laws. Republicans believe that they will stop fraudulent voting.

Democratic legislators say they have less

## **Debatable Debate Procedures**

Major Media Outlets Failing to Hold President Obama and Presidential Nominee Romney Accountable for "Facts"

When United States Presidential Candidates. President Barack Obama and former Governor Mitt Romney, met on stage to discuss economic issues facing the nation in their first debate, the eyes of the nation and media were upon

Minutes after the closing statements the major news networks declared victors and criticized both participants, as well as the moderator, on their performance. After the commotion, choruses rang out "Governor Romney Wins!" and "President Obama needs to do bet-

What was not said was actual journalism. It is not the media's role to tell who won or who lost. Journalists are meant to give facts and hold people accountable for what they say and do so the public is properly informed.

The concept of this fell by the wayside as comments over hair and smiles took prominence over the presentation of facts and evidence. Yes, attitude and demeanor play a part when both sides are committed to facts and truths, but that does not give any bearing on winners and losers. You cannot declare a winner of a debate minutes after it concludes.


In the background were the glimpses of

responsible journalism. Politifact.org ran live their opinions for them. fact checking of the statements and arguments made by both participants. The days following the debate, other sites, such as The Washington Post, caught up and began checking the multitude of lies and exaggerations that the constituents spouted and leaned on through the debate

Unfortunately, even as these other media outlets began to pick up the slack, very little attention was paid to fact and consistency checking by the national players. Instead, people were just treated to the news making up

When the Vice Presidential debate took center stage the moderator Martha Raddatz did her job keeping Vice President Biden and Congressman Ryan in check while focusing on

For this she was criticized by major news sources. When Candy Crowley stood up to the candidates and tried to enforce time restrictions and correct Governor Romney on the issue of the speech the President gave on the Benghazi attacks, she was attacked by certain news stations as being biased, while those



doing the criticizing were ignoring the role of the moderator in a debate

Making sure facts are straight if possible is part of the job Crowley was tasked. Some even said that the time for fact checking is after the debate, which is a bizarre concept. To not hold the participants accountable is a dangerous behavior that defeats the purpose of the

By ignoring facts, the words said, positions held and arguments made lose all purpose, and opinions would be better formed on what color tie the viewer likes more.

Between broken analysis, news networks and sites are focusing more on the public's reactions. Both Fox News and CNN ran articles and segments on Twitter reactions to the debate that are still popular and advertised through their sites

After the second debate, they reported on what terms were trending on Twitter instead of crosschecking numbers and statements

Reaction stories are fine, but they should not be the forefront of journalism and reporting. Reports such as these are just distractions to keep people from formulating their own opinions

the one we have. The wealthiest 1% of the American population owns 33% of the wealth."

Holder argued that if the tax system cannot be adjusted to accommodate the needs of the people than our ailing country faces more peril.


"If we look at the state of America in 2012, we see an Interstate Highway system that is in crisis. We see a decrepit railroad system when we compare it to advanced, industrialized countries," Holder stated. "We see bridges in need of repair, rivers that are polluted, an educational system that is slowly being bled, and a bloated military system where billions of dollars are being spent on things that are not necessarily needed to protect our security.

Professor Richard Flanagan of the Political Science, Economics, and Philosophy Department accompanied Professor Holder on the panel along with Finda Gbollie of the Legal Aid Society. Professor Flanagan opened next with his interpretation of the controversy behind voter suppression and state issued identification.

States are requiring voters to present photo identification. Democrats fear the measures will discourage minority voters, while Republicans say they are preventing voter fraud.

"The reality is that the state bureaucracy doesn't have the ability to produce I.D.'s in sufficient number to accommodate all the people who would need them with the election looming," said Flanagan. "However I don't think it will be an issue because I'm certain that both campaigns will have more lawyers than voters. You will have to swing through a balance of lawyers just to get to the voting booth."

The discussion progressed towards Health Care and how it was not a prominent issue when Obama was initially elected. Flanagan mentioned Obama's work with Health Care, how he got it done after Clinton could not. Flanagan argued that although critics will call Obama a socialist, historians will remember him for his big compromises.



October 4th alongside Calvin Holder and Finda Gbollie.

Finda Gbollie of the Legal Aid Society gave her expertise on student loans and education.

"Eight million Americans are receiving student loans, and 1.6 million Americans are receiving student grants from the government," said Finda. "Approximately 37 million Americans right now have student loan debt that is over 1 trillion dollars collectively."

Gbollie said that only a small percentage of people are able to pay for college with grants and the rest are piling on debt. Gbollie suggest that students check EqualJusticeWorks.org, a website which helps explain how to repay loans and offers advice.

The Pre-Election Panel was a non-partisan forum on the relevant issues in current politics. The panel presented an insight into the history and concerns of elected officials, candidates, and the community. Chief Librarian Jones said the discussion was, "informative and provocative."

The panel was hosted in conjunction with the Academy of Retired Professors, the NAACP of Staten Island, and the New York Urban League. The organizations urged eligible voters

Panelist Calvin Holder said, "There ar efforts to deny people the right to vote by having people meet certain standards that are not nece sarily important to the exercise of the franchise.'

Henderson rebutted by asking if the par elists believed that voter fraud is a real threat, "a seen by the chicago convictions of voter fraud" and if the motion to implement I.D.'s is justified by the threat of voter fraud. The panelists chose to avoid the question as to not stray from the

Dr. Irene Deitch, and Chief Librarian Wilma L. Jones encouraged everyone to, "take this back and share this experience with others," words that resonated through an audience composed of faculty, veteran voters from outside the college, effect.

to do with fraud and more to do with voter suppression. Democrats argued that Voter ID laws are a form of poll taxes, abolished by the 24th amendment. The Voting Rights Act passed in 1965 also prohibits the imposition of, "any voting qualification or prerequisite to voting, or standard, practice, or procedure."

In states like Pennsylvania and Mississippi n-person voter fraud is close to nonexistent. The strict voter ID laws were suspended for the upcoming election but were not permanently

Since 2011 there have been 180 voter ID related bills introduced in 41 states; 27 states are still pending legislation and 25 laws and 2 executive actions have been passed in the remaining 19

Thirty-three states in total have passed laws that demand a voter have proper identification. These laws vary state to state with many different requirements

States can be divided up into "strict" and "non-strict." In a strict state a voter cannot cast a ballot without first presenting valid and current identification. Those who are unable to show identification are given a provisional ballot that will be held for a short time after the election until the voter returns with acceptable

In non-strict states voters without ID can ign an affidavit of identity and are not equired to return with identification to have

They can also be broken down into "photo ID" and "non-photo ID" states. Seventeen states will now require a voter to present photo identification. The current non-photo laws will stay in effect for the upcoming election. If found to be constitutional under Section 5 of the Voting Rights Act, these laws will go into

# CSI Hosts Dean's Symposium on Staten Island Voting Patterns

Investigating Policy Changes and the Federal Elections

On October 4th, Dean of Humanities and Social Sciences Dr. Nan Sussman, introduced a Dean's Symposium investigating the "Voting Patterns and Policy Changes in the Federal Elections."

Dr. Richard Flanagan, Associate Professor, invited 3 notable guest speakers who kept the investigation central to Staten Island politics, the theme of his book with the late Dr. Daniel Kramer entitled, "Staten Island: Conservative Bastion in a Liberal City."

The speakers focused primarily on the polit ical history of the borough, discussing the relative sequestration Staten Island has cultivated from New York City.

Tom Wroblesky, Political Editor at the Staten Island Advance shared a desk with Jeffrey Krossler, noted NYC Historian and Professor at John Jay College, and Councilman James Oddo of the 50th District

Dr. Flanagan opened the panel with a tribute to his colleague Dr. Kramer, expressing his admiration and honor in being allowed to par take in Kramer's project. He also expressed his condolences to Roshanda Kramer before beginning a series of questions to the panel.

The panel was first asked to define the three most important events in Staten Island Political History. Dr. Flanagan pointed this out as the Construction of the Verrazano Bridge, the election of public officials such as Governor Rudy LA LANGE

Giuliani and Senator John Marchi, and the debates over the removal of the Great Kills I andfill to which all three panelists agreed

"The election of Rudy Guiliani," said Oddo "You could like, love, or hate him but he's made every other mayor have to live up to his relationship with this borough."

In discussing the politics of Staten Island, the panelists and Dr. Flanagan, focused on the fact that Staten Island is integral to the politics of NYC, despite the recurring theme of succession.

Keeping the symposium light with humor, Dr. Flanagan said, "Councilman Oddo is the kind of Republican a Democrat can vote for. I don't know how much of a compliment that is, but thank you Councilman.

Civilly and respectfully, the panelist debated over a series of questions, all streamlining the importance of Staten Island's political history in relationship to the politics of the city, constantly drawing notice to the difference in popular opinion from the "forgotten borough" and the rest of the city. Dr. Flanagan pointed his attention to the Great Kills Landfill as the premier example of Staten Island's status

"But there are landfills in the Bronx," said Krossler. "There are landfills in Queens too. What makes it so intolerable to Staten Island?"

The panel eventually landed at the point of Kramer and Flanagan's exposition: the Republican, conservative nature of Staten

Staten Island remains the only Republican stronghold in New York State, an isolated red region amongst an ocean of blue. Only in the last 20 years has Staten Island been classified as a Swing County with Republican tendencies. That opinion came about with the election of Michael McMahon in 2009 who quickly lost his seat to Michael Grimm in 2010

Staten Island falls in the 13th Congressional District along with a piece of Brooklyn, an argument that called for the construction of the Verrazano Bridge.

Years of Staten Island secession movements crippled a prosperous political relationship with

"There's a known political barrier to the title of the forgotten borough," said Wroblesky. "The landfill is like the Berlin Wall. But then Guy Molinari spearheads the removal of the landfill."

The symposium highlighted the spirit of a healthy bipartisan relationship between Staten Island and the other boroughs.

"For years Staten Island has dealt with an identity crisis," said Krossler. "It's always been Staten Island against the city. But as of recent we see the term 'Us' appear."

The symposium emphasized the need for bipartisan relationships in America, educating those in attendance on the possibility for cooperation between political parties.

when: a) homes are so overpriced it's impossible for ordinary people to buy, or b) once debtors become insolvent

"They were home renters and not homeowners," said Economics Lecturer Linda

Once people can no longer afford to pay their debts, investments for those markets implode. Money thought to be safe through investing seamlessly evaporates overnight. Those assets have little worth but still remain on bankbook ledgers

When money flowed through a single channel instead of spread out over several it inflated the market price, like the aforementioned housing crisis or the 90's dot-com crisis, it causes a recession. The more money invested in a sector, the bigger the recession. After money evaporated, every level of the economy starved, from government, to private business, to individual households. The money lubricating the financial sector dried up halting industry to a crawl.

"The worst financial crisis in two generations has erased \$14.5 trillion, or 33 percent, of the value of the world's companies," wrote Bloomberg News.

Banks no longer had money to give out loans for households, or businesses decreasing the demand for goods. This stopped businesses from hiring. The lack of accessible credit caused a cascading effect dissuading households from spending money, followed by more layoffs, followed by further decreased spending, followed by more layoffs.

Money is created when banks give loans. Those loans become an investment to whichever sector receives it. If a government borrows from a bank it immediately spends on

The Republican agenda touts government interventionism as inefficient and wasteful. They believe government to be obtrusive and an annoyance that boggles down innovation. They report society should rely solely on the ingenuity of business by investing money directly into private industry.

"Free enterprise has done more to lift people out of poverty, to help build a strong middle class, to help educate our kids, and to make our lives better than all the programs of government combined," said Presidential candi-

In order for a household to put money back into the economy they need expendable income. In order to have enough income to insert back into the economy individuals must have employment from business or outside investment from banks.

"Due to a lack of aggregate demand, banks are loaning more carefully," said Economics Lecturer Coull. "And households are saving

more and spending less." Banks are now able to give loans because

they were bailed out with \$14 trillion by global taxpayers. They must be willing to risk losing money, but private enterprises are unlikely governments receive an increase in tax rev-"Obama is trying to help Banks refinance enue to repay debts and the economy swells

homeowners," said Economics Lecturer Coull. "But the Banks want their palms greased."

Private industries provide a major chunk of the potential employment, but only when businesses have enough residual profits to reinvest in wages. A business is not obligated to provide jobs to employees.

Business' primary obligation is to provide the best product to their consumers and the greatest dividends to their stockholders. During times of recession a scarce supply of equity dissuades businesses from altering that

"Businesses will only invest if they see a free market in the future" said Political Science. Professor Hendrickson. "But there's no such thing as a free market; governments needs to play a role.

The United States' economic model is a triangle. Households, private business and government being the essential three pillars that contribute to its foundation. In order to reinvigorate a starving capitalist economy there needs to be a surge in spending from any of those three pillars.

Each sector of that trio is dependent on the other. Business needs consumers to spend money, consumers need money from business in the form of wages, and the government needs for the former two sectors to have money in order to recoup taxes and afford to fund courts, a military, a police force, a fire department, Social Security and Medicare.

When money dries up after a financial collapse governments intervene. They are the

only institution with fluid access to money during a recession, because governments aren't liable to make a profit. The Governments only responsibility is to keep the country afloat. Congress is debating over how.

Congress is fighting over who will contribute the least, either a de-funded government or a regulated corporate sector

"Congress is divided over two distinct political philosophies," Professor Hendrickson said. "The Democrats cite growth and government intervention, but the Republicans cite low taxes and limited regulation."

Partisanship has caused bickering between the two political parties.

"Congressman are beholden to a philosophical ideology," said Political Science Professor Richard Flanagan.

The Democratic stimulus has enabled a "slow quantitative easing to take effect," said Economics lecturer Coull, "Before, the economy was counting on credit; now, there's none."

Congress has forced through austerity to solve recovery. Austerity only works if people already have money, which the banks refuse to give to them. Businesses aren't creating jobs fast enough for speculators to invest properly.

There is investment, but only in commodities that have little impact on the jobs market.

A subsequent decrease in the need for labor, with many advances in technology, future generations will have to rely on their savvy and ingenuity as thinkers to become the inventing class of industry and not just it's wage earning class: a class of debtors.

"Equal quantities of labor are always of equal value to the laborer, yet to the persor who employs him they appear sometimes to be of greater and sometimes of smaller value,'

## The Political Machine - The Most Polemic Game of 2012

This PC only title is a very unique game. The basic concept is to become President by campaigning and winning a fictitious general elec-

The first major complaint comes even before the start of the game. You are forced to create an account with Stardock to play and thus, in order to play this game, I must first log into Steam and then into Stardock. There is no reason for this. Steam already provides built in digital rights management into its platform.

Community services and multiplayer are possible without the need for an account and again, the Steam network already covers this. This appears like a blatant and dishonest attempt to accumulate email addresses so that they can send "exclusive" offers to them. To Stardock's credit, I opted out of emails, and true to their word my inbox is offer free.

The first element to grab your attention is the art style. They use bobble heads to represent the candidates and everything has a distinct toy feeling to them. I found it humorous extremely large ears and Governor Mitt Romney's long chin.




Now MGS: Sons of Liberty is an eleven year old game, but conservative talk show host




