The College of Staten Island (CSI) Association, Inc. is a nonprofit corporation composed of students, faculty and administrators who administer the student activity fee at CSI. The Association also allocates an earmarked portion of the fee that it traditionally has applied to Commencement exercises, student leadership development, and administration of the corporation.

Scope & Content Note

The CSI Association approves all student activity fee budgets at its meetings, and each year the financial records of the Association are audited by an independent certified public accountant. The City University also periodically audits the Association's financial records. The CSI Association's records consist of these meeting minutes, meeting materials and annual financial reports, statements and audits.

Coverage of the CSI Association's meeting minutes is good, but not comprehensive. As meeting minutes for the academic year are issued with a consecutive number, it is clear that some minutes are missing, particularly for the academic years of 1987-1993.

Coverage of annual financial reports is comprehensive for the academic years of 1978-1987 and 1991-2003. Reports for the 1987-1991 academic years are missing, and the Archives has not yet received reports for the 2003-2004 academic year.
