#### **Biographical Sketch**

As an avocation since 1986, Mr. Rooney worked on park creation, wetland and stream corridor preservation, coastal issues, land use/zoning, and related transportation and air quality issues on Staten Island, and to a much lesser degree, regionally. He worked to preserve as much open space as possible in Staten Island, the fastest growing county in New York State.

This work was executed as a board member and Vice President of Protectors of Pine Oak Woods, Inc. (PPOW), and Chairperson of PPOW's Greenbelt Additions Committee; Co-Chairperson of the Staten Island Greenbelt Stewardship Council; an officer of the Richmondtown & Clarke Avenue Civic Association, Inc.; and an officer of the Joint Mid-Island Civic Associations, Inc.

To further his volunteer civic activities, Mr. Rooney was a columnist and contributing writer (1996-2003) for the alternative weekly *Staten Island Register*, and wrote numerous letters to the editor and opinion pieces concerning Staten Island's environmental and planning issues published in the *The Register*, *The Staten Island Advance*, *The New York Times*, and *New York Magazine*.

A native of Staten Island, he graduated from Monsignor Farrell High School and New York University.

NYCDEP's South Richmond Drainage Plan Advisory Committee Member, working on the redesign of the sanitary and storm water drainage plan for the southern third (22 sq. mi.) of Staten Island in order to recognize new parks and wetlands, and stream corridors that would have been obliterated by the existing 1961 plan. Realized from this plan was the Staten Island Bluebelt system.
