Abstract: Diana McCourt became involved in the efforts to expose and improve the conditions at Willowbrook State School after her daughter, Nina, was placed at the institution in 1971. She was involved as a parent organizer and advocate of the institution's closure, and remains involved in promoting individualized day and living options for people who need 24 hour support. She also worked for many years as a contractor, and co-founded Womanshare, a skills and service exchange program for women, in the early 1990's.

The collection contains materials related not only to these efforts

but also to the hepatitis program and the lawsuits against New York State over Willowbrook and compliance with the 1975 consent order. The folders are arranged alphabetically.

1		Audiotapes, c.1972, 1975 - There are two audiotapes. The first is a 1975 presentation of the consent decree by Bruce Ennis, Esq. The second is an undated tape labeled, "PAC Conference" that is probably from 1972 or 1973. PAC stands for Policy and Action Committee for the Handicapped.
1	1	Correspondence, 1971-1976 - Various correspondence on Willowbrook and other related issues. A few items of the correspondence are by McCourt, other items are copies of correspondence by others.
1	2	Correspondence - Responses to the Dick Cavett Show, 1972 - Diana McCourt appeared on the Dick Cavett Show in 1972. The folder contains five viewer responses to her appearance.
1	3	Handouts & Newsletters, c. 1972-1975 - This includes several undated handouts that were probably distributed during 1972-1973. These handouts are related to the anticipated dismissal of Dr. Hammond, administrative problems and the conditions at Willowbrook. There are also handouts of a few news articles from the same period. There is also a copy of the July 1975 newsletter of the Benevolet Society for Retarded Children.
1	4	Hepatitis Program, 1958, 1969-1979 - This folder contains correspondence, articles, newsclippings and other items about hepatitis and the hepatitis program at the Willowbrook State School. There are also some records related to the experience of McCourt's daughter, Nina, at the school.
