## **REYNOLDS BLASTS CUNY BUDGET CUTS**

Despite her desire to discuss proposed budget cuts to CUNY, Chancellor W. Ann Reynolds was repeatedly questioned by the student media about beefed-up University security measures, at a press conference in the Graduate Center last Tuesday.

Before handling the security questions, Reynolds strongly condemned Gov. George Pataki's proposed budget and described the \$96.3 million shortfall it could cause.

"We have to get base budget restoration to let us keep our very fine faculty- to hire new faculty," Reynolds said.

CUNY predicts that as a result of the shortfall, 334 full-time positions will be lost, 5,000 class sections will be canceled and library and student services will be reduced. Reynolds explained that CUNY was working to prevent this. "We're now in high activity, top peak activity level, lobbying senators and assembly people on this budget."

A large number of state colleges across the country pay a much larger percentage of student's tuitions, and summer be the major political issue," Reynolds said.

Reynolds emphasized the need for legislative and public support for CUNY and discussed some of the actions that have been taken to effect

Reynolds pointed out. And, except for three other states, New York is unique in its decrease in support of public higher education. "I believe, if we all do our job right, that higher education and funding for higher education will indeed, increasingly, over the spring this goal, including: contacting prominent leaders such as Cardinal O'Connor and CUNY alumni such as Colin Powell and Eli Wallach, undertaking a massive letter-writing campaign, supporting a voter registration drive, and beginning a "fun" campaign which notifies the media about outstanding students on financial aid so that they can be profiled. "I wish there were lots more coverage on education right now," she said. "It is completely being overlooked."

On the subject of CUNY security, the cost of which has been increased, Reynolds had only positive things to say. Some of the changes was the implementation of S.A.F.E. officers, which means Special Assistance for Events, which are an addition to regular Peace Officers. S.A.F.E. officers have been very popular in the media due to their involvement in the arrests of students participating in the hunger strike at CCNY.

When asked if the new measures were necessary, Reynolds answered, "absolutely." Before the new measures were implemented, she explained, rented security guards had a high crime rate and CUNY security was a "series of catastrophes just waiting to happen."

## PRESIDENT KAUFMAN ACCUSED OF BREAKING STATE SMOKING LAW

Several Student Government Senators came forward recently and admitted to reporters that SG President Meri Kaufman illegally smokes in the Student Government offices and has been doing so for some time. Senator Vincent Cobb stated, "The only person that I've seen smoking in the office is the same person who has an ashtray on her desk and a password on her computer, and that's Meri Kaufman."

When confronted with this issue, Ms. Kaufman denied that she smoked in the office claiming that the ashtray on her designated desk did not belong to her. However, other Senators backed Mr. Cobb's allegations, claiming them true. Senator Liz N. George said, "I've seen Meri smoking in the office and I've seen Mike [Johnson] smoke too... But Mike hasn't done it in a while." When asked if the allegations were true, Senator Mike Johnson admitted, "From time to time I have smoked- I have lit cigarettes in the office- but I don't do it any more."

The issue was first brought up almost two years ago when Senator Lori Seggio complained about smokers in the office during a November 1994 SG meeting. It was during this meeting when Ms. Kaufman first made the motion that students would not be allowed into the office unless a senator was present. Over the past two years, past Student Center commissioners have tried to deal with the smoking problem to no avail. Former Student Center commissioner Natalie Williams said, "I tried to stop them but people just don't listen... they just don't check themselves."

The issue continued to surface during meetings until recently when current Student Center commissioner Lori Seggio expressed that the smoking has not stopped. "When I ask the senators not to smoke in the office, they just laugh at me... they don't listen," said Seggio during a recent committee meeting. When asked if she enforced the smoking policy, SG Coordinator Ellen Krieger said, "The staff is here to advise students, not police them. I don't want to be in the position where I'm telling students what to do."

Former SG Senator Raul Torres also expressed concerns over the illegal behavior. "On numerous occasions, I have seen President Kaufman smoking and on other occasions, I have walked into the office when it was full of smoke and the only one there was Meri," said Mr. Torres. He continued, "She mainly smokes when no one is in the front office. She's breaking the law... how can you lead a group when you break the rules yourself."

According to State Health Codes, smoking in any public place is illegal and anyone caught would be subject to fines of up to \$1,000 dollars, loss of office privileges, or up to 30 days of incarceration. Just last year, January 1, 1995, the security office began to enforce these laws under the direction of former Dean of students, Frank Torre (See BANNER Vol. 2 Issue 8). According to the former dean, any student caught smoking in any of the buildings would be in violation of the law and would be issued warning summonses, lose office privileges, or be subjected to a fine.

Reporters tried to speak with Kaufman who only commented, "I'm not in the mood to discuss this right now... I don't feel like being interviewed." Kaufman also pointed at the ashtray on her desk stating, "This is not my ashtray."

Cobb argued, "It is her ashtray the same way as it is her password on the computer." He contin-

ued, "She's breaking the law. We had meetings about this issue and Meri was the first to start laying down the law with the phone abusing, and eating in the office... the same one who is penalizing others is the one that smokes in the office herself, abuses the phone herself, and minimizes the use of the computer because of her password... these are Meri's politics."

Former Senator Edward Deighan also spoke on the issue, "When I was a Student Government Senator, I witnessed Meri Kaufman smoking in the Student Leader's office without regards for the other senators health." Senator Joseph Canale stated, "Higher ranking members do engage in breaking the campus center smoking policy." Canale continued, "I disagree with the law being broken. In the Student Center Commission meeting, I tried to impose tough legislation with penalties such as loss of senatorial privileges during the next consecutive meeting following the offense but it was turned down by the committee and labeled as 'too harsh'." After over one hour of discussion, the Student Center committee tabled the issue of smoking in the office for future action.

Despite the many witnesses, Kaufman continues to deny that she has smoked in the office and offers 'no comment'. Torres argued, "She [Meri] should be penalized for breaking the law. There isn't suppose to be any smoking except for outdoors... if you're that desperate for a cigarette, just walk downstairs." Cobb added, "I don't see the need for more meetings ... we've already had many and the smoking doesn't stop." When reporters confronted security with the illegal smoking issue, Director of Security Gene Martinez said, "My people don't go to offices unless there are complaints about smoking but I will be sending someone to the Student Government office to speak to them and to Ms. Kaufman in particular. If anyone is found smoking in the office, they will be issued a smoking summons."

Upon hearing the allegations made against Kaufman concerning her illegal activities, Senator Charlo Almeda said, "The allegations presented and the comments spoken by my fellow senators are forthright, acceptable, and credible... I only hope that we will resolve this situation and others as soon as possible."

## **Printer Ruins Nursing Yearbook**

After months of fundraising, layout, and painstaking work, the 1995 Nursing Yearbook was returned from the printer as a disaster. Editor of the Nursing Yearbook, Sandra Colligan said, "We worked our asses off for that book and what we got back was horrible."

The yearbook was filled with smudged pictures and poor typing. Upon inspection of the book, it was deemed an obvious photostat job- a job which cost the Nursing Yearbook Staff \$2,700 dollars. Irwin Kashansky of the Jocapa Printing Co. explained, "When I first saw the book, I thought it was rather poor in printing as well." Ms. Colligan said, "When I first saw the book, I couldn't believe the printing quality, you could barely make out the people, but Irwin kept saying that people would recognize the pictures."

Publications Commissioner Joseph Canale commented on the book, "The printing is absolutely reprehensible, it was disgusting. How can you even think of taking such a book as a finished product?"

Along with the printing problem, there was a breech of contract with the printing company as well. The contract called for half tone pictures and a two color cover, both of which were not honored with the final product of the book. Kashansky

explained, "We made the mistake with the pictures but she [Colligan] continued to call us with more changes to the book.

When the Nursing Yearbook was first discussed by the publication commission, Ms. Colligan was told

that there was no money for the book. Colligan said, "Meri [Kaufman] was the big one during that meeting. During the whole meeting, she sat there giving me faces and then she said that there was no money for the book. I asked them if they could back us but they

"When Sandra first came to me with the Nursing Yearbook idea, there was no documentation stating that Student Government had additional funds to financially support such a project." He continued, "Allan DiBiase, Meri Kaufman, and myself were at this meeting, we told her that because of the cutbacks, we would not be able to fund the project but we would give her moral support."

Colligan and her staff immediately became active in fundraising.

"Most of the stuff we got was donated by companies. We held bake sales and flea markets to raise the money" said Colligan. After months of work, the Yearbook staff raised \$5,000 dollars for the book. A bid was taken for printing and Jocapa Printing Co. won

the bid at \$2,700 dollars. With \$2,000 another plus, the Yearbook staff wanted to throw a party for the book only to go head to head against the Publication Commission again. Ms. Kaufman said, "People paid and donated people money for a year-

book for the intent purpose of getting the yearbook off. I felt it was a conflict of interest for her [Colligan] to use the money for a party. I would feel offended if I donated money for a yearbook and found out later that it was used for a party." Colligan continued to argue, "When Mr. DiBiase and Ms. Kaufman heard the idea of the party, they hit the roof. We were told that we could use the money to upgrade the book or leave it in a line for the next Nursing Yearbook. In a nutshell, we couldn't spend the money that we raised as we

saw fit."

Mr. Canale also advocated for the Nursing Yearbook party saying, "I wanted them to be able to celebrate their achievements but because a party was never specified on any of the fundraising forms, it was not allowed." Kaufman responded to this, "There are certain guidelines that must be followed, Ms. Colligan just didn't want to do this, she wanted to run things her way." Despite this, the nursing students funded their own party.

Angered with the issue, Colligan said, "No one seems to realize how the Nursing program works. It is unlike any other degree- a lot of sweat, tears, and dedication go into this degree and by the time you finish the program, you become a family with your classmates. It is a very competitive field- a 'B' alone [as a grade] is a tragic situation."

After the constant struggle to print the book, Ms. Colligan held the finished product and said, "This is the final slap in the face. After all of that work, the printer tries to hand this poor quality yearbook over and think I'm going to accept it?" Also dissatisfied with the book, Canale spoke with the printer who agreed that the book would be done over. "Joe [Canale] has been great through this entire ordeal, I only hope that we get what we paid for" Colligan said.



## **Study Abroad: Hello from Ecuador**

Dr. Camilio Marquez visited CSI this week, promoting the Study Abroad program in Ecuador. Marquez is a professor of Psychology at the Brookdale Community College Learning Center in Guayaquil, Ecuador and is also a liaison for the College Consortium for International Studies. He, along with Margaret Prunty-Nelson, a Program Director at the Center for International Service, spoke in several classes including Prof. Greenspan's International Politics class and Prof. Brooks' Spanish classes.

In an interview with Dr. Marquez we discussed the Study Abroad Program in Ecuador. The program is based on the idea to broaden the views of college students and to gain perspective on the ideas of other peoples of the world. Today, more than ever, there is an increasing need for global understanding and communication. Dr. Marquez said that students should get involved in Study Abroad programs. Students have many options of where they can go and have participated in these programs for a variety of reasons. He explained that the program would help students to dis-

cover their heritage, gain a broader perspective in the application of their trade, and to see the beauty of another country.

CSI students can take courses from a variety of programs in Ecuador such as Language, Liberal Arts, Business, Bi-lingual Education, Art, History or any other major without any problems in transferring credits. Marquez stated that even a student who goes for one month can transfer up to six college credits. He mentioned that a wonderful part of studying abroad is that one meets students from Ecuador and Study Abroad students from other colleges, such as Cornell, Brookdale Community College (NJ), University of Wisconsin, Pacific Lutheran University (OR), and Auburn University (AL). Dr. Marquez did not visit CSI only to promote his program to students, but to visit faculty members and exchange ideas about the future of the program to get them involved as well. Since Dr. Marquez is a counselor for Ecuadorian Students who study abroad, he is considering CSI as one that he would recommend his students to attend.

In ending the interview Dr. Marquez said, "Regardless of your area of study, there is always room for a foreign language and social science course with international orientation."

"[Contrary to popular belief], it is not necessary to know the foreign language to study abroad,"

offered Ms. Prunty-Nelson. The programs are affordable to CSI students. Financial Aid is applicable and scholarships are available. Internships are also available for students who want to combine work and academic experiences. These programs helps students get jobs in the future because it shows that they took the initiative to broaden their horizons, both academically and personally. It gives students exposure to new cultures and introduces them to a new way of thinking about themselves and the people

around them. Many employers want people who know more than one language. It is especially important in an increasingly global community.

Ms. Prunty-Nelson is an alumni of CSI who graduated in 1988 with a degree in International Studies. Those classes exposed her to the cultures and histories of other countries. Through this major and the help of her academic advisor, Dr. Nan Sussman, she was introduced to the Study Abroad Program and studied in Florence, Italy though the CSI program in 1988. She said, "It changed my life in such a way that I wanted to spread the news to other CSI students." She attributes her experience to her active involvement in the program and incourages anyone who is interested to contact her at 982-2100.


Attention Please This is not a rumor!



Various churches are playing the role of social reformers, dealing problems. outward with such as drugs, AIDS, family values, and other social ills that have plagued our Many feel that families, society. schools, politicians and religious establishments should stress family values as a cure for our social and moral disorders. And certainly there is some merit to this belief; we do need to teach our children right and wrong; if we continue to entertain liberal opinion that there is no absolute right and wrong we will sink further into moral regression. However, all these problems, as well as our lack of happiness, hope, peace and joy that vex us are merely symptoms that arise from a deeper sickness inherent within our natures. Just as a fever is a manifestation of an unseen sickness, a social and moral problem result from a spiritual sickness of sin latent within our fallen sinful natures. "Wherefore, as by one man [Adam] sin entered into the world, and death by sin; so death

passed upon all men, for that all have sinned" (Romans 5:12). Fighting the symptoms will do us little good, we must fight the root sickness itself to have success. Jesus faulted the religious leaders of his day for concentrating on outward religious doings that were imposed on them by man and not God. They rigorously observed men's outward traditions. They were overly concerned with putting on a religious show for the people so they would look holier than thou. They liked the respect of the religious greetings they received, being called Rabbi [master] and Father, but nobody except God is to be called Master and Father in a spiritual sense (Matthew 23). Jesus said, "For from within, out of the heart of men, proceed evil thoughts, adulteries, fornications, murders, thefts, covetousness, wickedness, deceit, lasciviousness, an evil eye, blasphemy, pride, foolishness: All these evil things come from within, and defile the man" (Mark 7:21-22). It isn't the things that come from without that make us digress morally and spiritually, it is our sinful hearts. The solution isn't reformation, thus reforming ourselves outwardly by social and political changes won't help much; rather it is regeneration, which means we need a new inner spiritual nature-a new heart. Jesus said, "But new wine must be put into new bottles; and both are preserved" (Luke 5:38), meaning we need a new inner nature-a new spiri-

tual birth (John 3:3-6). Our bodies can never become new on this earth, thus sin and its consequences will always be with us (sorry, no heaven on earth), however, God can make our souls and spirits [our inner natures] new when we accept Jesus Christ as our personal Savior and Lord. When we receive him by faith, as opposed to works of righteousness which we do, his Holy Spirit by an act of mercy washes our sins away and makes us new creatures in Christ (Titus 3:5). On March 20, the first day of spring, the Farm Animal Reform Movement (FARM) will be sponsoring its 12th annual "Great American Meatout". Patterned after the American Cancer Society's Annual "Great American Smokeout", there will be educational events throughout the country that will attempt to educate people about the negative effects of meat-based diets.

The typical American diet has been linked to the major American killers: heart disease, cancer, and stroke, as well as other illnesses. According to the U.S. Surgeon General, 68% of the illnesses in the United States have a dietary connection.

It is becoming increasingly apparent that our nation's economic problems will not be solved unless medical costs are contained. The total health costs in the United States have soared from \$80 billion in 1970 (6% of the national GNP) to \$1.06 trillion in 1994 (14% of the national GNP). It is projected to reach 20% in 10 to 12 years. These high medical expenditures have contributed to huge annual budget deficits, and has led to a total U.S. debt of about \$5 trillion dollars in 1996, an amount five times greater than in 1980.

Vegetarian diets are not only healthy for

individuals, they are also better for the health of our planet. Livestock agriculture contributes to many environmental problems including:

•soil erosion

- •air and water pollution
- •the overuse of pesticides
- potential global warming

The use of chemical fertilizers and other unnatural agricultural inputs also add to this list of problems.

Animal-based agriculture is also extremely wasteful of resources. A meat/diary-centered diet requires about 17 times as much land, 14 times as much water, and at least 10 times as much energy as a completely plant-based diet. Since violence and war are often the result of actual or perceived resource shortages, the wastefulness associated with typical Western diets makes disputes more likely.

Non-vegetarian diets also contribute to the present widespread hunger that result in an estimated 20 million annual deaths due to lack of adequate nutrition. Seventy percent of the grain grown in the United States, including two-thirds of the grain that we export, is consumed by animals destined for slaughter, while so many of the world's people are chronically hungry.

Another powerful argument for vegetarianism is related to the brutal ways that animals are treated on factory farms. Since, as Gandhi indicated, the character of a civilization can be judged by how it treats its animals, should we ignore the methods used to produce typical American diets? Farm animals are caged, crowded, deprived, medicated, and mutilated until the butcher's knife ends their agony.

It is becoming increasingly apparent that vegetarianism currently is not only an important individual choice, but also an imperative for national solvency and global survival. The day of the "Great American Meatout" would be a wonderful time to shift away from a diet that is bankrupting the U.S. and the world, crippling and killing 1.5 million Americans annually with chronic diseases, threatening the world's ecosystems, wasting our scarce resources, contributing to world hunger, and brutally treating animals.

Brian Gasper hit 9 of 14 (65%) from the field to emass a game-high 22 points to go with 9 rebounds. Chris Kelly had 14 points while grabbing 17 rebounds.

#### February 21 vs Baruch

A tense and close game was on the menu against Baruch. Halftime ended with a 37-37 tie, and CSI hit their free throws at the end to nip Baruch 72-67 before a crowd of 1,000. In general, CSI shot poorly from the field. However, they made up for their poor shooting by hitting 10 of 15 (67%) shots from behind the threepoint arc. Stephanie Bird, Keri O'Brien and Lily Ann Sciametta had 13, 12 and 11 points respectively.


#### February 23 vs City College (CCNY) for the CUNY Championship

Since the retirement of one Joe Willie Namath, the New York Jets have been searching for that one marquee quarterback who can give the Jets some credibility. They haven't had a quarterback as nearly as good as Namath. They hope Neil O'Donnell can change all that. The Jets thought he was "too slow" and passed on him to select Al Toon, who turned out to be a good player, but he wasn't a Jerry Rice. Bad move. The Jets won't let it happen this time. This guy we're talking about also has a New York type of attitude: cocky, arrogant, outspoken and so sure of himself. He is exactly what the Jets are looking for in a person and as a player. His name, you ask, is Keyshawn Johnson, a wide receiver from USC. And guess what? He wants to come to the Jets! He loves the N.Y. spotlight and just fits in fine here. He has the potential to be better than Michael Irvin.

So picture this Jets fans: you have reconstructed your offensive line, which last year was downright *offensive* by signing Elliott and Williams. You have signed Neil O'Donnell, the established QB who will take you into the next century. You *will* draft WR Keyshawn Johnson from USC with the first pick ( or they might trade down
