


Mid-Year Budget Cuts Threaten CUNY



With the policy of more cops and more cuts is this the future of our glorious institution?

There are once again the ominous rumblings of another massive budget cut in the air. Although this is not confirmed, we have learned from several sources both administrative and student that a mid-year cut of some \$30 million will be meted out by Pataki. Such a cut it is said could very well be translated into a further rise in tuition by

CUNY has already been cut to the bone by the right-wingers in Albany and City Hall. Central administration instead of putting up a fight will inevitably seize upon any further cuts to raise tuition. The bloated administration in CUNY is used as an excuse by Wall Street's politicians to

smash CUNY as a public i.e. open institution. The thin fragility of the so-called "public" sector in a privately owned and controlled society is readily apparent. The 'public" sector whether CUNY, Transit or Hospitals has always been a way in which the failings of the Private free market economy can be dumped on the working class via higher taxes e.g. tuition, fare hikes, layoffs and service cuts. Guliani/Pataki and Dinkins/Cuomo before them have offered massive hand outs to corporations in NYC. In the name of stimulating the economy these bought and paid for politicians of Wall Street have given \$183 million to the NY Mercantile Exchange (roughly equivalent to the cut to CUNY),

\$26 million to Capitol Cities / ABC and \$234 million to the now merged Chase Manhatten. These hand outs or bribes were given with the promise that jobs would be created. City administration reports themselves indicate that this has been a miserable failure with more jobs being cut than created. Over the last 7 years 50,000 jobs have been cut in the Finance, Insurance and Real Estate (FIRE) industries that the "Republi-Crats" have so lovingly wooed. There are no massive increases in police budgets to go after these corporate thieves who have been mugging us in our schools

Students at CSI should be on alert. Another tuition increase could mean the end

of a college education for many of us who are stretched to our financial, physical and psychological limits. We must begin to organize now! Join the College Voice, form your own clubs, seek out information from the power brokers in administration and prepare for the conflict ahead. As the thousands chanted on March 23rd, "The Students and Workers United, Will Never Be Defeated"

Students Claim Prices In Cafeteria In Bad Taste

Are students tired of having to pay exorbitant prices for low quality bland food at the CSI cafeteria? Tough!! That was in a nutshell the response of the three leading bureaucrats of the CSI Auxiliary Services Corporation (ASC), which runs the cafeteria operation. Mike Daniels, president of the Board of Directors of ASC, Ira Persky, Executive Director and Gloria Garcia, Vice President of the Board were interviewed by the Voice and members of the Student Defense Campaign (SDC).

Don't ASC Me

The CSI cafeteria is an "in house" operation that is run by the school unlike the bookstore which has been privatized and contracted out to Barnes & Noble. The ASC Board serves as the owner/management team, coordinating the purchasing of food, setting up of prices, hiring of labor, etc. The ASC Board has 5 major functions at CSI which places it at a very crucial nexus of student life. They oversee the functioning of: 1) Dining Services i.e cafeteria, administrator/faculty lounge and library Snack Bar 2) Parking 3) Bookstore 4) Vending and 5) "Management" i.e. serving as a Trusted Agency for CSI. CSI being the equivalent of a small town, having roughly 13,000 students alone, the ASC Board manages a significant sum of money. \$1.5 million is expected revenue for fiscal year 95-96. Of this amount approximately \$765,000 is projected to be collected from the Dining Services.

SDC member Krishna Johulo has been leading an effort to organize students to register their protest against the "outra-

geous prices", poor quality of food and the inaccessibility of the cafeteria for evening students. In a matter of a week and a half he and fellow student Noble Varghese collected a half a thousand signatures demanding that CSI food be made affordable, edible and accessible. Mr Johulo an Engineering student without any proclivities towards activism was driven to action by an offending cheese sandwich. Frustrated with the poor choice available and not feeling inclined to culinary blackmail he ordered a simple cheese sandwich, a minimalist affair, consisting of two slices of bread and a slice of cheese. He was thunder struck to hear that this ascetic meal would cost him \$1.85. This experience seems to resonate with that of many thousands of students who have thus far endured this absurd state of affairs with only heartburn.

We Shall Eat, We Shall Win

Upon presenting the half thousand signatures to the ASC troika, Voice/SDC members appealed for relief. Mr Persky happily recommended that we join the, you guessed it, Cafeteria Committee. (The politics of "joining a committee" is enough to instill a sense of nausea in students familiar with bureaucratic process.)

Voice/SDC members were further instructed in the economics of food ordering which was a very enlightening experience. Mr Persky noted that since he is not able to order in bulk, he is forced to sell his items at a higher price. Voice member Lou Bardel, being rather unacquainted with this economics asked how it could be that a delicould sell a bottle of Snapple for cheaper

than the CSI cafeteria when the CSI cafeteria undoubtedly serves more people. We were instructed to compare apples to apples and not to oranges. This meant that different rules apply for cafeterias like CSI's than for deli's. Mr Persky although himself compared apples and oranges, noting sympathetically that it is cheaper to buy a bottle of Snapple at Pathmark than it is to buy it from the wholesaler. If the quantity required was not that great why could Mr Persky not buy Snapple at Pathmark then, said a puzzled Mr. Bardel.

At the conclusion of the meeting the Voice/SDC members left the room with a strange feeling of emptiness...in their stomachs. The SDC however plans to take its case to the highest echelons of the CSI hierarchy demanding that students be allowed to eat with dignity.

Food Not Bombs

Unfortunately this diplomacy does not seem to have brought in any new funds to CSI. At least some of us ate well.

This \$75,000 line currently called the Amenities line is according to Mr Daniels to be newly christened as the Community Relations Fund. This money, collected from students or rather extorted from students at the various dark alleys in CSI like the

cafeteria, parking lot and bookstore, we naively feel, would be better spent subsidizing the cost of our food. It is true that students at this great new campus are committed in holy matrimony to the services offered by ASC (the nearest deli being a good 20 minute walk) but this is no reason to abuse them by ripping them off at every turn whether it be the bursars line, the food line or the parking fine.

Mr Daniels and Mr persky have kindly volunteered to provide us with the information we need to show students exactly how their money is being spent in the cafeteria and other areas of ASC control. Domino and Cardplaying Banned in Cafeterai Rotunda While Everyone is Angry over Food Prices

Effective August 28, at the beginning of the fall 95 term, the campus center staff (aka Auxilliary Services Corporation (ASC)) asked everyone to refrain from cardplaying, domino playing, smoking and loud music around the rotunda and

inside the Green Dolphin. This was a unilateral decision by the president of the the ASC, and also the head campus center director, Mike Daniels with the supposed consultation of the Student Activities Council, headed off by administrator Allan DeBiase. There are no students on the Student Activities Council.

"Students don't only play cards here, we socialize and contribute to the money that

Auxilliary Services collects by buying food, and drinks throughout the day that we sit in the rotunda and play cards and dominos" said Diana, who is the ad-hoc representative of the Student Sororities and Fraternaties, who are complaining about the latest arbitrary decision.

When Diana visited the office of Mike Daniels (1C-201) in search of some answers, she was met by assistant Campus Center director, Mike Silver who told her that the reason for the new rules was because last year students were disturbing tables, were loud and obnoxious, and discouraged other people from coming into the cafeteria. According to Mr. Daniels the campus center is not a place just for students but is "more like a student union." Auxilliary Services is in charge of the campus center which serves everyone on campus including staff, faculty and Administrators.

"Daniels is taking away our rights arbitrarily which is unfair to all students. He is unjust and doesn't take into account our points of view," said Andrew, a member of one of the Greek Letter organizations. Students not only play cards and dominos

in the rotunda but it is also a highly visible area where students can meet and congregate. Much of the dissent about the new rules stems from students feeling pushed out of an area without any say in the matter. "We pay our student activity fee so

therefore we should be allowed to play anywhere in the campus center," said Peterson D. who was playing cards away from the rotunda.

When asked how students can have more of a say in issues such as this M. Daniels responded, "come to my office, make an $appointment \, and \, I'd \, be \, happy \, to \, talk \, about$ When told about the prospects of twenty five frat members coming into his office he said he much preferred a few representatives instead of such a large group. Told that the College Voice would like to arrange a meeting, between ASC and students, where all patrons of the Cafeteria could voice their concerns, he flatly refused. According to Daniels, ASC acts to advise students in issues that concern them, but students cannot meet together in front of the decision makers to ask them questions. This "advisory process" exists somewhere according to Daniels but students are hard pressed to figure out where.

Sentiments from students concerning the recent ASC decree do not differ too much in opinion. "People eat wherever they want and nobody gets disrupted by card playing, it never bothered me," said student Vanessa Valencia. "This is a student center, if the students want to play cards or dominos in the rotunda then we should have the right to. Or else they should change the name (of the campus

center) to the Auxilliary Center," said student rep. Diana.

When asked why the decision was made Daniels responded, "This is something that we're trying in response to concerns raised last semester, and I invite you (CV Staff), and any other student or groups of students to come and talk about it." In order to do this you must first make anappointment for the time that Daniels is "free", then hope that he takes your opinion into account the next time he makes a

decision. Students though have no idea what new issues are going to be decided and are kept in the dark until the decision is enforced by the campus security. "After all these years now he finds a problem with card playing and dominos, that's stupid," said another student Patricia M..

Student Senator Natalie Williams who is also the Student Government Campus Center Commissioner, said that she told Mike Daniels that students were upset, and Daniels told her that the area of the rotunda was where he wanted to have a high turnover. A place where people can come in for a bite to eat and then leave. Therefore, according to him, anyone who wants to meet with their friends and socialize should go to the back. The rotunda in the campus center can safely hold up to 150 people according to SG senator Ms. Williams.

When aked about the idea of the rotunda being a place for high turnover student representative Diana said, "This is not a buisness thing, it's a social thing, a people thing."

In fact according to Mike Daniels all

students are patrons of the ASC, which is responsible for funding, among other things, hundreds of thousands of dollars in amenites to the President and her administrative colleagues. "Sometimes administration forgets just whose school this is, it's our school you know," said Student senator Natalie Williams responsible for representing the students also.

The Student Government office is located on the second floor of the Campus Center, perhaps you can find them there.

While Dining in the CSI Campus Center Mike Daniels would like you to give up the right to play cards, dominos and listen to loud music.

Those interested in challenging the status quo should direct their arguments to President of the college Marlene Springer then one can petition CUNY Headquarters located at E. 80th st., from there we demonstrate at City Hall, eventually the White House and then the WORLD!

CSI's Cuts: The Reality of the Matter

Because of Mayor Guliani's and Governor Pataki's proposed financial plan for CUNY, a state of financial exigency declared by the Board of The City University of New York for the senior colleges, the retrenchment plan proposed in June of 95, and simply because of careless spending, The College of Staten Island as well as all of CUNY is now enduring the worst cuts it has ever faced in years. The \$4,500,000 slash in CSI's budget has forced the administration to make some drastic decisions. As said by President Springer herself, "The students will feel this most profoundly when they return to the cam-pus in September to face a significantly reduced schedule of classes and services, a radically diminished corps of full-time faculty and support, and greatly increased competition for entry into larger classes."

The words ring true, for this is now October, and students are feeling the prophesised pressures of the budget cuts. The staff of CSI also faced drastic changes, as well as the Administration. However, it comes into question whether the Administration has suffered as drastically as the reet.

As said before, the chops in staff are indeed severe. The retrenchment report given at the meeting of the same name states that 113 staff positions were needed to operate the new campus. However, none were included in the Executive Budget. This clearly shows that we are now understaffed considerably in CSI.-

The effect on teachers is also considerable. The number of part-time teachers

laid off is definitely enough to leave a mark, leaving the remaining professors with much more work and more students to attend to. This increased stress will definitely affect the quality of the classes, and inevitably, the academic quality of the college.

Departments have been hit hard. At the meeting in June, they came to the grave conclusion that a program had to be abolished. The Department of Student Development, (DSD) and The Department Of Health and Physical Education (DHPE) were the two chosen so far. It is inevitable that the teachers involved will have to go also. 1 HE assistant, 1 lecturer, 1 professor, and 3 assistant professors will face the knife in the DSD, as well as 9 associate professors and 1CLT in DHPE. The Center for Developmental Neuroscience, Teacher Education Tutoring, Prior Learning, Public Relations, Advanced Computing and Networks, Center for International Service, and Security are all losing somebody. Associate programs are also in danger of disappearing, for Pres. Springer is considering eliminating all two year-programs, which would also remove open admissions. This coincides with The Board of Trustee's plan to save money by closing 44 programs, and it's move towards privatizing CUNY.

All this definitely affects the students. Fewer classes mean crowded classes, and it also makes it harder to get in to them. As a matter of fact it is getting harder for the students to even get into the college. There has been a \$750 increase on tuition (with a

growing rumor that more may be added on later). Plus, any past dues not paid had to be paid in full by the student or else he/ she was denied entry. A study of enrollment of the 95-96 school year would reveal fewer students in CSI than last semester.

The services students were used to since last semester were also hit. The time that the campus is open has been limited, leaving students with less time to use resources like the library which they are paying for, and which is presumably available to them. Weekend times have been cut down drastically, with students having to leave the premises at 5:30. This is tough on the night going students who have jobs during the day.

The Administration has suffered some changes, but not as much as the rest of the college community, and therefore the topic is subject to some controversy. As stated in the Memorandum given by Pres. Springer on 8/31/95, and printed by the Banner in early September, the following changes were mostly position changes. No one in the Administration was fired, nor received any cuts in benefits or pay. None was depicted in the memorandum. The only discomfort suffered, it seems, is being put in charge of a department that they might not be able to handle. This is highly unlikely.

In the end, it is inevitable that CSI is in for some hard times, but how hard certain groups will be hit is highly questionable.

Third Sector Advocacy - In Who's Interest?

The attacks on the living standards of working class via the public sector did not end last year, nor did it remain on the campus grounds. Like CUNY, public transportation (including bridge and tunnel tolls,) will be facing fare increase on the heels of the biggest cuts to the transit system in its history. The decrease in services effects mostly those who use it for work and leisure. Like CUNY students the income of those who use public transporta-

tion reflects their class position. It has been estimated that two-thirds of those traveling on public transportation have family incomes below \$50,000.

Public Hearing - Public Mockery
Sitting behind an extended table, facing hundreds of people who trekked their way to this remote sight to vent their anger and disappointment, the (Mass Transit Authority) MTA board members sat listlessly lis-

tening to the speakers.

Obstensibly the public hearing is designed to determine, with public input given at the hearings held throughout the five boroughs, whether the proposals put forward by the board are sound and should be carried out. However, for the board the proposed fare increases are a *fait accomply*.

As the MTA boards brochure, Facts About the MTA Financial Plan, points out the current fiscal problem is a product of reduced federal, state and city funding. snortialis will result in an estimated \$4 billion budget shortfalls at the end of five years, even with cuts in spending. For the fiscal year of 1995 there will be a \$167 million budget gap. The board states that further cuts in services will not take place. However, in another section they claim that \$3 billion will be saved over the years. "The savings will come from administrative efficiencies, management and labor productivity gains, consolidation of interagency job functions, and privatisation measures." In short savings will be made up by laying off workers and increasing the workload of the labor force at hand.

There are also moves to privatize parts of the MTA, another way of driving down the wages, increasing the workload, laying off workers and ultimately breaking the union.

In the final segment of the boards propaganda they make clear that only a fare increase can resolve the problem. "At this time, the MTA's proposal to increase fares and tolls is the only way to assure the stability of the public transportation network into the 21st century and to protect one of the region's major assets"

Though the board pledges to maintain high standards of services and states that the bridges are "sound" a recent article in the union publication, *The Chief*, cites a board commission organized to investigate the June 5th train accident on the Williamburg Bridge. In the article they sight antiquated machinery as one of the reasons for the accident. It is apparent to transit riders that the trains may be clean, but many stations are in dire need of repairs and more services are needed not less.

The board claims that only two options are available in the face of decreased funding, either fare hikes or more cuts in services. No where is there any hint of demanding more funds, or opposing the governor and mayor. For the board the status quo is uncontested.

These handpicked board members of Governor Pataki's are not against the cuts or fare increases. One of the few conclusions from this public meeting was that the MTA Board is not a vehicle to persuade but to eliminate. For public advocacy groups, however, the main task is reforming the established power structures to act

Public Advocacy Groups - Public Swindlers

The cyclical budget problems posed each year will continue to burden the working class with greater intensity. Conservative reformist organizations, such as NYPIRG or its affiliated groups such as Strap Hangers, however, refuse to view the cyclical budget problems as structural rooted in both the economic and political spheres of

capitalist relations. How could they for the very existence of that group is dependent upon it

Third sector, nonprofit public interest groups begin their analysis presuming the "free market" (i.e., capitalist) economy is essentially correct, and that the abuses of mismanagement and corruption can be resolved through legislative reform. The economic base is left untouched, the rule of private capital remains the norm.

At the public hearing NYPIRG/Strap Hangers posed themselves as a nonpartisan alternative. Claiming to have the public interest at heart they sighted the facts. They pointed to the Mayor and governor for cutting the transit budget by over \$500 million dollars over the past year, the decrease in services and increases in fares. The facts speak for themselves, but what do these groups put forward in response to these attacks on the "public sector."

At the hearing top Strap Hanger, Gene Russianoff, put on a theatrical performance. Accurately sighting the facts, he parodied a three card montee game in which the three actors were the governor, the board, and the rider. In the short performance the governor tries to persuade the helpless rider that the board is to blame and not he. The moral of the story was that the board should take a stand against the governor in the interest of the public, and that the board and governor are two different bodies. Therefore, the rider needs to lobby the board to convince the mayor and governor that they are wrong.

The strategy employed leaves untouched the structure of the MTA. In fact it solitcits the help of the appointed board members to challenge the governor and mayor. This is not only foolish but fantas-

tic. Leaving aside personal squabbles of individual members the rise of fiscal conservatives in public institutions, coupled with the incessant ideology of corporate America dominating today's political scene, the chances of the board of opposing these views is as possible as the earth changing the direction of its rotation. It would be against their own interest as a class.

Instead of having a strategy exposing the undemocratic way in which the members of the board are appointed and the reason why they are qualified for the positions, these reformist groups just want to focus on the surface problems with exploring its roots. As if the two are not interrelated. The biography of the MTA board members reads like a Forbes portfolio. Like the Trustees of CUNY's board, bankers and business are in the highest commands of public institutions. Similar to the situation here at CUNY, the management of the institution is part of the problem. The board is only an extension of the politics of democracy for the privileged few, the ruling rich. For the nonpartisans avocacy groups such a point of view is out of order, therefore, the focus of their strategy is to "influence" the process, not to question it. Some would say that they are only spitting in the wind, but the ramifications of their politics does not only effect their little offices.

When it comes to the budget problem the positions they put forward are sectorialist. They look to other areas of the budget for more money, or to increase taxes somewhere else. Even the reformist

CSI Locus of Intellectual Ferment? Why not?

The question is whether CSI can pretend to become a college to be taken seriously or is it condemned to remain a third rate institution. The elements necessary to answer this quite arduous question are multiple. Part of the answer resides in the nature of CSI. Another element is the composition of the faculty and its fertility. Yet another point is the political direction that President Marlene Springer is willing to give our college

1. The Nature of the College:

The City University of New York has been created with the idea of providing working class people with a college education at the lowest cost, for free. The College of Staten Island was formed of the fusion between two entities of different natures. One Richmond College was more engaged in the Liberal Arts and willing to experiment new pedagogical methods. The other one was a technical college training technicians and professionals. The merger has survived and the consolidation plan, under the pretense of economic considerations, has forced the closure of the tech-

nology departments. The economic success of the nursing, and education programs allowed them to survive. A shortened qualitative analysis will follow

For a long time CSI has been producing technicians servicing local and regional economy. The especially high number of business students falls logically within this category since most of them are employed in local and regional small and medium businesses. CSI educated most of Staten Island's low and middle management. Nurses and teachers are of course in the same general category

The strengthening of the Engineering and Computer Science programs has a lot to do with the settlement of new immigrants in Staten Island. These immigrants' social backgrounds allows them to perform at a fair level. Many immigrant families will not be satisfied with a son becoming technician, nurse, or even highschool teacher. Other factors peculiar to immigrants (language, race, networking..) are at play, we will not explore them any further. The continuous work of the faculty in these fields is to be appreciated. The quality of the equipment necessary to any good education in the above-mentioned disciplines has certainly helped.

The price paid for computers and other machines was always a priority in the minds of technologically under-developed bureaucrats. The latter equate technology with quality education. Technomania is not a localized and benign syndrome. The pigeons of the"psycho" lab, and the state of the finances, can attest to some of its

painful consequences.

Some CSI departments are hostages to the successful programs and did not develop on their own. For example, despite its graduate program the English department didn't emerge, it still services primarily the Education program. The noted tentative of some professors will be discussed below. Likewise the departments of Math, History, PEP didn't show any success in placing students in prestigious programs. They are mainly auxiliary programs to Nursing, Business, and Educa-

tion. The necessary rethinking of the goals of each department has been long over-

Continuing our probe into the nature of CSI, let's look at the mega departments. The Department of Psychology, Sociology and Anthropology (PSA); The Department of the Preforming and Creative Arts (PCA); The Department of Modern Languages; and the Department of Political Science, Economics, and Philosophy and Geography (PEP) are to be done with immediately if CSI aspires to any higher status. The PSA for example should not accommodate three serious analytical disciplines under the same hat. The centralization of the decision process minimizes the chance for judicious long term planning. The least intellectually inclined end up, by default, being Chairpersons and Department Heads. The decisions they make will always be taken from their narrow perspective. There seems to be no special school of thought followed by the department. There is a wide range of schools represented however. The students are confused and cannot approach a problem with any consistency

The PSA is plagued by the Social Work program. There is a stark difference between the three analytical disciplines yet the differences between them are more or less reconcilable. This is not the case with social work. The nature of the training necessary to a future social worker forbids any intellectual probing into the validity of the textbook truths. The program should be adjoined to Nursing or Education.

The PEP suffers from its unholy alliance with the Business department. Most economics classes are cross-listed, and the staffs are interchangeable. The introductory courses seem to be designed for business students (little theory). The few who try to give a more consequential introductory material are discouraged-by the department and by Business students-and are sometimes fired. Economics students rarely pursue a graduate education in the field, and given the current situation it is not about to change.

The Political Science part manages to accommodate the need for bureaucrats on the Island. Prospective law-schoolers, lost International Studies majors, and Education majors constitute the main sources of students.

The Philosophy program mainly services Nursing despite the efforts to create a Pol/Phil major. The highly qualified hard working and underpaid adjuncts are overqualified for their own good. The ossification of the program has helped to keep out capable faculty members—from other departments—to teach at no added cost. This could lead to a stronger program...

The PEP as such doesn't offer the same closeness between the disciplines as does the PSA. The lack of success of the Seminar in the three disciplines is a wake-up call. The department in its current form has to be dissolved right away if CSI is to be considered a serious college.

The Department of Modern Languages works to fulfill the language requirement. The Spanish major seems to be moderately successful at attracting students who are not native speakers. There should be an independent Spanish Department that could grow instead of being parasited by the barren, yet popular, French and Italian which do not lead to a B.A.

The PCA offers the possibility of rapid

Professor Mason Cooley has been publishing for quite a while a marvelous series of aphorisms titled City Aphorisms. For those who don't know what an aphorism is, let me give you a definition. An aphorism is a usually pithy and familiar statement expressing an observation or principle generally accepted as wise or true. City Aphorisms will take you for a roller coaster ride at the end of which you'll be thrown out, Aphorisms take you for a roller coaster ride at the end of which you'll be thrown out, haggard, dizzy, but with a sense of accomplishment that you won't quite understand.

Relationships are no secret to him: "Keep your lies short and simple—I am often attracted to people with whom I could not hold a five minute conversation—Your argument defends an ideology; mine defends the Truth—Sincerity: Willingness to spend one's own money."

He writes about intimacy: "Every hole tempts my finger—Machines are capable of great intimacy. They will even pump our blood and breath for us—Promiscuity is like never reading past the first page; Monogamy is like reading the same book over and over—Orgasm: the genitals sneezing."

demand of increasing taxes on the wealthiest sectors of society is given little lip service. The end result is to ensure that present capitalist relations remain intact, and are not scrutinized publicly. This would be bad business for both the *publicly* funded group and its corporate allies.

These "moderates" do not want to appear to radical for the liberals they tail in the government. Behind their nonpartisans cloak there is the Democratic party. They would rather have a friendly face to talk to and be cut, rather than an authoritarian figure such as Guiliani. However, in the end the public that they serve will receive the brunt of the cuts while the "democratic" process (i.e., public hearing, letter writing campaigns etc.) ensures the flow of capital into the hands of the filthy rich. The "public" for them is only there to apply pressure on the elected officials, and

Analysis

Cuts in the public sector will continue and so will the strategies of these reformist organizations. Each year they encourage people to write or call their representative and demand that the cuts to their respective institution be reversed. The question to pose is how. The method employed by these groups have not worked, and will not work. The way forward is not to be found in reforming a government or the boards controlling the public institutions. The beginning of change will come from an analysis of capitalist relations, i.e., private ownership and class antagonisms.

To resolve the cyclical budget problem one must change the structural basis of the problem. The questions of who controls transit (i.e., the means of production) and

its function in society (i.e., for human needs) must be addressed. In these unstable economic times corporate America wants full control. In order to do so they must have third sector/nonprofit advocates assuring the public that the interest of business and social well being are not mutually exclusive. Introduction to the International section

Welcome to the International section of the College Voice. The Editorial board at the Voice has decided to add this section which will be dedicated to bringing inter-national issues to the attention of CSI students. Being aware of international issues in today's society is very important; international and national events are so intertwined that it is impossible to distinguish clearly the root of one from the other. The US economy is tied to a global economy. Capitalism and it's consequences not only effect the US citizens but people all over the world and vice-versa. When trying to understand national issues that effect the working class in the US, one cannot avoid the role that US and the Western countries play internationally. Underdeveloped-labor-intensive countries are of great significance for the Capitalists in western countries, because they provide a source of cheap labor and raw materials.

Democracy or Murder?

The interests of the US in the so called Third World is not one based on humanitarianism or democracy but rather one of geo-political interests. These interests are not to develop the countries concerned but are the profit interests of Trans.-National Companies (TNC). Haiti is one example, despite the resistance of the Haitian people against US intervention, US still maintains it's rule for its own purposes. The economic purpose to retain the cheap labor for the TNC's. One of Haiti's major roles is as a supplier of baseballs to the US, which the US cheaply buys in abundance. Haiti's strategic location is crucial to the US for military purposes in the Caribbean region. Through the use of the gunboat diplomacy, the US fulfills its geo-political interests- it destabilizes and further underdevelops countries to gain access to markets and profits. All of this it does under the banner of DEMOCRACY. The US continuously cries out that it is "restoring" or "defending" democracy. Then why are the Haitian people resisting US intervention and why doesn't the US pull out? One has to wonder what "operation

desert storm" was all about? The interest of the US in the Gulf was, of course, oil. Kuwait an undemocratic monarchy in the Middle East, was driving the oil prices down by overproducing oil and was slantdrilling from within Iraqi borders. Iraq which was in war with Iran for ten years was poverty stricken and was relying heavily on its oil revenues fro reconstruction. The Iraqi invasion of Kuwait gave the US an opportunity to build more military bases in that region and establish control over the production of oil. It wasn't a war, it was a one sided slaughter. If Saddam Hussein was such a threat to "democracy" in the Middle East, which hardly ever existed in that region, then why didn't the U.S. complete the job by assassinating

Saddam Hussein is a puppet of the Western bourgeoisie because his role in Iraq isn't to improve the lives of the Iraqi workers and peasants but he is a tool which the imperialists use. During the Iran-Iraq was, the U.S. supported and armed Saddam Hussein as it has many other despots the world over. The bombardment that we saw live on CNN incinerated 200,000 innocent people and many more are dying today as a result of a total embargo on basic necessities like food and medicine.

This process is made easier through the use of to easily pack up and leave and establish a alize the so-called Third World", but quite mon exploitation, their oppressions are at the hands of the international bourgeoisie. The world is divided into two parts- the industrialized and the non-industrialized. The non-industrialized countries are basically suppliers of raw materials and cheap labor. The living conditions of workers in the industrialized-imperialist countries might be "better" than those of the nonindustrialized countries, however, this does not imply that workers in the former benefit by the super-exploitation of the latter. Although this has long been the racist, clonialist lie spread by the bourgeoisie. The flight of U.S. jobs in auto, steel, rubber and other basic industry to low wage countries like Mexico and Brazil leading to the destruction of unions and working class communities in the U.S. clearly reveals the need for solidarity rather than competition over the border.

The social ills such as crime, drugs, cancer, environmental problems, etc., are seen everywhere throughout the world, in both industrialized and non-industrialized countries. The technology that the US and other imperialist-industrialized countries posses could be used to improve the conditions of people throughout the world, instead of the technology being under the control of the few and the benefit of those few. Children, women and men are being killed, if not through imperialist sponsored war than by hunger and basic disease which can be easily eradicated, by millions throughout the world under the disguise of "democracy" so the rich can keep getting richer. The bourgeoisie divides the workers by race, colour and gen-der, it creates racist laws to pick worker

against worker. The most important and crucial feature of the contemporary era has been the expansion of Capitalism into a World Capitalist system. No one has stood alone, every Nation and peoples have been effected by this transformation, the effects have most certainly varied in different forms and shapes, but nevertheless the process hasn't been an even process. R.T. Robertson in his book called The Making of the Modern World- An Introductory History, puts this phenomenon well. He writes: No country can stand alone. No peoples can remove themselves from their past or seek to deny the reality of present world circumstances. Undoubtedly the struggle for equality proceeds apace with transformations and will remain the major preoccupation of the world in the decades to come. But at no time can the effects of integration and transformations within the world order be simply pushed aside and history transcended.

so called "develop" the underdeveloped countries extends as far as employing little children to do hard labour. For example in Pakistan, Children as young as six chained to their posts to produce rugs for major Western importers and Mattel promoted a program of sterilization of its female workers in the Philippines in order to avoid maternity from affecting productivity.

Systematic underdevelopment of the "Third World."

The Corporate media which never bothers to inform the American audience the truth about what is going on around the world, rather feeds us demagoguery. The only thing we see is the late night commercials with Christian organizations advertising for the "poor, devastated hungry kids" in the Third World. Why are all those kids starving? Certainly the "Christian" organizations great effort isn't helping them. The so called Humanitarianism of US foreign policy is definitely not helping them, on the contrary it creates the poverty. The reason why the underdeveloped countries are "underdeveloped" is because the US and other Western imperialist countries feed off of them. Trans.-National Corporations are set up to employ labor at cheap costs and use the raw materials the country contains. Creating mass poverty to make a higher profit is the motto of U.S. foreign policy.

Capitalism is dependent on a global market; continuously searching for new markets to invest in. This dependency lies the contrary, they purposely keep it underdeveloped. Imperialists sets up companies, employs cheap labour and uses the raw materials, thus driving the economy down, where the country is so underdeveloped that it is forced to borrow money from the imperialists. Thus, the underdeveloped country is continuously dependent on the imperialists who keeps them in debt. The UN, World Bank, IMF and NAFTA are some of the institutions and mechanisms through which western imperialism keeps Third World countries under its control

The vanguard of the proleterianized masses of the semicolonial countries have responded to imperialism by adopting Marxism as their theoretical guide and communist parties as the vehicles of their liberation. In Vietnam and Cuba the workers and peasants or-

ganized in the communist parties were able to overthrow imperialist domination and bring their economies to meet the needs of the populace. In Cuba in particular, this has had remarkable results in bettering the lot of the Cuban masses. Free healthcare, free education, free childcare, full employment are amongst the gains that the Cuban people won by breaking from imperialist rule.

As oppossed to the narrow cultural nationalism put forward by charlatans who evoke a non-existent golden age in the preimperialist past, Marxists in the so-called Third World have recognized that a new culture is created with the onset of imperialism - the culture of the international working class.

The vicious nationalist wars that are swallowing up whole nations and regions eg. Eastern Europe, Africa, South Asia represents the temporary defeat of the proleterian communist vanguard by the forces of inmperialism. In the absence of an internationalist ideology that dilineates the interests of the toiling masses from "their" respective capitalist classes nationalist poison fills the vacuum. The fratricidal slaughter in the Balkans is sad testament to this fact.

Unequal development a term coined by radical economist Samir Amin is at the root of communalism. The civil war raging across the globe today from the Balkans to ex Soviet Republics, Africa, South Asia and East Asia are fueled by the investment strategies of capitalism that seeks the highest rate of profit.

The church as a institution of cultural imperialism is the oldest and bloodiest. The forced conversion of non-Christian peoples with the Bible and the bayonet was a standard practice for several hundred years in the period of colonialism. The bourgeois sociologist Max Weber wrote about the "elective affinity" between capitalism and Protestantism or in other words a system of production for profit by individual entrepreneurs and the ideological constraints of Protestantism or in other words a system of production for profit by individual entrepreneurs and the ideological constructs of Protestantism or the much ballyhooed protestant ethic. The forced introduction of Christianity helped to cement the empires being built by the West. At once the "weltenschaung" of non-European peoples who had developed quite sophisticated and elaborate cultural edifices were burnt down by the Bible wielding barbarians and upon its ashes the Christian ideology of the colonizer erected.

In many countries in Africa, Asia and Latin America the ideological superstructure was based on cultural values rooted in the agrarian, pastoral or hunting and gathering economies. This was replaced by the individualist ethic of Christianity which meant for the poor that they were responsible for their own suffering and that salvation can come only when you die and it created a ruling Christianized elite that would enrich themselves at the cost of the masses. This is not to say that oppression and misery were absent prior to colonization and Christianization. Landlords, caste systems, patriarchy and subordination to nature did exist but the forcible invasion by the west was not for the upliftment of the peole from their problems but was driven by profit and racism.

2 Modern Parasites and the Class of the Overthrow

The creation of a local elite in the image of the western imperialist is the principle means by which consciousness is trans-

Modernization in semi-colonial countries occurs through this elite corp of westernized personnel. The masses as a whole often suffer from lack of basic education thus ensuring the perpetuation of "elites" who only have access to knowledge. This class of "comprador" bourgeois form a extremely corrupt unproductive and parasitic caste upon the people distinguished only by their ostentatious lifestyle and ridiculous mannerisms they picked up from their imperialist masters. They are naught else but servile puppets of imperialism lacking an independent capitalist

The consciousness of Third World peoples is fortunately not restricted to the domain of parasites. The introduction of capitalist relations of production also gives rise to a industrial and agricultural proletariat. This proletariat develops a consciousness at once objectively opposed to the local bourgeoisie and foreign imperialists and also opposed to the stultifying backwardness of traditional customs and values. A modern class with a modern and revolutionary ideology - Marxism emerges. The history of the 20th century has confirmed the analysis of the Russian revolutionary Leon Trotsky on the logic of development in non-imperialist countries. Trotsky argued that given the weakness of the non-imperialist bourgeoisie, the tasks of the democratic revolution can only be achieved through a proletarian led socialist revolution. India despite its vast land mass, population and resources has not been able to make the transition to the bourgeois democratic model of the west.

Except for one small detail. We shall pass over the fact that Haiti is under foreign occupation. After all, do not the Haitian people themselves accept and even demand the occupation? Yet one must ask what are the US and their satellite troops doing in Haiti? Protecting the people? But then why allow the terror apparatus to remain intact and armed? Is it not to guarantee a permanent threat precisely so that a fearful people will continue to cling to the occupation? Well, if US troops are no in Haiti to protect the people from the Terror, then it must be that they are there to protect the Terror from the Haitian people. But, as I say, let us pass over this element of Haitian "democracy." Let us talk about more mundane things... such as who is making the decisions on what factories will be built, what wages will be paid, how much unemployment is "acceptable," what crops shall be grown, how many peasants shall be driven off the land? Who is making the decisions on how much to spend on health care and education? Who has decided to sell off Haiti's patrimony, to privatize her assets (meaning turning them over to US interests)? Who doles out the Haitian budget, when and as they please? Who has decided that he property of the local pirates shall not be touched? Who has decided on how many police to train, who is to train them, and where (and thus who they will be ultimately taking order from)? Of course it is the "international community," today's euphemism for Washington and the US establishment. All else is in Haitian hands. But what is left?

And should the Haitian government step out of line despite its assurances that it will go along with the IMF program, or should the Haitian people take sovereignty a bit too eriously, then waiting in the wings under US patronage is the old terror apparatus ready to take over once again.

In sum, Haiti is under the total control of the United States. What kind of democracy is it when a country lies under foreign subjection? And what do elections mean when

Americans, say the Serbs, are the Nazis of today. Isn't it time for Americans to look at themselves critically and to ask themselves what they are doing? What they are becoming? For surely others in the world are already making up their minds.

making up their minds. The internationaly respected Yugoslav philosopher Mihailo Marcovic has written an essay that should be widely read here entitled "Fascism and the New World Order." In it he draws certain historical parallels between the Fascistic "World Order" that Hitler and his allies tried to create in the 1930's and 40's, and the "New World Order" being constructed today. Marcovic streses that there are several important differences between the two systems: the ideology of liberalism versus fascism, the much higher level of economic and technological development in the America, the contrast between Fascism's culture of militancy with that of Liberalism's induced passivity and apathy. However, he makes clear that these differences are less important than the similarities. The main point being that while the U.S. may have different (and vastly more effective methods) for achieving its objectives, the intentions and objectives of American imperialism are almost exactly the same as those of Nazi Germany: establishing military and political domination over the entire world and over all peoples to ensure absolute and total obedience and total economic exploitation. America's aim of achieving a global monopoly of political and military power by the U.S. as well as a monopoly on the wealth of the world is little different in its essentials from the Nazifascist dream of a dominant Aryan race controlling the earth for a thousand years. As long as the Soviet Union existed, it

prevented the realization of both Nazi German and American world domination. But today this mad dream is deemed possible by the regime in Washington.

In terms of domestic and foreign policies there are more similarities than differences. The media is a good example. While there is a very limited degree of free speech here in the U.S. and Western Europe, criticism of the government and the elites is completely marginalized and excluded from the mainstream media. Indeed, there is a very clear line beyond which all media with any weight in American society will not overstep. Also the interests of the mainstream media and cultural institutions are harmonized in precisely the way the Nazis intended their own cultural establishment to be designed. In fact, they had a word for it:

designed. In fact, they had a word for it: "gleichschaltung," which meant the harmonizing of mainstream cultural institutions with Nazi institutions and its ideology. Thus, American society can be considered in the old sense of the word, totalitarian. It is also at least as cynical and corrupt in its objectives as Goebbels propaganda machine, while at the same time far more effective and damaging in its scope. Likewise, there are clear similarities in U.S. and Nazi methods for dealing with political dissent: the vast police and intelligence system of the American state dwarfs that of anything constructed by Hitler and Himmler, though the American approach is less crude.

The similarities are even greater *The method of applying sanctions against entire nations and states is* essentially fascist. An individual, individual responsibility and *culpability are axioms of the liberal cultural and political tradition*. If it proves impossible to identify the culprit for the crime, the true offender will, according to the tradition, be relieved of criminal responsibility rather than punish an in-

nocent man. Only fascist totalitarianism which, in this respect, followed the customs of the most primitive tribal civilizations, in principle allowed for the collective responsibility and collective punishment of a nation or race....

The current sanctions against all countries which have found themselves in the way of attainment of the interests of the

leading powers of the "new world order" equally affect all citizens, including the vulnerable old population and the newly born children, only because they belong to a country and a nation. This moral and political scandal of world civilization at the end of the 20th century manifests a way of thinking which does not belong to a liberal and democratic tradition and fully corresponds to fascism.

Methods of Global Domination in the New World Order used against the Serbs

Indeed, economic sanctions are an act of war, even though the U.S. and its allies deny that this is so. Naturally, they would consider it as such if these same sanctions were ever directed against the U.S. Nevertheless, sanctions are just one of the many new and sophisticated weapons of modern warfare that the New World Order is deploying against the Serbs. It is a type of warfare where both the victim and the aggressor are hidden from view: a warfare of unconventional armies and methods. These methods make sure to destabilize and weaken the country long before any direct military intervention is publicly discussed. In the end the country that is targeted is either coerced into absolute obedience, or else destroyed. Clearly, the intentions and goals of U.S. foreign policy in the New World Order bear a striking resemblance to those of Nazi Germany: the conquest or destruction of entire nations as part of a strategy for total world domination. Obviously, we need to review the methods

and institutions being developed and used today against the Serbs because they most certainly will be used tomorrow to destabilize and destroy other nations.

Cold war institutions of continuing significance for the New World Order are those of the IMF, World Bank and other aid agencies, which aim to impose a relationship of economic and then political dependency on the targeted country. If we recall the early stages of the effort to destroy Yugoslavia we will remember that it was through these agencies that U.S. foreign policy was enunciated prior to 1991. The role of these agencies is to make sure that all future economic aid and foreign capital is tied to the ever stricter imposition of policies made in Washington. Once this line is crossed the country in question has abdicated its sovereignty and becomes little more than a colony. For countries like Yugoslavia, which refused to bow down to the dictates of the IMF and the US government in the period 1988-1990, the next step is massive destabilization.

In the case of Yugoslavia this meant first of all the incitement of ethnic conflicts and financial and political support for seperatist or secessionist movements. The objective is simple: to divide peoples against each other, thereby legitimizing a policy calling for the destruction of their state, which can then be replaced with small, easy to control and exploit, ministates.

Sponsorship of ethnic conflict is closely followed by the launching of a media propaganda campaign against the targeted country and the introduction of the so-called "human rights groups." Human rights groups today have as little to do with human rights as the slogan "arbeit macht frei" did with the liberation of the inmates of Auschwitz. In reality these are merely agencies of the U.S. government — from which they receive their financial support. All human rights groups in the U.S. today receive sizable amounts of government financial assistance and repay that

financial assistance by carrying out the foreign policies of the U.S. government. Thus, they are sent to the country targeted for aggression with the task of investigating or manufacturing human rights abuses (such as the supposed oppression of Croats or Bosnian Muslims that we heard so much about) which can then lay the basis for the next step in the destabilization plan: the media war.

Since I've already written a piece on the role of media deception in modern warfare for this publication (February 1995) I will limit my comments to this: just as the human rights organizations set the stage for war by falsifying or blowing up small incidents into major atrocities, thereby pitting peoples against each other and creating international incidents, the media plays an even greater role in that not only is it the vehicle for propagating phoney human rights abuses (real human rights abuses rarely get broadcated), but in that it is absolutely necessary to demonize a people in the media in order to destroy them. This too has such clear parallels to Nazi methods of conquest that it needs no comment.

Another related institutions of modern fascist warfare that is being developed today against the Serbs is the use of so-called "international war crime tribunals." The brazenly one-sided and fraudulent nature of this new institution is glaringly apparant in light of the fact that no Croat or Muslim soldiers have been indicted, even as they rampage and pillage across vast regions of Serbian territory. Ironically, this new weapon of destruction derives most of its historical inspiration, not from the famous Nurenburg and other anti-Nazi trials, but rather from the Nazi and Stalin show trials of the 1930's and '40's. It is from the latter that they derive their real objective: the anihilation of all political opposition and freedom. In the context of the New World Order they are also designed to strip a people of their right to self-determination.

Closely related to the human rights or-

ganization are the so-called NGO's or nongovernmental organizations foundations. There is a massive literature that already exists on this extraordinarily sinister phenomenon which goes back to the early part of this century. The Rockefellers, who played a big role in es tablishing so many of these foundations spoke of foundations as being a force greater than governments for achieving the political objectives of the super-rich elites and their corporations. The most infamous of these in Europe today is the Soros foundation, established by the billionaire currency trader George Soros, re puted to be the richest man in the world Through foundations such as the Soros, a country can be effectively destoyed from within. The Soros foundation has bought off important figures throughout Eastern Europe and financed the training and activities of tens of thousands of young people indoctrinated in the most reactionary and totalitarian notions of American culture. In simple terms, Soros has created a new generation of future leaders fifth column — prepared to take over the governments and countries of Eastern Europe within the next several years and to govern them like banana republics, completely according to the dictates of Washington. Recently the Soros foundation has been shut down in Belgrade for the simple reason that it financed the most extreme pro-American and treasonous activities imaginable for the last three years, supporting every U.S. policy against the Serbs including sanctions and bombings! If this isn't sabotage, destabilization and treason on a large scale then nothing is. Also connected to the imposition of

Also connected to the imposition of American sponsored foundations is the pressure on smaller countries by the United States to allow a degree of political pluralism and diversity of opposition parties in the countries it seeks to destabilize that is

in every way the very antithesis of the monolithic, totalitarian and unitary state that it itself maintains. Thus, while in the U.S. there are no political alternatives to the so-called "two party system" whatsoever, the U.S. insists on and helps to finance literally hundreds of opposition parties and organizations in Yugoslavia today creating a political climate of extreme uncertainty, political paralysis and near ungovernability. Most of these got their start through Soros.

Of course, one of the very most important methods of world conquest in the New World Order is the use of the United Nations and the so-called "peacekeepers." With the collapse of the Soviet Union, the UN is today completely controlled by the U.S. and its allies. As such, the UN has been transformed into one of the most powerful and multifaceted weapons in the American arsenal for the establishment of the New World Order (i.e.: U.S. global conquest). It was through the UN that the U.S. was able to impose international economic sanctions and a naval embargo on the Serbs and make it binding on all nations. It is through the UN that international foreign policy of war against the Serbs is harmonized. And of course the imposition of UN "peacekeepers" in Yugoslavia was a key turning point in the conflict because it handcuffed the Serbs militarily and established the basis for a military occupation of the region against the Serbs. The UN acts under the false pretense of neutrality, but they are anything but neutral in the civil war in Yugoslavia. Their task from the outset was to militarily weaken and handcuff first the Yugoslav army and then the Croatian Serb and Bosnian Serb armies. In this way they prepared the way for the military build-up of the Croatian and Bosnian Muslim armies that were covertly financed, armed, trained and even led by (in order of importance) the U.S., Germany, Austria, Saudi Arabia, Pakistan and Iran, and ultimately the military defeat of the Serb forces there. Clearly, the UN plays a key military, diplomatic and economic role in the imposition of U.S. world hegemony by providing the cover of neutrality for the initial military and diplomatic assaults on the country targeted for destruction. This too has enormous influence on the media and the human rights organizations that are, in one way or another, connected to the UN. It should be noted that prior to the recent wave of NATO bombings in September, 22 of 23 human rights groups associated with the UN Commission on Refugees in New York voted for and advised in favor of the bombings. In other words, nearly all of the so-called human rights organizations called for war crimes against the Serbian civilian population of Bosnia! No doubt they will do so again in regard to Serbia proper (Yugoslavia) when the time

Finally, we come to the use of military force itself which, in contrast to the "New

World Order" initiated by Adolf Hitler, is shrewdly and correctly recognized by the American fascists and their allies to be used only as a last resort. In most cases the threat of massive destructive force is sufficient to impose total obedience over a people. Where it is not, as in the case of the Cubans, Lybians, Panamanians, Iraqis and now Serbs, it must be used, but only after the proper conditions are met so that its effectivenes is immediate. Because once it is introduced, all other methods, including war itself, gradually lose their potency. In the first instance, mercenary armies are covertly armed, trained and led by the U.S. and its closest regional allies (in the Balkans that is Germany). Hence, the build-up and

training of the Bosnian Mus-Croatian armies from zero to their present level of superiority in weaponry. Direct military involvement by the U.S. itself must be introduced when the endgame is near and only then. Otherwise, its expense, its unpopularity, its obvious barbarism, and its tendency to force the tortured victim to stand up and fight to the death against the American invader (as in

Americans toward involvement in these colonial wars (despite the scope of media deception). This problem is more than compensated though by the enormous technological advantage the U.S. has against its victims. Consequently, Americans can drop smart bombs from 50,000 feet or launch Tomahawk missiles from aircraft carriers hundreds of miles away, murdering hundreds of thousands of civilians, and yet suffer virtually no casualties. This is yet another important contrast between German and American fascism in that the Nazis were forced to exhibit a higher level of humanity and courage when butchering civilians than Americans, whose methods are by comparison far

more depraved and dehumanizing.

What is this war really about?

Having just returned from Yugoslavia I am an eyewitness not just to a war, but to a genocide. I know very well how this term is deliberately misused today by the media and governments to rewrite history, denying the real crimes while exculpating the real criminals. This is precisely what the Bosnian Muslims, the Croats, the Germans and the Americans have done. And why not? They are the biggest genocidal murderers of all time! Americans don't know and aren't told that at the Croatian

Vietnam) can turn the tables on fascists. I won't comment on the so-called arms embargo which was simply an illusion designed for liberals and other day dreamers to pender

rhus, American strategy in the New World Order is to hold back direct military involvement to the last moment and rely on other methods to weaken and destroy a people. Essentially, this means combining various methods of low-intensity warfare (sanctions, peacekeepers, media war, etc.) for long durations, decades if necessary, interspersed at strategic moments with high intensity, terroristic use of high-tech weaponry (the equivalent of the policy of dropping atomic bombs on Japan in 1945) for short durations. Another reason for this policy is the complete apathy of most

Bosnian Muslim concentration camp of Jasenovac nearly a million people were systematically murdered between 1941 and 1944, including most of Yugoslavia's Jews. Nor that two Bosnian Muslim SS Divisions were raised in World War II to murder the Serbs of Bosnia. But for those of us who do know the history of the Balkans, and who know what is happenning today, the term genocide is appropriate for describing what is being done and being planned for the Serbs. For if genocide means the deliberate destruction and murder of a people, this describes exactly what this war is all about

The early strategy was to divide and conquer the Serbs. First, you had the Serbs of Croatia. They already have been destroyed — all killed or exiled. Croatia today is a racially pure, Catholic state, just as they intended during the Second World War. It has race laws granting full rights only to pure Croatians; all other peoples have minority rights. And not only do they kill Serbs and burn and pillage their houses; they even burn books that mention the name Yugoslavia or that are printed in the Cyrillic alphabet.

Next are the Bosnian Serbs. They are currently being massacred by NATO bombings which have destroyed their communications, water, electricity, and housing, and prepared the way for the launching of new military offensives by the Muslims and Croats. NATO aggression will not stop until the Croat and Muslim forces are capable of a mass murder surpassing that achieved by the wartime fascist regime. The resurrection by the U.S. and Germany of a powerful fascist Croatia once again in central Europe will prove to be a nightmare for all of humanity.

And, finally, there are the Serbs of Yugo-

slavia proper. They are next. The U.S., Germany and its allies cannot tolerate even this strong a Serbian state in the Balkans. Three years of sanctions have literally starved the country, have killed hundreds of thousands of civilians and forced hundreds of thousands of other Serbs to emigrate. It shut down all industry. It cut living standards by half. It has created 50% unemployment. It has destroyed not just the economy but the very fabric of society, undermining the development of the country not for a few years, but for a generation. But that's just for starters. America is preparing to tear even Yugoslavia apart: Kosovo's Albanian seperatist movement lies in wait for its orders to attack and launch a new civil war in the south of Serbia and in Montengro. The U.S. and Germany are also determined to cut off the northern part of Serbia and hand it over to Croatia so that Croatia controls the Danube River and prevents the economic development of Serbia and the southern Balkans. There already are bills in Congress in preperation for this.

But why destroy the Serbs? First of all, it important to remember that the original objective was the destruction of Yugoslavia, and in paticular, socialist Yugoslavia. To destroy Yugoslavia it was necessary to destroy the Serbs because they were about half the population and they had the most to lose and the most to defend. Most importantly, they were the most interspersed people in the country, living in sizable proportions in all parts of the country except Slovenia. They were therefore the most supportive of the maintance of both the multi-national and socialist nature of the state. The Croats, Slovene, Bosnian Muslim, and Albanian populations on the other hand all had historical connections to fascistic seperatist movements supported by Germany and the U.S. and indeed had a long history of support for such movements. They were therefore the long destined clients of the U.S. and Germany in a post-Communist Balkans. When these movements were brought back to life by the West in 1989 they revived their old racist ideologies, programs and traditions as well, among which included the destruction of the Serbs. It must also be remembered that the Serbs are historically the most powerful of the peoples of the Balkans. Historically, it has been the Serbs who have posed the greatest threat and obstacle to foreign colonial domination. It was the Serbs who were mainly responsible for the gradual destruction of the Ottoman and Hapsburg empires in the Balkans, as well as the defeat later of Nazi Germany and its allies in the Balkans during World War II. In a neo-colonial new world order the Serbs would have to be destroyed at the outset or else the Balkans could never be conquered.

I ask myself often how it is that Americans can justify or allow the murder, the destruction of an entire people? And every time I come down to the same conclusion: in the end the Serbs really don't matter. This war is not really about the Serbs; it's about America and what it's becoming. It's about a country that can butcher ten infants and then turn around and preach about, "human rights" and "democratic institutions". It's about this new dark era we are entering, referred to as the New World Order. The Serbs, for all of their great accomplishments as a people and their age-old determination to be free of foreign tyranny, are to be destroyed by a new fascism that is developing in this country, before our very eyes. And the Serbs are only the first of many peoples to die as a result of it.

Imagine if Hitler, Himmler and Goebbels could awake from their graves and witness their present day vindication by America's new fascist alliance in the Balkans! Undoubtedly, they would reluctantly have to smile and say, "America, we've got to hand it to you. You did it far better than we ever could!"

THE POPE, THE NAZIS, AND THE CIA:

Blowback is one of the most important histories of the Cold War and ... the development of U.S. imperialist strategy, policies and institutions in its struggle to overthrow the Soviet Union and the other Communist led governments in Eastern Europe in the post World War II era. It uncover(s) previously unknown details about the origins of the C.I.A. and of U.S. covert operations and institutions, in particular the U.S. government's protection of, employment of and early dependency on former Nazi intelligence and other European fascists after World War II. In the case of Yugoslavia, these forces played key roles in the break-up of the country and in the establishment of post-communist regimes...

... Simpson gives a comprehensive account of how the U.S. intelligence agencies and covert operations in Europe got their start and how the U.S. strategy for containing, destabilizing and overthrowing communism in post-war Europe evolved, from the waning days of World War II to the present, with considerable help from two European institutions: the Nazi intelligence service and the Roman Catholic Church, both in search of new political allies after the defeat of fascism in Europe.... What this book confirms is the view that the states in Eastern Europe, particularly those of the Soviet Union and Yugoslavia, did not fall simply on account of their own internal problems; they were on the receiving end of decades of U.S. sponsored covert military operations working at their

...U.S. policy toward Yugoslavia after World War II flowed from a larger, general overall strategy or program for overthrowing communism world wide. In other words, while the historical record clearly shows that U.S. foreign policy had a unique tactical approach toward Yugoslavia within the broader context of the

Cold War that was supportive, the ultimate foreign policy aims or goals of the U.S. toward Yugoslavia were essentially identical to those of the U.S. everywhere else in Eastern Europe: the restoration of capitalism through counter-revolution.

The second general point is that U.S. strategy toward Yugoslavia necessitated a policy of covert action involving both intelligence gathering and military operations. Initially, this consisted of the recruitment, training and deployment of

large international networks of anti-Communist agents for covert operations. It was followed and greatly supported by the creation of CIA-financed, domestically based emigre organizations in the U.S. These emigre organizations (often affiliated in one way or another to Assembly of Captive European Nations - ACEN) were dedicated to the building of counter-revolutionary emigre armies and to assisting the U.S. achieve its policy goals of destabiliz-ing, invading and militarily overthrowing all of the communist states in East-... of these ern Europe. agents and emigres recruited by the U.S. govern-ment in Europe, the vast

majority of them were either former Nazis, former members of other fascist parties, or simply former Nazi collaborators. This point is actually the main focus of the book and is discussed in detail.

...in the immediate aftermath of the war, the Croatian fascist party (the Ustasha) built their own covert network for organizing and defending themselves and evading the scrutiny of international war crime tribunals. These escape networks were called "ratlines." ... these Ustashi 'ratlines" were based in Rome and were built with the indispensable assistance and protection of the Vatican. Hence, the book reveals that the Catholic Church played a significant role in the post-war strategies and policies of the U.S. in Europe. ... these ratlines were quickly discovered and soon thereafter protected and employed by the C.I.C. (Counter Intelligence Corp of the U.S. Army, a predecessor to the CIA). (Over time)..., from about 1948 on, the U.S. government greatly expanded the scope of its covert operations by relying on former fascists from Europe, spending millions of dollars annually on fascist Croatian and fascist Albanian organizations, publications and agents, both in Europe and in the U.S. It is essential to point out that the policy of these Yugoslavian groups and individuals sponsored by the U.S. has been and continues to this day to be violently nationalistic, anti-communist, anti-Yugoslavian: i.e.: for the break-up of Yugosla-

Finally, ... (we see) the full and inescapable responsibility of the U.S. government and the CIA for the survival, preservation and resurrection of Croatian (Ustasha) fascism, which thanks to fifty years of U.S. government support, today once again rules in Zagreb. With the help of the Roman Catholic Church, the U.S. government and its fledgling intelligence agencies saved and preserved pre-war Nazism and European fascism to the present day, carving out an important role for it throughout the Cold War, and positioning it for a reconquest of state power in the event of counter-revolution. The preservation of pre-war Croatian fascism and other extreme right wing nationalist movements in the Balkans (particularly Albanian fascism which is discussed here as well) is directly responsible for the breakup of Yugoslavia and for the current civil war in Bosnia.

perienced former Nazi intelligence officers such as Reinhard Gehlen and others to recruit and organize their European spy networks. Clearly, Nazi intelligence was best situated to penetrate and coordinate covert actions in the Communist bloc after W.W.II. ... until ... (the early 1960's), the majority of U.S. intelligence work in Eastern Europe was done by the "Gehlin Organization," a network of former Nazi and European fascist agents, recruited and directed by former Nazi General and head of Nazi intelligence Reinhard Gehlin. Gehlin was hired to undertake this by U.S. Army C.I.C. General and head of U.S. Army Intelligence in Europe Edwin Sibert, by order of the President, Harry S. Truman.

.. The reliance of the U.S. government on Nazi fascism for implementing covert action in its struggle against Communism was no anomaly. The U.S. government had a parallel policy for recruiting, staffing and carrying out its chemical, biological, missile, rocket and space research and development programs with Nazi scientists as well...

The most important ratlines in Europe following the collapse of the Hitlerite regime were those running away from Soiet controlled territories, for example like those running from Vienna to Rome -Rome being the true center of post-war Nazism and fascism for many years. Here fascists and fascist collaborators fleeing of the Vatican), which took special responsibility for developing and maintaining ratlines for fascists after the war. That organization was called the Intermarium.

The Intermarium was a Church organization in Europe which embraced and developed close relations with the fascist and Nazi parties and movement in Europe from the early 1930's continuing on through World War II and after. As Simpson puts it: "For much of the Catholic Church...W.W.II had been an interlude in a deeper and more important struggle against 'atheistic communism' that had been raging for decades," (page 177). The Intermarium built strong ties to all of the fascist governments and parties in Europe prior to the war, and some of its leading members became officials in several of the fascist states. Among the leaders of the Intermarium were Croatian Ustashi leaders as well as clerical fascists from Slovenia, Slovakia, Hungary, Ukraine, Lithuania and so on. The favor shown by the Papacy for Croatian fascism was no secret: the Ustasha leader Ante Pavelic was himself received by the Pope. It was through Vatican channels that the Intermarium was able to resettle fascists in Latin America. "In those Latin American countries where the church is a controlling or dominating factor, the Vatican ... brought pressure to bear which ... resulted in the foreign missions of those countries taking an attitude almost favor-

Rome being the true center of post-war Nazism and fascism for many years. Here fascists and fascist collaborators fleeing justice from all over Europe could find protection, a safe house, new identities and papers, as well as relocation in new lands such as in South America.

But why Rome? Weren't the fascists defeated in Italy during the war? While it is true that the fascist government was overthrown in Italy, its most powerful and important ally, the Roman Catholic Church, eluded any punishment or reproach. Thus, the protection of Nazis and other fascists by the Catholic church (which was official Church policy from the Vatican on down) proceeded without any interference from the Western powers. Not surprisingly, the Vatican has never renounced the many anti-Semitic and profascist pronouncements issued by the Church during the 1930's and 1940's. As Simpson details in his book, there existed one organization in particular within the Church (with close ties to the inner circles ing the entry into their country of former Nazis and former fascists...," (p. 180). In 1946 the Intermarium intervened with Pope Pius XII to save an entire Ukrainian Waffen SS division (some 11,000 men) and their families (ibid.). It should be remembered that this division had participated in some of the most heinous crimes of history: the mass liquidation of Jews, Russians and Communists in the Ukraine and Poland. By comparison, the German and West European divisions of the SS were merely "good soldiers," although they were adjudged at Nuremburg to have been "criminals in uniform." (See John Keegan's, Waffen SS: the Asphalt Soldiers, London: Purnell's History of the Second World War, 1970, pp. 130-155).
In Croatia and elsewhere these Clerical

fascists registered Jews in preparation for deportation to the gas chambers. In Latvia and Lithuania clerical fascist priests over-

SOME NOTES ON THE VATICAN'S ROLE IN THE DESTRUCTION OF YUGOSLAVIA

saw the mass executions of thousands of Jews and Communists. The Croatian Ustasha leader Pavelic, himself a Catholic Priest, proclaimed Croatia a "pure Catholic state," and presided over the extermination of 700,000 Serbs, 40,000 Jews and 25,000 Gypsies. Pavelic's policy toward the Serbs was to "expel a third, convert a third, and exterminate a third." This policy was carried out not just in Croatia but in what is today known as Bosnia as well, because most of present day Bosnia was at that time incorporated into the wartime fascist state of Croatia. Muslim collaboration with the Ustasha regime was critical to the execution of these policies in Bosnia.

Indeed, under the Croatian fascist state two SS Bosnian Muslim divisions were recruited: the 13th "Handjar" and the 23rd "Kama" Divisions of the SS. A third Yugoslav Muslim SS division, "the Skanderberg," was recruited mostly from Albanian and Montenegrin Muslim populations under Italian occupation. But it was the Bosnian Muslim Handjar division which was by far the most important of the SS divisions recruited in the Balkans.... Its political indoctrination was headed by the Grand Mufti of Jerusalem (the organizer of pogroms against the Jews in Palestine) who inculcated an ideology of Islamic fundamentalism and anti-Semitic and anti-Serbian racism that is today once again nurtured in the more elite units of the current Bosnian Muslim army. ... the Handjar division ultimately was beaten badly by the mostly Serbian and Yugoslav Jewish partisans it was sent to fight. Instead, as John Keegan explained in his 1970 study of the SS, "it confined itself chiefly to massacring and pillaging the defenceless Christians," (Keegan, p. 105). In other words, its main accomplishment of the war was the mass liquidation of Serbian civilians in Bosnia. As a result, what was previously a majority Serbian population in Bosnia before 1941 became a minority after the war.

One of the most important post-war leaders of the Intermarium was an Ustasha leader named Monsignor Krunoslav Dragonovich. During the war Dragonovich worked as a "relocation official" personally responsible for sending tens of thousands of Serbs, Gypsies, Jews and others to their deaths. He fled to a Vatican sanctuary in 1944. After the war Dragonovich ran some of the most infamous ratlines of all time. Not only did he organize the escape of Ante Pavelic and other leading Ustashi, but he is perhaps best known for organizing the protection and resettlement of numerous Nazi SS leaders including Klaus Barbie "the Butcher of Toward the end of the 1950's Dragonovich used his Vatican and CIA connections to become an international ambassador of sorts for the emigre Croatian community. Dragonovich's Ustashi comrades did not simply disappear into the woodwork once they reached their safe country: they went about establishing Ustasha cells in Croatian communities around the world. In 1989 and 1990 they directly financed and supported Tudjman's rise to power (see "Pro-Nazi Legacy Lingers for Croatia," New York Times, 31 October 1993 and "Pizza Magnate in Canada is a Croatian Kingmaker," New York Times, 16 January 1994). The fact that right wing Croatian political groups were carefully watched over and facilitated by the U.S. government throughout the postwar era is documented in the pages of Blowback (pp.176-184).

The success of U.S. policy in Greece,... (etc.) spurred the U.S. government to vastly expand its financial and logistical support to the creation of ever new right-wing "refugee relief programs." The most important of these was the CIA founded "Assembly of Captive European Nations" (ACEN) which became the umbrella organization and launching pad for innumerable fascist and far right refugee organizations and off-shoots, involving


itself in one or another in everything from Radio Free Europe and Readers' Digest to the American Committee for the Liberation of the Peoples of Russia, the Bulgarian National Front, the Slovak World Congress and the Croatian-American Committee for Human Rights. No doubt, the entire history of the anti-Tito/anti-Yugoslav organizations in this country since 1945 could be traced back to this institution....

These activities were no small affairs. CIA employee James Burnham estimated that in 1953 the CIA was spending over \$1 billion a year on its refugee liberation work (p. 127). By 1959 the U.S. Congress established a "Captive Nations Week," and the following year an enormous Captive Nations Day parade was held in New York thanks to massive CIA financing (pp. 270-1).

The vast expansion of funding for "refugee liberation movements" during the Reagan and Bush years directly affected the course of history by helping to undermine the Soviet Union and the other Eastern European regimes.... Today in the 1990's it is responsible for the destruction of Yugoslavia as a state, the destruction of the Serbs as a people in Croatia and Bosnia, and the resurrection of a new Nazi alliance in the Balkans headed by the U.S. and Germany through their new fascistic client states of Croatia and Bosnia....

Well, to give it a broad definition, it is the set of these values, meanings given to social relations and institutions during a particular era.

One Point of View on Citizens Trust of NYPD

Criminal activity seems to be a more frequent event among police recently. On August 30, 1995, I sat in on a trial that was taking place in NY Sate Supreme Court under the Honorable Judge A. Kufner Jr. The trial involves two off-duty NYC police officers who were indicted for robbery, theft and attempted homicide in 1992. It seems that many of the police in NYC think that they are immune from the system. Their so called "code of blue silence" doesn't help the situation either. In the past five to ten years I have heard of more criminal indictments and incidents involving police than ever before. The police department seems to be more concerned with the generation of revenue, opposed to the cleaning up the drugs and crime on the streets. Furthermore, how many policemen have been arrested for drug related crimes themselves lately? It must be more personally profitable for an officer to seize money and cash from a drug dealer and keep it for himself, opposed to actually arresting the dealer and having to do the extra paper work, which would in turn be more of a deterrent for the drug dealer.

When we have so called "dirty cops" in our law enforcement system, this does so much harm to the society at large. I have always personally held much respect for police officers. But in the present times I have more fear of the police officers of today than some of the most hardened criminals.

A typical NYC police officer has a tremendous amount of power and seems to be very often abusing it. I have personally witnessed many incidents of unnecessary abuse toward law abiding citizens from police and fire department personnel. The local law enforcement system truly needs to be revised. It seems the Internal Affairs of the NYPD only arrests police officers after very serious crimes are committed at an extreme level. What are the drug dealers and other criminals going to think if they know that the police personnel are getting away with crimes. This will effect criminals psychologically into thinking that they don't have to worry too much about getting caught selling drugs or committing other crimes, because the chances are that the police officer will only confiscate his drugs and money for him or herself and the criminal will not get arrested. This may not be the actual result of every case, but I'm sure indictments of this nature have taken place.

Something needs to be done in order to gain back the old respect most citizens had for the police department which has now turned to fear. More emphasis should be placed on getting drug dealers and criminals off the streets of New York, opposed to the issuing of summonses and the generation of revenue. If there was a way to statistically analyze illegal drug transactions in NYC, I would bet that for every summons that is issued for a parking violation or traffic violation, at least two or three drug transactions take place in this city. We need to address something other

I cannot think of a crime that is worse than when a police officer commits a crime. A police officer is supposed to stand for law, order and safety. Our lives, the lives of all the citizens of NYC are in the hands of the police department. Something is wrong and something needs to be done to raise citizen morale and their perception of the NYCPD, along with more severe measures for drug related crimes and when an officer is involved in a crime. The mayor, the police commissioner, and any other bureaucrats that implement policy in New York City with respect to these issues, should be aware that these issues



ing society as a whole, can be made unilaterally by them. Most of them advocate that the party take the vanguard role in a revolution and that the party should form the state and run the economic system. Perhaps some would even conceive of themselves as appointing their members to positions of authority. This my friends is the beginning of bureaucracy and a new ruling class.

As Daniel DeLeon put it, "Revolutions like comets have a small head-the enlightened thinking and determined minority and a very long tail- the sentiment of a cloudy majority." Leaders must be educators and agitators. They should be the guiding light. They must educate our fellow citizens to reason for a revolution, not only because it is right but because the future of a civilization is at stake. However they should not "assume" power without the consent of the people.

Let us not be parlor or armchair revolutionaries. A good idea is not good if it is locked up in a few people's minds. We have to get out and spread the idea. We have to communicate with people wher-

ever they congregate.

Up to now I have been talking about how we would like to see a revolution come about and assuming that the ruling class doesn't become fascist. We assume that we will have the right to vote for our political choice and that our civil liberties will remain intact. However, I pose the question "What would we do if the ruling class turns to fascism and our civil liberties are taken away well before election time?" There is a good chance that the ruling class will panic, recognizing a ground swell of class consciousness forming. They probably would then strip us working people, progressives and other average folk of all semblance of democratic right. Are we going to be like the working people of Germany of the 1930's just before Hitler took over? At that time, as some of you know, the working class of Germany had two parties that polled about 40% of the vote and they were organized into powerful unions. Their freedoms and strengths were whittled away by the Nazis little by little until they woke up one day and found that Hitler had taken over completely. The workers leaders were in jail and their political parties were outlawed.

I think that the working class of Germany should have fought back each step of the way with the same tactics that the German ruling class used. Hopefully we American progressives can be in a position to fight back if and when the American ruling class decides to be undemocratic.

In my view the only practical way in which to do this is to organize along revolutionary lines within the labor movement, the environmental movement, the student movement, the civil rights movement and any other progressive movement that we can. In other words we should fight back with a strategy of education, class consciousness and organization.

Here I come to another bone of contention with the Marxist Leninists. Some of them claim that in order for the working people and other progressives to successfully bring about the downfall of the ruling class government and establish a truly democratic government and more equitable economic system a vanguard party should lead the way. Some of them claim that the average people as a whole are not capable of establishing a truly progressive society.

They conveniently forget about the times when working people, fed up with oppressive capitalism rose up en masse. They forget about the role played by working people in the Paris Commune of 1870 and the Russian Revolution of 1905. Even the Russian Revolution of 1917 was a massive uprising. The Bolsheviks weren't the leaders in that revolution. After the uprising started the Bolsheviks successfully maneuvered themselves into positions of lead-

ership.

There were also massive uprisings of workers in 1918 in Germany and the Spanish Revolution of 1935. Then there were the uprisings in France in 1968 and in Italy in 1969. In the uprisings of 1968 in France the French working people were able to shut down the entire nation with general strikes for days

In the Portuguese Revolution of 1975, there was a power vacuum after the death of Fascist Dictator Antonio Salazar. This vacuum was filled by chaos and this chaos led to working people taking things into their own hands. They formed worker committees at many of the large factories throughout their country. These committees there took control of the factories and running them themselves for themselves.

In the United States we have had worker rebellions in the 1960's in primarily black areas of large cities. These rebellions were caused in reaction to the terrible exploitation that existed there.

Our last rebellion here in the United States occured in Los Angeles in 1992. It occured not only in reaction to massive exploitation of working people but also in

reaction to police brutality and oppression. Furthermore the rebellion included not only black people, it included Hispanics and the white population also.

In every case working people rose up instinctively against ruling class tyranny and exploitation. They took things into their own hands en masse and shook society to its roots.

Unfortunately all these revolutions did not succeed in holding on to power with real democracy. They all lacked sufficient organization. People in general weren't class concious and were not educated to ideas of holding onto massive or demo-

cratic control.

We can learn from these working class revolutions. From the Paris Commune we can learn to be very wary of ruling class power. From the German uprising of 1918 to the uprising in Los Angeles in 1992 we progressives should learn to rely and promote class conciousness, education and organization of as many common people as possible.

In conclusion what we progressives have to do is teach a few elementary principles. People don't have to be revolutionary scholars. Common people just have to know how to act in their own self interest. They have to be class concious. They have to recognize the ruling class and how it works. They have to understand, as Karl Marx pointed out, we live in an economically unjust society. They have to know what kind of system to put in its place that is economically just. Finally let us remember the immortal words of Thomas Jefferson "The price of democracy is eternal vigilence"

The Catholic Church-**Cancer Of Society**

The following article has been reprinted from 1969, and came out of the former Staten Island Community College. The article titled The Catholic Church-Cancer Of Society was labeled as a "scathing" attack upon religion. The commentary piece brought on a two-year lawsuit from concerned students and parents. The court case finally reached the NY Appellate Court and wasn't resolved until 1971. The Appellate division of appeals struck down a county court decision that required school administrators to interfere with student publications. Any type of imposition of restrictions upon the school publications was "an infringement of the right of free expression of the students attending these colleges." The Appellate Division declared that student newspapers "have been established as a forum for the free expression of the ideas and opinions of the students who attend these institutions of higher learn-

Is the Bible the inspired

If one is going to accept the Bible as the Word of God, one must ultimately do so by faith (Hebrews 4:2). However, faith in the Bible should not be a blind jump into the dark, but an intelligent decision grafted with in sound evidence (Hebrews 11:1). Many people reject the Bible, being ignorant to its content and its evidence of complete inspiration. Their opposition is complete inspiration. Their opposition is often based on worn out arguments and preconceived ideas that aren't in line with the facts, as well as an unwillingness to submit to the authority of scripture in their lives. I will argue that the whole Bible is the infallible Word of God that has been completely, not partially inspired by God.

The reliability of the Bible.

If we test the Bible for historical reliability by the same criteria we test any justori-

ity by the same criteria we test any historical document, without any anti-Christian, anti-supernatural bias we will discover that the Bible is an amazingly authentic that the Bible is an amazingly authentic piece of literature with high historical support. One test for historicity is the bibliographical test, which is the reliability of the copies, determined by the amount of manuscripts available and the gap between the original manuscripts and the earliest copies available. There are over 24000 manuscripts for the New Testament, way may then any other deciment of ancient. more than any other document of ancient antiquity. The gap between the earliest copies 130 AD and the original manuscripts-mid to late first century—is very small in comparison to other famous documents from antiquity, allowing no time for significant alteration from the originals to ome about. Bible theologian of Christian history John Warwick Montgomery says, "to be skeptical of the resultant text of the New Testament books is to allow all in accordance with God's promise and prediction to preserve his Word (Psalm 12:6-Matthew 24:35).

The Internal Evidence Test determines the credibility of the written records, which is the ability of the writer or witness to tell the truth by being near the events geographically and chronologically. The New estament passes this test with flying colors, as the accounts of Jesus life, death and resurrection are given by the original eye witnesses themselves, or those who re-ceived their testimony from eyewitnesses. (Luke 1:1-4, 2 Peter 1:16, 1 John 1:3). The New Testament was in circulation in the first century where the eyewitnesses, both in and out of classical antiquity to slip into obscurity, for no documents of the ancient period are as well attested bibliographi-cally as the New Testament. This estab-lishes that the New Testament has been preserved accurately throughout time, Christian community of faith would have been around to correct any wrong and exaggerated accounts of the life of Christ. However, many of the events surrounding Jesus of Nazareth were common knowledge, even to the opponents of Christianity (Acts 2:22, Acts 26:24-28, John 11:43-47).

The External Evidence Test determines if the evidence outside the documents confirms the history of the documents in que tion. Many independent testimonies agree tion. Many independent testimonies agree with the New Testament historical information. The Old Testament is supported as well and Christ completely endorsed the historicity of the Old Testament. Archeology also supports Bible history. Nelson Gluecxk, a renowned jewish archaeologists wrote, "It may be stated categorically that no archaeological discovery has ever controverted [contradicted] a biblical reference, the almost incredibly acceptable of the contradicted of the contradict has ever controverted [contradicted] a biblical reference...the almost incredibly accurate historical memory of the Bible, and particularly so when it is fortified by archaeological fact." The Bible's historical nature makes it unique to books that claim to be inspired by God, since other books don't have any historical basis or support.

The high moral character of the eyewitnesses and the tact that many of them died in defense of the resurrection makes the historical evidence overwhelming. One of the worlds greatest historians Thomas Arnold said, "I know of no one fact in the history of mankind which is proved by better, fuller evidence of every sort, to the understanding of a fair enquirer, than the great sign which God hath given us that Christ died-and reco God hath given us that Christ died, and rose again from the dead." 

The Stinking Corpse of Social Democracy or Why Capitalism Cannot Be Reformed - A Response To H.B.

HB in his article, A Way To Build A better Life, in the September issue of the Voice outlined a critique of "capitalism" or the "American way of life". We could not agree more with his passionate disapproval of the "grinding poverty", "low wages, crime, pollution, unsatisfying jobs". He attacks Reaganism and the right wing so-called trickle down economics that has turned American cities into concentration camps for the working poor and minorities. He concludes that, "there seems to be a problem with capitalism and how it is prac-

In searching for an alternative HB falls into the old trap of pragmatism which has been a perpetual malaise in Anglo-American politics. He states: "My vision of a $future\,more\,equitable\,economy\,is\,not\,some$ pie-in-the-sky lunacy. It is do-able." What is he referring to? "A mixture of capitalism and socialism...tak(ing) the best from each system." No one in their right mind will refuse a more expanded welfare state along the lines of Sweden where the standard of living of working people by all indices is much higher than the US. However strategy for all people interested in fighting for a more just egalitarian society must begin with a concrete historical and materialist analysis of the political economy

The US version of the welfare state initiated with the New Deal reforms under President Roosevelt in the Depression ridden 30s, as pathetic as it was compared to the Swedes or Germans, is still a relic of the past, an anachronism that only a expanding capitalism based on ever expanding markets and profits could afford. Dozens

dollars of land and equipment were destroyed in the second great inter-imperialist conflagration - WW2 - for the American capitalist boom of the post war years to be sustained. Is HB willing to condone a third such catastrophe so that his vision which is essentially welfare statist can be real-

The American ruling class is operating on the Stalinist corpse in Eastern Europe which it also helped to kill in addition to Stalinisms own internal degeneration. In fueling ethnic/nationalist bloodbaths it hopes that a subservient dependent capitalism can be created which will be a source of new markets and cheap labor. However unlike after WW2 American capitalism today is buried in debt, facing stiff competition from a rejuvenated capitalist Germany bloated after swallowing up former "communist" German Democratic Republic and Japan Inc. in Asia. The same uncontested hegemony that US industry enjoyed after the wholesale destruction of mainland Europe and Japan in WW2 does not exist today!

The US ruling class is thus seeking to maintain its dominance through forcing free market misery down the throats of the worlds people, the majority of whom live in semi-colonial regions like India and Africa. This increasingly fascistic New World Order can be seen in the gutting of welfare in the US and the accompanying genocidal rhetoric of ruling class politicians who dehumanize and criminalize the most vul-

poor, minorities, women, homeless, etc.. The same crisis of the welfare state that is afflicting US capitalism and pushing its rulers to new levels of ruthlessness is paralleled by a general crisis of the welfare state across all of the advanced capitalist countries in Western Europe and Japan. The saturation of world markets is causing a new and more destructive cycle of overproduction (or a devastated consumption base). Social Democratic regimes in western Europe are busy following the example of Reagan and Thatcher laying off thousands, busting unions, privatizing indussafety net. The US of course pioneers the way but the Social Democrats who are misery with a human face whereas Ameriians of the capitalist welfare state are very quickly dropping their "social" and becoming very much like US Democrats. US Democrats are dropping any pretense of "democracy" and becoming Republicans.



He who rejects that method places himself upon the barbarian plane, a plane where the capitalist class would be but too glad to see him, seeing that thereby would give the capitalist class a welcome pretext to drop all regard for decency and resort to the terrorism that would suit it."

There is another aspect to this approach and that is backing up the ballot box with the necessary physical force. Once again as DeLeon put it, "But civilization is civilization. It implies not only the effort for peace, but also the knowledge of the fact that right without might is a thing of air. Accordingly the civilized revolutionary organization proclaims the right, demands it, argues for it, and willingly submits to the civilized method of polling the votes. And it organizes itself with the requisite physical force in case it's defeated adver-

sary should resort to the barbarian's way of enforcing his will. The civilized man answers force with force. The barbarian begins with force.'

In other words if the ruling class and their henchmen won't bow out gracefully after we have won at the ballot box we should have an ace in the hole. We should take possession of our working places and lock out the ruling class. We must do this immediately and in an orderly way.

As far as the military or the police are concerned in a revolutionary situation we are going to have to rely on them not being able to supply the themselves. We should refuse to give them goods and services. We will also have to rely on mass defections of armed forces personnel away from

The reigns of government should be firmly placed in the hands of the people though the only real means of doing this which is real democracy. We should make sure we have this control through thinking out a system where we can express our views and be able to run for office. We the common people should have the authority to elect every position of leadership or office politically and on the job and take part in the decision making processes democratically. This, I think, is the essence of what a revolution can bring.

I would also like to caution against the usurpers of power. I think we should be aware of groups or parties who claim to be members of the vanguard who will in a revolutionary situation as Vladimir Lenin put is "assume" power. These groups be they Stalinists, Maoists, or Trotskyists all claim to be Marxist Leninist and all have the basic same flaw. That flaw is that they all advocate that the vanguard party consolidate power and authority under their control. They could then set up a system whereby some decision making concern-

Self-Evident; Institutional Racism

Mark Furhman; Bad Apple or Pick of the Lot?

With Democrats and Republicans both questioning the "virtues" of Affirmative Action, repealing civil rights legislation hard won through countless generations of struggle and spilled blood (the peaceful civil rights movement of Martin Luther King Jr. is marked by the blood of its martyrs,) it is hard to believe that racism in this society has retreated into the sewers where it belongs. More accurately the assault on blacks is part and parcel of a strategy to roll backs gains made by the entire working class with the tactic of racism. Is it ironic that the institution that is entrusted with "justice" and "equality" is marred most with racism and corruption? I am talking about "law and order;" cops, courts - the judicial system. Here it is important to frame the discussion clearly.

One must separate the police officer (subject) and the institution of armed men (object), i.e., the police, army ect. The police officer is part of the working class. She/he

are strikes, as in Detroit, they protect the private property of the boss as opposed to the livelihood of a fellow worker. Or when a community, a group of people (like the CUNY students last year) are protesting against unjust conditions they contain and oppress the dissenters. Ofcourse, there are the everyday acts of arrogance, brutality and law breaking behavior that people encounter. Most certainly they are not the commanders of the economy, just the enforcers of the ruling class' rule, albeit that is why Marxist dub the police as class

So for those of you out there who may have a friend or relative that is a "good" cop fine, all things are relative to a given context. My point is, however, in this article is to explain why there is nationwide abuse within the institution and what must be done to change it. I am confident that this change will be a relief for the entire working class, including even its it was a case of "mistaken identity." Not a very original excuse and one that is used often when non-white youth are shot.

In Brooklyn Officer Steven Mizhari shot and killed with the NYPD's new and improved 9-mm, youthful Yong Xin Huang. He claimed it was an "accident," he did not mean to shoot the 14 ear old youth in the back of the head at point blank range. Two Latino youths, 19 and 21 years of age, were gunned down while lying on the floor face down with illegal bullets by two Bronx detectives. They were both shot with over 15 times. What all these cases have in common is that the police officers were not charged or convicted of any wrong doing. They are still walking the streets today, protecting the public and upholding the law.

Officer Fuhrman retired with a pension though he broke the law he was never charged with criminal activities. Then there is the case of Officer Livito, also of the Bronx who used the illegal choke hold to strangle

> to death Anthony Biaz. Unlike Officer Livito's predecessors he was convicted by a grand jury on homicide charges. This thug in blue Livito had an extensive record of abuse over the years. He is facing other charges by another Bronx resident whom he choked nearly to death. Unlike so many other officers whom killed people, mostly black and Latino, he was indicted by a grand jury. This rare case of "justice" was recently thrown out of court because of a "technical error" by the DA's office. How does the DA respond? He replied that such mistakes are "one of the perils of the computer age," and "You hit the wrong button and the wrong charge comes out." Such dismissing remarks makes one wonder if indeed it happened by chance or contrived. Though the presiding judge did not have to dismiss the case, he did.

Mark Fuhrman described the support, cover-up, and collaboration of other cops. In Philadelphia (home to the infamous Mumia Abu-Jamal case [see pg.?]) six police officers were recently

convicted on charges of tampering with evidence, producing false evidence, and manipulating their authority in order to convict and beat blacks with impunity. The article went on to detail the trail of abuse that effected the lives of hundreds of black people in North Philadelphia; these Robbin' Hoods stole from drug dealers and terrorized the community. There actions where well known throughout the community for years indicating that such practice is common. One wonders how many other police officers knew about it and remained quiet. The convictions of these few "bad apples" will not end the abuse until the roots of the tree are eradi-

Well what about the FBI or the federal government? Because this branch responds to the interest of the national bourgeoisie, it may, as in the Rodney King case, convict a "bad cop," for the sake of national security, ie's, the prevention of mass uprisings. However, a recent NY Times article gives us some insight into the makeup of the "good old boys." Over 300 federal, state and local officers of the law attended a "Good Ol' Boys Roundups." A racist barbecue in the mountains of Tennessee organized by former federal agent, Gene Rightmyer. There were racist signs declaring "Nigger checkpoint" and racist paraphernalia sold. This former agent used his former office of the Federal Firearms Bureau in order to organize the event. This is not an isolated incident.

There is a lawsuit by women federal violence associated by these brutes was

linked to their sexual ways. The DEA instructors began classes by stating that "when you get home, you are going to fuck like you've never fucked before.

Get your kids out of the house because it's

going to be a fucking brutal assault." There are plenty of cases of racism and sexism in the FBI, which under former FBI chief J Edgar Hoover (pathological liar and sexually repressed) the FBI was indeed a 'good ol' boys' club made up of mostly white males. A few token blacks and females does little to change to dominant character of these institutions of "law and order." More accurately the characters of those individuals that join the team assimilate to the new environment.

Law and Order Need to be Changed

If the justice system is not solving the problem, but only maintaining its continuation, then the present system of laws must eradicated and replaced with a more humane system. The theories are out there, the organizations are needed. If the judicial system is based upon the laws of capitalism, and protect the ruling class, then another system based upon the needs of working people must take its place.

The Laws in capitalist USA are founded upon inequality. Whence, the officers that uphold the laws of inequality are nothing more than a reflection of the very system which they protect. When Mark Furhman was recorded saying, (Reut22:07 09-13-95) "If I had my way all the niggers would be gathered together and burned," we are hearing not only the words of an individual but the echoes of a segment of racist America reacting to the deepening economic crisis that the country faces. To turn our heads away, or to depend upon the government to subdue these tendencies will not work. The moral dilemma that we face today is rooted in an economy that places human greed in front of human needs, or profits before human welfare.

Today we must confront bigotry wherever it raises its ugly head. We must protest out in the streets when cops kill innocent people, when blacks are targeted by racist, when homosexuals are assaulted because they are gay. We must get out on the streets to demand a better standard of living that millions of Americans are facing today, we must demand higher wages, universal healthcare, jobs for all, a thirty hour work week. These demands are not far-fetched, for there is not a lack of money only will, then the problems that we face will wither away.

class they have to work each day, selling their labor power, in order to make ends meet. The police are more accurately understood as a section of civil (state) employees that are privileged; they are paid better, maintain excellent benefits and a pension that kicks in after twenty years of work, as opposed to most workers that have little or no benefits, pension plan and a 40+ hour mandatory work week. In short they are not the filthy rich, but neither are they as desperate as most working

people are.
The police officer, however, upholds the "law of the land," and this is what distinguishes her/him from the rest of the working class. That law is based upon the private ownership of capital; industry, banks and living labor. Unlike other wage earning positions the police officers job is uniquely different in that he secures the rule of the few over the majority with brute force. Recent Revelations - a **Historical Pattern**

LOS ANGELES, (Reuter) - Former detective Mark Fuhrman, a key witness in the O.J. Simpson trial, was an "arrogant monster" whose racism and sexism was typical of the Los Angeles police, a female officer who worked with him said in a television interview aired Wednesday. "

He walked on water, literally, and when he said he was God, he meant it," Officer Sherry Ray said on the news magazine "Day & Date," broadcast on KCBS in Los Angeles and other CBS stations.

Out of roll call, the statement he would make after he had coffee (was) 'Let's go fuck with the niggers.'...."He said it all the time, blatantly, outspokenly," said Ray, a 14-year veteran of the LAPD, who was often partnered with Fuhrman at the West Los Angeles division.... In the tapes he also boasted of beating suspects.

The recent revelations of the racist convictions of Mark Fuhrman, notorious former LAPD detective, made public via the OJ Simpson trial is again testimony that within the judicial system, in this case the police, there are outright racist maintaining "law and order" in our class ridden society. Such a case is not isolated to LA, but inherent throughout the entire country, in all police departments, as well as the other branches of our illustrious judicial system.

Mark Fuhrman described how he and fellow officers felt about other non-white ethnicity's. More disturbingly he also describes how blacks and Hispanic's were treated by other racist cops. In New York city a fellow black transit officer was shot at point blank range by a white officer. The white officer claimed

part II more complex. Universal suffrage was substituted for suffrage was substituted for suffrage for property-owners only; military service has become compulsory; everybody pays taxes. The class character of the State then become a little less transparent. The nature of the State as an instrument of class domination is less evident than at the time of the reign of the classical bourgeoisie, when the relationship between the different groups exercising State functions were just as transparent as in the feudal era. The analysis of the modern State, therefore, will also have to be a little more complex.

First, let us establish a hierarchy among the different functions of the State.

In this day and age, nobody but the most naive believes that parliament really does the governing, that parliament is master of the State based on universal suffrage. (That illusion is however, more widespread in those countries in which parliament is a fairly recent institution.)

The power of the State is a permanent power. The power is exercised by a certain number of institutions that are isolated from nomenon is a general one throughout Western Europe. The present Fifth Republic in France is presently the most striking and most complete example of this phenomenon.

Should this turnabout, this reversal, be seen as a diabolical protagonist universal suffrage by the wicked capitalists? A much deeper objective reality is involved: the real powers are transferred from the legislative to the executive; the power of the executive is reinforced in a permanent and continuous fashion as a result of changes that are also taking place within the capitalist class itself.

This process began at the time of World War I in most of the belligerent countries and has since continued without interruption. But the phenomenon often existed much earlier than that. Thus, in the German Empire this priority of the executive over the legislative appeared concomitantly with universal suffrage. Bismarck and the junkers granted universal suffrage in order to use the working class to a certain extent as a lever against the liberal bourgeoisie, thus assuring (in that already essentially capitalist society) the relative independence of the executive power exercised by the Prussian nobility.

This process shows full well that political equality is more apparent than real and the right of the citizen-voter is nothing but the right to put a little piece of paper in a recall that in the heroic era of parliamentarism it was not only with words and votes that this collective interest was hammered out; fists and pistols were used, too. Didn't the Convention, that classical bourgeois parliament during the French Revolution, send people to the guillotine by the slimmest of majorities?

it is necessary to pass an examination. The rule seems very democratic indeed. On the other hand, not just anyone can take any examination at all for any level whatsoever. The examination is not the same for the position of secretary general of a ministry or chief of the army general staff as it is for junior clerk in a small government bu-

But capitalist society is not going to remain atomized. Little by little, it can be seen organizing itself and structuring itself in a more and ore concentrated, more and more centralized way. Free competition fades away; it is replaced by monopolies, trust, and other capitalist groupings.

Capitalist power is centralized outside parliament

Now a real centralization of finance capital, big banks and financial groups, take place. If the Analytique of parliament expressed the will of the Belgian Bourgeoisie a century ago, today it is above all the annual report of the Society Generale or of Burufina, prepared for their stockholders' meeting, that must be studied to know the real opinions of the capitalists. These reports contain the opinions of the capitalists who really count, he big financial groups who dominate the life of the country.

Thus, capitalists power is concentrated outside parliament and outside the institutions born of universal suffrage. In the face of so high-powered a concentration (we need only remember that in Belgium a dozen financial groups control the economic life of the nation), the relationships between parliament and government officials, police commissioners and those multimillionaires is a relationship burdened very little by theory. It is a very immediate and practical relationship; and the connecting link is the pay-off.

The bourgeoisie's visible golden chain — the national debt

Parliament and, even more, the government of a capitalist State, no matter how democratic it may appear to be, are tied to the bourgeoisie by golden chains. These golden chains have a name—the public debt.

No government could last more than a month without having to knock on the door of the banks in order to pay its current expenses. If the banks were to refuse, the government would go bankrupt. The origins of this phenomenon are twofold. Taxes don't enter the coffers every day; receipts are concentrated in one period of the year while expenses are continuous. That is how the short-term public debt arises. This problem could be solved by some technical gimmick. But there is another problem a much more important one. All modern capitalist States spend more than they receive. That is the long-term public debt for which banks and other financial establishments can most easily advance money, at reau. At first, this too would seem normal

but-a big but-there's a progression in these examinations that gives them a selective character. You have to have certain degrees, you have taken certain courses, to apply for certain positions, especially important positions. Such a system excludes a huge number of people who were not able to get a university education or its equivalent, because equality of educational opportunist doesn't really exist. Even if the civil service examination system is democratic on the surface, it is also a selective instrument.

...mirror of the hierarchy in capitalists society

These invisible golden chains are also found in the remuneration received by members of the State apparatus.

All government agencies, the army included, develop this pyramidal aspect, this hierarchical structure, that characterizes bourgeois society. We are so influence by and so imbued with the ideology of the ruling class that we tend to see nothing abnormal in the fact that a secretary general of a ministry receives a salary ten times higher than that of a junior clerk in the same ministry of that of women who cleans its offices. The physical effort of this charwoman is certainly greater; but the secretary general of the ministry, he thinks! -which, as everyone knows is much more tiring. In the same way, the pay of the chief of the general staff (again, someone who thinks!) is much greater by far than that accorded to a second-class private.

This hierarchical structure of the state apparatus leads us to emphasize: In this apparatus there are secretaries general, generals of the army, bishops, etc., who have the same salary level, and therefore have the same standard of living, as the big bourgeoisie, so that they are part of the same social and ideological climate. Then come the middle functionaries, the middle officials, who are on the same social level and have the same income as the petty and middle bourgeoisie. And finally, the mass of employees without titles, charwomen, community workers very often earn less than factory workers. Their standard of living clearly corresponds to that of the proletariat.

The state apparatus is not a homogeneous instrument. it involves a structure that rather closely corresponds to the structure of bourgeois society, with a hierarchy

and independent of so changeable and unstable an influence as universal suffrage. These are the institutions that must be analyzed if we are to learn where the real power is: "Government come and governments go, but the police and the administrators remain."

The State is above all, these permanent institutions: the army (the permanent part of the army — the general staff, special troops), the police, special police, secret police, the top administrators of government departments ("key" civil servants), the national security bodies, the judge, etc. —everything that is "free" of the influence of universal suffrage.

This executive power is constantly being reinforced. To the extent that universal suffrage appears and a certain democratization, albeit completely formal, of certain representative institutions develops, it can be shown that real power slips from those institutions towards others that are more and more removed from the influence of parliament.

If the king and his functionaries lose a series of rights to parliament during the ascending phase of parliamentarism, on the contrary with the decline of pariamentarism (which begins with the winning of universal suffrage), a continuous series of rights are lost by parliament and revert to the permanent and irremovable administrations of the State. This phe-

ballot box every four years. The right goes no farther, nor, above all, does it reach the real centers of decision-making and power.

The monopolies take over from parliament

The classical era of parliamentarism was the era of free competition. At that time the individual bourgeois, the industrialist, the banker, was very strong as an individual. He was very independent, very free within the limits of bourgeois freedom and could risk his capital on the market in any way he wished. In that atomized bourgeois society, parliament played a very useful, and even indispensable, objective role in the smooth functioning of everyday affairs.

Actually, it was only in parliament that the common denominator of the interests of the bourgeoisie could be determined. Dozen of separate capitalist groups could be list, groups opposed to one another by a multitude of sectional, regional, and corporative interests. These groups could get together in an orderly fashion only in parliament. (It's true that they did meet on the market too, but there it was with knives, not words!) It was only in parliament that a middle line could be hammered out, a line that would express the interests of the capitalist class as a whole.

Because that was then the function of parliament: to serve as a common meeting place where the collective interests of the bourgeoisie could be formulated. Let us In sum, all functions of the State apparatus are reduced to this: surveillance and control of the life of the society in the interests of the ruling class.

heavy interest. Therein lies a direct and immediate connection, a daily like, between the State and Big Business.

The hierarchy in the State apparatus...

Other golden chains, invisible chains, make the state apparatus tool in the hands of the bourgeoisie.

If we examine the methods of recruiting civil service people, for example, we see that to become a junior clerk in a ministry, of classes and identical differences between them.

This pyramidal structure corresponds to a real need of bourgeoisie. They wish to have at their disposal an instrument they can manipulate at will. It is quite obvious why the bourgeoisie has been tying for a long time, and trying very hard, to deny public service workers the right to strike.

Is the State simply an arbiter? This point is important. In the very con-


These men contribute no productive labor but are supported by the other members of society.

In normal times, there is not much need for watchdogs. Even in Moscow, for example, there is no one charge of collecting fares on buses: Passengers deposit their kopeck boarding, whether or not anyone is course, concessions to the exploited can be made by arbitrators: that depends essentially on the relationship of forces. But the basic aim of arbitration is to maintain capitalist exploitation as such, if necessary by compromising a bit on secondary quesPromethean Panther

The watch-State, testimony to the poverty of society

Second, the State is an entity created by society for the surveillance of the everyday functioning of social life; I is at the service of the ruling class for the purpose of maintaining the domination of that class. There is an objective necessity for this watchdog organization, a necessity very closely linked to the degree of poverty, to the amount of social conflict that exists in the society.

In a more general, historical way, the exercise of State functions is intimately connected with the existence of social conflicts. In turn, these social conflicts are intimately connected with the existence of a certain scarcity of material goods, of wealth, of resources, of the necessary means for satisfaction of human needs. This fact should be emphasized: As long as the State exists, it will be proof of the fact that social conflicts (therefore the relative scarcity of goods and services as well) remain. With the disappearance of social conflicts; the watchdogs, rendered and parasitical, will disappear-but not before! Society, in effect, pays these men to exercise the functions of surveillance, as long as that is in interests of part of

watching them. In societies where the level of development of the productive forces is low, where everyone is a constant struggle with everyone else to get enough to live on for himself out of a national income too small to go around, a large supervisory apparatus becomes necessary.

Thus, during the German occupation [of Belgium], a number of specialized supervisory services proliferated (special police in the railways stations, supervision of print shops, of rationing etc.). In time like that, the area of conflict is such that an imposing supervisory apparatus proves indispens-

If we think about the problem a bit, we can see that all who exercise State functions, who are part of the State apparatus, are—in one way or another— watchdogs. special police and regular police are watchdogs, but so are tax collectors, judges, paper pusher in government offices, fare-collectors on buses, etc. In sum, all functions of the State apparatus are reduced to this: surveillance and control of the life of the society in the interests of the ruling class.

It is often said that the contemporary State plays the role of arbiter. This statement is quite close to what we have just said: "surveillance" and "arbitrating" aren't they basically the same thing?

Two comments are called for. First, the arbiter is not neutral. as we explained above, the top men in the State apparatus are part and parcel of the big bourgeoisie. Arbitration thus does not take place in a vacuum; it takes place in the framework of maintaining existing class society. Of

society. But it is quite evident that from the moments group in society has a stake in the watchdog function being exercised, the function will disappear along with its usefulness. At the same time, the State will

The very fact that the State survives proves that social conflicts remain, that the condition of relative scarcity of goods remain— the hallmark of that vast period in human history between absolute poverty (the condition during primitive communism) and plenty (the condition of the future socialists society). As long as we are in this transitional period that covers ten thousand years of human history, a period that also includes the transition between capitalism and socialism, the State will survive, social conflicts will remain, and there will have to be people to arbitrate these conflicts in the interest of the ruling class.

If the bourgeois State remains fundamentally an instrument in the service of the ruling classes, does that mean that the should be indifferent to the particular form that this state takes- parliamentary democracy, military dictatorship, fascist dictatorships? Not at all! The more freedom the workers have to organize themselves and defend their ideas, the more ill the seed of the future socialists democracy grow within capitalist society, and the more will the advent of socialism be historically facilitated. That is why the workers must defend their democratic rights against any and every attempt to curtail them (anti strike laws, institution of a "strong State") or to crush them (fascism).

riot gear but were forced back. Local television stations interrupted their regular broadcasts to show live film of cops being hurled back across the highway. As a result, more workers left their homes and joined the lines. At about midnight, the frustrated cops began using industrial fans to fumigate the crowd with pepper gas. The pickets responded by using their signs to fan the fumes back towards the cops. After about an hour of this, the cops began hurling canisters of pepper gas and eventually tear gas. All hell broke loose as pickets hurled the canisters back — along with anything else they could think of. A few choice projectiles also landed on the heads of security guards inside the plant fence.

The cops had no hope of clearing the main driveway, they knew. Their plan, it turned out, was to cause a diversion so that the scabs trucks on the inside could rush the back gate. Unfortunately they were largely successful. As a number of pickets went home in disgust, the cops attacked the main gate on foot in order to bring in a scab caravan waiting out on the road. This led to a second, very fierce battle with the remaining pickets.

The pickets were forced to retreat, but not before a new element jumped into the fray. A group of about two hundred high school age youth from Sterling Heights had earlier begun pelting the cops from behind their lines on the other side of Mound Road. Now some of the youth came across the road, a little north of the cops' position, to engage them more directly. The cops turned north to face the whole body of the youth and the remaining pickets. Eventually the cops would prevail, but only after taking several injuries in two hours of fighting. So ended the Battle of Labor Day.

Local media, the day after began blam-

ing the violence on "outside agitators", specifically the Strike to Win Committee. Shamefully, the Teamsters bureaucracy chimed in, only parenthetically blaming the cops and rarely if ever mentioning the tear gas canisters. That the Strike to Win Committee has been a leading element in all the best struggles on the picket lines there can be no doubt. But it was simply ridiculous of the bureaucrats and media to try to hide the cops' viciousness as well as the fact that hundreds of workers fought right along side the "agitators." Television

ing spirit of labor. But the newspapers have recently made some moves to shore up their position and to try to wear down the strikers in a war of attirtion. On September 9 they began using helicopters to fly scab papers over the heads of the pickets. On September 16, they opened up production at their downtown Detroit plant, and also won a court injunction that limits the number of pickets at the north plant's main gate to ten.

None of this would present an insurmountable task to a strike leadership com-

reporters searched for "peace-loving" strikers who they hoped would denounce the Strike to Win Committee. They found instead long standing Detroit area union members, including "outsiders" from the UAW, wearing bandannas and full-faced ski masks. The workers pointed their fingers squarely at the cops, and the media hysteria began to wane a bit.

A Race Against Time

Saturday night pickets since Labor Day weekend have so far produced more of the same: clashes between strikers and riot-geared cops, with the bureaucrats assisting the cops in clearing a path through the lines only after several long hours of stand off.

The company is certainly finding the whole affair a rockier road then they had first anticipated. Other corporate bosses in the area undoubtedly worry that their own staid "labor relations" may soon be effected with the spread of this new fight-

mitted to winning. The injunction could simply be defied with continued mass pickets. Many workers are aware that. Detroit teachers won a bitter strike in 1992 by openly defying a judge's back-to-work order. Properly mobilized, the striking unions and their supporters would easily have the numbers to shut two newspaper plants. And if the scab workforce can't get in to produce the paper, the helicopters would have nothing to fly out with.

Detroit's black community has no love for corporate America but does have a special fondness for bold working class fighters. As labor's natural allie, it could be mobilized by the thousands if strike leaders wanted.

But the union bureaucracy frankly fears that winning this struggle in such a big way would only embolden the rest of the working class to begin fighting likewise. Thus they are steadfast committed to restraining things. With each passing day, they more boldly try to demobilize and demoralize the pickets. On September 16, the Teamster bureaucrats demanded that pickets leave the plant gate lines and join in an idiotic car caravan around the plant. The result? A bunch of traffic tickets and an open scab plant!

It is now a race against time to build a new strike leadership. The Strike to Win Committee continues its fight and is stressing the need to ignore ("bust") the injuction. The group says also that the strikers should democratically elect picket captains and other strike leaders committed to building the mass pickets. It calls on the unions to bargain jointly and not return to work until members in all six striking locals have ratified contracts my majority vote. The members of the Strike to Win Committee have shown terrific courage against the police on the picket lines, and a remarkable tenacity in fighting for the strategy that would win this strike. Their work has set a sterling example for other union members and working class political activists around the country.

High Stakes

The stakes in this fight are exceptionally high. A uniondefeat would devastate the lives of the strikers and theirfamilies, of course. But it would also have a terrible impact onthe spirits of all Detroit labor. A

victory could embolden the entire workers' movement, and act as an example of what workers everywhere need to do as they are confronted with the tidal wave of cuts in their living standards and rights sure to come over the next few months and years.

Detroit's corporate elite, for their part, may fear the strike, but they undoubtedly see defeat of such a big action as an important pre-emptive assault against a possible rising tide of trade union militancy over the coming months. In the bosses' terms, American labor is going to have to swallow some pretty strong medicine soon; better to begin doing it now before it is ready to fight en masse.

This growing warfare between society's two major classes is the death knell of the American labor bureaucracy, which has made its living in the era of American class peace. That era has now come to an end. If labor is to survive, let alone go forward, the labor statesmen of yesteryear must be shown the door at the union hall.

The fight of our lives brews. We must enter it with a new leadership committed to a program that can achieve victory. Labor can win strikes by mobilizing mass pickets and shutting scab production! Labor can win big social and political gains too by breaking with the Democrats and building its own mass workers party!

Solidarity Actions Needed Now

When it comes to other workers around the country supporting the Detroit strike, the same issue of fighting the bureaucracy confronts us. If militant union members and supporters wait for their union officers to organize the necessary solidarity actions, they may well wait until hell freezes over. The rank- and-file must take the initiative immediately!


The bureaucrats are talking — its mainly idle chatter so far — about a possible regional or national mobilization to Detroit. Members need to force the issue and begin immediately organizing weekend caravans to join the Saturday night mass pickets.

The two struck papers are owned by two national media chains — Gannett Inc. and Knight-Ridder Inc. Gannett owns USA Today. Labor and its supporters in other cities must hit these companies with pickets and mass protests on a regular basis. Sympathy strikes at other Gannett and Knight Ridder businesses should be our goal.

This is the age of high technology and incredible concentrations of corporate wealth and power. The bosses fight as one, with well worked out national and even international strike- busting plans. The workers movement must do the same.

The Detroit newspapers strike is a pivotal issue for the entire American workers movement. Labor everywhere must give it every ounce of support we can. And we must adopt its militant tactics in all of our struggles. We need to unite and fight for our very rights to work and live! We need to strike to win!

It was men in shields with billy clubs and guns against pickets armed only with sticks and paper signs. But in the end it was the cops who were forced to retreat. For a few minutes the pickets even controlled the north-bound highway, shutting down traffic.

It took the union bureaucracy to do what the cops couldn't by themselves. First, officials from the plant's Teamsters Local 2040 made direct appeals to the pickets to stand aside and do "as the cops asked." But this was met with a stony and embarrassing silence. Next, they tried quietly convincing some of the more ambivalent picketers into leaving the driveway. There were just enough pickets to begin with, so when a few bowed out the cops saw that they had a second chance. This time they broke through, and thanks to the union chiefs, a huge herd of scabs got in and the papers got out.

For the rest of that night, and over the next several weeks, the bureaucrats put everything they had into stopping further

mass picketing. It was "adventurism" they said, that would lead only to a court injunction limiting the number of oickets. Their policy

instead? To ridiculously self-impose the same limit on pickets, and divide up the strikers into groups at each of a myriad of distribution sites throughout the metro area. The result was that within a few days the company was putting out hundreds of thousands of scab p apers. But the bureaucrats' treachery went even deeper. In the months before the strike, newspaper carriers had been trying to unionize and thus fight the consolidation of their routes. But the Teamsters and other newspaper union did nothing to help, even falsely telling their members that a carriers union would put some of them into supervisory classification and hence out of the union. Even after the strike began, they offered the carriers nothing! Evidently the bureaucrats' real fear was the tra pressure from below an additional several thousand new union members would put on them in a

In an equally despicable move, the carriers' organizing committee "leadership" refused to respect the strikers' picket lines. Needless to say, that was the end of their union- organizing efforts. Many a carrier threw in their lot with the strikers anyway. But those that were convinced to cross the lines became the nucleus of company's then-fledgling scab distribution system.

Dismantling mass pickets, helping the cops scabherd, and crossing picket lines again the trade union bureaucrats show ve earned the reputation as the "labor lieutenants of capital. In Detroit, within a matter of days, they had turned an outstandingly favorable situation for the striking unions into a difficult fight. That is how things remained throughout the rest of July and into early August.

Labor Day Weekend Begins

By mid August it was becoming cleared to many strikers that leaving only a handful of pickets at the main scab plant and instead trying to stop the scab distribution system was simply not working.

Increasing numbers of militants gradu-

ally began to come out to the North plant to beef up the lines on Saturday nights when the critical Sunday paper is produced. Union officials were having steadily declining success in convincing their members to leave and picket elsewhere.

A much larger than usual picket line on Saturday August 12 delayed production for two hours, before the cops, again with the help of the bureaucrats, got the scabs through. The lines were even bigger on the next Saturday, August 19, and this time the cops were driven back across Mound road in a scene memorable of the first night of the strike. Again the bureaucrats and cops eventually prevailed, but not before the point had been made that mass picketing was back in season.

Another critical advancement during this period was the organization of the Strike to Win Committee, comprised of a growing number of rank-and-file strikers, members of other unions, and youth supporters of the strike. This writer is also involved, representing the Working Class Organizer newsletter, as are political supporters of the Revolutionary Workers

The Strike to Win Committee really took the lead in fighting to build pickets and oppose the bureacurats sell-outs right from the start. They were on the pickets lines nightly and at every union meeting. As an August 16 flyer by the committee put it, "Every week it becomes clearer that there are two sides to our strike. On the one

> hand, strong rankand-file support for the strike and militant workers using militant tactics fighting in every way they can for the strike to win. On the other hand, union leaders treacherously calling off long-

promised mass picketing, some Teamster and other union leaders breaking up union pickets in order to get scabs through ... We must reject the 'role over and play dead' policies of these union leaders and spread the militant tactics of the workers who have been standing up and fight ing to win since the first night of the strike."

The rekindling of the mass pickets and the creation of the embryo of a new leadership — this set up the events of Labor Day weekend. And the Labor Day weekend events gave the strike new life.

On the Saturday of Labor Day weekend, the AFL-CIO officialdom finally felt it had to organize a mass march from one of the nearby UAW local halls to the scab plant. But as one official later admitted to the media, the bureaucracy's hope was that the papers would be out by the time the rally arrived and the event would thus merely "symbolize labor solidarity."

What happened instead is that several hundred pickets as well as the Strike to Win Committee showed up early at the plant and held off the scabs. Still stinging from their battle the week before, the cops failed to get up the nerve to come across the road. When several thousand union marchers finally arrived on the scene, the plant gates were sealed.

When it comes to betraying the union membership, however, the bureaucracy never gives up without a fight. Their next actic was to try to turn the mass picker into a "non-violent civil disobedience" Among several hundred unionists that had bussed in from across the country, were a number of "marshalls" who - absurdly enough — were urging people to sit down 'when the cops come across" and "let them to drag us to the paddywagons".

But Detroit pickets would simply not permit this. "No" they flatly told the marshalls. "Absolutely not." Many blankly stared when they first heard the plan, not believing their ears. Then, after hearing a marshall's windy explanation: "You mean

you just want us to sit down? That's crazy!" Some just pointed at the cops armed to the teeth, and shook their heads. "We'd just be giving them the gate. So what's the point?!"

In the end, they wouldn't even allow the marshall themselves to sit down, telling them to go home if they couldn't do something positive. Sizing up the situation from across the street, the cops wisely chose to stay where they were.

Later that night, at about 3 am, a scab 'semi' made a botched attempt to smash through the chained-shut back gate of the plant and literally run over the picket line there. The cops had refused to protect the back gate from the start of the strike, and so the pickets now had a completely free hand. The end result was three destroyed scab delivery trucks forged into a barricade on the driveway leading up to the gate. This was the first of many barricades that picketers were to build during this strike

In the end, the cops did not come across on Mound Road until pickets had dwindle to 40 at 8:30 the next morning. Those picketers who stayed all night did so largely under theassumption that the union was organizing a replacement shift for the morning. No second shift ever material-

Pickets at the plant were tiny throughout Sunday due to picketers exhaustion as well as their anticipation of another possible mass action Monday night, Labor Day. Labor Day began with the usual march of about 35,000 in downtown Detroit, sev-

eral miles from the Sterling Heights plant. The AFL-CIO a n d **Teamsters** bureaucracies felt forced to

organize a short mass rally at the main office buildings only a few blocks away.

But again at the microphone union officials gave no leadership. As the rally's numbers began to dwindle there were a few short words from the podium about "coming out again next Saturday night." Angry union members, on the other hand, chanted about shutting the plant down again that night. A Strike to Win Committee flyer called on workers to go directly to the plant to resume mass picketing. One striking Teamster Vice President, however, suggested that people "enjoy the holiday" and relax with their families. Of course, the bureaucrats also paraded out the usual group of Democratic politicians to profess their pro-labor sentiment. The leading liberal Democrat US Congressmen, and former member of the now defunct Congressional black caucus, John Conyers outdid them all, however, when he called for pressuring the INS to stop scabs from crossing the border from Mexico!

Throughout the strike, rumors have circulated that the scabs include many Mexican immigrants, and this has produced periodic displays of bigotry on the part of the mainly older white male strikers. The truth is that the vast majority of the scabs are themselves white American males. But that didn't stop Conyers, a supposed antiracist Congressional activist, from inflaming the racism and national chauvinism that has historically been the key roadblock for the American labor movement.

The need for labor to break with the Democrats and build a workers party has never been clearer! In both Detroit and Sterling Heights, the cops answer to Democratic mayors and city councils. One of the two struck papers, the Free Press, is in fact the liberal Democratic voice of the Detroit area. It has also come out recently that former "first-lady" Democrat Rosalyn Carter sits on the Board of Directors of the national corporation which owns one of the two struck papers!

THE WAR AGAINST THE SERBS AND THE NEW AMERCIAN FASCISM

To travel from New York to Belgrade and then back again is to pass from the enemy's camp to the beleaguered camp of a small oppressed people and then back again. But it is also to pass from a world of lies and war crimes to a world at war. The United States of America is at war with the Serbs. Everyone in Yugoslavia and in most of Europe knows this. But here it is denied.

Even when the most massive weapons of destruction

are launched from U.S. aircraft carriers in the Adriatic or from NATO warplanes 50,000 feet in the sky, each day brutally butchering civilians, — men, women and children — still, war is denied.

Even as one million refugees flood into Serbia in the greatest humanitarian catastrophe in Europe since the Second World War—and the U.S. deliberately withholds medicine, blankets, food, aid of any kind, in order to punish the Serbs as part of its war policy against not just the government, but the entire people — still, war is denied.

Even when an entire people, the Serbs of Croatia, are destroyed in a true act of genocide, carried out by the fascistic Croatian military, but organized and led by U.S. military personnel — still, war is denied.

These events are either not reported or under-reported, for the details are too gruesome, too revealing, and too convincing of America's guilt. For the truth is that America is guilty of war crimes in Krajina. In the Krajina, the Serbian region of Croatia, an entire people have been wiped out. Still, America's war against the Serbs is denied.

Instead, Americans are taught to stick their heads in the sand of television dope-operas like the O.J. Simpson "murder mystery." In this way, our cultural establishment successfully trains a country of ostriches how to accept, love and obey a government and a system that destroys smaller countries and peoples, encouraging them to kill each other, while at the same time spouting the most cynical lies about "peace plans," "democracy" and "human rights."

Fascism and the New World Order

We are living in a new age that we do not yet fully understand. What is certain is that our American institutions, our so-called "intellectuals" and "cultural leaders" will not explain it for us. Out academics, scholars, teach-

ers and journalists are as likely to tell us the truth as a whore on 12th Avenue is likely to resemble a nun. Their job is to justify and legitimize the status quo, or simply to obfuscate the mendacities of the power-brokers in Washington or Wall Street. Hence, you get the verbal gymnastics of a Professor Dobos who does fine tricks to convince people that Islamic fundamentalism and Croatian fascism are nothing to worry about, and that all the while America is really on the side of the Serbs.

But people in Belgrade (and I'm sure in other countries, as well; whereever entire peoples are threatened by American military aggression) are beginning to theorize about this new age of darkness that humanity is now entering, this new age since the end of the Cold War that is sometimes referred to as the "New World Order."

I arrived in Belgrade on August 29th, the day before the NATO bombings of the Serbs began. I was there throughout the two weeks of massive bombings. I saw the massive destruction of civilian villages and the atrocities committed by NATO against the Bosnian Serbs on Serbian tv and in the newspapers. On one day ten infants were blown up by NATO jets. On another a small Serbian farming village that unfortunately lay on the road between Belgrade and Pale was destroyed, killing the inhabitants and the livestock. I was at the Serbian parliament and saw that miserable wart of a man Richard Holbrook walk out of his meeting with Yugoslav President Milosevic, acting as if he owned the building, the city and the country. I heard the reports of threats by Holbrook and the U.S. of the bombing of Belgrade. And I saw the mood of the people of Belgrade and Serbia undergo a transformation during the three weeks I was there, from a feeling of betrayal and sadness to one of ever growing outrage and hatred for America and its Western European allies. I saw demonstrations of thou

Newspaper Strikers in Detroit Build Mass Pickets! Active Support Needed Now from Across the Country!

Detroit. September 22.

A strike by 2500 workers against Detroit's two main daily newspapers and their operating agent, the Detroit Newspaper Agency, has now entered its tenth week. Company efforts to develop a full scale scab operation have led strikers here to build some of the most massive and militant picket lines seen in the midwest in decades. Bloody battles between pickets and cops are now a regular scene each Saturday night, as the six striking unions attempt to shut down the production and distribution of the Sunday paper.

The strike has certainly not been wont for support from the overwhelmingly working class Detroit metropolitan area. Hundreds and sometimes thousands of other area workers, especially United Auto Workers (UAW) members from the many neighboring auto plants, regularly join the mass picket lines. For most this has become a fight "for all Detroit labor." And although the company, with police help, has been able to get many scab papers onto the streets, actual sales are widely recognized to be pitifully small. In a desperate attempt to buoy the commitment of its greatly reduced list of advertisers, the company has instructed scabs to continue delivering papers to tens of thousands of people who long ago canceled their subscriptions in support of the strike.

The strike's achilles heal, however, has been its lack ofleadership from the officials of the six striking unions. The "Council of Newspaper Unions" tops, including those from the two Teamsters locals, without exception refuse in practice to organize the mass pickets in a serious way and shut scab production down. At times they even sabatoge and openly destroy the pickets lines.

In some instances, thousand-strong mass pickets organized by the rank-and-filers and their supporters have succeeded in shutting the plant throughout an entire

night. But the failure by the union officials to mobilize even a few hundred replacement pickets for the next morning only puts the plant gate back in the hands of the company again.

The result is that the scab operation survives. And a potential quick union victory has turned into a long drawn-out affair that could potentially lose. In a war between a multi-million dollar corporation and its wage workers, time is always on the company's side.

Initial Betrayals

Newspaper workers were already laboring under a wage freeze when the old contract expired in the spring. The unions had accepted the freeze as part of a "joint-operating agreement" (or "JOA") between the two "competing" papers. Under the terms of the JOA the two also put out combined Saturday and Sunday papers.



This in turn led to the consolidation of numerous union jobs. At the negotiating table before the walk-out, unionofficials were willing to give the company just about everything to avoid the strike. But company

demands for cuts in wages, hours, health care and union rights simply went to far. The company also planned to consolidate the routes of several thousand non-union "carriers" who deliver papers to subscribers' homes or sell them on the street. A proposed new "agency" system would have end the jobs of possibly half thecarriers as well as many unionized drivers.

So on the afternoon of July 13 the strike commenced. A rally that evening by union chiefs at the downtown Detroit newspape office buildings was long on tough-sounding rhetoric but short on specific instructions. Luckily a militant core of rank-and-filers new just what to do: By dark hundreds had gathered in front of the "North" plant in neighboring Sterling Heights to keep scabs out and each papers locked in

and scab papers locked in.

Normally the North plant plays second fiddle to the company's main plant in downtown Detroit. But for the first nine weeks of the strike, the company would keep the downtown plant shut, and make the North plant the key to its scab production. Just a few hundred pickets was all it took that night, and the company was quickly in trouble. Cops clad in riot-gear from Sterling Heights
