

# **JDO Threatens CSI Students**

**Student Government Votes To Re-Invite Leonard Jeffries**

tudent Government has decided to bring the controversial Dr. Leonard Jeffries back to the CSI campus as part of the rescheduled CUNY in Crisis forum. After the abrupt cancellation of the originally scheduled lecture, the forum has been rescheduled for Thursday, April 2nd at 6pm in the Center for the Arts building, Dr. Jeffries and CUNY student attorney Ron Maguire will once again speak on the topic of Open Admissions. The decision to re-invite Jeffries was reached last Thursday, on March 12th, when Student Government convened an open mic meeting in the Green Dolphin Lounge. At the meeting, each member of the Student Government and the entire CSI student body was given the opportunity to express his or her feelings on reinviting Dr. Jeffries. After listening to the feelings and opinions of some of the more than one hundred students, faculty, staff and administration in attendance, Student Government took a vote on whether to reschedule Dr. Jeffries' lecture on Open Admissions. The vote was 4-3-1 in favor of having Dr. Jeffries return to campus.

On March 16th, just four days after this Student Government meeting, the CSI campus was bombarded with phone calls from an organization calling themselves the Jewish Defense Organization (JDO). A man who identified himself as David Seigal representing the JDO telephoned The Banner office. The resulting conversation began with Mr. Seigal inquiring about placing an advertisement in the newspaper. He offered to place an advertisement criticizing the Hillel at CSI club for not protesting Dr. Jeffries' appearance on campus. In place of protesting, the Hillel Jewish student club decided to celebrate Judaism at the CSI Club Fair in order not to provide Dr. Jeffries the attention and publicity which he lives and profits on. When The Banner informed Mr. Seigal that the paper would not print an advertisement that degrades and belittles CSI students, he continued chastising Hillel for not demonstrating when Jeffries came to campus. He called Hillel and other CSI students cowards for not taking more direct action against the Jeffries lecture. The conversation concluded by him giving out the official JDO hotline number.


Immediately following this phone call, an editor called this hotline number. This is a transcript of the JDO's answering machine message:

(Note: The CSI Student and Club Advisor's names have been removed for their protection)

"The College of Staten Island just had Leonard Jeffries, the viscous Jew hating pig. The Hillel, led by [Club Advisor], Jewish student

organizations people like [CSI Student], sit on their hands like cowards and hand out cookies. They don't demonstrate against a viscous Jew hater, who calls Jews skunks. They don't protest the anti-Semitic rhetoric of Jeffries. They don't take to the streets. They don't do the same thing that Black students would do if the Ku Klux Klan was scheduled to speak in the same school. Tell these cowardly Jews that run Hillel to get off their hands and take to the streets to demonstrate or the Jewish Defense Organization will OUR way. We're tired of Jewish cowards sitting on their hands during the Crown Heights pogrom, during Leonard Jeffries' numerous visits to spread his viscous Jew-hatred all over the country. The JDO is taking action, we're putting the Hillel directors on notice: you better take to the streets, you better rally, or the next demonstration will be blasting you, for your cowardice. We say enough Jewish cowardice and enough weakness and enough confusion. The [CSI Student] and the [Club Advisor] are the same kind of Jews that will lead us to the cattle cars should, the time ever come. We've got to have action and not weakness."

Following this phone call, the CSI student named on the hotline was contacted. The student was already aware of the message on the JDO's hotline and then told a Banner editor that the Club Advisor had received a phone call threatening to demonstrate on the Club Advisor's front lawn. The Club Advisor was so frightened that he/she had to call the police.

A while later The Banner received a second phone call from an anonymous source, who claimed to have been at a JDO meeting the night before in a Manhattan synagogue. This source claimed that there were over 700 people of Jewish and Italian descent as well as representatives of the Italian American Civil Rights Coalition at the meeting. The anonymous phone caller stated that the leader of the IDO, Mordechai Levy, came in with approximately fifty bodyguards

and spoke to the audience for over an hour. Levy reportedly called Jeffries a black Nazi and called for his "head". He reportedly spoke about Jeffries' recent visit to the CSI campus and that CSI [Student Government] had re-invited him. He insulted CSI president, Marlene Springer and called for a rally on her front lawn. Springer's home phone number was also given out during this meeting. Lastly, Levy called for Jewish and non-Jewish students to hold a massive rally against Jeffries when he returns to the CSI campus on April 2nd.

Also at the meeting was the Italian American Civil Rights Coalition which followed Mr. Levy's speech with a 45 minute lecture. This group was reportedly also appalled at Jeffries' impromptu speech at CSI. The caller allegded that the coalition proposed contacting CSI Alumni in an effort to convince them to cut off funding and contributions to CSI, to pressure CSI president, Springer to cancel Jeffries scheduled reappearance.

On the morning of March 17th, an editor of The Banner once again called the JDO hotline to discover that a new message had been recorded. The following is the official JDO hotline recording as of March 17th:

"The College of Staten Island is planning to have Leonard Jeffries a vicious black Nazi who believes that Jews and Whites are devils. He hates Italians as well and calls them the lowest of the white devils. What kind of a college invites a vicious Jew hating, white hating, pig like Jeffries and worst of all offers to pay him money. He shouldn't be invited to speak He shouldn't be given a nickel He should be banned from the campus. We're going to be having protests at the home of the President of the college if she doesn't ban him. Her name is President Marlene Springer, you can call her at (718) XXX-XXXX that's her home and tell her how you feel. Or you can write to her at President Marlene Springer 99 Bull\*\*\*\* St. Staten Island NY 10304 Please let your voices be heard. You can reach her office at (718) 982-2400 and give a piece of your mind and let them know that your money is not going to go into that black Nazi's

pocket. No \$1,000 for Jeffries or any other hater. Would the campus allow a Klu Klux Klan representative to speak. And as far as the Jewish students go they have to learn they've got to take to the streets demonstrate angrily stop acting like clowns and cowards who are only capable of giving out milk and cookies as a way to protest Jeffries. Leave your name and number at the tone You've reached the Militant Jewish Defense Organization if you want to volunteer for our protest leave your name and number at the tone. you don't have to be Jewish to hate Jeffries, Shalom. Leonard Jeffries belongs in a trash can and not in a campus."

Responding to the JDO hotline messages, Gene Martinez, head of CSI security stated, "I have no response. . . It [the JDO hotline message] speaks for itself." Both CSI President, Marlene Springer and Vice-President for Student Affair, Carol Jackson, both failed to return phone calls placed by The Banner.

Is Dr. Jeffries speaking at this campus so important that the Student

Government should endager the lives and mental health of CSI students and faculty? Is Dr. Jeffries the only qualified speaker on Open Admissions? These

are the questions asked to students and their replies were: Andre Woods-"No, Student Government invited a well

known racist without informing any communities that are not African American. They won't take responsibility for their actions, they don't feel that they didi anything wrong. Then they go and hide behind the First Amendment Rights. They are so willing to sequestor and surpress others. There are many other people that could have come and speak about Open Admissions, Leonard Jeffries is not one that should have been invited. They (Student Government) decide to invite a well known racist, against the will of our student body- that says alot about our Student

Government."

William Wharton (SG President) "I don't think it's endangering the lives of any student. The JDO is a very small, far right operation and this is the way they operate. There are many qualified speakers on Open Admissions and Dr. Jeffries is one of them."

Wayne Peacock- "Not at all. There has to be eight thousand other people that were viable and appopiate to speak No white racist would have been allowed in here, I'm not saying that ones better than the other but if your going to let one pig in, you got to let them all. You got to be an equal opportunity racist showcase . He shouldn't have been here, even though he didn't speak on race, he shouldn't have been here. He shouldn't have been paid. If he was here for free it would have been bad, but the fact that some idiot decided to pay him, and everyone else went along with it I think that's terrible. I'm embarassed."

Rowland Beoku-Betts - "No I don't believe Leonard Jeffries is the only person that could talk about Open Admissions and cultural diffrence, because Marable came and spoke about it and there was no riff about it, I don't believe Leonard Jeffries is the only one."

Although JDO is a small, right-wing organization, it is still one that has threatened the lives and mental health of CSI students and faculty. Even the most remote possibility that these threats might be carried out makes them dangerous. No speaker is worth that risk! The fact that the JDO has gone to such lengths as to research Hillel, get Hillel's academic advisor's name, address and home phone number, threaten these people with demonstrations at their homes, and then do the same to President Springer, make this organization one that should not be taken lightly. Campus Security can help these members of the CSI community-while they're on campus-but what do they do when they're off campus? These are the situations that Student Government needs to consider, as well as the fact that it might be best to recind Jeffries' invitation.

# **Jeffries speaks on campus**

The tension ran in high waves last Thursday, March 5, at the Center of the Arts building (1P) on what was supposed to be a formal open forum about the CUNY struggle to keep open admissions. The controversial Dr. Leonard Jeffreis arrived at the College of Staten Island, after being invited by the Student Government, to present a lecture concerning open admissions in CUNY history. A large crowd of students gathered at the main atrium of the 1P building waiting for Dr. Jeffries' appearance at the Williamson Theater.

"The reason why I came here was to talk about open admissions and its historical content." It was the straight answer from Professor Leonard Jeffries to some relevant concerns of students who despised his presence at CSI. Jeffries, who did not know that his presentation had been canceled at the last minute by the Student Government, due to the fact that History Prof. Calvin Holder had canceled as moderator of the open forum on the day of the event. Jeffries arrived at the College of Staten Island around 2:15 in the afternoon. The arrangements were set for him to have a informal lecture in the North Administration Building, 2A, room 106. Students, the few who did not leave the building, transported themselves from the Center of the Arts Building to the Registrar room, as soon they learned that Jeffries had arrived at CSI.

Jeffries had been under the disapproving eye of a large sector of the student community who highly rejected and opposed his presence at campus. One of the several issues raised were the concerns of the racial epithets hurled against Jewish people made in his former speeches . Different concerns of the CSI community had come up with arguments and issues against Jeffries sealing a label on his forehead of being a racist and an anti-Semitic person.

Jeffries put a lot of emphasis on the people who degraded the African American community. He, also did not hesitated in accusing Hollywood as an enterprise that has dedicated its entire existence to creating a negative image of black people as a bad influence to American society. Even though the main focus was open admissions at CUNY, Prof. Jeffries delivered a well developed and rich speech about history on the slavery trade. "The question of struggle for open admission was not only an admissions question, for me it was more than that. It was an opening up of the real World to the people of the World," adding "The City University of New York was opened for the poor people not for the rich people. When we, the Black and Latino opened CUNY for open admissions, we opened for you too, the Greeks, Italians, and Irish"

Dr. Leonard Jeffries' appearance at the College of Staten Island had created a hostile and tense environment among the students, specially amongst the black and Jewish community. "I cannot be walking through campus without being called racist" an African-American-Latino Student Government senator, said. The Student Government

has been severely attacked by different students organizations, specially Hillel, the new student organization on campus. Several Jewish students gathered around the halls of the Center of the Arts building were Professor Jeffries was supposed to appear, showing their disagreements and concerns of his presence at campus. "There's no space in this campus for a racist," said Steven Garfinkle. "I am very disappointed at the Student Government. They didn't consult the students about Jeffries coming to campus. They (Student Government) have neglected us, " he concluded. The Banner had pub-

lished an article about the public controversies of Leonard Jeffries in the past. The issue had raised deep protests and criticisms from the students of CSI. "Couldn't they [Student Government] bring another person to talk about open admissions?" wondered one student. Jeffries' response to the Banner article was simple. " When people raised questions of Jews are skunks, we were talking of a private situation in 1992 in a roast, where people were making fun of the imperialism that came into Africa. We were talking about the people like the Germans, British and Jews imperialists that wanted to make a division in Africa and wanted to take a piece from Africa." adding later, "If I find someone attacking my people I will expose them. like or not, that's why I am here for, to defend my own people" He denied being a racist person or being an anti-Semite. He recalled the time when he was in college and one of his friend was a fraternity brother, Mike Moscaw who happened to be Jewish. "I have a lot of friends that are Jewish" he said. "Don't let them fool you with the anti-Semitism thing, I'm here for all of you!" He responded energetically to his detractors.

In spite of these statements, a tense moment was lived in the room when a Jewish student asked him about the Holocaust. Jeffries inquired back asking her of which Holocaust was she talking about. He will say later, "When you come to African people you come with humility, when you come to African people you come to apologize for what other white folks did in the name of whiteness," some students applauded his

[Editor's Response,

The Banner is the official newspaper of CSI and as such, has an ethical responsibility to report current events to the students, faculty and staff of CSI. Every week, the editorial board of the paper meets and discusses the issues affecting CSI students and decides which news item is the most relevant and significant news piece which students should or want to know more about. After interviewing several students, it was obvious that the debate regarding Dr. Leonard Jeffries was the most crucial issue which students requested further information on. The editorial board unanimously concluded that the front cover of the paper should contain an article on Dr. Jeffries because it was the most appropriate news item relating to students at the time.

Granted, there was some debate among the officers of The Banner about whether placing an article with an eye catching headline would play into the controversial myth of Leonard Jeffries. However, a majority of officers felt it was the paper's right and moral obligation to the students, the college and the community, to report what is probably the most controversial speaker to ever speak on campus. Our intention was not to provide more publicity for Jeffries nor to prevent a discussion on Open Admissions from taking place, as Dr. Jeffries concluded in his impromptu speech. Our intention was to inform the student body on the history of Dr. Jeffries and to report the varied opinions of students on both sides of the argument. Had we completely ignored his appearance or buried the article in the latter pages of the paper, we feel that we would be violating our journalistic integrity and the trust which CSI students place in The Banner.

# **Student Government Meets With President Springer**

Once a month, CSI President Dr. Marlene Springer meets with the Student Government. This month's meeting on March 4, was quite a bit little more animated than usual since it ranged over issues from open admissions to the coming visit of Leonard Jeffries. It was attended by seven Student Government members, approximately 25 concerned students, as well as Vice President for Student Affairs Carol Jackson, and Director of Student Life Marla Brinson. Noticeably absent from the meeting was Student Government President William Wharton.

Dr. Springer opened the meeting welcoming all in attendance and stating "the purpose of these meetings are for me to answer your questions and find out student's ideas, and try to enlighten your inquiries or find someone who can." The first issue brought up was open admissions, a topic of concern to many students. It has been harshly debated within the CUNY Board of Trustees in recent months and is a critical issue for CUNY as it is the core principle on which the university was founded. The debate has

reached new levels since Mayor Guiliani called for change in the CUNY policy in his State of the City Address in January. "I can't make any predictions on how this debate will end," said Dr. Springer. "I don't know what will happen—no one does. As for standards I don't want any that will push out large numbers of students from the college."

Remediation, another hotly debated issue within the university, was also brought up at the meeting. Senator Jo Ann Gallo asked "Are we or will we be cutting back remedial classes in this school?" The President responded by saying, "I think the plan that goes through the Board of Trustees will be for fall and/or spring immersion programs that will help students move through remediation more quickly.

"But I have some questions about the proposed plan," said Springer. "Whether or not students will get financial aid for these immersion programs or not is a big concern for me." The President also made it clear that student financial aid is crucial to her announcing that "next Monday I'm going to Albany to lobby for student financial aid."

Concerned, Senator Gallo followed up her initial inquiry by

asking if all students would have to do an immersion program. "I asked the same question of the Board of Trustees and in the Council of Presidents, " said Dr. Springer. "Our students have full lives working full and part time jobs and if these programs are in the Summer what of child care for students with children?" The Council of Presidents is body of all CUNY College Presidents which meets regularly to discuss university policy.

Another issue that was brought up was space on campus for clubs. Club Commissioner Morgan Healy and Deputy Club Commissioner Jo Ann Gallo brought home the need for club space, stating "clubs deserve more respect" and "they are part of the academic health of the college." The President said that the issue was a priority and that it was being looked at. At the suggestion of Healy and Gallo, the space issue will be looked at with the far northern academic buildings in mind. The President said that aca-

demic needs will also be assessed when looking at the far "N" buildings and that academic need must take priority.

The hottest issue of the meeting was the lecture scheduled for the following day by Dr. Leonard Jeffries, sponsored by Student Government. Steven Garfinkle, a student seated in the gallery asked, "What is the administration's stance on Leonard Jeffries appearance?" To which Dr. Springer responded, "I did not invite him nor would I have invited him. Given his past, it's reprehensible. I find him insulting both to me personally and my children. I and my administration are against this."

Garfinkle went on to say that "Student Government is using money capriciously for their own purposes and there is also risk of violence."

Dr. Springer responded by saying that "the first issue is an issue for the students. You elected them that is something you need to address to them." Dr. Springer said that there was little risk of violence. "There is no indication of that, a comprehensive

security plan has been worked through and if needed the police department can be on campus in minutes," she said.

Mark Grey, who chairs the committee for Student Government which invited Jeffries, questioned why students where so concerned about this speaker and even placed blame on students for not taking an interest earlier.

"You saw students were against this," responded Garfinkle. "I came to your office and told you and many others did too."

"Lots of people did," one student shouted. "You could have called an emergency meeting and changed the vote and canceled Jeffries but you didn't. You had the 48 hours necessary to change this and you did nothing." Dr. Springer then urged everyone to calm down. "I ask that all of you help us get through this civilly," she said

Senator Jo Ann Gallo criticized the members of the Student Government who voted to bring in Prof. Jeffries by saying "Much of this, all of this could have been avoided," she said. "You and others chose not to avoid it and now we have this."

Student Government Senator Sheneka Aspinal in explaining the Student Government's decision to invite Jeffries said, "No stu-

dents ever come to our meetings and express themselves. It's not our fault no one takes interest."

As tensions flared, Senator Diane Isaac stated, "We don't want violence. I voted that if the Student Government represents the entire panorama of CSI, we should support Neil Schuldiner's view and not support bringing Jeffries to come and speak," said Isaac. "We did not even have background information." Schuldiner, the SG's Finance Commissioner, objected to Jeffries coming to campus and presented arguments and background material to try dissuade SG from voting to invite Jeffries.

"I want you to understand violence will not solve anything—what is important is that tomorrow we will all breathe the same air," said Isaac. Her comments seemed to bring an air of calm to the meeting and tension subsided.

# **God's Trombones- A Musical Inspiration**

From Williamsbridge in the Bronx to the our own Sandy Ground, African-American preachers have provided words for their parishioners to live by and as food for the soul.

All over the city and country church pews are filled every Sunday to sing, praise and listen to miracles found in the sacred stories of the Lord. The performance of God's Trombones was its own miracle. It saluted preachers and the book from which those words come from. It was a wonderful way to culminate the Black History Month celebration here at the College of Staten Island.



#### With only a simple set of chairs, plants, a bench

and a few lights, God's Trombones captivated the small crowd at the Performing Arts Center. The musical, written by James Weldon Johnson, was as impressive as his Who's Who passage in the program for the show. The first black person admitted to the Florida Bar Association and later executive secretary of the NAACP, Johnson was taken by how ministers would transfix and electrify their audiences to shouts and praise. He was so in awe that he wrote God's Trombones and CSI was lucky enough to see an all-star cast perform it.

From the beginning of the musical, the audience was invited to sing and holler along. Rev. Sister Rena Pinkston, played by Tony-nominated actress Theresa Merrit, welcomed the crowd to the mock service and song. Merrit gave one of the night's most powerful and reverent performances. She was followed by Joseph A. Walker, who played Rev. Bradford Parham. He began the sermon with the Creation story and the rest of the cast members continued with other stories, such as the First Sin and Revelation.

Merrit has been with God's Trombones since its beginning at the Astor Theater in the early sixties. The National Black Touring Circuit, Inc., the group that puts on the production, has performed God's Trombones all over the United States. While explaining the performance, Merrit said that the preaching of God's Trombones is much like the preaching in the movie The Apostle and that many of the events that happen today can be reflected in the stories of the Bible.

The music from God's Trombones was phenomenal. Debbie Blackwell-Cook, who plays Sister Odessa Jackson, one of the members of the choir, gives a bright performance, holding a note for over fifteen seconds in one of the musical's gospel pieces. Blackwell-Cook gives credit for her musical abilities "to the Lord and lots of vocal lessons."

Cliff Frazier, who plays Rev. Washington says the music of God's Trombones is "astrong and positive, emphasizing encouragement while bringing each sermon to a complete picture." Songs like "Let My People Go" were hailed with cheers Saturday night.

Del Flores, a member of the audience, reveled in the performance. "I have never seen anything like this," she said. "The music and monologues were wonderful. There should be more productions like this on Staten Island."

If you would like to see the National Black Touring Circuit, check the events listing for any of the CUNY schools. They are regular visitors to CUNY. Other major events include the new pop singer and songwriter Shawn Colvin, winner of a recent Grammy Award, rhythm and blues legend Roberta Flack, and smooth jazz pioneer Spyro Gyra. It is a lineup that is worthy of musical inspiration.

# **Great American Meatout**

On March 20, 1998, the first day of spring, the Farm Animal Reform Movement (FARM) will be sponsoring its 14th annual "Great American Meatout". Patterned on the American Cancer Society's annual "Great American Smokeout", there will be educational events throughout the United States that will attempt to educate people about the benefits of vegetarian diets. FARM hopes that many Americans will sign the "Meatout Pledge" promising to "kick the meat habit", at least on the day of the Meatout, and to "explore a less violent diet." Hence, this is a very good time to consider the many important reasons for switching to a vegetarian diet:

1. Concerned about health? Animal-based diets have been strongly linked to many degenerative diseases, including heart problems, strokes, and various types of cancer.

2. Concerned about animals? Over 9 billion farm animals are killed for their flesh annually in the United States after suffering horribly in confined spaces where they are denied fresh air, exercise, or any satisfaction of natural instincts.

3. Concerned about the environment? The production of animal products is a major contributor to soil depletion and erosion, extensive pesticide use, air and water pollution, the rapid destruction of tropical rain forests and other ecosystem's, and potential global warming.

4. Concerned about world hunger? Over 70% of the grain grown in the United States is fed to animals destined for slaughter, while 20 million people die annually due to hunger and its effects. The U. S. is also one of the world's largest importers of beef and fish, and these imports are generally from countries where people are starving.

5. Concerned about resource scarcities? A meat-based diet requires up to 20 times more land and 14 times more water and energy than a vegetarian diet. Non-vegetarian diets also require vast amounts of pesticides, chemical fertilizer, and other resources.

6. Concerned about peace? Animal-centered diets, by wasting land and other valuable resources, help to perpetuate the widespread hunger and poverty that frequently lead to instability and war.

7. Concerned about spiritual values? Vegetarian diets are most consistent with religious mandates to act with compassion toward animals, preserve human health, help hungry people, protect the environment, conserve resources, and pursue peace.

8. Concerned about convenient, tasty meals? There are many delicious vegetarian dishes that don't involve extensive preparation or the fat, cholesterol, hormones, and antibiotics associated with meat.

So, for our health, for defenseless animals, for millions of starving people, for our earth and its resources, and for a more peaceful, just, and harmonious world, let's go vegetarian! And a great time to start is March 20, 1998, the day of the "Great American Meatout."

answer, others were utterly shocked, then he continued, "you don't come to me and throw your Holocaust over my business, because I got to tell you I got my Nazis, and my Nazis looked like you! My grandfather dealt with Nazis and his Nazis looked like you" Pointing at the female student, with a energetic voice of command, "and my nephews and grandchildren will have their Nazis and they will have to deal with it and they will look like you!!!" An enraged student fired back, "you are breathing pure hate!!!" "Yes I am breathing hate, because I'm talking about the death and destruction of the African people." It was his immediate response. A pregnant silence took over the room. "I'm gonna tell you this, I would rather have died in the gas chambers and ovens in the Holocaust the Germans put in place, than be in the situation where I have been worked to death for ever and ever, and my people have worked to death for generations and generations." addressing the student again, "You can talk about your death, but don't bring it to me. Take your death to the white folks that put it in place and carried it out " He concluded.

Nevertheless, Professor Jeffries said clearly that he was not antagonist of any religious group, but that he was not going to tolerate the ongoing massive destruction of the poor minority, he urged the students to wake up and rise and fight for their rights as CUNY students. He attacked the elite of rich people who have taken control over the American Society . He reiterated that they [the rich people] were the ones who have tried to racially split the students by creating all kinds of defamation against his character. Finally, in a cry for unity he encouraged the students to unite forces and stand together to in the fight for open admissions. Professor Leonard Jeffries will return to CSI on April 2 at the Williamson Theater to deliver his postponed formal open forum about open admissions in CUNY.







# **Sexual Do's and Don't**

# Exploring the twisted roads of sexual miscommunication and other intimate No-no's.

#### Part 1: The women

Is SHE really not in the mood or are you just terrible in bed? Is SHE afraid of trying new things or are you a twisted pervert? Maybe-then again maybe not. In 1990, the band was signed to Creation Records (London's one time premier label which also played host to Oasis' first albums) and soon was licensed to A&M Records, here in the States. The band's first album, Raise achieved great success within the college radio community and sold out dates nationally. Their second album, Mezcal Head didn't fare as well, and the band was dropped from A&M. The follwing two years proved to be quite the tumultuous ride for the band, which obviously put Adam Franklin (lead singer), Jimmy Hartridge (guitars), Stephen George (bass),

soon let go. So few majors were willing to take a chance on the band due to the bleak prospects many had for them. Independent labels soon realized that the album was ready and could be the band's chance at crossing over into mainstream waters. One independent in particular pursued the band, promising them unlimited support, proving that they would be the most successful band the label had signed ... which was true. The New York-based Zero Hour label won the final bid for Swervedriver, signing them to a three album contract.

Given the chance to grow over the last decade, the band has managed to veer slowly away from the "dream-pop" scene (which is now dead and evolved into "Space Rock") while maintaining the same sophisticated and lavish sound that launched their initial success.

# **The World On-Line**

Hey, use the internet to find lost friends! Someone found me just by reading this column, and contacted me via e-mail. Just thought you'd like to know. More on this a little further down.

The issue of copyright infringement on the web is very tumultuous. Some copyright owners, such as Paramount, who owns what is the most popular TM on the web, Star Trek, go after violators with a vengeance, sending letters from their lawyers demanding that they stop using materials copyrighted by Paramount. Others, such as Fox, don't go so aggressively unless the characters or company are being libeled. And then there's Comedy Central, with the hottest property on the internet, South Park. Many sites have popped up, dedicated to the show. Most of them have .GIFs and .WAVs from the show, but some have full episodes in Apple's cross-platform QuickTime, Windows .AVI, or Real Video format.

Comedy Central hasn't been having a problem with the South Park sites, until the full episodes started showing up on-line. While most publicly recognizable logos are usable by the public, because they are in the public view, and even more are in the public domain, any trademarked item may not be legitimately used by anyone other than the trademark holder with their permission. Paramount cracked down on the use of their Star Trek icons and shut down several fan web sites. There was a huge outcry, but many of the fan sites have shut down, and Paramount entered into an agreement with Microsoft to host a Paramount-designed web site, which is only accessible to users of Microsoft Internet Explorer (Microsoft IS the Borg). This is the fear of South Park webmasters. So far, CC has been sending letters, but has not issued an order to cease and desist to these sites.

Remember, if you are using graphics on your web site that were created by someone else, or are trademarked by a corporation, you are legally responsible for the content. If you use a company logo on your web site, and disparage them on that web site, you could be sued for libel and for using the trademark. Additionally you may have your web site deleted by your Internet Service Provider (ISP) for violating that user agreement you may never have read. While cases such as this are rare, http://www.adsucks.org, an anti-America On-Line (AOL) site was troubled by AOL by the use of the term 'America On-Line', and for the use of AOL trademarks and artwork. While this case has been resolved to the favor of the aolsucks webmaster, it illustrates what can happen when you confront a major corporation.

The next issue concerns censorship. Many free web hosts, including Geocities (http://www.geocities.com) have limits on the type of content that they may display. Among banned content, pornography, libel, racist, sexist, or other insulting language, or language demeaning to others.

AOL has an entire guide of terms and words that are deemed offensive by the corporation, and can result in an AOL member losing their account. Below is a partial list of words, and the policy behind them, that AOL considers 'vulgar:'

Guide Policies: Vulgarity Guidelines This section contains examples of vulgar, conditionally vulgar, and acceptable phrases

and subjects. Synonyms of these are usually unacceptable. Gender should not be taken into account; if "men on men" is not allowed, neither is "women on men". Asterisks and other symbols cannot be used to "mask" a violation if any letters of the vulgarity are still present. "F— you" is vulgar, but "my \*\*\* hurts" is okay.

Key: *VULGAR:* Unconditionally vulgar. *ROOMS:* Vulgar in room names or screen names.

ROOMS (SEXUAL): Vulgar in room names or screen names if possibly sexual. These words are only allowed in screen names or room names if other phrases clearly make them not sexual. For instance, a member may not create a room "Oral," but "Oral Roberts" is permitted. " Slaves here" is not allowed, but "Free the slaves" is. "Jimmy69" would be fine, but "Ilike69" would have to be deleted.

OK Acceptable. These words do not, in and of themselves, constitute vulgarity or sexual connotations.

As for Geocities, their policy is mostly geared toward blocking pornography. Below, a letter received by a geocities member now at <a href="http://members.tripod.com/~pel-lon">http://members.tripod.com/~pel-lon</a>, explaining why their page had been deleted from their system.

Dear Community Member,

Our guidelines have been carefully crafted to promote the free flowing exchange of ideas about your interests, activities, and hobbies, and at

the same time maintain standards consistent with the Internet community and the societies of the world at large.

We appreciate your support and participation with GeoCities; however, your homepage was inconsistent with our current guidelines and has been removed from GeoCities.

You are welcome to establish a new homepage within GeoCities at any time, provided that it complies with our content guidelines. We urge you to review these guidelines carefully before you set up a new homepage.

This just goes to show that your right to free speech on the Internet is limited and patrolled by the corporations who now control a system that was originally set up for educational and defense purposes.

An additional control, this one governmental, was instituted in the Communications Decency Act (HR1004/S314 and amendments), otherwise known as the 'CDA'. This law would have made the electronic publication of any form of pornography, words of hate, and anything else that someone could deem 'offensive' illegal. It places curbs on your first amendment rights, and as such, was believed to be unconstitutional. The Electronic Frontier Foundation, (http://www.eff.org) the American Civil Liberties Union (http://www.edu.org) and the American Libraries Association went to bat to protest this law filing a class-action lawsuit against the United States Of America. This law was struck down as unconstitutional by the 3rd US Circuit Court of appeals in June 1996. However, the Governor of Arizona has just signed a bill into law that limits Internet communications, and in February Senator John McCain advanced a "sequel" to the CDA: A new Internet censorship bill, "The Internet School Filtering Act", (S.1619), that would force federally funded libraries (and schools) to use software filters to censor their Internet connections in the name of "protecting children from pornography". Such filtering software does not actually perform as advertised, and in fact not only is physically incapable of blocking material that fits a particular legal definition such as "obscene", but also has been demonstrated to block numerous sites with no "obscene" or "indecent" content whatsoever, even as much as 99% of on-line material that is perfectly suitable for children. EFF believes this bill to be unconstitutional, along with the House version (H.R. 3177, Rep. Bob Franks) and the unnamed "CDA 2" sponsored by Sen. Dan Coats (S.1492). Both the McCain and Coats bills have cleared the senate Commerce Committee, which is the first step before the senate votes to approve or disapprove a bill.

On March 12, Sen. Conrad Burns introduced an amendment to S.1619, replacing McCain's censorship language with a simple certification requirement that allows local libraries to decide what material if any is "inappropriate" for minors, instead of trying to dictate this at the federal level. The Burns alternative does not require filtering or labeling software to be installed. However, theocratic organizations like the Family Research Council are urging the Senate to oppose the Burns alternative, and pass the McCain censorship bill.

I suggest writing or calling your local congressman and tell him/her to vote 'NO' on these bills.

"YOU SHOULD CLEAN YOUR ROOM"



# WHAT HAS STUDENT GOVERNMENT DONE FOR YOU LATELY?

es, that is right some members on student government (what is fast being called "CSI's Worst Student Government") are engaged in a new project. No, it's not parking; no it's not high cafeteria prices, and no it's not going to do a damn thing to help the average student at CSI. What is the new project? A lawsuit against well ALL STUDENTS, at least the body that collects all students student activity fee, the CSI Association.

Enforce the Open Meetings Law and the Freedom of Information Law with respect to the CSI College Association. Be it further resolved: That William

Wharton is authorized to act in his official capacity as a plaintiff or petioner on behalf of student government and to authorize such other plaintiffs as may be necessary for the purposes of the lawsuit. It is understood that the defendants in the proposed lawsuit or lawsuits will include members of the CSI and CUNY administrations as well as directors of the CSI College Association. What all of that stupidity means (probably written by Ron McGuire Esq. L{augh} O{ut} L(oud)) is that Student Government is suing the Association over: an Open Meetings Law which was never broken because the Association falls outside the law and is indeed permitted to vote by closed ballot. The Association is being sued over the first amendment issue of not allowing Ronald McGuire who is Wharton's attorney (and is trying to get Wharton \$20,000.00 in another lawsuit) to price gauge students and come to CSI and be paid \$2,500.00 of student's money for 2 hours of his stuttering ramblings, an amount that is more than anyplace he has ever spoken (except Hostos). # Ticked Off @ The Media

On February sixth, President Clinton and the Prime Minister of England gave an address. They spoke of several significant and impacting issues of our society. When they were done and the press was allowed to ask questions, an unsurprising tragedy (of the Media) occurred. Rather than asking follow up questions to important issues (Iraq or the economy), they instead began with inquiries into the President's sex life. How this is relevant to the state of the union is beyond my comprehension.
