Who Protects Us From You? Civilian Oversight for CUNY Public Safety

In the wake of recent allegations of bias and assault against two students by CUNY college Safety Department of Public Sergeant Peter Licata, it would appear that an appropriate committee would be convened in order to investigate the allegations. A committee represented by the diverse college community: Administrators, Faculty, Staff and Students. However, no such committee exists on the College of Staten Island or any other CUNY campus. Administrative appointees investigate incidents involving CUNY Public Safety officials. Administrative hacks that are looking out for the best interest of the college and not the student body. Obviously the outcome of such investigations will most assuredly exonerate the Public Safety Officer involved. Otherwise, the college may risk tarnishing its great name in the public. Constant examples of administrators before students. So what is the solution to the problem? Simple, the City University of New York should follow the example of the mayor created New York City Civilian Complaint Review Board, and implement a similar system. Doing so would be a sign of good faith by the CUNY administrators in showing that they not running biased investigations. So how can CUNY organize a Civilian Complaint Review

First it is important to understand the way in which the NYC CCRB functions. As stated on their official department website (h t t p : / / w w w . n y c . g o v / html/ccrb/home.html)

The process begins with the assignment of your complaint to an investigator who will be your contact person throughout the investigation. This investigator will attempt to contact you by phone 24 hours after you file a complaint to schedule an interview. During the interview, you will be required to give a formal statement about the incident involving the police officer(s). In some cases, the investigator may offer mediation.

The investigator finds witnesses and victims and interviews them as well. The investigator will interview the police officers who were on the scene at the time of the incident. Members of the New York City Police Department are required to appear when summoned by a CCRB investigator.

The Investigation

In addition to gathering testimony, the investigator canvasses and photographs the scene of the incident, analyzes Police Department documents, reviews medical records, and collects other evidence, sometimes through subpoenas. Case law, legal references, and police department procedures are researched to help determine the legality of the police officers' actions, and whether the acts occurred with good intent or in bad faith.

The Board's Final Decision

Upon completion of the investigation, the case will be presented to a three-member panel of the Board. To assure total objectivity, Board panels are comprised of representatives from each of the designating authorities: the Mayor, City Council, Police Commissioner. The Board will notify you by letter of its finding. Complaints and their dispositions will remain on the officer's history.

This basic information is a good template to begin with. Of course, certain changes to the makeup of the agency would have to be corrected. First, the Mayor, City Council, or Police Commissioner, would not designate the appointees. Instead, there would be a twelvemember panel. CUNY Central would appoint six board members **CUNY-wide** consisting of administrators. The other six members would be individuals from the 5 boroughs that will all make application for the position of board member. The civilian applications will be reviewed by an elected CUNY-wide student panel that will then make the final decision as to who the other six appointed members are. Each appointee, whether CUNY or Civilian, will hold his or her position for a term of one

year and can't serve two consecutive terms but may be reappointed. All of these appointees would be working without compensation, although stipends should be made available for minor expenses such as travel reimbursement.

Unlike the investigators employed by the CCRB, the CUNY board will not have any employees working for them. Instead, the twelve panel

members will be divided up into four, three member panels. Each panel will be responsible for an evenly distributed caseload. Once a complaint is received regarding a **CUNY Department of Public Safety** member, whether in written or verbal form, it will be assigned to one of the panels. The 3-member panel will be responsible for interviewing the complainant and witnesses, reviewing documentary evidence such as incident reports, audio tape, video tape and any other investigation related item, and interview the subject public safety officer as well as any other public safety personnel present at the time of the incident. Once the panel has reviewed and examined all information obtained through the investigation, a decision will be made as to whether or not disciplinary charges will be filled against the appropriate public safety officer.

Just because a Public Safety Officer has a complaint lodged against him or her, doesn't automatically mean the officer is guilty. Because of the nature of the

work, a Public Safety Officer always has to be ready for anything. However hostile an individual may be towards an officer, the officer must handle him or herself in the most professional manner. Not ever action by a Public Safety Officer will be construed as being proper. Complaints about officer's actions are part of the job. It goes with the territory. There is no doubt that a frivolous complaint can be filed. But regardless of whether the complaint is legitimate or not, shouldn't the complainant feel secure in knowing that his or her complaint will be investigated with the utmost professional and unbiased manner? Wouldn't it also be important for the Department of Public Safety to acknowledge the fact that there may be misconduct on the part of their officers? This way, even on unsubstantiated complaints, the Department of Public Safety could institute some type of retraining process for officers who have had a certain number of complaints lodged against them.

The need for civilian oversight in any law enforcement agency should be top priority. Media coverage offers constant reminders of all the foul-ups and corruption associated with internal investigations. It has been shown time and time again that the police can't police themselves. If that is the case with a large city police agency, what makes the CUNY Department of Public Safety feel that they are up to the task? There must be some type of immediate action taken to institute a policy which would authorize a CUNY-wide Civilian Complaint Board. Review Let administration do this to ensure that the rights of the students are not infringed upon. If we can't trust the people who are responsible for ensuring that justice is administered on campus, then how can we trust them to administer justice to one of their own? The answer is obvious: WE CAN'T!

NYPIRG GUIDE TO THE 2002-03 FINAL HIGHER EDUCATION BUDGET

The 2002-03 final budget is disappointing for New York City students. With this budget, an affordable, accessible, and quality higher education in New York City is now further out of reach for the city's students.

Cuts to the Peter F. Vallone Merit Scholarship. The 2002-03 City Budget cuts \$1.5 million from this grant program at the senior and community colleges. These cuts may lower the award at CUNY. Currently, the scholarship provides \$1,450 per year to thousands of deserving New York City students who attend CUNY.

No increases for full-time faculty lines. Full-time faculty are critical to high-quality higher education in New York City. To succeed academically, CUNY undergraduates need to foster ties with professors who are not transient and who have office hours and space on their campuses. Since 1974, CUNY's full-time faculty declined by nearly 49%. Today, just 44 percent of faculty at CUNY community colleges are full-time. The 2002-03 City Budget allots not additional funding to allow CUNY to introduce more full-time faculty lines in their undergraduate programs.

Cuts to CUNY's community colleges. The 2002-03 City Budget cuts \$1 million from the community colleges administrative budget. The burden to fund community colleges must not fall on the students who are currently paying much more than their one-third of the share to make up for the city's lack of funding. CSI STUDENTS RALLY AGAINST HATE & RACISM ON CAMPUS

This semester racism and hate has been the main issue on campus. Throughout midterms and finals students at CSI found the time to speak out against racism and hate in our college. The December 4th rally in the Campus Center was a result of several incidents that have occurred at CSI. The focus of this rally in particular was to finally get a response from the administration about Safety Officer Licata and his assault of CSI student Ayman Elsayed. This safety Officer who was hired to protect students violated student's rights by tearing down a flyer advertising an event discussing the impending war in Iraq. Not only did Officer Licata violate this students right to free speech but he went on to tell the student that he did not like what the flyer said and to "kill all the Arabs in Iraq" followed by "kill all the Arabs" several times.

Concerned students organized this rally to demand results from the administration's investigation and more importantly to pressure the CSI administration to establish a Review Board for Public Safety. The purpose of this Review Board is to investigate any allegations dealing with public safety officers. This is similar to the Civilian Complaint Review Board which follows up on charges on NYPD officers. No one can police themselves, how can someone who is liable for charges investigate those same charges. If a student is attacked by another student he/she can call Public Safety to resolve the situation but what does a student do if they are attacked by Public Safety? That is why this Civilian Complaint Review Board is needed. It will help protect students and their rights on campus and will offer a fair due process.

The organizers of the rally personally invited President Marlene Springer and Vice President Carol Jackson to address these issues, especially why this case is taking so long and why Officer Licata is still working on our campus. Various student and community members asked President Springer why there was such a stall on this case and why her office did not release a statement condemning racism in CSI. The president rudely did not even wait a minute to listen to the students; while they were still talking she blatantly walked out of the room and never came back.

Students also confronted the head of Public Safety Gene Martinez. Mr. Martinez also failed to address these issues. If the CSI administration does not listen to the student's points and value the opinions of the campus community they are not doing their job. What we need is a written statement stating that if a public safety officer from the college is found guilty of any bias crimes on campus he/she will be suspended

and removed from the college.

During the rally CSI students, Student Government Senators, Community leaders, and

Student Government President from Hunter College spoke about the seriousness of this case and the need for our administration to attend to the students concerns. Michelle Payton-Garrett a CSI student and Government brought up the fact that Muslim students who have been praying in the library for the past five years were asked to now pray in a storage room in the Campus Center. This storage room can only hold students; approximately 40 however, there are over 1000 Muslim students on campus. John Bostrom, the President of Peace Action Staten Island lent his voice to speak about community support and to stand up against racism along with CSI students. Zara Khan and SLAB from Hunter College brought up the pertinent issues of institutional racism in CUNY and the fact that we may be paying \$750 more dollars for tuition next semester.

Ronald Macguire the lawyer for Ayman El-sayed, the student who was assaulted explained to the audience the relevance of this case and why it is important to fight racism on our campuses. university is a place which should cherish diversity and a place where students should feel safe. Ronald Macguire also addressed ongoing problem of racism at CSI and the incompetent ways in which Public Safety Officers are investigated. Students from the City College of New York (CCNY) and Hunter College stood in solidarity

with CSI students and community members to say no to racism and

The College of Staten Island is a diverse university and all students pay tuition. Foreign students pay double to attend CUNY. All the students on campus should be guaranteed security no matter what their religion is or where they come from. Our administration has failed to guarantee the Muslim, Arab and South Asian students security. All students should be outraged by this and should stand together. A HISTORY OF CUNY

The City University of New York ("CUNY") is the third largest university in America. CUNY is supported by public funds and tuition. CUNY consists of eleven senior colleges offering comprehensive graduate and undergraduate programs, six community colleges offering two year degrees and transfer programs leading to baccalaureate degrees, a graduate center awarding doctoral and master's degrees, a law school and a comprehensive medical program offering a combination B.S./M.D. degree and dedicated to increasing the representation of African-American, Latino and other under-represented groups in the medical profession. CUNY is governed by a Board of Trustees which includes ten trustees appointed by the governor of New York State, five trustees appointed by the mayor of the City of New York, a voting student trustee and a non-voting faculty trustee, as provided by New York State Education Law '6201 et. seq.

CUNY contains the largest of Black and Latino ever to have attended any university in the history of the United States. A majority of CUNY's 200,000 students are Black and Latino. CUNY annually awards the largest number of Associate, Bachelors and Masters degrees to Black and Latino recipients of any institution of higher education in the nation. The majority of CUNY students also work and come from families with low incomes.

40. In 1847 New York City founded

the Free Academy with the mandate to provide higher educational opportunities to the poor of the city. Several years later the Free Academy was renamed City College and New York City established other public colleges which were eventually consolidated to form CUNY. However, as late as the early 1960's, the student body of CUNY was virtually all-white. CUNY was integrated in the late 1960's and early 1970's when the university adopted a policy of "Open Admissions" offering admission to all graduates of New York City high schools or recipients of high school equivalency degrees. The integration of CUNY was a major development in the history of American higher education because it transformed CUNY into the university with the largest number of Black and Latino scholars in the history of the United States. Since the implementation of its historic Open Admissions policy, CUNY has provided unparalleled opportunities for higher education to communities which had heretofore been drastically under-represented in our colleges and universities.

41. CUNY's 129 year long policy of free tuition ended in 1976, the first year that the majority of CUNY's first year class was non-white. As the proportion of non-white students in CUNY increased, public aid for instruction and financial aid at CUNY diminished and tuition increased. Presently tuition at CUNY community colleges is \$2,500.00 annually, one of the highest community college tuition rates in the nation. Tuition at senior colleges is even higher. Surveys of CUNY students who left without obtaining degrees revealed that the main reason given by the students for their lack of persistence was unmetfinancial need and the need to work full time, not academic failure.

42. Since the 1930's CUNY has had a history of student activism and students have organized demonstrations and mass movements that have often criticized policies supported by college and university officials or elected

political leaders.

43. Against this backdrop, thousands of CUNY students in 1989 and 1991 organized peaceful student strikes to oppose a proposed state budgets that would have drastically cut the CUNY budget and to imposed large tuition increases on the student body. The 1989 strike ended peacefully after the Governor and the leaders of the state legislature agreed to restore the funding to CUNY, eliminating the need for the tuition increase. Former CUNY Chancellor Joseph Murphy, granted amnesty to the student strike

44. Following his decision to grant amnesty to the student strikers in 1989, Joseph Murphy resigned as CUNY Chancellor and in September, 1990 he was replaced by W. Ann Reynolds. In April, 1991 the Governor again proposed drastic budget cuts and a sharp tuition increase and thousands of CUNY students again peacefully sat in buildings on their campuses in protest against the proposed budget cuts. Chancellor Reynolds threatened the

students participating in the strike with arrest, suspension and expulsion. However, in January 1991 the CUNY Board of Trustees passed a resolution specifying that only college presidents had the authority to call the police to campus in response to non-violent demonstrations, not the Chancellor. The January 1991 resolution also required that a college president undertake consultations with campus student government officials and leaders of faculty governance bodies before calling police to a CUNY campus to respond to a demonstration.

45. During the 1991 student strike the CUNY college presidents declined to call the police and the strike lasted for three and a half weeks until the university obtained injunctions from the New York State Supreme Court to evict the strikers.

46. Until 1991 security on CUNY campuses was provided by private security firms contracted by each college. There was no centralized university security agency and the security guards were not authorized to make arrests. If there was a need for law enforcement activity, the college would contact the local police precinct for

47. Several months after the 1991 student strike, Chancellor Reynolds created the University Office Of Public Safety and hired the university's first Public Safety Director. Shortly thereafter CUNY enacted a security initiative that drastically increased funding for

CSI Arab-American Student Sues the College of Staten Island

Students at all CUNY colleges have had problems with their administration and Public Safety. Public Safety have been caught tearing down student fliers, spying on students, racially and physically assaulting students. Student first amendment rights have continuously been violated. Many students have stood up for their rights and have taken legal against their administration, Peace Officers and the Board of Trustees.

A CSI student, Ayman El-Sayed is suing the CSI administration and Sgt. Peter Licata for violating his first amendment right to post up fliers and racially attacking him by saying "kill all the Arabs". Ayman El-Sayed is an Arab American student. Ayman El-Sayed was a past Student Government Senator and is an editor of the College Voice newspaper. This student along with others conducts several events on campus to bring awareness of issues affecting CUNY students.


On October 15, Ayman El-Sayed was posting up fliers Student advertising Government funded event on Campus the next day. The event was a discussion on the possible war in Iraq. Speakers who just visited Iraq were invited to speak students, faculty community members about their experiences. Ayman witnessed Sgt. Licata tearing down his fliers. He confronted Licata who was standing with two other Peace Officers, Robertson and Flood. He asked Licata "why did you tear down my fliers". Licata told Ayman that "I don't like what it says" and "we need to kill all the Arabs". The students felt very threatened and scared that a Peace Officer would be saying this to him. He did not know who he can complain to and called the photographer of the College Voice newspaper to take pictures and write an article. Licata attacked photographer by grabbing his camera and twisting the strap around his neck. The student identified himself as student press and Licata let him go.

Ayman El-Sayed than filed a complaint with another Public Safety officer. This officer told Ayman that he was not allowed to take pictures of Public Safety officers. Ayman told him "that is incorrect, I'm a student journalist and I know my rights, I can take pictures of any public officials

especially in public space". The student realized that nothing was going to come out of his complaint and contacted his lawyer. The reason he did this is because Licata racially attacked him and the student felt threatened to walk around campus while the officer was on duty. Ayman also takes late classes and works on campus. He does not finish work until 10pm and was scared to walk to his car late at night while this officer was on duty. Ayman El-Sayed felt there was no other way to guarantee his security but to contact his lawyer.

The students is suing the demanding first college "Prohibiting CUNY Peace Officers from selectively removing literature espousing disfavored viewpoints from public places" and second "Requiring CUNY to establish a procedure for civilian complaints against Peace Officers to be reviewed independently". The administration has not released a statement about the incident and has been investigating the incident for over a month and a half with no result. Students cannot expect Public Safety or administration to investigate public safety and administration. An independent body needs to set up to investigate complaints by students, faculty or workers against public safety. Students should be guaranteed safety on their campuses no matter who they are.

Ayman El-Sayed is suing along with students from three other CUNY campuses, Hunter, City College (CCNY) and Hostos college. Students from these colleges have also had problems and confrontation with Public Safety. Public Safety have been tearing down student fliers, spying on students and arrested several students for protesting new fees and the cancellation of several classes on their campus. All these students first amendment rights have been violated and nothing has been done. We will see what will come out of the lawsuit. The students have lots of evidence to prove their cases. Students all over CUNY need to stand up to protect their rights on campus. We hope change will come from this lawsuit but it takes student, faculty and workers unity to really make things better on our campuses. Students, faculty and workers need to run our campuses because we know

IRAQ, OIL & IMPERIALISM BOMBING FOR DOLLARS


After a talk he once gave about his covering of the first world war in Europe, radical journalist John Reed was asked what he thought that conflict was all about. He shocked his audience when he replied with one word: profits. The same holds true insofar as the impending war with Iraq is concerned. Only we can be even more specific and say oil. The NY Times let the cat out of the bag when it revealed, in October, that government officials were already making plans on just how they would divide up "the second largest proven reserves of oil in the world (which) they would essentially control...for as long as the(y) administered Iraq." For whether it's Europe in 1917, or the Middle East today; whether it's the Kaiser or Saddam Hussein who are the butt of pro-war propaganda, it is, in fact, the expand or die appetite of America's economic elite that leads to military conflicts with other countries. Or, as a Marine Corps officer, Major General Smedley Butler, put it in a speech he gave in 1933, "when the dollar only earns 6% over here...it gets restless and goes overseas to get 100%. Then the flag follows the dollar and the soldiers follow the flag." The need for economic domination necessarily requires political and military domination to back it up. Imperialist war is the continuation of capitalist "globalization" by more forceful means! After all, they can't just steal the oil and then sell it off at bargain basement prices without having some muscle around to enforce order. No wonder Butler concluded that he "could have given Al Capone a few hints (since) the best he could do was to operate...in three districts (whereas he) operated on three continents."

Of course, today's official explanations focus on lies like "weapons of mass destruction" and "terrorism" just as World War One was supposedly fought to "make the world safe for democracy" and was "a war to end all wars." John Reed was more on the mark, when he called it a "traders' war." For the "democracy" that Americans were fighting to make "the world safe for" certainly didn't apply to Black people. In half of the country they couldn't even vote, while in the other half, where they could, they couldn't even sit down in the same restaurant, or rest room, for that matter, with white people. The war that was supposed "to end all wars" only set the stage for another, even more bloody, world war, a little more than 20 years later, when those powers that had either lost out in the battle for profits (Germany), or felt that they hadn't gotten their fair share of the spoils (Japan and Italy), sought to reverse the results. In between the two "big ones," there were countless little wars. Those were more like the kind we've become used to; where Uncle Sam sent in the marines to ensure Washington's and Wall Street's rights to pillage and plunder the riches of what latter came to be known as the "Third World" or to crush revolutions aimed at ending that

oppressive relationship. Thus, General Butler, who served in almost all of those wars called himself "a racketeer, a gangster for capitalism" who "spent most of (his) time being a high-class, muscle man for big business, for Wall Street and for the bankers."


Since, as Butler went on to say, such "wars (are) just a racket...conducted for the benefit of the very few at the expense of the masses," they have to be carried out under the guise of defending American "interests" or "security." Only it's never said just which particular Americans' "interests" or "security" were, or are, being defended. It is, in fact, the "interests" of the the richest

people, who work on Main Street rather than Wall Street, the imperialist aims and ambitions of America's ruling rich have to be presented in terms of "democracy," "human rights" and the like at the same time that they are being presented to the peoples of countries like Vietnam, Lebanon, Grenada, Libya, Panama Iraq, Somalia, Yugoslavia and Afghanistan (to name only the most recent recipients) with napalm, agent orange, depleted uranium and cluster bombs. America only goes to war to enhance the ability of its ruling rich to get even richer at the expense of either its economic rivals or to rip off the resources of much weaker states. US



0.5% of the population, which owns 42% of all financial wealth and owns the state that protects their ownership of it, that are being "secured" overseas just as they are at home. And, in the case of the current war drive, it's not just oil interests that stand to cash in. The massive increase in the "defense" budget, which predates September 11, benefit a handful of corporations that get almost half of the Pentagon's orders and couldn't survive without them in the world of "free enterprise" they claim to be defending. Since September 11, the share prices of the biggest defense contractors went up by nearly 10% while the S&P index of the 500 leading share prices on Wall Street went down 20%. (Bush hopes the war will get the rest of the stock market back on its feet.) Needless to say, unemployment, indebtedness, homelessness and hunger have risen as well. But the concerns of working people are not amongst the American "interests" whose "security" needs to be protected by a government of, by and for the rich.

For the other 95% of the American



State Department official George Kennan, one of the architects of the "cold war," layed out the economic interests behind that strategy (which continue to hold true today) when he stated that "the US has about 50% of the world's wealth but only 6.3% of its population. Our real task...is to devise a pattern of relationships which will permit us to maintain this position of disparity." Only to get popular support for this, it's got to cover those aims in lofty phrases that are usually just plain lies. After all, how many working people, who are the ones who will have to pay for the wars, not to mention, fight and die in them, would be willing to do so, if they were told that they were fighting to help make the same bosses who exploit and oppress them here even richer by allowing them to do the same thing to working people, just like themselves, in other countries. They lie, workers die.

So even if Iraq doesn't have any "weapons of mass destruction" or ties to "terrorists," let alone to September 11, its does have oil...and lots of it. In fact, it

has the second largest reserves of oil on the planet and this system runs on oil. By getting rid of Saddam Hussein, the US (along with its allies in the Arab world like Saudi Arabia and Kuwait) will control most of the world's oil supply. They can then hold their alleged allies in Western Europe and Japan, who are more and more reverting to being their imperialist rivals, hostage, since all of them are far more dependent on oil from the Middle East than the US is. Thus, former CIA Director R. James Woolsey told the Washington Post that if France and Russia chose to play ball with the US and not get in the way of the war, "we'll do the best we can to insure that the new government (in Iraq) and American companies work closely with them." Henry Kissinger, however, said it best, when he stated that "oil is too important to be left to the Arabs." As for all the fine words about bringing "democracy" to Iraq, those will have to take a back seat to securing cheap and plentiful oil supplies. A new dictator, this time an American general, will be installed by Iraq's would be "liberators" to preside over the divvying up of the oil loot. After all, what "democracy" would vote to turn over the main source of it's wealth to a gang of outsiders?

official, in a rare display of official honesty, stated that "if Kuwait grew carrots we wouldn't give a damn." Thomas Friedman, the NY Times foreign affairs columnist and unabashed apologist for all the economic inequality that "globalization" has ushered in, was, as usual, even more up front about US motives. "The US has not sent troops to the Saudi desert to preserve democratic principles," he stated. "This is about money, about protecting governments loyal to America and about who will set the price of oil." That's why General Butler, when he "helped make Mexico...safe for American oil interests 1914," called racket...something that is not what it seems to the majority of people." If "it seem(ed) to the majority of people" that Bush, Cheney, Rumsfeld and Rice were willing to go to war so that they can get their hands on Iraq's oil, then how many of them, many who can't even afford a car, are going to to willingly give away large portions of their paychecks, let alone their lives, for it. They know that if any of them tried to stage an armed robbery on a gas station, which is what this all comes down to, albeit on a global scale, they'd be either dead or in jail.

During Gulf War One, a government

When George Bush says that "the danger to our country is grave (and) is growing," he's right. Only the danger isn't coming from Saddam Hussein or Iraq, it's coming from him. For all the talk about "weapons of mass destruction" and "terrorism," Saddam Hussein is not the problem. George Bush, or rather the American ruling class and American imperialism that both he and the Democrats represent and its expand or die appetite are. Indeed, the US possesses far many more "weapons

of mass destruction" than Saddam Hussein (or all of America's enemies and allies combined) could ever imagine, not to mention biological and chemical weapons. And unlike Saddam Hussein, they have already made ample use of them around the world...including in the US! Nor has the US allowed anyone to inspect its arsenals or are they about to. Bush not only blocked a treaty banning biological weapons but tore up the ABM treaty with the Russians in order to go ahead with "Star Wars" style missiles in space. The Bush gangs' war plans with Iraq were drawn up by the "Project for the New American Century," a right wing think tank, even before they stole the election back in 2000, just as plans for their phony "war on terrorism" with Afghanistan were on the books before the first plane hit the WTC.

Now that the USSR is out of the way, the US is the world's sole superpower and it's going to use any and every occasion it can to remind the rest of the world. That's what the "Bush doctrine" is all about; my way or hit the highway. Vice President Cheney spelled it out back in 1992, when he was working for the first Bush regime and its "New World Order": "Our strategy must now focus on precluding the emergence of any potential future competitor." Paul Wolfowitz, currently the deputy defense secretary, who also worked for Bush's father, added that that meant using military might to American "discourage" any potential rivals such as "the advanced industrial nations from challenging our leadership or even aspiring to a larger regional or global role." War secretary Donald Rumsfeld, another ex-employee of the Reagan and Bush administrations, was even more explicit when he called for "the US (to) be able to impose terms including the occupation of an adversary's territory and change of it's regime." As an example to be emulated he cited Nazi Germany; adding that "blitzkrieg was an enormous success." This was stated some three months before September 11th! The US "National Security Strategy," published this September, sums it all up. The US will use its "unparalleled military strength" to "preemptive(ly)" push the "single sustainable model" of "free enterprise" across the planet. So now the dollar will follow the flag and the soldiers.

Bush claims that Saddam Hussein is a "dictator" whose "regime has...ties to organizations." terrorist supporting "dictators" and "terrorist organizations" around the world are standard operating procedures for US imperialism just as the possession and use of "weapons of mass destruction" are. Back in the late eighties, Reagan, Bush and Rumsfeld couldn't get enough of Saddam Hussein, after they switched sides in the Iran-Iraq war. Just where and from whom did Saddam Hussein get all of those "weapons of mass destruction" and chemical and biological weapons in the first place? If Saddam Hussein is addicted to weapons of mass destruction the way Bush says he is, who was his pusher? The US had no problem with his gassing of the Kurds because they gave him the technology and the gas to do it with. That's because the US has never had any great problem with backing bloody dictators to begin with. In fact the only way the American ruling class can control the world's workers and wealth is by having people like Saddam Hussein do it for them. Just like the big Mafia dons have the local punks and thugs collect the protection money for them and keep outsiders off their turf, the US uses the third world ruling classes to do the same thing, only on a larger scale. That's why the US brought dictators far more bloody than Saddam Hussein to power in places like Guatemala, Iran, Brazil, Indonesia and Chile and has backed terrorists from the "contras" and death squads in Central America to the gusanos in Cuba to Pol

the alternative, or as the other world that is possible.

Unfortunately, to many in the antiglobalization movement of today the connection between the advance of global capital and the advance of US military might remains a mystery. Following the lead of the Democrats and their labor lieutenants in the AFL-CIO, who are more concerned with opposing America's "enemies" than they are in opposing the American ruling classes' wars, they have tried to distance the struggle against war from the struggle against globalization, separating politics Fukuyama pointed out that "Microsoft or Goldman Sachs will not send aircraft carriers to the Gulf to track down Osama Bin Laden-only the US military will." Indeed, capitalist governments work hand-in-glove with bodies like the WTO, the IMF and the World Bank, supplying the military muscle that backs up their blackmail and extortion threats. These bodies were created by the monopolies (today referred to as "multi-national" or "trans-national" corporations) to regulate and economically enforce the division of the spoils. "International" organizations like the UN provide a



Pot in Cambodia to Jonas Savimbi in Angola to both Osama Bin Laden and the Taliban in Afghanistan. And they backed Saddam Hussein when he first came to power by overthrowing a leftwing nationalist regime that was threatening to nationalize Iraqi oil in 1962. Saddam rewarded them by crushing the Iraqi Communist Party and the left and labor movement just like Suharto did in Indonesia and Pinochet did in Chile. It's only when Saddam outlived his usefulness to his bosses in Washington, by becoming too big for his britches, that he, like Panama's Noreiga before him, had the US turn against him. Meanwhile dictatorships like Egypt, Turkey and Pakistan and absolute monarchies like Saudi Arabia and Kuwait remain within Washington's good graces.

When all is said and done, the war against Iraq is a war for oil. The only thing that motivates America's rulers to do anything anywhere is protecting their profits and their power to make even more of them. War is the continuation of "globalization" by more forceful means. And "globalization" is nothing more than a new name for an old process. Those who ardently advocate the "single sustainable model" of "free enterprise" would probably be the last ones to deny it. What's commonly referred to as "globalization" today is the ruling rich's latest attempt to impose its will on every inch of the earth; something that has been going on at least since the end of the 19th century and which used to be referred to, at least by those on the left, as imperialism. Only for revolutionaries, like Lenin, "politics was concentrated economics", ie, two sides of the same coin. Imperialism led to war and to oppose one, meant not only opposing the other, but supporting socialism as

from economics the same way reformists have always done by claiming that "the nation state no longer matters in an age of global capitalism." As if the American ruling class and its armed forces weren't trying to make the world safe for American corporations...not just at the expense of Afghanistan or Iraq but at the expense of their imperialist rivals as well. According to study carried out by the Defense Department, the number of armed interventions around the world was higher in the course of the 1990s (the heyday of "globalization") than in the "cold war" period of 1945-1990 when the presence of the USSR was a roadblock to such interventions.

If opponents of "globalization" are slow to make the connection, the same cannot be said of its advocates. The NY Times' Thomas Friedman said, "markets function and flourish only when property rights are secure and can be enforced, which in turn, requires a political framework protected and backed by military power." During the bombing of Yugoslavia in 1999, Friedman added that "the hidden hand of the market will never work without the hidden fist. McDonald's cannot flourish without McDonnell Douglas...and the hidden fist that keeps the world safe for Silicon Valley's technologies to flourish is called the US army, air force, navy and marine corps." Echoing Friedman was former state department hack Francis Fukuyama, whose prior claim to fame was proclaiming that the "collapse of communism" signified the "end of history," only to admit that it wasn't all over just yet after witnessing the rise of the mass movements against the capitalist globalization that he thought had "ended history." Getting his two cents in for the "war on terrorism,"

"humanitarian" fig leaf to cover up the endless acts of aggression carried out by the same imperialist powers who created it and continue to control it. After all it was the UN that gave the "international community's" blessings to the Gulf war and which agreed to and has applied sanctions against Iraq which have killed over a million and a half people. And it was the UN Security Council which only recently gave the US a green light to launch yet another war.

If on the left today, talk about imperialism is confined to a handful of revolutionary Marxists opposing it, the same can't be said for those on the other side. So arrogant are America's ruling rich becoming that more and more of its mouthpieces are openly embracing it; calling on the US to "take up the white man's burden" and actively intervene where and whenever a "failing nation" or a "rogue state" requires a "nation building" "regime change" to protect the interests of American corporations. A few fine words about the "humanitarian" values of depleted uranium and cluster bombs will entice the limpwrist liberals to jump on board the bandwagon, cementing the "united we stand" consensus the same way anticommunism did during the "cold war." After all, American imperialism is presented with an opportunity unique in world history...with the USSR out of the way, there is apparently no one left to stand in the way of its doing anything and everything it wants to do when ever and where ever it wants to do it. No one except the American working class, that is. The Bush gang has already shown that it can fool the Democrats all of the time. The question is whether it can continue to due the same to the American people. *



WHO IS MUMIA ABU JAMAL

Mumia Abu-Jamal is an awardwinning Pennsylvania journalist who exposed police violence against minority communities. On death row since 1982, he was wrongfully sentenced for the shooting of a police officer. Mumia Abu-Jamal's fate rests with all those people who believe in every person's right to justice and fair "I remain innocent. A court cannot make an innocent man guilty. Any ruling founded on injustice is not justice. The righteous fight for life, liberty, and for justice can only continue." Mumia Abu-Jamal, 31, Oct. Facts about Mumia's 1982 trial: * The policeman was killed with a 44 caliber gun. Abu-Jamal's gun which he was licensed to carry as a night-time taxi driver, was a 38 aliber * The police never tested Abu-Jamal's gun to see if it had been recently fired. They never tested his hands to see if he had fired a gun. They have never shown Abu-Jamal 's gun to be the fatal w e a p o n .
* No police officers present at Abu-Jamal's arrest claimed to have

heard Jamal's "confession" until two months after it allegedly occurred. This was right after Abu-Jamal had filed police brutality charges. * Abu-Jamal's doctor said that Abu-Jamal, who was unconscious,



said nothing. He reported that a nurse found police with loaded guns pointed at Mumia as he lay unconscious in his hospital bed.
* William Singletary, a Vietnam veteran and local businessman, saw the whole incident and has testified that Abu-Jamal was not the shooter. However, the police forced him to change his story and intimidated him into leaving

Philadelphia.
* Other key witnesses, such as Veronica Jones — who now testifies in support of Abu-Jamal, were harassed into giving false testimony. Two prosecution witnesses were given special favors, including exemption from criminal prosecution, for their testimony.

Elements in an unfair trial:
* The Judge, Albert Sabo, sentenced more people to death than any other sitting judge in the

* The public defender didn't interview a single witness in preparation for the trial, and didn't have funds for defending a capital case.

* The prosecutor removed 11 qualified African Americans from the jury. He also argued for the death penalty because of Mumia's membership in the Black Panther Party, a practice later condemned as unconstitutional by the US Supreme Court.

* The racial bias of Philadelphia's courts has resulted in 120 people on death row, all but 13 non-white.

WHO ARE THE FIVE POLITICAL PRISONERS BEHIND BARS IN THE U.S.A.

Who are the Five?

They are five Cubans who were trying to stop the ultra-right terrorist groups in Miami from carrying out violent actions against the people of Cuba.

Since 1959, these organizations have conducted bombings, assassinations and other sabotage, killing hundreds of innocent Cuban civilians. Groups like Alpha 66, Omega 7, Brothers to the Rescue, and Cuban American National Foundation have terrorized the Cuban people for years with impunity.

their society. They have been victims of terror attacks by the Miami-based mafia, many of whom came from the wealthy class that left Cuba after the popular overthrow of dictator Fulgencio Batista. Others of the ultra-right in Miami were police thugs for the Batista regime.

Gerardo Hernández, Antonio Guerrero, Ramón Labañino, René González and Fernando González, acting in defense of their people, were living in Miami, monitoring these terrorist groups to prevent future violence.

But because the U.S. government -

terrorists.

This is the only reason that the five Cubans are in prison. They were framed up in a political witchhunt and railroaded by the U.S. in a 7-month trial in Miami, where it was impossible for them to have an impartial and fair trial.

Falsely charged with espionage on the U.S., in reality, the five brothers' mission was to follow the activities of the right-wing to prevent harm to innocent people. After their arrest by the FBI in September 1998, they were convicted June 8, 2001 and sentenced December 2001.

The months-long struggle to free Elián González from the Miami right-wing showed the U.S. people the true nature of these Mafia-type groups in Miami, who so cruelly tried to deny a father and his son their right to live together in their own country, simply because that country is Cuba.

Terrorists like José Basulto and Ramón Saúl Sánchez, who have been convicted of criminal acts, actually became "spokesmen" for the Miami family. They vowed never to let Elián return home and put him at tremendous risk for their political aims.

FACTS ON THE PALESTINIAN-ISRAELI CONFLICT

Fact: Over 34 new settlements were created since Sharon took office.

The Israeli government has established 34 new civilian Jewish settlement outposts, including eight over the last two months, in the West Bank and Gaza Strip since the February 2001 elections, according to an aerial survey conducted by Peace Now. The number of Jewish settlers is now more than 300,000.

To maintain and protect these settlements, Israel must maintain military occupation in West Bank and Gaza. The Palestinians are segregated in non-contiguous enclaves, surrounded by Israelicontrolled borders, with Israeli settlements and settlement roads cutting through, essentially violating Palestinian territorial integrity.

Fact: The occupation is illegal

under international law.

Under UN Resolution 242, Israel is required by international law to withdraw from all the territories occupied in 1967, including East Jerusalem. The UN has stated time and time again, the only way to end the violence is to end the occupation.

The occupation is killing children and innocent civilians.

Israelis possess overwhelming military superiority over the Palestinians. The Palestinians have used violent means to resist the occupation, but that does not take away from the fact that Israeli soldiers are shooting individuals with missiles, using American made F-16s and Apache helicopters. Tanks roll into refugee camps, supposedly to root out terrorists. But so many of these socalled terrorists are small children.

According to B'Tselem, 897 of the Palestinians killed from September 29, 2000 though March 30, 2002 have been civilians, including 192 children. There were over 108 assassinations (a war crime according to the Hague Convention -1907).

Fact: The Israeli government demolishes homes, uproots crops, and confiscates land.

Since October 2000, 580 homes

were demolished or blown up. 291 acres of land was confiscated. 34,606 olive & fruit trees were uprooted. In East Jerusalem, Palestinian homes are demolished and land confiscated in order to ensure Jews have a majority in the city (the "Silent Transfer").

Fact: Palestinians suffer a

Occupation

The Israeli occupation government has been stealing annually, since 1967, up to 80% of groundwater from the "Mountain Reservoir," a group of groundwater aquifers located underneath the mountains of the Occupied West Bank of Palestine, including the Occupied Jerusalem. The Palestinian people are allowed no control of these extensive water resources.

Fact: Over 1,000 Israelis have refused military service due to the Occupation.

"We will no longer fight beyond the Green Line for the purpose of occupying, deporting, destroying, blockading, killing, starving and humiliating an entire people," declares a petition signed by the reservists.

Fact: You fund the occupation. Israel, whose population is 0.1% of the total world population, gets roughly one-third of all US foreign aid. Annually this amounts to more than \$3 billion in US taxpayer dollars going to Israel, \$2.04 billion of that is military aid.

Fact: Peace is possible.
It is a myth that Palestinians need to be subjugated to keep Jews safe. The occupation is only worsening the position of Jews in the Middle East. True safety only comes with justice and equality. NOVEMBER 21 - Even though Iraq has agreed to even the latest set of outrageous demands from that US/UK figleaf that goes by the name of the "United Nations," the US is making it clear that that still isn't good enough for them. Bush and his underlings are currently going around the world trying to line up support for war; hoping to get either military or financial backing for it. So even if Iraq gets a clean bill of health from the UN weapons inspectors, Bush will still opt for war...since Saddam is, no doubt, hiding a nuke or two under his bed or in the attic. After all, if Iraq is shown to have "weapons of destruction," not only will the Bush gang be shown up for being the liars that are but there will be intensified pressure on the UN to lift its starvation sanctions and

would then proceed to rape and divide 'China. At the twelfth party congress in 1982, Deng outlined the course of the party as follows: "China is now at the primary stage of socialism. Throughout this stage the basic line of the Party in building socialism with Chinese characteristics is as follows: to lead the people of all our nationalities in a united, self-reliant, intensive and pioneering effort to turn China into a prosperous, strong, democratic, culturally advanced modern and socialist country by making economic development the central task while adhering to the Four Cardinal Principles and persevering in reform and the open policy."
The Four Cardinal Principles

referred to by Deng above—adhering to the socialist road, adhering to the people's democratic dictatorship, adhering to Marxism-Leninism and Mao Zedong Thought, and adhering to the leadership of the Communist Party of China were enshrined in the Constitution of the People's Republic of China as the basis to maintain the

nation.
So Deng effectively combined a steadfast commitment to socialism under the guidance of the party with a policy of opening up to the outside world and reforming the economy. As a result China has grown by leaps and bounds. Its growth rate was in double digits in the 1980s and continued to develop to the worlds envy through the 90s into the present.

Jiang Zemin, the current and outgoing party president continued and built upon the achievements of Deng. His "three represents" theory has now been inducted into the party's constitution as an invaluable tool of guidance. The three represents theory states as follows:

states as follows:

"The Communist Party of China represents the requirement to develop advanced productive forces, an orientation towards advanced culture, and the fundamental interests of the overwhelming majority of the people in China."

The three represents theory is basically a combination, refinement and application of the Four Cardinal Principles and Socialist Modernization to the present and future needs of China. One of the significant changes that Jiang's Three Represents theory reflects is the opening up of the party to the new capitalist elements in China. Jiang outlined the rationale for this policy as follows:

for this policy as follows:
"The basic components and backbone of the Party are

those from workers, farmers, intellectuals, servicemen and cadres. At the same time, it is also necessary to accept those outstanding elements from other sectors of the society who have subscribed to the Party's program and Constitution, worked for the Party's line and program wholeheartedly, and proved to meet the requirements for the Party membership through a long period of tests."


There has been quite a bit of left criticism of this policy as there had been for the policy of economic reform. However, the Party leadership seems to

Corruption has reforms. become the number one political and social issue for the country. The Party leaders have focused a lot of attention on fighting corruption but the problem remains a massive one. Corruption in a workers state is what passes for normal legal business practice in capitalist states, but given that China is not a capitalist country the emergence of corruption is a source of great anger for the masses.

However the overall picture of the Chinese economy and society is undoubtedly healthy. China is a country whose per capita GDP is China is able to neutralize the anti-communist, profit hungry jackals of US capitalism from waging war on China and at the same time grow the basis for a strong independent socialist China.

In the arena of foreign affairs China's policy consists of "standing firmly on the side of the people of the Third World countries, opposing hegemonism and trying to preserve world peace." Consistent with this policy China acts within its capacity as an independent developing nation to stem the war drive of US imperialism. In regards to Iraq, "China firmly advocates

As the private sector has become an important part of the economy, the party has taken steps to include it.



understand that it is better to have the capitalist elements within the Party fold subject to the policy and discipline of the Party than to leave them to develop a political line more consistent with their bourgeois class interests. In stating that the Party represents the "overwhelming majority of the people" rather than just the workers and peasants, Jiang makes the policy shift to accommodate outstanding elements from sectors who have subscribed to the Party's line and program".

There is no question that the course that the CPC is following is fraught with danger. In the mid 80's a trend towards bourgeois liberalization and restoration of capitalism developed in the Party and was defeated. At the same time, the opening up of the economy, allowing market forces to determine productivity and growth, has caused quite a bit of pain to large numbers of workers and peasants. The numbers of unemployed are estimated to be around 40 million and a social insurance net is still not fully in effect to care for these workers. Peasants too are hurting under the market

increasing rapidly. Hope for a better future is very much alive for the Chinese people. While the motor of growth of the economy is the market, the steering wheel is commanded by the Chinese people as represented through its 60 million strong vanguard of the Communist Party. Public ownership remains mainstay of the economy as a way of providing employment to the overwhelming millions of workers of China. While the privatization of agriculture has been painful, it has also led to the increase in the size of the industrial proletariat. The objective of socialist modernization seems to be to absorb the best of scientific techniques, in essence to grow capital, from the outside world, so as to make the whole of the Chinese economy including its outmoded public strong independent. It is not the IMF and the predatory capitalist powers that are leading this growth. This is key. The growth is for China and not for foreign capitalists. Foreign capitalists are allowed to take part in the growth, by investing their capital and importing cheap Chinese goods but it is not for their benefit. So in one stroke

peaceful settlement of the Iraq issue through political and diplomatic means and within the framework of the United Nations." This is not an ideal policy from the standpoint of socialism but it is a policy based on the reality of the balance of forces in the world today. The number one objective of China has to be to build up its productive forces and become an invincible world power that cannot be bullied by imperialist threats. The ability of US imperialism to wage limitless war and dominate the world will develop in inverse proportion to China achieving world class power. The present War of Terror by the Bush gang will end, if not stopped, with the destruction of socialist China. imperative progressive people the world over to defend China from counterrevolution. The defeat of the Chinese Communist Party will surely unleash a level of barbarism on the part of US imperialism that will make this horrific New World Order seems like the good old days.

Student Government Statement Opposing Racism

Re: An Open Letter to the College Community

With regard to the alleged incident that took place on October 15, 2002 between a CUNY Peace Officer and a CSI Student of Arab-American descent, the College of Staten Island Student Government would like all members of the college community to be aware that we do not condone, nor should we tolerate any acts of bias on this campus.

Refence of the university as a sanctuary of academic freedom and center of informed discussion to be guarded vigilanty is clearly stated in the Campus Behavior Code (Henderson Act), which was adopted by the CUNY Board of Trustees many years ago. The rules and regulations established by the university are there to protect the rights of all members of the college community. With particular regard to students it affords them the right to learn and express their views free from external pressure or interference. The behavior code also states that these freedoms can flourish only in an astmosphere of mutual respect, civility and trust.

With regard to the aforementioned incident the following rule seems to apply best:

(5) Each member of the academic community or an invited guest has the right to advocate his position without having to fear abuse, physical, verbal or otherwise from others supporting conflicting points of view.

Further, within these guidlines are listed the rights and obligations of the university when these rules are violated. We hope that the College of Staten Island will uphold these rules and that regardless of whom breaks them that fair and equal penalties, within the requirements of due process, will be dealt to those who violate this code.

We must remember that the College of Staten Island is an extremely diverse community and that everyone here has the right to express their viewpoints in a civil manner without fear of reprisal. To us the protection of these freedoms should be one of the primary goals of an educational institution.

Actually as it goes the fee of \$15.00 for the parking ticket is absurd. I have paid for parking permits for over 16 years at the College. During all those years I have been on the campus 5 days a week. In recent years I have observed NO traffic enforcement on the roads. Each morning I am subject to cars using the campus as a short cut. Tailgaters, dangerous speeding and passing on the campus roads. Upon entering the campus, I observe students being issued temporary parking permits well into the 15th week of the semester. (And as of the writing of this letter 3 cars of students in front of me last night were issued temporary passes). Those same students fill up the staff lot especially during the first two weeks of the semester.

Once again may I state-I live less than one mile from the campus, I left 35-minutes early on the day I was issued the ticket (which was on the first day of class). Due to non-enforcement at the rear gat (i.e.: no traffic control and issue of temporary parking permits) the traffic was backed up at the rear gate. It took me 35 minutes for a regular 2 ‰ minute drive. As preciously stated, I did in fact park in a service area. One that I knew was NOT in fully used in the evening. I have worked in the Campus Planning Office for over 16 years, was part of the team that built this campus and works with Public Safety and B&G [Buildings and Grounds] on a daily basis, therefore I knew the routine. The main issue is that as a faculty member in the evening I was denied a spot in the faculty/staff lot of which I pay a permit fee of \$100 per year. In addition to students who also pay for a parking permit are also denied a space due to the indiscriminant issue of temporary parking passes.

As the years go by I also find it quite a considerable feat that the college has decided upon a tyrannical and fascist approach to the parking summons situation. Actually was it not policy that during the first week of the semester a tolerance was granted regarding the over abundance of automobiles on campus? I find it absolutely appalling that the college is so intent on collecting parking fees that I know as a fact are misused in other areas. In addition the supposed fees are NOT used for the designated repairs and maintenance of the lot as they are intended for.

As it might appear, I am angry, but then again the college and the comical parking enforcement office has created a campus-wide situation of apathy that has permeated throughout the staff, faculty and students and yes you have the \$15. And you can even use it to paint a house for all I care. I consider it a small price to pay for me to get some issues out in the open and into the college newspapers, college community and the Staten Island Advance.

continuing of colonialist/imperialist policies of robbing the rich resources of Africa, the crushing debt, the environmental destruction and the stifling of democracy in the region by euro-american corporations and governments are the clear roots of the "prevalent malnutrition and infectious disease and lack of a health infrastructure". an out of control killer in sub-(Black) Africa. Saharan Twenty million human beings from Black Africa are already dead due to the disease. 28 million out of the world's approximately 40 million approximately 40 million present HIV carriers live there. Roughly 9 - 11% of African people through ages 15 - 49 are said to be infected with the disease and the rate is reportedly a catastrophic 40% in Botswana. Eberstadt goes on to point out that it is so-called "ecological factors" or more clearly, "prevalent malnutrition and infectious disease" and the lack of adequate health care that is the root cause of why the AIDS pandemic took root in Black Africa as opposed to Europe and North America.

He counsels the capitalists that unlike the "marginal" peoples of Black Africa who have no money, the combined income of the Eurasian region in 2000 was a whopping \$15 trillion, greater than that of the US or Europe, so they had better pay heed. If that isn't enough for Messrs. Capitalists of US and Europe to be concerned, Eberstadt points to the "four out of five of the world' million_man strong armies, and four of the seven declared nuclear states"

One can't fault bourgeois
social scientists for not
knowing their facts but it is their logic and reasoning that is deeply flawed. Eberstadt wishes to warn the capitalists of the west as we said of the impact on their profit margins of the spread of AIDS in Eurasia, however, his own facts reveal that it is precisely profit interests of the American and European capitalist expansion otherwise known as globalization that is the principal culprit in the spread of AIDS in the region. In the case of Russia, Eberstadt writes that, "the demise of the Soviet state set the stage for the disease's rapid spread", further "the upheavals of Russia's ongoing transition - economic and social dislocation, increased new freedoms poverty, (including greater opportunities for geographic mobility, extramarital sex, prostitution, and drug use) — transformed the country into a far more conducive setting for the spread of HIV/AIDS." Ebersfadt quite confidently rattles off statistics pointing to how IV drug use is out of control in free market Moscow today, how curable sexually transmitted disease has increased 33 fold since the wonders of the free market hold and took prostitution is a high growth industry amongst Russia's newly liberated women. He states with no apparent cheek, "Russia's transition from communism to capitalism has also coincided with a tremendous increase criminal activity, a trend with important implications for the future of the HIV/AIDS epidemic."

In the case of India, the victory of free market forces over greater state control has had similar devastating results in terms of the spread of AIDS. While India was not a socialist country, the existence of the Soviet Union the Indian bourgeoisie to traverse a more independent economic and political policy that shielded it from being completely at the mercy of the forces of globalization. Indian state capitalism was still never pretty, never fully overthrowing the shackles of poverty imposed upon it by the British Empire.

As in Russia, the spread of HIV follows the pathways of capitalism. commercial Introduced commercial centers Mumbai (Bombay), Chennai (Madras), and Bangalore the disease has spread along the main trunk roads that serve as the transport network for this enormous country. As in Russia the opening up of the Indian economy globalization has caused a sharp rise in prostitution and illegal drug use. In the early 1990s, Indian social scientists estimated that 2 million prostitutes were at work in the country, and demand has only grown during the intervening decade. Drug use and HIV



flourish along the border with Burma.

In China we witness the same horrifying pattern of HIV infection. There are anywhere from one million to six million HIV carriers in China today depending on your sources. This upper boundary if accurate would make China the country with the single largest HIV population. Eberstadt relates familiar theme of HIV transmission in China. The rise of prostitution with the opening up of the Chinese economy and the sale of tainted blood are principal routes of the diseases spread. The rise of sexually transmitted disease in China increased . over one percent from hundred

1985 - 2000, the period encompassing the free market reforms in China. Eberstadt states without reservation that the spread of HIV, "reflects the realities of China's ongoing economic transition. With the demise of the rural commune system and the attendant disintegration of public health care in the Chinese countryside, both patients and doctors needed new means of financing rural health care. One such method was the sale of blood or by impoverished plasma farmers to pharmaceutical clinics. concerns, unregulated agents called heads. These blood transactions typically took place without the benefit of fresh, disposable needles. Officially encouraged through the early 1990s, this trade in blood was outlawed in 1998 yet it still continues.

Dying Can Be Hazardous To Your Health (and Profit Rates) According to UNAIDS there are over 5.5 million HIV carriers in the three countries -China, India and Russia but going by the U.S. intelligence's statistics, the collective figure may be as high as 12 million. Eberstadt while outlining the facts of HIV transmission i.e. the spread of poverty and deterioration of public health facilities concurrent globalization, in an amazing twist of logic warns the capitalists of the US and Europe that "HIV breakout could have lasting economic in effect. consequences cutting afflicted countries off from globalization". So in short, globalization facilitates the spread of HIV but endangers the globalization project at the same time. This is a typical manifestation of the sharp contradictions inherent in capitalism. Capitalism creates wealth but



inequality also extreme thereby endangering capitalism itself. Capitalist expansion or globalization wealth créates multinational corporations and local elites but spreads HIV endangering globalization itself. For bourgeois commentators like Eberstadt it is impossible to draw the logical conclusion that to stop the spread of HIV capitalist globalization must be stopped. It is impossible to state that an opposite global project to that of capitalism, a project of eradicating poverty worldwide and providing healthcare, sanitation and education to all, in other words, that a democratic and socialist project must replace the irrational capitalist globalization project. No, that would endanger his own position as a well paid apologist for the system.

What Causes AIDS? HIV or

Indeed there is an increasing chorus of opinion questions some of the fundamental beliefs about HIV and AIDS. The principal point of contention put forward by people such as Gary Null and many others, scientists as well as the infected, is the connection between HIV and AIDS. It is apparent to even the lay observer that HIV takes root most readily in the fertile soil of extreme poverty thus its epidemic spread in sub Saharan Africa. Even Eberstadt admits as much in his essay. AIDS or the complete breakdown of the immune system is said by Null and others to result from the drugs that are administered to treat HIV infection and is not an automatic product of HIV as is contended by the established authorities on the subject. The current drug regimen in place for AIDS has been likened to the power of nuclear weapons. Yes, you kill some of the infection(s) but you destroy the whole body in the process.

While the truth of the matter seems to require further examination one thing that is abundantly clear is that the pitalis healthcare/pharmaceutical industry is driven by the flow of profits and not by the search for a cure. Indeed curing disease will only kill the golden goose that lays fat profits for capitalist health. So Eberstadt is only partially correct in stating that an HIV epidemic in Eurasia will threaten globalization. The threaten globalization. The profits of multinational drug dealers like Merck will only rise. However as the overall societies decay there ability to provide cheap labor to the

whole gamut of euroamerican corporations will be diminished. The way forward lies in the globalization of justice, democracy, human rights, and not in the globalization of capitalism.

Every catastrophe predicted by the doomsayers of old will not only come to fruition but will seem mild compared to what the profit mad irrationality of capitalism is leading us to. The plague of HIV, the endless wars of Fuhrer Bush, the ecological disaster of global warming are the products of this sick, immoral, rotting system. We have a choice before us follow the mad bomber imperialists to a collective suicide or fight for a society whose logic is to meet the needs of humanity in harmony with the ecology.

What is the essence of North Korea's nuclear weapons, revealed by the U.S. administration?

On October 16, the US State Department announced that North Korea had admitted, during an early October diplomatic visit to the capital city of Pyongyang, to having established a uranium enrichment program for nuclear

According to the New York Time's article of Oct 29, 2002, "The Greatest Threat", by Nicholas D. Kristof, "The scariest place in the world right now is not Iraq, but rather the Korean peninsular," pointed out Kristof. Based on the logic of Bush administration's "war on Iraq," this is honest response to the North Korea's admission that have been secretly developing a nuclear weapons program in breach of international agreements. For months US officials have been arguing that Saddam Hussein must be ousted militarily on the basis of unsubstantiated claims that Iraq is covertly developing "weapons of mass destruction," including nuclear, biological and chemical arms. While Iraq has been denying such unreasonable claims of the U.S., North Korea obviously acknowledged that they have a program to enrich uranium for nuclear weapons. If this is so, North Korea is more dangerous than Iraq as Kristof pointed out. Yet, the U.S. response to North Korea was a solution through peaceful It is a glaring diplomacy. contradiction between its stance over Iraq and North Korea. This response exposed the complete hypocrisy of the Bush administration's plan for war against Iraq.

In this contradictory situation, we can ask a question. Despite exposing the contradiction between Bush's administration stance over Iraq and North Korea, why did the Bush

administration announce that North Korea had admitted to have nuclear weapons program? By the Ho Suk Han, a Korean

By the Ho Suk Han, a Korean affairs expert, we can get a answer from the following events since 1993. On March 10, 1993, North Korea announced that it would not allow the 'special inspection' by the International Atomic Energy Agency (IAEA) instigated by the United States. On March 12 of the same year, North Korea announced that it was withdrawing from the Nuclear Non-Proliferation Treaty (NPT). North Korea was the first country to take such a drastic step that no other nation would dare. None of the US officials had anticipated North Korea to react to the US pressure so dramatically and they were at loss on how to respond to North Korea's challenge.

To the consternation of the world, North Korea went on the offensive: on May 29, 1993, North Korea test-fired a 500 km missile that landed in the ocean near Japan's Nodo Peninsula; on the following day, it test-fired two missiles of 3,000 km range (2-stage Inter Continental Ballistic Missiles) with one landing near Guam and the other splashing down near Hawaii. North Korea had demonstrated that it could strike US military bases anywhere in Japan, Hawaii, Alaska, Guam, and Okinawa. It was a chilling demonstration to the US military. In this way, North Korea applied simultaneously political and military pressure on the United States

The Clinton administration had threatened military actions, if North Korea refused the IAEA special inspection. But in the face of North Korea's defiance and show of force, Clinton was forced to back down and proposed a peaceful solution. Consequently, U.S. and North

Korean representatives met in New York from June 2nd to 11th in 1993. This political conference was a major setback of Clinton's hard-line policy. North Korea laid down its basic demands and the United States military issues.

On October 16, the US State Department announced that "we have recently received intelligence reports that North Korea has a nuclear program to enrich uranium." A Wall Street

had no other choice but to accept them. The historic US-North Korea Joint Declaration was

signed on the 11th.


The 1993 US-North Korea contains declaration principles: (1) The United States abandoning it's hostile policies toward North Korea, (2) Denuclearization of Korea, and peace and security in Korea guaranteed, (3) Respecting North Korea's national sovereignty and non-interference in internal affairs, and (4) Peaceful unification of Korea. In October 2002, the Bush administration dispatched a special envoy, James Kelly, to Pyongyang, to renegotiate the US - North Korea Few newspaper reporters and analysts are aware of North Korea's three principles enunciated in the 1993 US-North Korea joint Declaration and of the fact that North Korea has been after the United States to put into practice the three principles it had accepted in 1993. They claim, erroneously, that North Korea wants material compensation for scrapping its nuclear program and that North Korea is using its nuclear card to force the United States to enter into making political deals with North Korea. Nearly all news reporters and analysts are under the mistaken notion that North Korea is using its nuclear program to squeeze out more economic aids. It is naive to think that North Korea has been confronting the United States politically and militarily in order to wring out some dollars from the United States. It is true that economic aid is indeed mentioned in US-NK, Japan-NK negotiations but economic aid is only secondary to political and

Journal article of October 17, 2002, states, citing Bush officials, that the Bush administration received an intelligence report in July 2002 on North Korea's acquisition of enrichment equipment from a third country. Did the United States learn of North Korea's uranium enrichment program in July 2002 for the first time? Not really. Published reports indicate that the United States knew about the enrichment program as early 1999. Pakistan tested a uranium bomb in 1997 and a US government report published soon after stated that North Korea would have uranium bombs by 2004. Benjamin A. Gilman, a US Congressman, stated in a speech at the Asia Society meeting held in October 1999 that North Korea was developing uranium bombs. Bush's security advisor, Condoleezza Rice, told a CNN reporter that "there were scattered reports of North Korean nuclear program prior to 1999, when we received convincing evidence of the North Korean nuclear program. We have received conclusive evidence of the program this summer."

The United States has two 'rogue' nations under "nuclear' suspicion: Iraq and North Korea. The US policy on Iraq differs substantially from its policy on North Korea. Bush is preparing war on Iraq to topple Saddam Hussein and replace his government with a pro-US government. In contrast, Bush wants a peaceful settlement with North Korea.

The United States has negotiated several agreements

with North Korea since 1990 even after North Korea's nuclear program became known, even to the point of agreeing to a Clinton-Kim Jong II summit. Saddam has had no such luck with the United States. Instead, he has been under constant threats of war, continuing embargo, political and diplomatic isolation. Bush makes no bones about his desire to replace Saddam.

Why is this so? The answer lies in the relative military capabilities of Iraq and North Korea. Colin Powell admitted in an NBC interview (October 19) that "North Korea's military is much stronger than the Iraqi military." North Korea has nuclear weapons whereas Iraq does not, and North Korea has (Inter Continental **ICBMs** Ballistic Missile) whereas Iraq does not. If North Korea had no nuclear weapons, the United States would not have bothered to negotiate political settlements and North Korea and Iraq would have been in the same boat. The United States negotiate with nuclear powers but wage war with non-nuclear nations.

At a news briefing on October 17, Rumsfeld stated that North Korea is believed to have 'one or two' nuclear weapons, based on the intelligence collected since 1990. Bush's special envoy James Kelly told Japanese

foreign minister Kawaguchi Yoriko and other officials that North Korea has 'a small number' of nukes. A Newsweek article dated October 18th, citing a US official, states that North Korea could be producing 'six or so' warheads within a year. The United States informally admits that North Korea has nuclear bombs and the general public accepts that. According to the British magazine, the Sunday Times (October 27, 2002), China warned the US CIA that North Korea might have 3-5 nuclear bombs. It has been established that North Korea has nuclear weapons, although no one knows exactly how many. Nuclear North Korea is no longer a secret and one must accept this fact and deal with the political and military issues in Korea accordingly. Nuclear North Korea limits the US options.


Why is it that the United States refuses to acknowledge nuclear North Korea? Why hasn't North Korea declared its nuclear power status? First of all, if the United States admits officially that North Korea has nuclear bombs, than Japan would want to build nuclear bombs and the Far East will plunge into a nuclear arms race. The United States must not allow Japan to acquire nuclear weapons in order to keep the US-Japan alliance and the Nuclear Non-proliferation Treaty (NPT) alive. Hence, the United States

cannot publicly accept nuclear North Korea. Secondly, North Korea has not openly admitted to possessing nuclear weapons. The reason why is that North Korea has no reason to admit it because all North Korea has to do is to threaten to break the Nuclear Non-Proliferation Treaty (NPT) and not necessarily break The threat alone is sufficient to force Bush to come to the negotiating table. The issue is not North Korea might develop nuclear weapons but it is saving the Nuclear NPT. The reason why the Nuclear NPT is so crucial to the US foreign policy and its military should be fully understood. The Treaty is the foundation upon which the US dominance of the world is based. university security and created a CUNY
Peace Officer Corps to replace the
private security guards at CUNY
facilities. The proposal envisioned that
the CUNY Peace Officers would be
sworn peace officers licensed to use
firearms and with the power to make
arrests. In 1994 '2.10[27] of the New York
Criminal Procedure Law ("CPL") was
amended to give police powers to the
CUNY Peace Officers, including the
powers to make arrests and to use
deadly force as provided by CPL
'2.20[1].

48. The initial purpose of the Peace Officer Corps was to create a force responsible to the CUNY Chancellor that could be rapidly deployed to arrest student demonstrators without having to go through the procedures mandated by the CUNY Board for calling police in non-violent demonstration situations. Since 1994 the Peace Officer Corps has been used to conduct surreptitious surveillance and intelligence operations monitoring student activists on and off campus; to arrest student protesters engaged in legal First Amendment activity and to prohibit the distribution of literature deemed offensive by college or university officials.

49. In 1995 CUNY Peace Officers arrested 47 students who were engaged in a peaceful hunger strike to protest cuts in funding to CUNY. Charges against the hunger strikers were eventually dismissed. However,

documents obtained by subpoena and through the New York State Freedom Of Information Law ("FOIL") (N.Y. Public Officers Law "84-90) disclosed that in 1995 CUNY Peace Officers compiled a "black list" of 91 students and faculty that was circulated to CUNY college presidents and other CUNY officials. The list was based on information obtained from the New York City Police Department regarding arrests of the subjects at demonstrations that were held off campus. Documents revealed through discovery in a student disciplinary case revealed that in 1994 CUNY Peace Officers in plain clothes conducted surveillance of students attending a demonstration at City Hall.

CUNY officials banned controversial speakers invited by student organizers of Black Solidarity Day ("BSD") events at York College in 1994 and 1995 and deployed Peace Officers to prevent the banned speakers from appearing on campus. Documents disclosed in discovery in Ford v. Reynolds, 96-CV-0246 (E.D.N.Y.) (SJ) revealed that several CUNY Peace Officers brought firearms to York College on the day of the 1995 BSD event despite an explicit order by the college president that Peace Officers would not be permitted to carry firearms at the

51. In 1996 the CUNY Peace Officers began a pilot program utilizing dogs to patrol several campuses.

atrol several campuses.
52. In 1998 CUNY Peace Officers

installed a video camera hidden inside a smoke detector at the entrance to a room used by student activists at City College to conduct their meetings. Sigal v. Moses, 98 Civ. 3940 (TG) (S.D.N.Y.). In an affidavit submitted in Sigal v. Moses Defendant Timothy Hubbard admitted that one of the reasons the surveillance camera was installed was to conduct surveillance on students college officials suspected to be planning a demonstration to coincide with the college's graduation ceremony.

53. On May 26, 1998, CUNY Peace Officers arrested a 77 year old woman, a nun, and the chairman of the New York State Assembly Committee on Higher Education, the Honorable Edward Sullivan, when they refused to leave a public meeting where the CUNY Board of Trustees was about to vote on a proposal to end all remedial classes at four year colleges in the CUNY system and had illegally gone into executive session. A New York State Supreme Court Justice subsequently found that the closing of the meeting and the excessive security tactics utilized by CUNY security personnel violated the New York State Open Meetings Law.1 Crain v. Reynolds, Index No. 115990/95 (N.Y.Cty. Sup. Ct. August 10, 1998) appeal dism'd as moot 687 N.Y.S.2d 79 (1st Dep't 1999).

54. In 1999 a female alumna who was arrested by CUNY Peace Officers for allegedly shouting at a public hearing filed a federal lawsuit alleging that she

had been strip-searched by a police officer while she was in the custody of the CUNY Peace Officers.

55. In 1999 a FOIL by student journalists request revealed that over a two year period the CUNY Office Of Public Safety purchased over 100,000 rounds of ammunition including hollow point ammunition and hundreds of rounds of buckshot and birdshot that, on information and belief, would be illegal for the New York City Police Department to possess.

56. In the mid 1990's, the President of City College disapproved a proposal by Defendant Timothy Hubbard to authorize CUNY Peace Officers stationed at City College to carry firearms when on patrols in the community surrounding the campus. However, several months later Peace Officers began carrying firearms while escorting students and employees to the subway station at City College at night at night. At a meeting with faculty members the college president denied that she knew that the Peace Officers were carrying firearms in violation of her directive.

A Peace Officer, someone whom students should look to for protection has destroyed. for protection, has destroyed this seal of trust students have with the Public Safety and any other person in authority. According to law enforcement agencies in the year 2000, a total of 7,530 known offenders were associated with 8,063 hate crimes. 64.4 percent were white, 18.7 percent were black, 1.4 percent was Asian/Pacific

Islander, and 0.6 percent was American Indian/Alaskan Native. (Hate Crime Statistics, 2000)

According to the Hate Crime Statistics, incidents of biased crimes committed in schools or colleges are 11.4 percent. Incidents occurring on or in residential properties are 32.1 percent, and incidents committed on a highway, road, alley, or street accounts for 17.9 percent

Congress has passed many anti- crime legislated acts which include, the Hate Crime Prevention Act of 1999, the Church Arson Prevention Act of 1996, the Hate Crimes Sentencing Enhancement Act, and the Hate Crime Statistics Act of 1990. The Office for Victims of Crime (OVC) works to try to improve the justice system's response to victims of hate crimes. The Bureau of Justice Assistance (BJA) has a training initiative for law enforcement agencies to generate awareness and to help in identifying, investigating, and taking appropriate action for bias crimes. The BJA also arms agencies with tools for responding effectively to any biased crime. The Office of


