



CSI/CUNY **No Justice No Peace CSI Students Rally Against Police Brutality**

lack, white, fuck Giuliani! echoed through the CSI campus on the after-D noon of Wednesday March 23, as students rallied against police brutality. The trend of student apathy at CSI seemed temporarily nonexistent as a group of about sixty students marched from the campus center to the front of the library. The students chanted anti-police brutality and anti-Giuliani slogans in response to the fatal February 5th shooting of Amadou Diallo. Students were especially enraged because the officers who killed Amadou had not yet been indicted. However, the rally was also aimed at challenging a political system which allows such atrocities to happen.

Upon reaching their destination, the library, students were given a chance to voice their opinions on police brutality,

Leslie-Ann Alvaradous, who passionately demanded the active participation of her fellow students in the fight against police brutality. On the MOVE! she cried out, in an open expression of her admiration towards a group of revolutionaries known as MOVE who spoke out against police brutality and other social justice issues some twenty years ago. There were about thirteen speakers, some with conflicting views of how the issue of police brutality should be dealt with, but all in agreement that the death of Amadou Diallo proves that there is an issue of police brutality in this city, which needs to be addressed.

The overall message that most speakers tried to convey is that change requires the participation of every one, that to stop police brutality we need to organize and be active in the movement. Organize wherever you are, stated William Wharton who was a key




can Dream now? Shot forty one times! The demonstration did not consist entirely of students, Professor Calvin Holder, of the CSI History department, voiced his opinion as well. Look at how the police department functions as an institution, it could not behave the way it has over the years if it did not have the sanction of the organizations in this city, stated Professor Holder. He then urged students to participate in the struggle against police brutality through organizing and voting. Manjula Wijerama, a student, rejected the idea of reforming the police all together, claiming that Its not a few bad apples, it s a rotten barrel! Mr. Wijerama is a militant revolutionary who feels that the police department, along with the entire capitalist system needs to be overthrown.

Some speakers related there personal experiences with police brutality. I ve seen police brutality, I ve been put in a police car and beaten. I don't know Amadou, but I m going to fight for him, stated student, Kwan Burton. I am an

immigrant from Barbados, stated Diane Isaac, I have three sons. Any one of my sons could be in the position of Amadou, I weep for them.

Tabitha Elkins, another CSI student, delivered an especially powerful speech about the role that police brutality plays in a capitalist society and how blacks and whites need to unite in fighting oppressors If one of us is oppressed we are all oppressed, she stated, We are being brainwashed. Poor white people fighting poor black people for dinky jobs...this is about human rights, our rights are being taken away by corporations. Another student, Jeremy Burnstein, lead the group in counting to forty one as a representation of the forty one bullets that were fired at Amadou Diallo.

Overall, the demonstration proved that the student body at CSI is not completely apathetic. There are in fact many students who care about civil rights issues and are willing to stand up for what they believe in. The movement may be small, but it is growing

I finally received my fair hearing on February 23 and the judge ruled in my favor.

He stated that HRA had failed to provided sufficient evidence to support their determination. The judge ordered HRA to recompute my childcare and transit allowances immediately and disperse my check. The judgement was signed and dated February 26, 1999.

Today s date is April 5 and neither my childcare provider or I have received one penny from HRA. I will once again be forced into court with a lawyer to get HRA to comply with a court ordered decision. How long must I wait?

As a college student on public assistance it is extremely difficult to fight these battles with HRA and the Mayors office. Students Against WEP (SAW), a group formed this semester to fight for students rights, desperately needs your assistance. If you are a college student that receives

public assistance or you are opposed to the slave labor of the Work Experience Program (WEP), please come and see me. You can call me at (718) 876-5115 or 5126. We need to come together and act as one voice for our futures in college are surely in doubt.

If you are a student or faculty member who truly believes in CUNY's mission to educate the poor and low income people you cannot stand still for what the mayor is doing. We must work to pass laws that will protect people not punish them because you might be in my shoes one day.





How's this for a policy of student leadership? If you throw in some minor squabbling and anti-administrative rhetoric that about sums up the leader-ship strategy of this student government.

It's a little difficult to demonstrate student leadership when half your slate quits in the first two months. Jay Baitner perhaps the most rationale member of the government left in the first month after tiring of the dictatorial Gallo and the weak kneed Healy. Finance Commissioner Kaleen McCabe quit two months in to the new government after a falling out with Gallo. SG Senator Meredith Fogelman was verbally and physically attacked by Gallo after a Student Government meeting in which Fogelman opposed Gallo. After SG Senator Alycia Parker was banned from the government following a racial incident, the government did nothing - not a motion, a declaration or demonstration - in her support. SG President Morgan Healy then a member of the Student Faculty Disciplinary Committee that convicted Parker, actually quit the commission the meeting before the verdict was delivered thereby scaling her fate.

Overall

As one CSI administrator remarked recently, "This is the ,most pathetic Student government in the history of student governments!" Nothing more needs to said when the bureaucrats themselves deliver that type of critique. Gallo/Healy/Woods have delivered the student government back into the hands of the CSI administration through incompetency and inaction. They have neutered the student controlled institution with the largest amount of funding and the greatest possibilities for positively influencing students lives. Change, a movement towards an activist based progressive student government with the guts to stand up to administrative authority and fight the battles that count deserves the votes of the CSI student body.

As the time for student government elections roles around once again it is crucial that the current government of Gallo/Healy/Woods is harshly criticized for their lack of action. Sidestepping and ignoring crucial social and student issues is the path of bureaucrats, confronting and organizing for change is the job of activists. The choice is obvious - action or nothingness.

Yesterday I received 35 pages of receipts for ammunition, weapons and accessories purchased for CUNY Security from late 1995 to early 1998. The information was forwarded to me by the student editors of the Hunter Envoy who made a Freedom Of Information Law (FOIL) request to obtain the material.

The receipts appear to indicate that during a 20 month period from April 1996 through January 1998 CUNY Security purchased over 80,000 rounds of ammunition, including at least 4,000 rounds of hollow point ammunition.


The receipts show purchases including 25 Glock automatic pistols, with 15 round magazines and six night sights as well as 400 units of pepper spray, 44 units of MACE.

Most disturbing, the purchases included 390 rounds of shotgun ammunition (110 rounds of 12 gauge buckshot, 130 rounds of 12 gauge slugs and 150 rounds of birdshot or skeet).

Who has the authority to authorize CUNY security to use buckshot?

Under what circumstances will CUNY security fire shotguns? This material should be presented to concerned elected officials before it s too late. Any suggestions?

I am indebted to Keith Higgenbotham and the other student journalists on the Hunter Envoy for uncovering this material.

COLLEGE VOICE EDITORIAL Defeat Imperialist Murder from the Bronx to Belgrade!!!

The police mentality that drives American domestic policy is also the driving force of American foreign policy. As minority and working

neighborclass hoods are occupied by trigger happy cops in the US, bombs rain down on the peoples of Yugoslavia and Iraq - all in the name of peace. Black youth, like Amadou Diallo are sacrificed by racist cops on the streets of NYC for the sake of preserving the quality of life for Wall Street yuppies.

American domestic policy

like American foreign policy is a policy of divide and rule. In the US, Blacks, Latinos, immigrants, youth and whole sections of the American populace are targeted by the State as de facto criminals to be policed, incarcerated and brutalized. This policy of racial classification and segregation has served to construct the illusion of white privilege , which for the majority of working class and poor whites , is a pathetic lie.

Unfortunately, the psychology of domination imposed by the American State has been partially successful. It is easier to

> hate, ridicule and dehumanize those who are vulnerable. An illusion of superiority, of privilege, is created in the minds of those who are not being treated like criminals, even if they are simultaneously being downsized from their jobs - they

think at least I m better off than them .

Similarly, American foreign policy criminalizes whole peoples - the Iraqi s, the Serbs, the Cubans, the North Koreans, the Chinese - and, through its mass media complex, lulls people into supporting or turning their backs on fellow humans being bombed to hell. Since when can the US, which has committed genocide against the original inhabitants of America, that enslaved Africans, that bombed the Japanese with nuclear weapons, that napalmed 2 million Vietnamese to death, talk about self-determination?

In fact they do not support the right to independence of the Kosovars in Yugoslavia. They are using the plight of the Kosovars as a cover to bomb Yugoslavia. The plan of the American imperialist State is nothing short of world domination. The world will be a US marketplace and anyone who does not follow the rules will be demonized and annihilated. What arrogance for the US with its miserable history of genocide and slavery to intervene in the affairs of a sovereign states in Europe (Yugoslavia) and the Middle East (Iraq).

The bombing of Yugoslavia is a criminal and immoral act just as the killing of Amadou Diallo was a criminal and immoral act. However, both crimes are being justified by the State. In the case of the police killing of Amadou Diallo the widespread outrage of New Yorkers, particularly the Black and Latino communities, has exploded the lie that murder is justifiable simply because its carried out by the State. As broader sections of the population are waking up and realizing that Amadou was executed, the friends of the people Democrats and other defenders of the racist, capitalist status quo are scurrying around trying to channel peoples outrage into a safe channel. The police are good and helpful, they cry, we just need to train them better, and oh yes give them a pay raise and they won t kill anymore.

The struggle against police brutality at home must be one with the struggle against imperialist world police brutality abroad. Every murder that the US gets away with whether its on the streets of NYC or in Yugoslavia or Iraq serves to strengthen and embolden the murderous State. It follows that every defeat of this murderous state apparatus at home or abroad is a victory for all people, everywhere.

The multinational working class of New York must demand an end to police brutality and an end to imperialist bombing in Yugoslavia and Iraq. The racist imperialist policy of divide and conquer must be countered with the workers policy of solidarity and action.

A Baby's Death Equals A System's Failure

Recently a ninetcen-year old woman's baby tragically died of starvation due to her efforts to breast feed while lacking breast milk. As if this were not enough, she is being brought up on charges of manslaughter. If convicted, she would face up to fifteen years in jail. Who is pressing these unprecedented charges? The father of her child, who was not there to care for

his family after the birth? Was this a question of apathy? The boyfriend, whom she was not on good terms, advised her to see a doctor. Apparently the woman sought the customary follow-up visit after birth but was denied access to medical care due to bureaucracy. Although the baby was medically covered from birth this woman was refused a doctor s appointment. Troubling issues come to mind:

Is it fair to criminalize a young and inexperienced person for an error in judgement? Breast-feeding is currently very popular, being perceived of as the nurturing and correct thing to do. This idea is promoted both by mainstream culture and by the medical establishment. Information about the downside of breastfeeding is not so readily available. Many experts agree that it would be easy for an inexperienced new mother not to detect the signs of starvation in the way that a trained medical professional would.

She sees the baby every day and may not notice small weight losses would add

up over a period of a few weeks. She may miss or be unable to cope with the idea of her child being sick or in danger.

Most women need the weeks after pregnancy for a time of recuperation. Pregnancy is an ordeal for both body and mind. The main reason for the standard established leave of absence from employment, two weeks before the birth and four weeks after, is medical necessity. Assuming the mother has kept track of her last men-



strual cycle correctly, the baby s approximate birth date can be determined within two weeks. The company employing you does not want you to go into labor at work, so this time is given to you. The same is true of the time after birth. The month you are allowed off from work is due to the fact that women can easily hemorrhage during that time period (until the bleeding stops). Postpartum depression is also a common occurrence after birth. This may not be the best time for good judgement or decision making.





If a person is not aware of the risks and consequences of their judgement, and acts with the best intentions, can they be criminally responsible for a negative result? Is not the real criminal action the denial of medical care to our most vulnerable members of society, unprotected babies and poor mothers? It seems this baby s death could have been avoided with proper medical advice.

The role of the father here and in much of our general society seems to be peripheral, one of distant adviser and judge. As a father, he is entitled to his grief and perhaps anger. But as a person, can he not empathize with another human being? Was his judgement any

more correct in not utilizing any a v a i l a b l e sources? If an emergency situation was perceived, why wouldn t he have contacted that Gestapo

agency, child welfare, who can gain access to people s houses unannounced and search for signs of neglect or abuse, from anonymous phone calls. If ever there were a justification for calling such a questionable resource, this would be it. I have had firsthand experience with the difficulties of breast-feeding. When my first child at first refused the nipple, then, after nursing, seemed cranky and sleepless. I tried to obtain advice by calling La Leche, an organization that promotes and assists women with breast-feeding problems, but they basically advised me some problems were to be expected and to keep at it. Fortunately her father and I discussed the matter and were able to agree on supplemental bottles, which solved the problem, as the milk came in better later on. The importance of positive and supportive relationships with men after childbirth and while raising children can t be denied.

Unfortunately, in this particular situation the young mother had no one to consult with about her newborn s health.

Obviously the problem here is not her negligence, but a failure of the healthcare system and the position of single mothers in our society.

tioned murder by racist police officers, butchering genocidal Serbian Nationalists, and NATO warplanes.



It is not because he is a murderer, rather because he is a rebel, because he seeks justice in an unjust society, because he defies the thin boundary between right and wrong defined by the state. 
URBAN WARRIOR, WHAT ARE YOU TRAINING FOR?

On Monday March 15, 700 troops supported by 6,000 Marines and sailors along with 2,000 civilians, refugees, reporters and police invaded California s Oak Knoll Naval Hospital and Alameda Point in Oakland. The Marines were equipped with M-16 s, helicopters, Humvees, guns, artillery, laptop computers, digital radios and acoustical anti-sniper weapons that automatically fire .50 caliber bullets at the sound of gunfire. In actuality there was no real attack, only a show complete with actors and scripts. All of this was part of Urban Warrior, a military combat operation in which 21st century military technology could be tested and troops could learn how to make massive landings, attack and bombard urban coast-Local police and firefighters lines. would be able to sharpen there response to a disaster.

This war game did not come without protest, 22 demonstrators were arrested at Oakland City Hall, demanding to see Mayor Jerry Brown, the supposed progressive liberal, who authorized the military s operation. Another 100 residents protested at the arrival of the ships and stealth bombers on Monday morning. The demonstrators cries of Child care, not warfare and You can t stop our spirit, it is strong like a mountain, was barely heard over the roar of Sea Stallion and Sea Knight helicopters flew by.

One well known leftist was quoted saying this is just a dress rehearsal for war...we think there are just preparing for Iraq. But is this really what the goal of Urban Warrior is, does the military really need to train troops for Baghdad, when all they need to know is how to press a button which releases a bomb? The problem the government anticipates may be closer to home, it could be in Detroit, San Francisco or New York. In 1991 the police were almost powerless when Los Angeles residents took to the streets in riots during the Rodney King trial. Here in New York Giuliani upgraded the level of police force at the Million Youth March, sending out cops in riot gear ready for action. Could it be that the government is preparing for the next uprising? After the Diallo shooting over 1,200 people were arrested, demanding that the four policemen responsible for his death be indicted and arrested. The level of consciousness and

awareness is rising thanks to state sponsored repression. Each case of police brutality opens the eyes of more youth and pushes the community to take real action. Thus, operation Urban Warrior ensures that troops will be ready when the people try to take the power back.

Marines held a march and a public display of their weaponry to wide eyed youngsters, in the Oakland suburb in hopes that they would inspire the next generation. Demonstrators and residents alike responded to this as a recruitment tactic masked behind a training exercise.

Yugoslavia is not responsible for the torture of Abner Louima, the murder of Amadou Diallo and the attempt to legally lynch Mumia Abu Jamal with the racist death penalty. No, OUR enemy is at right here, home ... on Wall Street and in Washington. Our enemy is America s ruling rich and their Democan and Republicrat politician pals like Bill Clinton and Rudy Giuliani. American workers should oppose the bombing of Yugoslavia not because it supposedly strengthens Serb strongman Slo-

bodan Milosevic, but because it strengthens Bill Clinton and the American ruling class and its ability to wage war against workers around the world and in this country as well.

How America Takes Care of Its Own After three American serviceman were captured by the Serbs, Clinton boasted that America takes care of its own. Well, Clinton certainly takes care of his own, like the bankers and bosses who pay his way and who have made record profits under his administration. But how does Bill Clinton s America take care of its own working people. By closing schools, hospitals and factories and throwing people out of their homes and on to the streets. And how does Clinton s America take care of working people in other countries, countries like Iraq and Yugoslavia. By bombing hospitals, schools, factories and homes when starving people through embargoes and blockades no longer does the trick. The same government that makes war on the people of Yugoslavia and Iraq has been making war on the living standards of working people in this country since the seventies. American capitalism's foreign policy is the logical extension of domestic policy; they are two sides of the same coin; they both serve the rich and they both harm working people. Every nickel, dime and dollar spent on bombing

schools, hospitals, homes and factories in Iraq and Yugoslavia is a nickel, dime and dollar less spent on building them in this country! Not one dime, not one man or woman for the imperialist war machine; money for jobs, education, housing and healthcare instead!

Imperialism with a Human Face?

Clinton and the prostitute Pentagon press insist that they are bombing Yugoslavia for humanitarian reasons, supposedly to save the Albanians, just as in Vietnam, they had to bomb villages to save them. The only thing that motivates them to do anything is protecting their profits and their power to make even more of them. For these are the same humanitarians that have bombed and starved the people of Iraq for the past decade and continue to do so today under the aegis of the UN which they use as a fig leaf to legitimize their endless acts of aggression around the world. These are the same humanitarians who

bombed the Sudan and Afghanistan last year. These are the same humanitarians who supported the death squads in El Salvador, the contra killers in Nicaragua, Pol Pot in Cambodia and the women-hating Taliban thugs in Afghanistan and who bankrolled bloody dictators like General Pinochet in Chile and Suharto in Indonesia. All to guarantee that the same bosses and


bankers who exploit and oppress workers here can do the same in the rest of the world with impunity. And let s not forget, Bill Clinton is the same humanitarian who incinerated 86 people in Waco Texas in 1993. And now it s Yugoslavia s turn.

Divide and Rule in the Balkans

What American imperialism really doesn t like about Yugoslavia is not Milosevic s persecution of the Albanian Muslims. The US cares as much about the Albanian Muslims as they care about the Kurdish Muslim victims of their Turkish allies, the Palestinian Muslim victims of their Israeli allies or the Iraqi Muslim victims of their own bombs and blockades. What they don t like about Yugoslavia has nothing to do with the Albanians at all. It has to do with the fact that Yugoslavia, like Iraq, refuses to bow and scrape to every dictate of American imperialism. The Balkans is a strategic crossroads between Western Europe and the oil-rich Middle East and Caspian Basin. Yugoslavia is the only country in the Balkans that has refused to allow American troops on its soil; troops that will be used to crush the workers of those countries and the workers of Russia when they have had enough of the mass misery that Westernstyle democracy and the madness of the market has brought them.

That is why the US media has spent the last ten years demonizing Milosevic the same way they did with Noriega in Panama and Sadaam Hussein in Iraq...to prepare the American public for war. As Noam Chomsky pointed out, tossing terms like genocide about is how the media manipulates the masses to support more massive military action. That s why the US has had an Iraq-like embargo against Yugoslavia since 1992 and why it wants to detach the mineral-rich region of Kosovo from what s left of Yugoslavia. What s left of Yugoslavia, because Yugoslavia used to be a multi-

national state until the counterrevolution that swept over the former Soviet bloc got hold of it and, aided by Germany and the US, broke it up into a whole host of economically unviable western puppet states, all at each others throats and all occupied by US troops. In order to enforce this situation the US and its NATO allies helped their Croatian and Bosnian allies bomb 600,000 Serbs out of the Krajina in 1995, the biggest act of ethnic cleansing, forced population transfers, of the entire war. That is the kind of humanitarianism imperialism has brought to that region and will continue to bring until working people there unite to put a stop to it. It took the Yugoslav socialist revolution to unite working people of all nationalities against all the nationalists and their imperialist backers during World War II; it will take another revolution to do the same today only this time they need to create not just a Yugoslav socialist federation but a federation that encompasses all of the Balkans. That is the only humanitarian solution for the Albanians...and all the people of the region and it is the one solution that the US is dead set against because it spells dooms for their plans to dominate the region by continuing to divide it!

So what can antiwar activists in the US do? We have to begin build a powerful antiwar movement that allies itself with the struggles of trade unionists, of Blacks and other minorities, of women and gays, of all the exploited and oppressed victims of Washington and Wall Street s war on working people. But we cannot build any kind of effective antiwar movement by allying ourselves to the war-mongering Democratic party of Bill Clinton the way the misleaders of the unions, the mainstream Black organizations and the middle class feminist groups have done and will continue to do. They claimed that keeping Clinton in and the rightwing Republicans out was the lesser evil. Yet for the Iraqis and the Yugoslavs who is the lesser evil? The truth is that both bosses parties are equally as evil. That is why workers also need to build a political party of, by and for the working class; a revolutionary socialist party, that can make and take the power once and for all so that Bill Clinton and his class can no longer do any damage here or anywhere else!

The NATO Bombing: US Imperialism in Action by Europa Gronenthal In yet another example of US domination, NATO, with full US support, is bombing

Yugoslavia. The worst part is that the United States is carrying on its killing and violence in the name of humanitarianism. How can we expect to get the real story, when it is General Electric who owns NBC and co-owns MS/NBC, and who is one of the largest military contractors which supplies engines for NATO jet fighters?

The main excuse is that the bombing is to protect the rights of the Albanians in Kosovo. However, all nationalities in Yugoslavia are being killed in this war, and their land is being poisoned with radioactive depleted uranium weapons. The United States obviously does not care about the rights of the predominantly Muslim Albanians, because US policy of sanctions and war is killing 300 Iraqis every day, who are also mostly Muslim.

It was the United States and NATO powers who played a key role in breaking up Yugoslavia in 1991-92, arming and supporting secessionist movements. For 45 years after World War II, the many nationalities that made up Yugoslavia lived together in peace. In the civil wars that followed the break up of Yugoslavia, there were many fatalities and human rights violations on all sides. The biggest single act of ethnic cleansing was the forced removal of 600,000 Serbs from the Krajina region of Croatia by the US-trained and armed Croatian military in 1995. Now, more than 55,000 of the people made refugees by the NATO bombing are these Serbs, who were resettled in Kosovo.

Every cruise missile costs one million dollars. Instead of using this money for housing, healthcare, education, and other much needed social programs, it is put into the militaryindustry complex and big business, with no benefit to the working class here, and at the expense of many lives across the world.

Searching for a new identity following the collapse of the Soviet Union, the United States has offered, itself up as the great purveyor of democracy and humanitarianism. The great evil is no longer the threat of global Communism but the rise of dictators and demagogues in historically unstable regions of the world. The new civilizing mission of the U.S. includes

most undemocratic regimes to help spread global democracy. Clinton has referred to the rise of Milo-

sevic as a threat to our national interests as the American corporate media machine pounds the drums of war. A litany of Milo-

Kuwait the great bastion of freedom. was defended by the US against the aggression of the first threat to the free world Sadam Hussein. While the Kuwati ruling class danced the night away in the safety of Egypt, US forces terrorized Iraqi troops with a barrage of sophisticated weaponry. Eight years later the bombing and persecution of the Iraqi people continues unabated enforced by fighter planes and a brutal embargo which has resulted in the death of over 600,000 Iraqi women and children. Hussien's control over political power in Iraq has been consolidated as the people of Iraq rally around him in the face of US imperialist aggression. Let s examine the type of society the US was fighting to preserve.

Political Freedom

Kuwait is dominated by princes from the Al-Sabah family who have ruled Kuwait in consultation with prominent community figures for over 200 years. Protecting the Kosovars

ONCE again, and led by the United States as usual, a war is being conductedthis time in Europe- against an unprincipled and racist dictator who will almost certainly survive the onslaught even though thousands of innocent will pay the actual price. The pretext this time is of

course the persecution, ethnic cleansing and continued oppression of Albanians in the province of Kosovo by the Serbian forces of Slobodan Milosevic.

horrible things have been done to the Albanians under Serbian domination, but the question is whether US/NATO policy will alleviate things or whether they will in fact be made worse by a bombing

campaign whose supposed goal is to make Milosevic give up his policies.

Since, as in most cased, the bombing campaign is not all that it seems to be, a look behind the headlines is worth the effort, especially given the new ferocity and willingness to intervene militarily on

the part of US foreign policy decision makers (Clinton, Cohen, Albright ,Berger). One needs to remember that since the US is a world, and not merely a regional, power one calculation that enters each of its foreign policy decisions is how the deployment of its military might will affect the US s image in the eyes of other, especially other competitive countries.

Punishment is its own goal, bombing as a display of NATO authority its No one at all doubts that own satisfaction, especially when there is little chance of retaliation from the enemy.

And neither wee the consequences thought through, i.e., the certainly that the Serb forces would respond to NATO bombardment by intensifying their attacks against Albanian civilians, more ethnic cleansing, more refugees, more trouble for the future. There is now talk of 200,000 ground troops (mostly American) to enter the battle and expand the war, with the attendant problems of prolonged occupation, guerrilla warfare, greater devastation, more refugees and so on. A lot of this comes from the delusion that the US is the world s policeman. In the meantime, its genocidal policy against Iraq continues, and its sanctions policy against other Islamic or Arab countries also continues. continued on pg.18

Lebanon to expand its so-called security/death zone. Israeli soldiers and allied Lebanese militiamen entered Arnoun with bulldozers, trucks and jeeps. They set up a barbed wire fence around the village and surrounded it with mines to prevent people from leaving or entering their homes without Israeli permission. Almost a hundred villagers, Arnoun once had 3000 residents, woke up and were told that they were now part of the Israeli occupied zone. After Israeli bombing and killing, most of the residents fled to live somewhere else in Lebanon. Israel has bothered the residents in many other ways- setting up checkpoints at the entrance to the village, searching homes and detaining residents they accuse of helping Hizbullah. Israel Defense Force has prohibited cars from entering the area and residents have to make a 3 kilometer journey to another

Let the whole world know that Arnoun is Lebanese, the whole south is Lebanese said Ghassan Daou a student who entered the village. On February 26, a group of Diab, head of the Communist Party Union of Democratic Youth of Lebanon. In Beirut, a group of people including ministers and deputies staged a sit-in in front of the headquarters of the UN Economic and Social Commission for Western Asia. They sent a letter demanding that UN secretary-general Kofi Annan force Israel to withdraw from the village.

The state of Israel has only caused problems for the Arab people. The US, which is supposed to be the mother of Democracy has only proven the opposite. Israel and the US are both built on genocide, through the forced relocation and extermination of indigenous peoples. I just wish that the Jews that inhab-

students, community leaders and political activists gathered in a protest to end the seizure of the village. The group of 2000 shouted Death to Israel as they marched to Arnoun, which is 5 miles away from the Israeli border, with Lebanese flags and metal cutters. Keeping The Pressure On Momentum Builds for April 24th March

Less than a month away from the march which is sure to make history, the College Voice and the Academic and Curricular Affairs Commission sponsored a teach-in around the case of political prisoner Mumia Abu-Jamal. The event followed the successful 'march conducted on campus the previous day against police brutality. Four speakers form the national campaign, Monica Moorehead, Marie Jay, Sarah Sloan and Imani Henry, spoke at the event and provided students with an overview of Mumia s case and an update on campus organizing throughout the country.

The first speaker Monica Moorehead, a National Coordinator of the Millions for Mumia Campaign, described the manner in which the campaign was put into motion after the Pennsylvania Supreme Court turned down two appeals by Mumia's legal team for a new trial. This action leaves Mumia with 6 months to a year before the state of Pennsylvania moves to execute him. Moorehead also stated that April 24th has even more importance due to the fact that Pennsylvania Governor Tom Ridge has planned two executions on April 22 and April 27.

Given this new sense of urgency Moorehead felt that, the time has come to widen and broaden the campaigning to include as many sectors of people as possible. She viewed the possible execution of Mumia as a major blow to the whole movement and that by Pennsylvania targeting him they were targeting all of us. Moorehead also felt that Mumia was targeted because he is a revolutionary who spoke out about police brutality. She questioned the motives of the police department by asking the crowd, If they (the police) are interested in getting to who really killed this cop why don t they want a new trial? Ultimately, Moorehead saw the need to have a new movement built in this country.

The second speaker, Marie Jay began her presentation by recognizing the fact that the event was taking place on the 88th anniversary of the fire at the Triangle Shirtwaist Factory. She called Mumia, a victim of the worlds oldest, best hidden conspiracy

to silence the voices of dissent. According to Jay, these v o i c e s e m e r g e from the roar of the

have s and the have n o t s. Mumia was one of the people who dared to ask the question Why?

Jay called the struggle to save Mumia s life, our line in the sand

for the 21st century. Sarah Sloan, a youth organizer for the Millions For Mumia Campaign, provided the crowd with an update on national campus organizing for the April 24 march. Sloan felt that, how far we can get this out to college campuses and get students involved would be an important determinant in the success of the march. There are currently 70 organizing centers in 28 states and 65 campuses, including CSI, which have affiliated with the campaign.

On February 26 at William Patterson College, the Student government and the campus newspaper simultaneously denounced a group of students who organized a teach-in on Mumia. Turning towards the community for support, these students have now chartered a bus for the march in Philadelphia despite the on-campus resistance. Sloan reported that

Hunter College is currently running one of the most successful organizing efforts and has chartered 7 buses for the Hunter march. organizers have office space specifically dedicated to Mumia organizing and hold weekly poetry and speak outs to keep the campaign in motion. Imani Henry, a Rainbow Flags for

Mumia organizer, felt that April 24 was history in the making. Henry stated that, April 24 will be the largest march for any political prisoner in the history of the U.S. Rainbow Flags attempts to organize Lesbian, Gay, Bi-Sexual and Transgendered people around Mumia s case. Henry felt that the LGBT community had a a better understanding of what it is to be jailed or arrested for being who you are. The connection with Mumia is very clear. She also felt that the opposition to Mumia

would attempt to divide the communities based on race, sex and gender because the march was no longer just symbolic, whole communities of people are beginning to come forward.

During the question and answer session, students inquired as to why Mumia s brother had not testified in court. Monica Moorehead responded that William Cook did not testify because Mumia wanted to protect him because of his own situation. Moorehead also told the meeting that at the time of the trial, Mumia s mother was extremely ill and Mumia did not want her to face the strain of having two sons in jail. She also related the fact that Daniel Falkner, the police officer who was shot that night, was notorious for his racist attitudes and actions. Moorehead felt that, I think Falkner was expendable for them to get to Mumia. She closed the presentation by saying that, they want April 24th to be the end of things, but we want to build a new movement in this country.

The event served to invigorate organizers who have been vigilantly working on the Mumia campaign and introduce new students to the struggle. Massive outreach to oppressed communities throughout the New York city area is currently underway and working class and poor youth have provided the backbone of this effort. While the campaign for a new trial received a much needed boost from high profile events like the Rage Against the Machine concert the movement is built through the everyday sacrifices of organizers such as Moorehead, Jay, Sloan and Henry. Mumia Abu-Jamal is a political prisoner held on death row for a crime he did not commit. He is a former member of the Black Panther Party in which he organized and built at age 15. He has been followed since 15 by the FBI who compiled 800 pages worth of survelliance documents on him. After leaving the Party he decided to become a journalist and political radio commentator. As a journalist and commentator he exposed police brutality and racism towards the poor and people of color. This made him a target for the Fraternal Order of Police (FOP). He was framed by the state, accused of killing a police officer, Daniel Faulkner, in Philadelphia in 1981.

His whole case has been a cynical joke ever since the start. It was totally unjust

and bias: (1) The judge who presided the case, judge Sabo, was a member of the (FOP). (2) The police coerced eyewitnesses - Cynthia White, Veronica Jones and William Singeltary - by threatening to arrest or harass them if they did not lie. (3) Two witnesses supported by the FOP lied saying that Mumia confessed to the killing of the officer (a) the doctor who was with Mumia the whole time reported that Mumia did not say a word (b)Gary. Wakshul an officer who was with Mumia the whole time wrote down that the male Negro made no comments (c) Another officer, emerging after two months vacation, claimed that Mumia had confessed in the hospital but he had forgot about this confession (4) The gun that killed officer Faulkner was a 44. caliber however

Mumia s gun was a legally registered .38 caliber. After this was proven by ballistics experts. Also, at the scene of the shooting the medical examiner wrote down that it was a 44. caliber. They did not sniff the gun to see if it was fired and didn t check for gun powder residue and found no evidence of the shooting, so they claimed that they forgot to do these routine tests.

All this is enough proof to show Mumia s innocence. The police and prosecutors are trying to kill Mumia and they know that he is not the real killer. On October 30, 1998 the supreme court rejected Mumia s appeal for a new trial. This places Mumia in the hands of Republican Governor Tom Ridge who pledged to sign the death warrant, Mumia maintains his innocence but the government is willing to do all it can to silence him. Mumia spoke out against the injustice in the world and the lifestyle of capitalism. This is the reason they want to kill Mumia, not just because he is black but because he is a revolutionary.

We must all do our best to stop this execution. We must all demand a new trial for Mumia based on fairness and allowing new or hidden evidence to be heard. Also, all the witnesses who feared for their lives should have a right to speak the truth about what happened that night. We must organize to expose the truth and injustice of this world. We must all come down April 24th to help get Mumia a new trial. If Mumia is given a new trial he will be freed because as John Africa said

THE FOLLY OF CALLING THE FBI

When are you Black folks gonna throw off the KILLERS that are JAILIN you for murder?

John Africa, _On the MOVE!_ (July 26, 1975)

When Black folks are beaten down by cops all around the United States, and when they are shot down in their cars as in the cases of Dontae Dawson of Philadelphia. or Malice Green of Detroit, or the beautiful young sister (Taisha Miller) who was shot over 15 times in her car in Riverside, California recently, or...(We can go on and on) one of the first things that many Black leaders do, is to announce that they are asking for the FBI to come in to solve the case. What such an announcement means, of course, is that they recognize that local police are in no position to meaningfully investigate such cases, as their interests are in protecting their own . But why the FBI?

Such a call sounds strange when one considers that the FBI played a significant and an openly dangerous role in the history of African-American struggles for freedom in America, and they were deadly enemies of such leaders as Martin Luther King, Jr., Malcolm X, Marcus M. Garvey, and of such groups as the Black Panther Party, RAM, SNCC, the Republic of New Afrika, and the like. In truth, the history of the FBI shows that they have waged a secret war against Black America, and frankly, it seems kind of stupid to look to them for relief from other state forces who are waging a part of their long white supremacist war against Black folks.

James Forman, the former head of the Student Nonviolent Coordinating Committee, after being beaten by white supremacists and Klansmen while demonstrating for civil rights throughout the south, constantly requested FBI protection from the violence. Instead, they would turn up every time that he was beaten, stand by, and take notes, never stopping any of the violence, but instead were involved in gathering dirty and derogatory personal information on civil rights workers. He finally concluded that the FBI was a part of the governmental structure, and were, in effect, the enemy of Black people [from O Reilly, K., _ Racial Matters : The FBI's Secret File on Black America, 1960-1972_ (New York: Free Press, 1989), pp. 108-109]. Forman noted:

We did not say it that way in 1963, but we did know that the FBI was a farce. It wasn t going to arrest any local racists who violated any and all laws on the statute books. Instead, it would play a game of taking notes and pictures. The files in Washington must have been growing thick even then with documents from the civil rights movements and with photographs of us all doing everything but screwing, and maybe even that. [p. 109]

The former FBI chief, J. Edgar Hoover, found it intolerable that Negroes would want to be addressed as Mr. (p. 257). Scholar Kenneth O Reilly writes that the job of the FBI was, in large part, to stifle black unity:

Division Five also worked to prevent the _rise of a _Messiah_ someone who could unify, and electrify, the militant black nationalist movement. Malcolm X had been the most likely candidate, but his assassination removed that threat. Malcolm was simply the martyr of the movement today. Muhammad was hardly a more viable threat because of his age. In the final analysis, Division Five said, [Stokeley] Carmichael and [Martin Luther] King were the only serious candidates. They both dreamed of becoming a messiah and had the necessary charisma. Not even [William C., head of Domestic Intelligence] Sullivan considered King to be a militant, but that was beside the point. King could be a very real contender for this position should he abandon his supposed obedience to white, liberal doctrines (nonviolence) and embrace black nationalism. [p. 282]

The role of history has taught us that the state has its interests and the people have another; and they do not coincide.

Now, with much of the nationalist movement in pieces, with some aligned to the Democratic party, some involved with community organizing, and others involved in other areas of social and cultural life, it is somewhat surreal to read of community calls for the FBI every time that a young person is murdered by cops.

Since when are they the solution? The propaganda shown by the movie Mississippi Burning doesn t come close to showing the true role of the FBI. It s time folks acted as if they knew that.

COLOR BLINDNESS AND THE LAW

In order to get beyond racism, we must first take account of race. There is no other way.

Justice Harry Blackmun University of Calif. Regents v Bakke (1978)

In cases decided every day across America, the theory of color-blindness is said to govern the judicial process, a reflection of the flawed notion that the mere mention of race is somehow racist. Consequently, the law serves up yet another legal fiction, which obscures the complexity of real life, in furtherance of a false and fatal simplicity.

There can be no sustained study of American law without coming face-to-face with racism that drenches judicial thought, in a clear, unapologetic tone, which leaves no question as to the objectives of the court:

It is obvious that the objection on the part of Congress is not due to color, as color, but only to color as an evidence of a type of civilization which it characterizes. The yellow or bronze racial color is the hallmark of Oriental despotisms. It was deemed that the subjects of these despotisims, with their fixed and ingrained pride in the type of their civilization, which works for its welfare by subordinating the individual to the personal

authority of the sovereign, as the embodiment of the state, were not fitted and suited to make for the success of a republican form of government. Hence they were denied citizenship.

Terrace v. Thompson

(US District Court Washington; 1921)

The anti-Asian bias that oozes out of this opinion, clothed in a kind of quasi-sociological justification, actually justified laws in western regions that outlawed the sale of land or property to Japanese, on the basis if ineligibility of citizenship (until the 1950 s, Chinese, and other Asians, were denied Naturalization)

Despite our pretensions of Color-Blindness, scholars assure us that, over a century after the Chinese Exclusion Act of 1884 became law, the court case that upheld the Act remains good law to this day. The Supreme Court majority in Chai Chan Ping v. US (1889), found the presence of foreigners of a different race in this country, who will not assimilate with us, is properly excludable.

For over a century, such decisions, which made whiteness the sole prerequisite for US citizenship, and explicitly excluded people it deemed nonwhite , had, at its very core, not color-blindness, but color consciousness informed by a profound white supremacy

It is fitting here to note that in 1935, two countries in the world had racial restrictions on naturalization: Hitler s Germany; the USA Color blindness?

For the better part of two centuries race has been at the very heart of the law. It remains so despite the latest fashion of the legal fiction of color blindness.

How people are treated in court, how they are charged, and how they are sentenced is a direct reflection of what race they are assigned by the physiognomy presented to the world.


Several years ago, a prominent American law professor asked his students to imagine if they were to wake up the next day as black folks. The white students reasoned that such a disability required monetary damages of a million dollars a year for life.

Why damages, unless color does matter? Unless whiteness is a valued property, which, when lost demands a premium payment? And black is devalued?

We are blind to everything but color.

but the non-Kuwaiti judges are restricted to 1 to 3 year contracts which are reviewed by the prince. The State Depart-

ment Human Rights report felt that this arrangement seriously undermined the independence of non-citizen judges.

The government has banned all political parties and there con-

reports that despite a constitutional prohibition on torture, the police and members of the security forces abuse detainees during interrogation. The report stated that such abuse was more likely to be inflicted on non-Kuwaitis, particularly of other non-Gulf Arab nations and Asians, than on citizens.

In the area of freedom of the press, the Ministry of Information censors all books, films, videotapes, periodicals, and other imported publications deemed morally offensive. The ministry also enforces informal censorship of newspapers by persecuting journalists who have crossed the line.

Womens Rights

Women suffer suffer some of the sharpest forms of oppression in Kuwati society. To obtain a passport for travel married women...must obtain their husbands signature on the application form. Even after getting the passport, he may prevent her departure from the country by placing a 24-hour travel ban on her. Stripped of the right to vote, women have little voice in society that offers the slimmest of political options. In industry, the law restricts women from working in dangerous industries and trades harmful to health

Workers Rights

Public assembly is severely restricted as public gatherings must be pre-approved by the government along with private gatherings of more than five people. The State Department also reported that vorkers from those nationalities leaders supported Iraq, especially Palestinians, Jordanians and Yemenis have been targeted by the government.

In order to enforce this control, workers have been prohibited from freely establishing trade unions. Currently, 50,000 persons (less than 5 percent) of a total work force estimated at 1,100,000 are organized into 14 government controlled unions. The courts can dissolve the 14 unions at any point for threatening public order and morals. The prince also has the ability to dissolve the unions by decree.

all women are banned from driving motor vehicles and must enter city buses by separate rear entrances and sit in specially designated sections. Available information pointed to the fact that physical violence and abuse against women was a common problem.

Workers Rights

All forms of union organizing and collective bargaining are prohibited in Saudi Arabia. Strike activity is expressly prohibited and wages are set set by employers and vary according to the type of work performed and the nationality of the worker. There are no minimum wage controls established.

Peru

Political Freedom

Despite the fact that Peru is officially a multi-party republic, a pow-

erful executive branch led by current president Albert Fujimori, has dominated the electoral and judicial systems. Instead of an independent judiciary, the State Department reported that Perus judicial system was inefficient, often corrupt and has appeared to be easily manipulated by the executive branch. Torture tactics are routinely used by security forces against the two main revolutionary groups in the country - the MRTA (Tupac Amaru) and the Shining Path. Torture tactics combined with

amazingly harsh prison conditions provide the backbone of a harshly repressive judicial system. The State Department reported that at years end, only one-third of a total prison population of 26,330 had been sentenced, while the remainder still either were awaiting trial or had not yet been sentenced finally. In a pattern intimately familiar to the US, Peruvian police are charged with routinely detaining persons of African descent on suspicion of having committed crimes, for no other reason than the color of their skin.

Increasingly university students have acted as agents of change, challenging Fujimori s anti-democratic measures. The government has responded with a massive police crackdown which resulted in the police beating and injuring a number of the participating students, some shop windows were broken, and allegations were made that government intelligence agents took photographs of protesters.

Women s Rights

The State Department reported that Violence against women, including rape, spousal abuse, and the physical and sexual abuse of women and girls, is a chronic problem, according to local human rights groups and law enforcement offices. Discrimination against women went hand in hand with continued discrimination against indigenous peoples, the disabled and other racial and ethnic minori-

ties.

Child labor, including forced labor. continues to be a major problem in Peru. Of the countries 8.5 million workers only 5% are currently; represented by trade unions. Indigenous people represent a large portion of the unorganized labor pool. The government has banned unions from engaging in explicitly political, religious, or profitmaking activities. Despite this official ban, workers played a key role in the opposition movement which developed after Fujimori engineered his continued control over the executive apparatus.

Imperialism and Humanitarianism

All three of these repressive regimes are US client states located in key geopolitical areas. While the US media

feverishly attempts to transform Milosevic into the new Adolf Hitler, nary a word is spoken about the hypocritical foreign policies of the US. The mask of the humanitarian mission is nothing more than a cynical cover aimed at tugging at the liberal heartstrings of the American public as they are prepared for war. Control over commerce and markets are the true motivational forces behind US foreign policy. If this Albert Fujimori - protector means bodybags for Serbians and Iraqis, amputat-

ed hands for Saudis or arbitrary imprisonment for Peruvians, so be it. The great democratic project of the US is built upon the violent material and political repression of the underdeveloped world, where the national interests of the US ruling class receive primacy over the fundamental human rights of the masses both at home and abroad.

Before we buy into the next round of corporate media propaganda condemning the great evils of the Castro s, Milosevics and Husseins of the world take some time to wonder why the Fujimori s, Saudi s and Al-Sabah s receive so little attention. Is humanitarianism not merely a code word selectively used to deceive and motivate American citizens to participate in the senseless slaughter of others? With each bomb dropped and soon with each shot fired at the Serbs we move that much further from forging a peace which will guarantee rights for both Albanians and Serbians. For over 30 years Stalinism, the gross deformation of 1917, maintained some semblance of ethnic peace. For the last 8 years US imperialism has managed to produce a series of massacres, ethnic cleansing and right wing nationalist movements. Until a new movement is built to challenge this notion humanitarian bombs and benevolent embargo s will continue to be part of our national interests.

Saudi Arabia

Political Rights

Saudi Arabia offers even less political freedoms than Kuwait. Ruled by King Fahd Bin Abd Al-Aziz Al Saud, there are no elected representatives and all political parties are banned. Opposition views are actively stifled as the State Department reported that the government commits and tolerates serious human rights abuses...prohibiting or restricting freedom of speech, the press, assembly association, religion and movement.

Credible reports have been issued which charged the government with abusing detainees using beatings, torture and sleep depravation. In addition to this, six right hands have been amputated for repeat thievery offenders. Reports indicated that the total number of political detainees...is estimated at more than 200 persons.

Defendants usually appear before judges without representation of an attorney and are sentenced in accordance with the religious law of the Shari a. During these proceedings, the testimony of one man equals that of two women.

Freedom of the press is harshly suppressed with all criticism of Islam, the ruling family and the government expressly banned. Along with this, the Government censors all forms of public artistic expression and prohibits cinemas and public musical or theatrical performances. In the educational system all study of the works of Freud, Marx and Western Philosophy is banned. Professors have reported that they believe that informers monitor their classroom comments and report to government and religious authorities.

Womens Rights

Womens freedom of movement is extremely constricted as all Saudi women must obtain written permission from their closest male relative before the authorities allow them to board domestic public transportation or to travel abroad. This harsh policy is backed up b the fact that





China

3,000 Miners from the state-owned Dujiang colliery face layoffs in the province of Sichuan. Many of the workers have not received pay for as much as three months. The mine is intending to file bankruptcy as a result of an explosion in May that caused the death of 23 workers. Also the mine faces financial crisis, there have been reports of the embezzlement of \$US4.3 million in state funds that were supposed to be allotted for redundancy payments.

On March 15 ten coal miners were injured and five arrested in an around-the-clock demonstration outside the Chengdu government office which is located 50 kilometers from the Dujiang colliery.

Sri Lanka

The United Health Workers Union along with the Socialist Equality Party of Sri Lanka staged a mass strike of 6,000 workers demanding immediate wage increases, removal of cuts imposed by overtime payment, job security for temporary workers and improved working conditions. The striking employees rallied in Vihara Maha Devi Park, Lipton Square and marched to the Health Ministry in Colombo on March 26.

At the Hunnasgiriya tea plantation two night watchers were assaulted by the estate s Assistant Superintendent. When the tea workers on the plantation heard about the assault 3,000 of them immediately stopped work and began a strike. The workers belong to the Ceylon Workers Congress (CWC) which is led by government minister Saumyamurthi Thondaman. The workers are also in negotiation for improved working conditions. CWC threatens that if no real agreement is struck before April 6, 1999, workers along the Matale District will hold a mass strike.

Brazil

During the Holy Week of Easter more than 2,800 peasant families took over 15 Brazilian ranches. The families belong to the Movement of Landless Rural Workers (MST). The farmers are trying to get the state to deed them land in Northern Brazil. The workers chose the week of Easter because armed guards would be off from work and courts would be in recess.

Reginaldo Pacheco, MST leader, condemned the government for allowing the International Monetary Fund (IMF) to cut the available funds for each family land grant from \$9,800 to \$2,890. Eighty-eight percent of arable land is owned by the richest 20 percent of the country while the poorest 40 percent of the farmers do not even own 1 percent of the arable land. There still remain 5 million families with no land at all.

Chile

At the height of exportation in Chile, 3,500 workers shut down ports in San Antonio, Valapariaso, Iquique and Tocapilla. Forty workers were arrested in street protests. In the days following workers from Arica, Coquimbo and Talcahuano joined the strike. The strike affected 70 percent of imports and exports and caused over a million dollars in losses in fruit and copper exports. The cause for the strike was the privatization of the docks, which would result in the loss of many jobs due to layoffs. The workers are asking for retraining facilities, increased severance pay and an early retirement program.

Canada

In Newfoundland 4,500 nurses were ordered to go back to work after a two week strike. The nurses wanted a 17 percent pay increase, a reduction in the workload and an increase in full-time positions. Newfoundland nurses are the lowest paid in all of Canada. Their starting wage is \$15.19 opposed to \$19.99 in Alberta. The strikebreaking legislature imposed only a 7 percent increase.

South Korea

On April 3, 1999 subway workers from Seoul Metropolitan Subway Corporation rallied in 18 cities across South Korea. Approximately 10,000 students participated in the protest demanding an end to the rising layoffs and corporate restructuring. The workers were heard chanting Stop mass layoffs and Reduce working hours ; they were also seen waving red flags.

The Seoul Metropolitan Subway Corporation plans to cut 2,078 workers from an 11,492 workforce. Lee-Kap -Young, the head of the Korean Confederation of Trade Unions said that if demands were not met soon, the organization would call a mass nationwide strike on May Day. The government responded by stating intentions to raise repressive measures against workers who take internal action.

On this same day the Education Minister of South Korea announced the cut of 1,276 teaching positions, including 102 principals and 330 deputy principals.

Colombia

Guerrilla forces from FARC-EP, the People s Liberation Army have blown up 10 high-tension towers and one of the main pipelines 27 times for this year alone. Due to these attacks the Colombian government has began rationing electricity in Cartagena and Santa Marta on the Caribbean cost of the country. FARC-EP has also set up roadblocks on a main northern highway in the middle of a popular tourist section so they could allegedly rob and kidnap tourists on their way to Caribbean resorts.

United States-Virginia

Over 9,000 members of the United Steelworkers Local 8888 walked out the shipbuilding yard in Newport News Virginia on April 6. The workers are asking for an increase of \$3.59 per hour over 3 years. The workers have not received a raise in over six years.

Union Leaders of the Teamsters who represent UPS workers and Communication Workers of America who represent workers from Bell Atlantic and Lucent Technologies said that they support and respect the Steelworkers picket lines.

The Newport News Shipyard is the only producer of US Navy nuclear powered aircraft carriers and with 17,400 workers, they are the largest private employer in Virginia.

Mexico

The US Immigration and Naturalization Services rescued 59 undocumented Mexicans trying to cross the Southern California border but only after 8 died. The workers were overcome by overwhelming unseasonable cold weather and snowstorms that have hit the hills of Baja. The Mexican workers were not dressed for the weather and 30 people are still missing.

This year already 29 people have died trying to cross the Mexico-California border. Last year a record 141 died mostly in drowning accidents.

TERNATIONAL The Revolution in Colombia -US Backs Drug Traffickers and Death Squads

Colombia is a mountainous country of some 35 million people in South America. Its most important cities are Bogota (8 million), Cali (3 million) and Medellin (2.5 million). Colombia earns most of its foreign exchange, some \$1.5 billion, through the export of cocaine. Other major exports include coffee, petrol, coal, gold and agricultural produce.

Fascist gangs roam the land wearing black hoods, carrying deadly weaponry, murdering peasants, trade unionists and human rights activists. An internal refugee crisis, the dezplazados, has posed a humanitarian disaster that even the unfortunate people of Kosova have not seen. The Resource Center of the Americas reports an estimated 1.4 million people to be part of an internally displaced population.

This crisis stretches back into the early 80 s and has worsened in the 90 s as a result of intensified attacks by gangs of fascists on rural communities. The fascists forces, principally the United Self-Defense Forces of Colombia (AUC), are in the pay of big coca growers, cattleranchers and



other members of the Colombian ruling class who seek to forcibly take over land to expand their enterprises.

The rural population has developed armed organizations of their own to defend against the drug barons and their fascist thugs. The Revolutionary Armed Forces of Colombia (FARC-EP) and the National Liberation Army (ELN) are the strongest of these peasant based guerrilla movements. In recent years, the FARC has been successful in beating back the fascist AUC and the official military. Today, the FARC along with its smaller brother ELN control close to half of Colombia. Colombia - Cocaine Capitalism

Key figures of the Colombian state, its leading families and military officials are well known to be heavily involved in narco-trafficking and backers of fascist death squads amongst other crimes. American officials admit that Castano, the leading Colombian fascist is a drug baron, producing heroin at least in El Nudo Paramillo. Indeed officials admit that the AUC is financed and supported by a crosssection of the Colombian ruling class drug barons, cattle ranchers, mineral barons and other landowners.

The Colombian attorney general s office is reported to have a long list of senior and middle ranking officers in the armed forces known to be members of the AUC. However the state apparatus from the President down will not take any action to bring these killers to justice since they are connected by so many strings to this very same state apparatus. As sections of the Colombian ruling class are attempting to reign in the fascist forces for the purpose of stabilizing the situation to buy time in

their war against the guerrillas they are finding that the administration by death squad that they have given rise to, cannot be tamed by the toothless fiction of a civil administration.

The Miami Herald reported that a letter was delivered to Colombian federal human rights prosecutors from the AUC with the full names of some 65 workers in the office despite the fact that their identitics are a closely guarded secret. (Miami Herald , 2/23/99) The arrest of Colombian emerald

capitalist Victor Carranza for sponsoring death squads and assassinating leftists last year was a rare exception in the charade that passes as government efforts to prosecute murderers. President Pastrana, who presents the new Colombian ruling class line of peace to the public, has done nothing to take any real action to reign in the fascists.

US War Against Drugs -

A War By Drug Lords Against the People Meanwhile the Economist, mouthpiece of European capitalism writes, the United



States does indeed wink at the drug-running of the only forces [the fascists] that look effective against the insurgency of the far left. (Economist, 2,20,99) This same article states that a recent US aid package of \$290 million includes the equipping of the Colombian helicopter. fleet with 20mm cannons. The 1998 aid package writes the Economist was classified by the US gov t as category 2 - for military operations short of war.

The US sells this brazen financing of narco-traffickers and death squads to the public as a war against drugs. The Washington Post quoted a senior military official in 1998: We call anything counterdrugs. If you are going to train to take out a target, it doesn t make much difference if you call it a drug lab or a guerrilla camp. There s not much difference between counter-drug and counter-insurgency. We just don t use the word (insurgency) anymore because it s politically too sensitive. However, the Economist quoted a DEA agent frustrated with Americas fake drug fighting policy bluntly stating: ...the essential American line, set mainly by the Pentagon and the CIA, is to prepare for war.

No crime of fascists and drug dealers measures up to the threat of a population rising up in armed insurrection in defense of their collective interests. To crush the revolutionaries of the FARC and the ELN the US is willing to finance and arm a conflict that has cost 30,000 lives by conservative estimates.

Colombia is number three behind Israel and Egypt in military aid offered by the US. Colombia is the leading recipient of US aid in the hemisphere. Colombia received \$290 million in US backing to

Nothing of what the US or NATO does now has anything really to do with protecting the Kosovars or bringing them independence: it is rather a display of military might whose long-range effect is disastrous, just as is a similar policy in the Middle East. In 1994 when a US intervention might have averted genocide in Rwanda, there was no action. The stakes were not high enough, and black people not worth the effort.

Therefore it seems to me imperative that the NATO bombing should stop, and a multi-party conference of all the peoples of former Yugoslavia be called to settle difference between them on the basis of self-determination for all, not just for some, nor for some at the expense of others. This is the same principal that has been violated by US-sponsored peace processes elsewhere, notably in the Middle East.

There is nothing about the current policy of bombing Serbian forces that will either guarantee democracy for Serbia or protect the Albanians who are still being treated horribly by Milosevic s forces. In its arrogance and ill-considered military deployment the US has forced NATO to go along with it, whereas it is quite clear that there is increasing disunity within the NATO ranks, not just Greece and Italy and Turkey, but also France and Germany.

The greatest danger of all is that more people will be displaced; more lives lost, and more fragmentation will occur in places like Macedonia and Bosnia-Herzegovina. All this for the US to assert its will and to show the world who is boss. The humanitarian concerns expressed are the merest hypocrisy since what really counts is the expression of US power. What I find most distressing is that destruction is being wrought from the air along with a fastidiousness articulated about the loss of American life that is positively revolting. Clinton knows well that Americans will not tolerate the loss of life for Americans. Yet he can destroy Yugoslavian lives with impunity from the safety of the ultimate in modern technology and airpower, with American pilots and bombers sanitizing their horror with the illusion of safety and distance.

What will the smaller, lesser, weaker peoples realize that this America is to be resisted at all costs, not pandered or given in to naively?



Born Without Faces 500 Years of Struggle

Iman Elsayed

Work, land, shelter, bread, health, education, democracy, liberty, peace, independence and justice is the succinct elevenword program of the Zapatistas. No human being should be deprived of any of the elements of this program. The world can successfully be organized by implementing this, however capitalism - the landowners and corporations - steal and strip these qualities of life from workers and peasants throughout the world. The motivation behind these actions can be summed up in one word - Profits. Profits and money are the main reasons the rich rob and murder innocent people who simply want to feed their babies, educate their sons and daughters, and live in a world where you can die happy and not hungry. Denving the native people these features of life is the motivating force behind the Zapatista uprising, a rebellion of the indigenous people of Mexico.

THE UPRISING

On January 1,1994, San Cristobal de las Casas was occupied by men and women without faces. Ski masked rebels surrounded the capital of the Mayan highlands in Mexico s southernmost state of Chiapas. The Zapatistas hung leaflets on the walls and slipped them under doors proclaiming: We declare war against the Mexican Federal Army, the basic pillar of the dictatorship under which we suffer. We will advance to the capital, defeating the federal army as we march forward. The declaration of war was signed by the Zapatista Army of National Liberation (E.Z.L.N). Holding up their black flag with the red stars and letters, the E.Z.L.N. derive their name from the brave Nahua Indian Emiliano Zapata, who led the Mexican revolution of 1910 against the haciendas (landowners). Having gone through hundreds of years of genocide and oppression, the native people have experienced the worst holocaust in the history of the world. Continuous oppression is the reason the Zapatistas formed and continue their struggle, fighting for the well being of people all over the world.

NAFTA S ROLE

The date of the uprising coincided with the signing of the North American Free Trade Agreement (NAFTA) between the US and Mexico. NAFTA was the main reason

NAFTA has only caused problems for working people in the United States and the natives in Mexico. Bill Clinton claimed that 200,000 new jobs would be created, however by 1995, 200,000 jobs had been eliminated because of NAFTA. In Mexico, Allied Signals 3,800 workers earned a combined total of about \$7.8 million in 1995, less than the CEO Bossidy raked in by himself that year. In Mexico well over a million workers have been laid off and 2.5 million workers have crossed the line of poverty to extreme poverty, according to the Secretary of Social Development. Wages have dropped 50% since 1993 and the crime rate has doubled since 1995. NAFTA has benefited the CEOs but harmed millions of other people who are better off begging than working. NAFTA has given the Zapatistas even more reasons to fight for their rights and against the injustices corporations are inflicting on the people.

PARAMILITARY GROUPS

Violence against the people who worked for social and political change existed long before 1994. Private police

forces known as the white guards were created in 1961. The state governors granted ranchers legal permission to carry arms and hire private police forces. The white guards enforce the rule of the ranchers and big landowners. These private police continue to exist, occasionally joining forces with the police and the army to battle peasants in disputes over lands. By the 1990 s the presence of guards

diminished, but this was not the end of armed groups in the region. These private police still exist but under a different name- paramilitary. Paramilitary

all the agreements negotiated with the Zapatistas. After the Zapatista takeover of San Cristobal de las Casas on January 1994 there was a cease-fire which ended the open military confrontation of the first days of the uprising. The first level of peace talks were held on February 1994 in the cathedral of San Cristobal de las Casas between the rebels and the Institutional Revolutionary Party (PRI). The Zapatistas realized that the only true way to get peace and democracy was not only through economic demands but social and political reform. (The agreements addressed by the Zapatistas would not connect with the situation in Chiapas since the existence of the single-party rule at the national level.) After months of deliberations, the Zapatistas rejected the accords, arguing the government completely ignored their demands for democratization. The Zapatistas decided to expand their influence in civil society.

A survey conducted on January 7, 1994, showed 61% of the residents of Mexico City supported the Zapatistas goal but not their use of violence. This percentage had risen to 75% by February 18, while the first peace talks were taking place. Following the rejections of the government s peace proposal, the Zapatistas wanted to strengthen their bargaining position. The EZLN called for the first of three National Democratic Conventions in August. This inspired and aided the formation of other coalitions and organizations. Organizations like the National Women's Convention, state conventions (in Chiapas, Oaxa-

> ca, Morelos, Veracruz, Durango, Sinaloa, Zacatecas, Guerrero and Michoacan), and the Movement of National Liberation, headed by former presidential candidate and current governor of Mexico City, Cuauhtemoc Cardenas. This broad based organizing brought fear in the eyes of the government. Zedillo (current president of Mexico) broke his cease-fire. The army launched a massive military offensive in Chia-

territory that had been under Zapatista control

and arrested dozens of unarmed political activists suspected of being Zapatista supporters. Despite the governments violation of the 1994 cease-fire, the EZLN agreed to start a new round of peace talks. On Feb.16 1996 the San Andres Accord was signed between the Zapatistas and the government. This accord was made to grant the rights for the indigenous people. It would have guaranteed limited constitutional autonomy to the nations indigenous people. After many months of negotiations, it gave Mexico s 800 Indian-majority municipalities or counties local control over their own territories, natural resources, justice and educational sys-

attackers pursued the victims as they fled into the mountains and killed 45 unarmed. innocent Indians. Autopsies proved that the majority of the victims were shot in the back while fleeing for their lives. Thousands have died at the hands of these paramilitary groups (500 were killed in 1997 alone). The paramilitaries are created to protect the interests of the rich and leave the poor Indians landless, with nothing, not even their lives.

There have been many attempts for peace in Mexico between the Zapatistas and the Mexican government. Throughout negotiations, the Mexican government has shown its unwillingness to negotiate in good faith for peace. They have violated

fight the FARC. The American CIA has the biggest Latin American station in Bogota, capital of Colombia. The School of the Americas (SOA) based in Georgia notorious for training some of the most brutal military killers across Latin America had graduated 124 out of the 247 military personnel cited in El Terrorismo de Estatado en Colombia for human rights abuses in Colombia.

In 1991, the US lead a revamping of the Colombian military intelligence apparatus. Forty one new intelligence networks or death squads were for the surveillance of unarmed civilians. One of these was responsible for the murder of 57 civilians

over two years of operation in the Magdalena Valley. Amongst the murdered were the President, ' Vice President and Treasurer of the local Transportation Workers Union.

Information about these secret networks was revealed only after

ex-agents fearing FA for their lives testi-

fied. Saul Segura one such ex-agent who spoke out, was murdered inside his prison cell.

In 1994, Amnesty International accused the US of allowing anti-drug aid to be diverted to murderous counter-insurgency programs. Frank Smyth, a freelance journalist, writes that, the CIA bears some responsibility for the proliferation of drug trafficking in the Magdalena Valley since it supported rightist counterinsurgency forces who run drugs.

The US policy indeed was slow to warm to new Colombian President Pastrana's strategy of peace and offering limited concessions to the guerrilla forces. The recent victories of the FARC against the fascist/military forces have forced the Colombian ruling class to talk peace with the rebels. Talks between the FARC and the Pastrana regime which officially opened on January 7 this year have broken down due to a murderous rampage by the fascist AUC.

According to the Economist, in the village of Playon de Orozco in the northern province of Magdalena a group of 70 heavily armed AUC thugs dragged 27 churchgoers, several children among them, out of a baptismal mass and shot them in front of the priest and their families. In the southern jungle town of El Tigre, some 30 peasants were shot, decapitated or hacked to

death with machetes. In all over 150 people were killed within a week by the AUC. Their b ut c h e r y ranged over six provinces where they tortured and killed anyone suspected of sympathies to

FARC.

Lead fascist Castano demands a place at the talks between the FARC and the government. Guerrilla leader Marulanda of the FARC has rejected this out of hand pointing out that the fascists are sponsored by the government. Indeed under the previous regime of President Samper in Colombia, there was a much more open coddling of fascist forces. Samper initiated a policy of setting up legal armed selfdefense groups, known as Convivir, for the purpose of fighting the guerrillas. These served as an effective recruiting ground for the main fascist organizations. The AUC grew to an organization of some 5000 men nation-wide thanks to this policy. It was later revealed that Samper received \$6 million in funds from the Cali drug cartel.

It was a well known by Human Rights organizations that the official military forces and the fascist forces would on many occasions engage in joint operations against villages suspected of rebel sympathics.

Coca Cola - Brings You Death

The service of right-wing paramilitaries does not stop at the Colombian ruling class. Foreign multinationals like Coca Cola, Nestle and British Petroleum amongst others who have set up shop in Colombia have been accused by human rights and labor activists as sponsoring death squad violence against labor organizers. The International Confederation of Free Trade Unions states that of the 300 trade unionists murdered around the world in 1997, 156 were from Colombia. More than 2,300 activists of the Central Unitaria de Trabajadores (CUT) the main labor federation in Colombia have been murdered since its founding in 1986. In the troubled oil producing city of Barrancabermeja fascists murdered at least 11 workers of the London based British Petroleum Co. prompting a series of strikes by gun-carrying trade unionists. (Economist 9,5,98) What the bourgeois Economist failed to mention was that the workers struck because they suspected the company (BP) to be behind the attacks, according to the Resource Center of the Americas. According to this same source on December 5, 1996 fascists killed a union organizer at the Coca Cola plant in Carepa, tried to kidnap three others and burned down the union offices. At the Cali Goodyear plant, death squads calling themselves Colombia Without Guerrillas and Death To Trade Unionists have been threatening the lives of trade unionists.

threatening the lives of trade unionists. The Armed Struggle of the People Must Be Supported

Anyone familiar with the novelist

Gabriel Garcia Marquez s A Thousand Years of Solitude will have an understanding of the long history of repression and civil war that has plagued Colombia. The primary struggle has involved the armed violence of landowners against the rural population. The present day guerrilla forces have their roots in the 60s, particularly in response to the massacre of Marquetalia in 1964 when the Peasant Republic of Marquetalia was brutally destroyed by the army. The Revolutionary Armed Forces of Colombia - People s Army (FARC-EP) and the National Liberation Army (ELN) were formed with strong bases amongst the rural people of Colombia. The FARC was influenced by the Colombian Communist Party and the ELN was inspired by Cuban revolutionary Che Guevara s strategy for taking power. These two groups remain the strongest rebel movements in Colombia controlling roughly half of the land mass.

The FARC and ELN are both committed to a vision of a socialist society in which the resources of the nation are stripped from the drug lords and big landowners and used instead to alleviate the great suffering of the Colombian masses. The struggle of Colombias rural poor and urban working class to defend their lives and livelihoods against the US backed Colombian cocaine-death squad state has reached a critical point over the past year. The Economist writes ominously, Were the talks to breakdown...it might even drag the US, however unwillingly, halfway into yet another jungle-based guerrilla war. Efforts by the US to prop up their weakened client state at the expense of the people of Colombia must be fiercely resisted by the American working class and all people of conscience.

tems. Unfortunately, Zedillo vetoed the agreements after 7 months.

Zedillo wants peace under his own terms, which means the liquidation of the Zapatistas, not the aspirations of the masses. EZLN responded by breaking off peace talks because their demands were violated. The Zapatistas pledged not to return to peace talks until they were convinced the government truly wanted peace and had stopped hunting them down as terrorists. They accused the government of talking peace but sanctioning increased military activity in Chiapas state.

The situation in Mexico gets worse daily. After the signing of NAFTA the situation in Mexico has gotten bloodier. NAFTA with its pollution, land stealing and sweatshops, coupled with the paramilitaries assaults and suppression of the people, have enforced a grim reality upon the indigenous peoples of Mexico. Over 18 million citizens live in extreme pover-

ty. The longest-ruling state party in the known universe, the PRI, continues to control the political machine in Mexico. The Zapatistas are trying their best to get the rights of the Tzotzil, Tzeltal, Tojolabal, Chol, Zoques, and Mams of Mexico. The oppression of these Indians has been a reality since the nations of Europe began their brutal conquest of the New World. 
