


CSI Baseball Field Out of Commission Again

For the second year in a row, the campus baseball field has been out of commission. Last year, there was a problem with drainage. And know the new problem with The College of Staten Island's baseball field was it was submerged with sewage. There are sewage pipes located under the field that are for buildings 1A, 2A, 3A, and the Staten Island Developmental Center. The submergence was caused by a boulder sitting on top of the pipe; the boulder eventually broke through the pipe, breaking it and creating a hole which the waste seeped through.

Not only was there a hole, but some of the surrounding pipes were cracked. Approximately one hundred fifty-five feet of pipe has to be replaced. Mr. Eugene Marshall, the Athletic Director at the College of Staten Island, stressed the fact the school is doing everything in its power to right this problem immediately. He also said Vice President of Student Affairs Carol Jackson and Vice President Academic Affairs Marilla Afron are key players in getting the situation fixed.

Vice President Jackson said it was actually Vice President of Finance and Administration John Hudacs who played the key role in getting everything arranged. When Vice President Hudacs was reached for information and comments, he was extremely cooperative. He said the soil on the baseball field must be tested, and if all is not well, it will be replaced. In addition, the manhole located underground on the field behind home plate is going to be moved off of the field. *The Banner* asked Hudacs how long it will take for the field to be repaired. He said, " Two weeks for the pipe to fix and for the manhole to be relocated".

When the problem was discovered, a surveyor was brought in to video tape the inside of the pipes. After that, the college had to find the lowest bidding contractor who met the specifications. The Matthew Ruggiero Plumbing Company of Brooklyn was picked to do the job because they offered the lowest bid.

Vice President Hudacs also mentioned there has been a moisture problem on the field before. It seems the soil in that area doesn't absorb the rain water properly, so the field winds up with big mud puddles. Mr. Marshall also mentioned problems with this area previously. He believes it is the fault of the people who built the field.

While the problem is being rectified, the team will be practicing on the softball field, which is smaller than the regular baseball field. It is hopeful for them to be able to use the field at Clove Lakes, and something is in the works with Wagner College. It seems the baseball team had quite a few home games which now has to be played away.

The Banner had the chance to speak with Mr. Marshall about the problem with the Ball field he said, "I would probably say the field is gone for the session , but there is a slight chance that it may be playable by the end of the session," he also went on to say , " the team and the coaching staff has been fantastic, their just playing there games on the road and not complaining, in that aspect they make me proud." Mr. Marshall ended this interview by saying, "I think the college is doing what they have to do and I feel that they are taking some unnecessary heat. It not there fault, but the contractors."

CUNY Students Rally to Stop Budget Cuts and Tuition Hikes

About 400 CUNY students and faculty gathered yesterday in front of City Hall to voice their opposition to the city's proposed financial aid cuts and \$400 tuition increase. Many student government organizations were represented.

Along with a tuition increase which would bring each semester's tuition to \$3,600, Governor Pataki's proposed budget will reduce the Tuition Assistance Program (TAP) by \$172 million, according to C.C.N.Y. Student Government Association.

Pataki's plan is for half of Pell awards to go directly toward tuition instead of living expenses, counting against recipients in determining their Tap awards. TAP for graduate students and independent students making more than \$10,000 a year will be completely eliminated in the governor's budget, which also cuts another \$56.9 million in state support from CUNY's operating budget.

Students voiced other concerns about, the demise of open admissions, faculty layoffs, the jeopardy of ethnic and remedial studies, the lack of funding for child care, and the problems with Workfare.

Workfare, a Public Assistance program for those on Welfare, requires a Work Experience Program (WEP) that assigns recipients to jobs to pay off their monthly checks. However, students are being asked to work in parks and sanitation, according to the Student Liberation Action Movement! (SLAM!). Refusing these positions, which, students say, provide no training or skills applicable to their education, means a loss of public assistance. According to SLAM!, the program prevents students from getting the education they need to get off welfare

"I am a victim of Workfare," said Jannet, an upper-freshman at Baruch University. "I had to reduce to a two-year degree because they will no longer pay for four years. For this I receive \$143 every two weeks for my living expenses. Education is my right and I want more for my son's future." Her son Marcus, six, stood at her side with a sign "Workfare is Unfair."

More than 10% of the students, about 20,000, at CUNY receive Public Assistance, most being single parents.

Yamile Mendez, a senior and President of Student Government at Hostos Community College, spoke on behalf of Latino students who are "entitled to an education and a chance to be someone," says Ms. Mendez.

"I need only three more classes to graduate, nine more credits. If this budget goes through I may not be able to register for next semester," says Ms. Mendez. "I am a Computer Science major. I really like what I'm doing and want to finish with a degree."

Sumair Hammed, with SLAM!, also spoke. "They have the money. Why do they have to hit the students?"

The rally ended with the members of SLAM! announcing that the protest was not over. Their "Day of Outrage" continued at the City College Shanty Town until midnight.



CHANGING OF THE GUARD

Over the past few months, CUNY has undergone some drastic changes in leadership. The most important change has been the recent replacement of James P. Murphy, who served as Chairperson of the Board of Trustees from 1980 to 1997, by Dr. Anne Aturra Paolucci.

The Board of Trustees is the top administrative board of CUNY, which currently sits sixteen members. Fourteen, including the Chair and Vice Chair are appointed by the Governor and the Mayor of New York. The final two being Dr. Sandi Copper, the Chair of the University Faculty Senate and Ifeachor Potts, who is the Chair of the University Student Senate. The Trustees who sit on the executive board with the Chancellor and Vice-Chancellor decided policy and budgets that affect the entire CUNY system

A February 22, 1997 press release announces the decision by Governor George Pataki, it reads as follows: Governor George Pataki today designated Dr.Anne Attura Paolucci as the Chair of The City University of New York Board of Trustees, Dr. Paolucci will replace James Murphy who has served as Chairman since 1980. George Pataki also designated Herman Badillo to be the Vice Chairman of The City University of New York Board of Trustees, replacing Edith B. Everett. "I am grateful to Mr. Murphy and Ms. Everett for their steadfast commitment and leadership during their tenure as Chair and Vice Chair of the CUNY Board of Trustees," Governor Pataki said. "I am pleased they will remain as board members, and look forward to working with them to provide the highest quality education to each and every student in the CUNY system."

Chairman Murphy said, "It has been a great honor to have served as Chairman of The City of University of New York Board of Trustees since 1980. My principal focus as Chairman has been and will continue to be as a member of the board to preserve and strengthen the mission of the City University in providing access to affordable quality higher education for thousands of New Yorkers."

Governor Pataki said, "Dr. Paolucci and Mr. Badillo's exceptional credentials will ensure that CUNY students continue to receive the highest quality education possible as we move into the 21st Century. I am confident Dr. Paolucci and Mr. Badillo will bring commitment, leadership and vision to their new roles as Chairman and Vice Chairman of the CUNY Board of Trustees."

Mayor Rudolf Giuliani said, "Herman Badillo has proven record on education. He has committed his career and his livelihood to the betterment of New York City schools. I am sure that Herman, a product of CUNY himself, will continue to be a role model for the thousands of students who have entrusted the City University with their hopes and dreams of a quality education."

Chancellor W. Ann Reynolds said, "We look forward to working with Chair Paolucci and Vice Chair Badillo. We all share a deep commitment to the vitally important education mission of The City University of New York."

Paolucci has been a full time English Professor at St. Johns University since 1969 and the Director of the Doctor of Arts Degree program in English since 1982.

A Fullbright Lecturer, Dr. Paolucci, a resident of New York City, has a bachelor's degree in English Literature and Creative Writing from Barnard College, Columbia University, a master's degree in Italian Literature from Columbia University and received her Ph.D. from Columbia University in English and Comparative Literature.

Mr. Badillo is currently practicing law at Fischbein, Badillo, Wagner, Harding located in New York

City. He currently serves as a member of the CUNY Board of Trustees, a member of Mayor Rudolph Giuliani Advisory Committee on the Judiciary and was appointed as Special Counsel to the Mayor for Fiscal Oversight of Education.

Mr. Badillo, a resident of New York City, has a bachelor's degree in Business Administration and graduated Magna Cum Laude from City College, and was Class Valedictorian and a Cum Laude graduate of Brooklyn Law School. He was admitted to the New York Bar in 1955 and became a Certified Public Accountant in 1956.

These designations do not require Senate conformation. There is no compensation other than reimbursement for necessary expenses. Dr. Paloucci was confirmed as a member of the board on June 30, 1996. Her term expires June 30, 2003, Mr. Badillo was appointed as a member of the CUNY Board of Trustees by former Governor Mario Cuomo on July 1, 1990 and was reappointed in July of 1994. His term expires on June 30, 2000.

This wave of change in leadership even reached the Chancellor's Board with the naming Dr. Louise Mirrer the new Vice Chancellor for Academic Affairs. Her replacement of the acting Vice Chair Anne L. Martin will become effective July 7, 1997.

Dr. Mirrer was Chair of the Humanities Division at Fordam University from 1991-94. She joined Fordam's Spanish Department in 1979 as an Assistant Professor and rose to become a full Professor of Spanish and Comparative Literature. Dr. Mirrer holds a double Ph.D. from Stanford University in Spanish and Humanities. She earned a Diploma in Linguistics from Cambridge University in 1975, following her Graduation from the University of Pennsylvania with a B.A. magna cum laude with honors in Spanish.

Tibet Supporters Hold Gathering in New York

Over 500 Tibetans and Tibet supporters gathered March 10th in New York to commemorate the 38th Anniversary of Tibetan National Uprising Day. This event concluded a Tibetan Awareness Week. The event was organized by a committee of which I took part in. The week was designed to bring public light to the political, social and cultural situation, past and present, regarding Tibet.

Tibetan Awareness Week began March 3rd and the New York committee sponsored special community outreach events all around the Tri-State area. One event took place on the College of Staten Island. It was headed by the Students for a Free Tibet on campus. This organization is non-profit and student supported. Their goal is to educate the public of human right violations in Tibet.

The special event sponsored at the College was a slide presentation by a Tibetan in exile. In regard to the presentation of the club, Vice President Brendan Kelly said, "This is a clear and obvious injustice here [in Tibet], anyone who learns of the circumstances immediately becomes outraged, but the problem is very few are aware. That is why I think it was important we did this event." Another club member, Jennifer Pena, commented on the turn out at the March 10th rally in Manhattan. She said, "It's nice to know people really care, and are willing to donate their time to protect the human rights of others."

The March 10th rally began at 11am with a number of distinguished speakers before the United Nation's building. This was after a some one read a writing statement made out by his Holiness the Dali Lama Speeches were given by many well known figures.

The list of people had Jose Ramos-Horta (1996 Nobel Peace Prize Laureate), Adam Yauch (activist and member of the Beastie Boys), Lodi Gyari (Special Envoy to the Dali Lama in Washington), Professor Robert Thruman (President of the Tibet House), and Xio Quiang (Executive Director of Human Rights in China). There were other that spoke words of inspiration, but more than words followed. A protest soon began in Manhattan.

At 1pm, the crowd began marching towards the Chinese United National Mission, carrying dozens of placecards and Tibetan flags. Along the way, the marchers were joined by many bystanders. This caused a spectacle along some of the main avenues. It also caused traffic to stop.

Upon arrival at the Chinese Mission, the protesters put up a deafening noise, filling the entire block opposite the 10 story building. At 3:30pm, thirty Tibetans and Tibet supporters staged an act of civil disobedience. These activists laid themselves in the street before the mission. They draped their fallen bodies with the Tibetan flag. The terrible sufferings of the Chinese people under the Chinese since 1949 were over the loud speaker. Sixteen activists were subsequently arrested and released later that evening.

The demonstration and the arrests were covered by the *Daily News, New York Post*, on March 11th. CNN presented a half hour live coverage show, including an interview with Adam Yauch. Also present were reporters and camera men from the *Associated Press, Reuters*, MTV Radio, the Chinese TV network of Hong Kong, Radio Free Asia, and the Voice of America. It was 38 years ago when Tibetan rose up against the might of China and declared their desire for freedom and independence. March 10th, 1959 was when a movement was initiated by the rank and file if the Tibetan people. China was able to quickly suppress the uprising, but not spirit of the Tibetan people.

The uprising was a spontaneous movement of the Tibetan people aimed at the Chinese tyranny and occupation. Angered by the diplomacy of the Tibetan government to appease China, and in order to avoid further shedding of Tibetan blood, the smoldering resentment of the Tibetan people burst into one last ditch effort to strike. On March 12th, the women of Tibet took to the streets of the Capital of Tibet, Lhasa.

It took the "Peoples Liberation Army" a little over three days to wipe out the uprising in Lhasa, but the resistance movement mushroomed all over Tibet. According to China's own estimate, about 87,000 Tibetans were killed in Central Tibet alone to re-assert the Peoples Liberation Army's shaky occupation. As a result of the resistance movement that Started 1949 over one million Tibetan have died.

A statement submitted by Senator Alfonse D'Amato to be read at the march, said: "March 10th 1959 represents a dark day in history for all of us. It was on that day that the Chinese troops viscously attacked and murdered Tibetan civilians who sought to protect their beloved Dali Lama, a man whose love and peace is known to all of us. The pattern of intimidation and human rights abuses by the Communist Chinese government against the people of Tibet continues today, and is unsuitable for a country like China which seeks status as a responsible member of the Community of Nations." To this reporter, it effectively summarizes the present situation.



Theater Review: 'Casey is Alive at the Irish Re

n 1922, Ireland was declared a 'Free State.' Not that life improved under the new banner, however Ire-land now had their own Parliament. Around the time of the first world war, the situation in that green isle was rough for there was often high unemployment, and intense poverty. This is the atmosphere for Sean O'Casey's play, "The Plough and the Stars," directed by Charlotte Moore, now appearing until May 11 at the Irish Repertory Theatre.

The story begins in Dublin in the year 1915, and the lights go up on Act I in a living room of the Clitheroe flat in a Dublin tenement. This is where a hilarious exchange occurs between the characters The Covey and Peter Flynn. The banter starts when The

Covey, a marxist in his mid twenties, played by John Keating, taunts the character Peter, a Parnell patriot, played by John Leighton. Peter, who is preparing for a meeting and trying to look official, is dressed in a green and white uniform, complete with sword, but he resembles a leprechaun more than a soldier. At one point The Covey is persistently ridiculing Peter, and the old soldier becomes so agitated he pulls out his sword and chases The Covey out of the room. The Covey goes on taunting Peter through a window in the door, all the while the audience is twisting in their seats with laughter. What makes this section of the play work is the character Peter's pretentiousness, which The Covey easily undermines with his acerbic wit.

The dialogue between The Covey and Peter Flynn is played with a comical flair, yet it is an important part of the conflict in the play. Throughout the first two acts Peter extols the virtues of the Irish war for independence, but The Covey thinks the movement is stupid because it is not about the economic

emancipation of the proletariat. "There's only one freedom for th' workin' man: control o' th' means o' production, rates of exchange, an' th' means of disthribution," says The Covey, essentially expressing the moral of the play. The message gets developed particularly through Acts III and IV, set during Easter 1916 when the Irish

Republicans tried to seize the Dublin Post Office. The tragedy was that they were easily outmaneuvered by the British army, who literally turned the Irish into shambles.

O'Casey himself was a founding member of the Irish Citizen Army in 1913, which was one of the precursor groups of the currently banned Irish Republican Army. In the early days of the 'Freedom' movement there was a significant socialist presence in the armies ranks, and this seems to have influenced the politics of the play. The character, 'The Covey,' a young militant, is characterized throughout the play by his disgust with the patriots, who he sees as shortsighted.

The character, Mrs. Nora Clitheroe, played by Louise Favier, whom the Covey and Peter Flynn both live with, is forced to reprimand the pair after she appears in Act I, as Nora is trying to keep a civilized home. It is no wonder then that she has a nervous breakdown after her husband goes off to fight the Brits, as a member of the ICA. The central conflict of the play is that Nora's husband Jack Clitheroe, played by Paul Mc Grane, must decide between the love of his wife and the love of his nation. The question is answered when in the heat of battle, during Act III, he blurts out, "Ireland is greater than a wife!"

The last two acts, III and IV, after intermission were significantly different in tone than the previous two. Gone was the hilarious hijinx replaced by the more solemn and tragic situation of bloody battle and death. The play takes the audience member on an emotional rollercoaster, which leaves one never to look at rhetoric and patriotism the same way again

Feisty, sometimes riotous, supportive roles were given by Des Keough, who played Fluther

Good, and Terry Donnelly, who played Mrs. Gogan. This holds especially true in a boisterous section of Act II, situated in what is called a 'public-house,' and the baby-toting Mrs. Gogan almost has a fistfight with the character Bessie Burgess, played by Pauline Flanagan.



The early sixties marked the dawn of the Silver Age of comics. Creators like Jack Kirby and Stan Lee set the standards for the decades to follow. Realistic personalities and real life problems were introduced to the superhero genre, allowing readers to better relate to the characters. Books like the Fantastic Four, Avengers, and Spiderman helped to propel Marvel to the top of the industry. Maintaining that position ever since by consistently setting new standards for the genre. That was until the nineties when tragedy befell this once noble publisher. The company became open to the public and an army of greedy shareholders led by the maniacal Ron Perelman invaded the placid community of comic creators. Mr. Perelman was not interested in the artistic expression or quality of comics only in how much money he could suck from the readers. He flooded the market with gimmick books that had no real value to them. Mass merchandising became his chief concern the books were second to action figures and T-Shirts. In a matter of a few years Marvel was gutted from the inside out. Nothing more than a shell remained of what took a good portion of this century to build.

In actuality creators Jim





Lee and Rob Liefeld were given the creative rights to the books for one year. This idea was half successful in that Jim Lee is an excellent creator and editor. His books came out on time and were quite good. Liefeld on the other hand can not put out a decent book to save his life. As a consequence his two works the Avengers and Captain America have severely dropped in readership. Which is shameful considering before he took over Captain America, the book was at an all time high in popularity due its excellent creative staff. DC Comics has always understood this in fact when the Flash returned to comics in the sixties they began numbering at 105 where they had left off at when Flash was canceled in the forties. The hope was that the reader was going to get the same high standard book he had received before. Marvel should follow this with the return of their books to the Marvel Universe. We the fans can only hope they do the right thing and if they don't then DC has plenty of good books to read.

I would like to point out that not all women want to be treated badly. On the other hand, there are some that do. HIGHER ED: NOT AN EXPENSE, AN INVESTMENT

In Governer Pataki's budget proposal for fiscal year1977-98, he is recommending a \$300 million cut to higher education. If that cut is enacted, tuition at the State and City University systems will have increased by 40 percent in the two and a half years Governer Pataki has been in the office. His penny-wise, pound-foolish approach to higher education is jeopardizing the public university system. Even more troubling is the response of the two university boards, which are supposed to serve as an advocate for the University. There has not been any cry of protest from either board, most of those members were appointed by the Governor.

The Governor looks at education as not an investment but as an expense. His tuition hikes send an unfortunate message to our young people: go study somewhere else. The problem is, some kids can't afford to go study somewhere else, and those that can afford to will probably live somewhere else after the graduate.

New York can't afford to lose young minds. Our State needs bright, energetic, educated young people to create new businesses, fill technical jobs and develop new products. The Governer may have missed it, but the world's economy has changed. If New York is going to regain its competitive edge, we have to change also. We need to focus on the most important tool for economic success education. Today's global economy doesn't have much room for unskilled, uneducated workers.

Regrettably, the Governer has tried to make his lack of commitment to higher education into a partisan issue. It's not a partisan issue. It's an economic issue, and the future of our State depends on our willingness to invest in the future. A study done in Illinois showed that for every dol-

lar Illinois invests in higher education it gets back four dollars and thirty-one cents in taxes along with an educated, innovative work force. New York needs to make an investment in higher education because it's the best investment for a strong economy.

Thirty years ago, then-Governor Nelson Rockefeller, a Republican said, "Our goal is to assure that no young man or young woman in this State with the desire and capacity for education shall be denied it for lack of facilities or personal financial means."

Governor Rockefeller had the vision to recognize the importance of making higher education available and affordable. He understood the value, not only to the individuals but to the State as a whole, of a higher education system that gives students, poor, rich or middle class, the opportunity to become contributing members of society. Governor Pataki should take a page from Governor Rockefeller's book and recommit himself to New York's economic future.

If our State is going to be a competitive in the future, we have to invest in the young people who will shape the future. We shouldn't penalize those young people for going to school in New York. We should be doing everything we can to make sure they have an opportunity to stay here, learn here, and when they graduate, contribute to the economy here.

Students have to make their government realize that tomorrow's opportunities are created by today's investments. It's imperative that every student on every campus stand up and be counted. Get involved. Your future, and the future of New York, depend upon a commitment to providing every person with the "desire and capacity" the opportunity for a quality education.



I am sure you have heard about the cuts to child care funding, but do you know how these cuts are going to affect the Children's Care Center on our campus? Last year the Federal Child Care and Development Block Grant to CUNY was cut by 21.6%. These cuts may be in place

again this If year. cuts these go into effect the infant/toddler room, including evening and weekend classes may be eliminated. President Springer, our college president,

has been supportive of child care on campus. An increase of \$1.2 million in additional state funds has ben requested in the CUNY chancellor's proposed budget. In addition, an increase in the CUNY child care block grant subsidies from \$1.27 million to \$2.7 million is being sought from the state.

If the state cuts the CUNY Child Care and Development Block Grant again, a loss of \$350,000 would result. This would cause more children to be dropped from the program, which would cause more parents to drop out of school. There has not been an increase in State Educational funding since 1987. Meanwhile the number of children needing these services has increased by 102%. CUNY child care serves over 1,500 student parents and children and has 3,100 children remaining on active waiting lists. This means that CUNY Child Care centers meets less than 25% of the need on CUNY campuses. CUNY child care provides work for 220 employees and 84 family day care providers, many of which are present or former CUNY

Mariano Rivera was the best set up man in baseball. When he was in there, the seventh and eighth innings were automatic and then John Wettleland got the job done in the ninth inning. In the post season everybody in the bullpen got the job done including Graeme Lloyd, Brian Boehringer, Jeff Nelson and David Weathers. Their bullpen can be compared to the Cincinnati Reds old bullpen that was featured "The Nasty Boys" (Rob Dibble, Randy Myers and Norm Charlton). Throw in some clutch hitting out of Bernie Williams and that's how the Yankees won the World Series. Here's a look at the defending World Series Champs, the1997 New York Yankees.

Infield

At first base Tino Martinez had a really solid year offensively smacking 25 HR and117 RBI. With his good performance, Yankee fans did not miss Don Mattingly that much. At second base Mariano Duncan was the best hitter the Yankees had with a .340 batting average. More importantly, he came through and became valuable when Pat Kelly was unable to play. In the offseason there was talk of trading him and putting Pat Kelly at second, but Joe Torre decided that Duncan is the starter. At shortstop Derek Jeter had a spectacular rookie season (.314 BA, 10 HR, 78 RBI) and was named AL rookie of the year. At third base it looks like Wade Boggs will play most of the time primarily because he is the lead off hitter and gets on base a lot. Reserve third baseman Charlie Hayes should get more time because he is a power hitter and is a good hitter against left handers. As the season progresses expect to see Hayes getting

more time at third base. Luis Sojo is a capable backup at short and second because of his solid fielding. During the off season Jim Leyritz was traded to the Anaheim Angels because they needed to cut down their \$60 million dollar payroll. Joe Girardi last season hit .294 and unlike most catchers he has surprising speed (14 stolen bases). Jorge Pasada is the backup to Girardi and he is there just to give Girardi a day off. The addition of Cecil Fielder gave the Yankees the power hitter they desperately needed. During the offseason no other clubs were interested in giving him a long term deal so he only had to settle for 9 million dollars this season. Cecil Fielder is a lot like Dave Kingman—he is homerun hitter but he is a below average fielder.

Outfield

Bernie Williams had a great season (29 HR 102 RBI) and a spectacular post season. He wants Ken Griffey Jr.-type money but I feel he has to have a similar season to get that money. He has the toughest agent to deal with in Scott Boras so expect negotiations to go on for a long time. Paul O'Neil had a solid year with 19 HR and 91 RBI's. Left field is the question mark. Daryll Strawberry is already having health problems and I feel that Tim Raines can definitely get the job done so there is no way this guy should be traded because injuries do happen and depth is a necessity. Mark Whiten is a solid backup outfielder and brings some left-handed power off the bench.

Starting Rotation

The Yankees have two great pitchers, but I feel that David Cone is the ace of the staff. If he did not get injured, he would have put up similar numbers that Andy Pettite put up (21-8). The Yankees did lose Jimmy Key to free agency but they signed free agent lefty David Wells because despite his cockiness (asked to have Babe Ruth's number) he pitches great in Yankee Stadium. Kenny Rogers was a huge disappointment last season primarily because he was pitching when he was hurt and did not tell any of the coaches that. For him to have a good season he has to stay healthy. Doc Gooden will be best remembered for his no hitter against Seattle and is a question mark this season because it seems recently the injury bug has caught up to him. Thankfully, Ramiro Mendoza can step in and pitch well, if not better, than Gooden could.

Bullpen

Everyone's job changed when John Wettleland signed with Texas. There was no way the Yankees were giving him six million per season. Mariano Rivera will step in to be the closer. The Yankee bullpen will blow more games now that Rivera is not the middle reliever. To pick up that slack, the Yankees signed lefty Mike Stanton who was the second best middle reliever in baseball last season. He should have the role Rivera had but it looks like Joe Torre will do it by committee. It looks like lefties Mike Stanton and Graehm Lloyd will only pitch against left handed hitters and righties Jeff Nelson, Brian Boehringer, and David Weathers will pitch the rest of the time.

Final Prediction

I feel that the Yankees will win the division because with the exception to John Wettleland this is pretty much the same team.

They are still better than Baltimore and even with all the improvements Toronto made, the Yankees will have no problem beating the Jays. The team that will give them problems is the Seattle Mariners. Lately, they have had a very tough time with them. If they face the Mariners I feel they will lose to them but if they don't face them, they will have a good chance to get to the World Series again.

Jets, Giants Feelin' The Draft

The flowers are starting to blossom. The pollen count is alive and kicking. The Mets are already out of it. That can only mean one thing. It's spring time and it's also time to focus our attention on football. No, we're not talking World League Football or the hideous Arena football league which will feature the New York Cityhawks who will play at the Garden (Oh joy!). We're talking National Football League here, specifically the NFL Draft to be held on April 19-20 in the Paramount Theatre. This is an event that is known for its intrigue, suspense , excitement and downright embarrassment and this year should be no different.

For the second year in the row, the New York Jets have the first pick overall in the draft and for the second year in a row, they will probably tab a USC player with that pick. Last year, it was wide receiver Keyshawn Johnson. This year, it could be defensive tackle Darrell Russell. Russell is a 6'4" 320 pound wrecking machine who can collapse the pocket and dominate a game at times but he ahs also been accused of taking some downs off. New coach Bill Parcells will not let this happen. He will be on Russell's case from day one if the Jets tab him and that's a very likely scenario. The Jets are alarmingly thin at the defensive tackle position and they are in dire need of an impact player there who has size and the abil-



ity to stop the run and also put pressure on the passer. Darrell Russell can do all that and more. The Jets are also

considering Ohio State offensive tackle Orlando Pace

with their first overall pick but the Jets have a lot of money invested in their two tackles, Jumbo Elliot and David Williams. The Jets are also said to be concerned with Pace's knee. But if that knee checks out, Pace can be the most dominating offensive lineman the NFL has seen in years. The Oakland Raiders have traded up to the second pick and are salivating for Pace. The Seattle Seahawks pick third and they have their sights set on the best cornerback in the draft in Ohio State's Shawn Springs who's 6'0" and weighs 195 pounds. He has excellent size and speed (4.35 in 40 yard dash) to be a Pro Bowler on this level. The Jets are also interested in Springs because they are thin at corner and they need players with size at the position to team up with Aaron Glenn. A potential Glenn-Springs corner combo could become the best in the NFL so the Jets are intrigued by that scenario.

The Jets could use any one of these three high impact players, meaning Russell, Pace or Springs. Those are positions that the Jets need an upgrade. They are in a prime position to better themselves and if they play their cards right, they will come out of this draft like real winners. They are sending smoke signals out for everyone to notice that they love these three players and they may be leaning toward one player over another, even if they don't prefer that player. But they will do that to get a team like the Raiders (second pick), the Seahawks (third pick), or a team like the St. Louis Rams (sixth pick and they love Orlando Pace) to worry that the Jets may take the player they want. The Jets will hold on to this pick until draft day and look for them to make a deal with one these teams or perhaps someone else (49ers?) who might make a tremendous offer that the Jets cannot refuse. The Niners have reportedly offered the Jets defensive tackle Dana Stubblefield and a couple of picks to move up because they want Pace. The Jets hold all the cards so let's see if they have a good poker face when draft day rolls around. Prediction: the Jets will trade down one spot with the Raiders with the Jets getting a third round pick. The Raiders will grab Pace and the Jets will draft USC defensive tackle Darrell Russell. You read

it here first! The Giants pick seventh overall in this draft and they need a left tackle and a wide receiver as their top priorities. They are said to be looking at Florida State offensive tackle Walter Jones, who's the second best tackle in this draft behind Pace. Jones has decent size (6-5, 300lbs.) and has cat quick feet to play the all important left tackle position in the NFL. He would fit in well with the Jints. The guy they may end up picking however is Miami wideout Yatil Green. He came out as a junior and he may the right choice. He had an awesome combine workout where he ran a 4.29 forty on a slow surface and has great size (6-2, 200lbs.) and big play potential. He's an impact receiver with good hands and the best receiver Miami has had since one Michael Irvin. The Giants need impact players at the receiver position, especially one that can catch the ball and Green fits that perfectly. Either way, Big Blue will get themselves an impact player with that seventh pick overall. Here's a look at the rest of the draft:

Quarterback

Virginia Tech's Jim Druckenmiller is the top QB and the only one who will get drafted early in the first round. He has good size (6-4, 233lbs.) and is very strong physically with a cannon for a arm. Arizona State's Jake Plummer is a winner with a big heart but not much size or arm strength. I'm not too high on him nor Heisman winner Danny Wuerffel. BYU's Steve Sarkisian is a natural passer who played in a pro style offense. He'll be a steal for someone in the third round. Sleeper: Colorado's Koy Detmer. Younger brother of Ty is not big (6-2, 205) but he has a quick release, tough competitor and plays well in cold weather. Looks like a poor man's Brett Favre.

Running Back

Decent group led by Houston's Antowain Smith who's a 6'2" 225 pound workhorse with great speed (4.4) for his size. Washington's Corey Dillon is also a big back with big play potential. Florida State's Warrick Dunn and Iowa State's Troy Davis are undersized backs who may not be able to take the NFL pounding. Sleeper: Tennessee's Jay Graham. An all purpose back in the mold of Chris Warren. He can run, catch, and block. Keep on eye on this guy.

Wide Receivers

Miami's Yatil Green is best of bunch and should be scooped up by the Giants. Colorado's Rae Carruth has blazing speed and has been compared to Joey Galloway. Florida's Reidel Anthony has burner speed who makes plays and is better than teammate Ike Hilliard. I love Texas' Mike Adams potential as a gamebreaker and will make some team happy in the second or third round (Giants?). Sleeper: Kansas State WR Kevin Lockett. Will open up some eyes on the next level with his size (6-1, 190lbs.) and great hands. Could be one of the most

underrated players in the draft.

Offensive Linemen/Tight Ends

LSU's David LaFleur and Cal's Tony Gonzalez rate out as the top two tight ends in the draft with Southern Illinois' Damon Jones not far behind. All three will go in top two rounds with Lafleur being best of bunch with his enormous size (6-7 280lbs.). Michigan's Rod Payne is top center along with TCU's Ryan Tucker. Colorado's Chris Naoele and Michigan's Damon Denson are top flight guards but watch out for Washington's Bob Sapp, said to be best pulling guard to come out in years. Ohio State's Orlando Pace is top tackle followed by FSU's Walter Jones and Arizona's Juan Roque. *Sleeper:* Central Michigan ON Scott Rehberg. His size and speed (6-8 320 lbs. 5:2) make him a small school gem just waiting to be discovered.

Defensive Linemen/Linebackers

USC's Darrell Russell is top DT in draft with Cortez Kennedy/Chester McGlockton potential and should go to the Jets at #1. Myron Elzy of Central State (6-4, 305 lbs.) and Texas A&M's Ed Jasper (6-4, 305 lbs) are big bodies who can be solid NFL defensive tackles. FSU's Peter Boulware (6-4, 255lbs.) and Clemson's Trevor Pryce (6-5, 280lbs.) are the top ends in the draft. Alabama's Dwayne Rudd (6-3, 245 lbs) is top 'backer in the draft and should go in the top ten. The Virginia LBs Jaime Sharper and James Farrior (both 6-3 and 235lbs.) have great closing speed and are versatile. Tyrus Mccloud of Louisville and Matt Russell of Colorado are the top inside linebackers.

Sleeper: Colorado OLB/DE Greg Jones. At 6-4 and weighing 255 pounds, Jones played end in college but depending on who drafts him, he will make a Pro Bowl outside linebacker for a team that plays a 3-4 scheme. Plus, he has 4.55 speed which makes him more appealing. Would be a great picker for Steelers or Carolina but may end up with Cincinnati which just switched to a 3-4.

Secondary/Kickers

Best crop I've seen in years with Ohio State's Shawn Springs (6-0, 195lbs 4.3 speed) and Texas' Bryant Westbrook(6-0 200 lbs. 4.4) the top two corners in this draft and both are sure fire Pro Bowlers and top five picks. Iowa's Tom Knight, Louisville's Sam Madison, Kansas State's Chris Canty, and Nebraska's Michael Booker are all top flight cornerback prospects. Ohio State's Rob Kelly (6-2, 200 lbs 4.5) and Miami's Tremaine Mack (6-0 195lbs 4.4) are the top two safeties with Penn State's Kim Herring is not far behind. Jets may tab Kelly in second round. Ball State's Brad Maynard is said to be the best punter in the draft since Ray Guy. He's got a powerful leg and can really boom it. Penn State's Brent Conway is the top placekicker.

Sleeper: Texas safety Chris Carter. A big play safety with size and speed (6-1, 205 lbs 4.5) that will remind you of a young Tim McDonald.
