Most CSI freshmen aren't ready for college

The Majority of students entering the College of Staten Island (CSI) are not prepared for college-level courses.

According to figures compiled by the college, only 20 percent of last year's freshman class of 1,800 passed all three math, reading and writing placement tests signifying their readiness to do college-level work.

Of the 80 percent who didn't pass all three-R's, 30 percent failed one of the exams; 30 percent failed two, and 20 percent flunked all three tests.

Consequently, CSI has scheduled more then 70 remedial classes in basic math, reading and writing this fall.

CUNY officials point to a growing immigrant student body as one reason for the high enrollment in remedial education at both its senior and community college campuses. Indeed, nearly half of the system's 200,000 students speak a language other than english as their native tongue.

At CSI, however, that figure is less than 10 percent.

Nevertheless, the school's enrollment in remedial education remains high.

Like other colleges throughout the City University, though, CSI adheres to an open admissions policy, which does not require students to take the standard college entrance exams before acceptance to the institution - as private colleges and universities do.

Exams such as the Scholastic Assessment Test (SAT) test verbal and math skills. Older students, who have been out of high school for several years, also account for a large percentage of CSI's enrollment.

Forty-six percent of students who enrolled at CSI last fall were older than 25, while 63 percent of students who graduated in 1995-96 academic year were older than 25.

CSI enrollment statistics are not available for this fall's freshman class, but the class schedule lists 31 remedial classes in reading and writing skills offered by the English Department, and 40 remedial classes by the Math Department.

Overall, remedial courses account for about 24 percent of the total course work of CSI freshmen.

Registration begins Thursday and continues throughout the month on scheduled days.

"Getting students up to college level work

consumes a significant amount of our resources," admits Dr. Leonard Ciaccio, special assistant to the president for external relations.

"One of the things it means is that we have to either spend a substantial amount of money to hire adjuncts to teach these classes, or use our full-time faculty, which means they may be unable to teach advanced courses in their field specialty," he explained.

According to the CUNY Budget Office, remediation costs a little more than \$1 million at CSI in 1996. CUNY spends about \$35 million of its 1.2 billion budget on remedial education.

Moreover, CSI is still working its way back from budget cuts of a few years ago, which forced faculty and staff layoffs, larger classes and fewer course offerings.

Critics of CUNY have said the problem is systematic and have called for a tightening of admissions and academic standards across the board. CUNY chancellor W. Ann Reynolds, who came under fire for failing to upgrade standards during her tenure, announced last month that she was resigning to become president of the University of Alabama's Birmingham campus.

City University trustee and Staten Islander Alfred B. Curtis Jr., Mayor Rudolph Giuliani's appointee to the board, said he finds the situation "very troubling."

"The problem seems to be systemic; it's a sad commentary. It's wonderful to offer access to higher education but you must be prepared to do college work," he said.

"We need to take a critical look at the whole issue and [create] an agenda that will lead to kids being better prepared for college and for the work force," he said.

Private colleges and universities also routinely administer placement tests, which require them to schedule remedial for freshmen whose basic skills are not up to par.

At Wagner College, approximately 10 percent, or "40 to 50," of the 420 incoming freshmen are expected to take a remedial course in basic writing skills this fall, according to Dr. Susan Robinson, associate provost.

She said the english department may schedule "two or three" classes, which Wagner refers to as "preparatory" courses. St. John's University also administers placement tests and basic skills to its incoming freshmen; it was not immediately known how many freshmen at St. John's will take remedial classes in the fall.

CSI refers to remedial courses as "developmental" or "prerequisite" classes, which are required in order to move on to more advanced work.

The classes do not satisfy requirements toward a degree but are listed on a student's transcript.

In June 1995, the CUNY Board of Trustees voted to limit students to 1 Year of remediation at its ten senior colleges; students with the need for more remediation must begin their studies in an associate's degree program.

Jerome Berg, Staten Island's former trustee who was recently replaced by Curtis, was a strong proponent of alleviating CUNY's need for remedial classes.

Among other initiatives, Berg rallied for High-school testing as an early indicator of the need for remediation.

He also advocated CUNY's Language Immersion program, which is now available at five CUNY campuses and provides immigrant students with the chance to learn English before enrolling in college courses.

The class of 2000, which entered CUNY last fall, is in fact being touted as the best prepared class since the University began its open admission policy in 1970.

CUNY officials attribute the improvement to a four-year-old collaborative program between the University and the Board of Education known as the College Preparatory Initiative (CPI).

CPI is designed to encourage public high school students, who account for more than half of CUNY's beginning freshmen, to enroll in more demanding academic courses in an effort to boost their college performance. Gradual implementation of the program began in the fall of 1993 and is expected to be completed by the fall of 2000.

At that time, students enrolling in all CUNY degree programs will expected to have completed 16 academic high school units approved as college preparatory by CUNY and Board of Ed. officials.

Requirements will include four units in English, three in math, four in social sciences, two in lab science, two in a language other than English and one in fine or performing arts.

CUNY officials report that students entering CUNY with 13 or more CPI units showed higher first semester grade point averages, better retention rates and more credits earned.

Chancellor Reynolds Leaves CUNY

CUNY's chancellor, W. Ann Reynolds will be leaving CUNY to become the president of the University of Alabama at Birmington. She announced on July 17th she will be leaving CUNY in mid-September.

Before becoming the Chancellor of CUNY, Ms. Reynolds worked as the Chancellor of the California State University. She resigned from her position in California over a dispute with the University's trustees over raises she had given herself and other top executives. Ms. Reynolds had raised her salary from \$136,000 to \$195,000. She also raised the salaries of college presidents to \$145,000 from \$110,000. Ms. Reynolds and the board chairwoman, Marianthi

Lansdale had been delegated authority for salaries from the trustees. After raising the salaries the trustees complained they had not been consulted about the need for raises.

Ms. Reynolds became the Chancellor of CUNY in 1990. A CUNY search committee decided that she was not at fault in the dispute between herself and the trustees at the California State University. Her selection was approved by a 17-member board of trustees at CUNY on the basis of her demeanor in two interviews and her record.

Within the past year Ms. Reynolds has faced a great deal of tension between herself, Governor George E. Pataki and Mayor Rudolph W. Giuliani. The Governor and the Mayor hired a new board of trustees who voted to take \$1 million out of her budget to hire its own researchers, consultants and legal staff. The purpose of these researchers was to supply itself with information and advise aside from that of Chancellor Reynolds's.

Ms. Reynolds claimed to have worked with the board on making several changes in CUNY. Apparently they had worked together to create immersion programs to teach English to students before starting college. They had also worked on making High School coursework more rigorous for potential CUNY students. Nevertheless, the board criticized her job performance, claiming that remedial programs which she had supported were unsuccessful and CUNY education was poor under her leadership. A Professor, who asked to be unnamed, was quoted in the March 30th issue of the New York Times saying, "The Chancellor has been publicly humiliated by these people. If this were Japan, she would have fallen on her sword."

Ms. Reynolds accepted the job of President of The University of Alabama at Birmington which has a \$1.3 billion budget. She claims to have had positive experiences with CUNY, and is looking forward to her new position in Alabama.

Student Liberation Update

Returning to the college after a long summer break is never an easy thing for students to do. The task of returning to the College of Staten Island (CSI) has been made even more problematic due to the constant bashing the City University of New York (CUNY) has taken in the media. Indeed, this summer has been one of drastic changes both locally at CSI and most especially at a CUNY wide level. As a result of our election victory last semester the CSI Student Union has been able to develop into one of the most active forces in the student struggle on campus and throughout CUNY. In order to assist the students of CSI in their transition from summer break it is essential to give a brief description of the events that have transpired and the actions of the Union while students were off campus.

On a CUNY wide level the summer ushered in a new conservative controlled Board of Trustees (BOT) and ushered out the equally conservative Chancellor of CUNY Ann Reynolds. Trapped in the middle of a power struggle that involved the BOT leadership, Chairwoman Ann Paolucci and Herman Badillo, and the students of Hostos Community College, Reynolds bailed out of her post and escaped to the University of

Alabama at Birmingham. While the students of CUNY will not miss Reynolds or her policy decisions which diverted millions of dollars from education and into a paramilitary security force, known as the S.A.F.E. team, the issues raised by the BOT have sounded warning bells for students and educators throughout CUNY. The dispute between the students of Hostos and the BOT revolved around the imposition of a flawed writing exam, the CUNY Writing Assessment Test (CWAT), as a graduation requirement a mere three days prior to graduation. In response to this, students protested against this politically motivated measure and spilled out into the streets of the Bronx in order to express their outrage. Hostos students, with the assistance of student advocate-attorney Ron MacGuire, then took their case to court and won a preliminary injunction which allows them to receive their diploma's while they await the results of the larger lawsuit. The BOT, with the help of various local newspapers including the Daily News and the Staten Island Advance, used the crisis they created as an opportunity to attack CUNY and begin the process of eliminating the policy of open admissions, a policy which they view as expensive and wasteful. For many CUNY students open admissions has allowed them their only chance to receive a college degree.

Open admissions was a policy that was won in 1970 as a result of bitter struggle between the Black and Latino students of the City College of New York (CCNY) and the various White political forces in New York City. CCNY is located in Harlem and prior to 1970 its student

body makeup, mainly White, did not reflect the makeup of the community which was largely Black and Latino. After several peaceful attempts at opening up the school to the community, the students engaged in a strike which resulted in the takeover of 5 buildings on campus. As a direct result of the pressure and militancy applied by these students the policy of open admissions was enacted. Thanks to the sacrifices of these courageous Black and Latino students all of us here at CSI have access to a college education. As a result of the conservatively charged BOT's political maneuvering open admissions is currently far from secure and as responsible students and citizens we must begin to take

measures to defend open admissions from those who wish to challenge it on the BOT or any other political body.

Back on campus the CSI Student Union has been working diligently and effectively to enact progressive changes. The 1997-98 budget includes \$150,000 worth of student activity fees which have been liberated from the reserves. Many new services will be enacted as a result of this liberation including a speakers series which will bring some of the biggest names in the intellectual community to campus, extended coffee services for evening and weekend students, an allocation for the purchase of library books to increase our currently limited holdings and a joint project with the New York Public Interest Group (NYPIRG) called the Book Exchange which will provide students with low cost used books to name just a few of the changes that are in the works. In the area of increased access to facilities for students the Union has made some amazing accomplishments. As a result of the pressure placed on the Administration, library hours have been extended on weekdays and Sunday hours (12-5) have been added, computer lab's will be open until midnight on weekdays and the Campus Center hours will be extended. All of this would not be possible without the Union's goal of building a mass student movement at CSI and the participation of many students at CSI. Off campus the Union has worked with the students at Hostos during the CWAT controversy, the Staten Island

Teamsters Union during the recent strike against UPS, CUNY wide meetings geared towards defending open admissions, marches in Philadelphia to demand the release of political prisoner Mumia Abul-Jamal and we recently marched with 15,000 other New Yorkers in a rally in support of policy brutality victim Abper Louisse.

port of police brutality victim Abner Louima.

While we have achieved many victories we have also faced stiff resistance from the Administration. In order to properly serve the students at CSI we have begun the process of opening up the books of the college to understand exactly how funds are being spent. This investigation has set off defensive flags all over the administration which have effectively cut the Student Government off from the information they need. To combat this we have filed two Freedom of Information Acts in order to exercise our constitutionally guaranteed rights to examine the financial information at this public institution. The process of investigating the administration has clearly illuminated the need for the Student Union to stick to the original tenets of the

It is essential that the Union continues its mission of building a mass student movement on campus. As such, we request more from the student body than any one else does. In order to continue to re-shape CSI into a student centered, student run University students must get involved. Getting involved translates into many different things for many different people. For some it means joining the Student Union and becoming an active, vibrant participant in the struggle for student rights, while for others it

may mean something as simple as not purchasing books from the Barnes and Noble run CSI Bookstore because they price gouge students. Whatever way it comes out, our hope is that it does indeed come out. Student victories have been and will be won through activism, not through passive or dealing with the Administration, to think as much is to deny one's identity as a student, not a politician or an Administrator. The CSI Student Union wholeheartedly welcomes all those students that are interested in enacting the changes that will democratize our school and create a bright, vibrant institution for the 21st century!



Controversy at Hostos

Hundred plus students at Hostos College were given a surprise when told they can not graduate with out passing a writing assessment test (WAT) this past term. This was told to them only days before their graduation. These students took a test that only a handful could pass. People would ask why over a hundred students could not do this. There are two reasons.

One reason is how Hostos is set up. The college was explained in a May 22nd New York Times article entitled, "City U. To Require English Test At Hostos." It stated, "What makes Hostos unique in the City University system is that it was created to allow bilingual students to take many classes in Spanish. About 80 percent of the 5,000 students at the college are Hispanic. Each year, about half of entering freshmen score too low on the college's English placement test to enroll in regular English courses and must take classes in English as a second language, which are non credit courses."

The second factor is how English is taught at Hostos. An article written in The Chronicle of Higher Education wrote about this. "The instructors often rely on outmoded techniques, omitting rigorous instruction in grammar, spelling and writing. In some years, as few as 10 percent pass the writing competency test. The rest repeat second-language courses as much as three or four times and must pay each time." What is covered on this test makes these courses useless.

The test offers two questions to students asking them to choose one. The students are not allowed to use dictionaries and had a time limit of fifty minutes. The items reviewed for grading are organization, sentence structure, punctuation and spelling.

This test is similar to a CUNY placement exam which incoming freshman take here at CSI. The difference with the WAT test is that it is given to Hostos students right before graduation. It checks if they have reached college level writing. There has been some debate about the exam.

Herman Badillo, a CUNY trustee agrees with taking the exam. He is quoted to say, "We have to have standards that apply throughout the university, and proficiency in English is one of them." Mr. Badillo also commented, "If they've written strong-enough essays to pass the composition course, they should be able to do this test." Mayor Rudolph Giuliani, who stands by the exam said, "We should be setting higher standards, not reducing standards." There are some people that disagree with them.

"I don't think one paper reflects the capacity of any one student," said President of Hostos student government Yamile Mendez. "Student who grew up writing and speaking Spanish often need more than fifty minutes to craft a descent essay in English." Brian Gallagher, a professor of English at La Guardia Community College said, "It's a timed test that allows you to write only one draft." Dr. Galllagher believes, "In our courses, we stress redrafting, rewriting, peer critiquing. We don't think the test is all that valu-

As of now, the case is pending in the New York court system. The school has offered summer programs to aid these students to pass the exam. The question that remains is, Why after four years of college, do they need a summer session on writing?

Banned Contractors Worked On CSI

An extensive investigation by Newsday into City University of New York (CUNY) construction practices has revealed that, during the building of the College of Staten Island complex in Willowbrook which was completed in 1995, not only were there large cost overruns, but a number of contracts were awarded to builders who had been banned from work by other government agencies, had indictments filed against them or had convictions in their background.

Published in the Queens edition of the newspaper two weeks ago, the articles by articles by staff writer Graham Rayman were the result of a six month investigation which involved obtaining thousands of internal CUNY documents and conducting dozens of interviews.

In the case of CSI, Newsday found that the final estimated cost of building the Willowbrook campus, \$394 million, was 38.2 percent over the original estimate, a pattern which emerged throughout most of CUNY's recent building boom. On top of its high price there was there was the fact that CSI's ventilation system, which cost \$28 million itself, was too weak, resulting in a "sick building syndrome" due to mold growing in the air ducts and apparently causing illness among CSI faculty and students. Repairs will have cost another \$10 million.

"These facilities seem to

(This article was reprinted cost tax-payers two dollars for every dollar they would cost in the private sector," Jerome Berg, Staten Island's former representative on the CUNY board of trustees, told Newsday. "And they can be constructed more economically. With that, we can build more space."

> The former chief executive officer of East Coast Lighting, Berg is a highly regarded expert on administration, construction and development.

> There has been a ten-year construction frenzy taking place at CUNY involving 22 major projects. These projects, which are carried out jointly by CUNY and the State Dormitory Authority, were supposed to cost the taxpayers of New York a total of \$1 billion. But, according to Newsday's research, so far they are more than \$600 million over the original estimate.

> According to berg, the CUNY board is asked to approve just pieces of a contract at any given time, making it impossible for them to get a grasp on the total costs.He's also quoted as saying that the Dormitory gives insufficient incentives to contractors to complete projects on time or within their budget. And, he said, the complications of the divided process between CUNY and the Authority create scenario in which projects often take as much as eight years to complete, forcing delays and added costs.

Another area that Newsday explored, particularly involving the College of Staten Island's Willowbrook campus, was the

awarding of contracts to companies that, if they were trying to do business with other agencies of government, might be disqualified.

One of these was a company called Hi-Tech Mechanical, a firm from Astoria, Queens, which received \$2.4 million for three contracts at CSI's Willowbrook campus during the period of 1991 through 1994.

Hi-Tech, which is now out of business, reports Newsday, was a spin off company of Arc Plumbing and Heating. Arc had listed famed mob figure John Gotti as one of its

Hi-Tech, says the report, was founded by Anthony Gurino, an Arc executive, and another employee after Arc was barred from City contracts in 1989. The following year the inspector general of the School Construction Authority - the agency that builds the City's elementary and secondary schools barred Hi-Tech from any contracts for school construction.

In June 1985, says Newsday Gurino had been indicted and was then convicted in federal court of conspiracy, obstruction of justice and money-laundering.

Claudia Hutton, a spokeswoman for the Dormitory Authority, said that Hi-Tech was awarded the CSI contract in November 1990 because it was the lowest qualified bidder for the job. She claimed that, at the time of the award, the Authority's background checks on contractors were more limited than they are now.

Perna Contracting

During the period of 1990 to 1992, four contracts worth a total of \$23.5 million at the College of Staten Island were awarded to Perna Contracting of Queens in spite of the fact that its chief executive had had recent legal difficulties. In November 1988 Anthony Perna had been convicted in federal court of labor racketeering for bribing union officials, said Newsday.

The firm itself had not been indicted, but it had been disqualified from School Construction Authority contracts in 1989, and the office of the City Comptroller had also barred the company from City contracts in 1991.

Michael Shapiro, Perna's Lawyer, told Newsday that Anthony Perna - who was fined and sentenced to five years' probation by the court - was indicted because of a refusal on his part to cooperate with federal authorities out of concern for his personal safety. Shapiro said that the Dormitory Authority was aware of the conviction when they awarded Perna the CSI contracts.

Kew Electric

A Staten Island firm called Kew Electric received \$4.6 million for work at the College of Staten Island, said Newsday, as well as \$7.6 million for contracts at the Baruch College library during the years 1991 through 1994.

Yet, from 1990 to 1993 the company was barred from work on

Continuation of Banned Contractors

School Construction Authority projects after the conviction of one official of the firm on labor law violations, the newspaper quoted a "law enforcement source" as saying. The source stated that Kew had failed to reveal one of its executives had pled guilty to a charge of falsifying business records.

Hutton told *Newsday* that Kew had been initially disqualified from the Baruch contract because of the executive's conviction, but that in May 1991 the company presented evidence to the Dormitory Authority "that the convicted former owner was no longer associated with the firm."

EMD Construction

A company from Woodside, Queens, called EMD Construction received \$8.3 million for work at The College of Staten Island, according to *Newsday*. The contract was awarded in December 1990.

Eleven months earlier, in January 1990, the School Construction Authority had refused to prequalify the same company to bid on school contracts. Furthermore, EMD Construction was accused of multiple safety and equipment violations of Environmental Protection Agency rules in 1991, according to the City Comptroller's office.

The company was denied a number of City Contracts in 1992, said *Newsday*, after the Comptroller's office accused it of having filed false statements on legal disclosure forms and of having double- billed the City on Previous contracts. In 1992 the City's Department of Parks & Recreation cancelled a contract with EMD.

Hutton of the Dormitory Authority

told the newspaper that EMD had been awarded the CSI contracts because it was the low bidder.

"Because of State law," she was quoted as saying, "the Dormitory Authority could not have used SCA's information (the School Construction Authority) alone as grounds to disqualify, even if aware of the refusal to prequalify."

Quality Roofing

Another firm called Quality Roofing was paid \$1.3 million for work at the College of Staten Island, according to *Newsday*, despite the fact that one of its executives, Roger Martin, pled guilty in 1992 to charges that he had paid a \$25,000 bribe to Joseph Lipari, the mayor Passaic, N.J.

One of the bottom line conclusions of the *Newsday* investigation is at the system of contracting in use by CUNY during this inadequate to prevent such abuses. The Dormitory Authority lacks the legal authority to check on firms before they submit bids for construction work, as opposed to the School Construction Authority to do that is part of its charter.

Furthermore, oversight of the firms working on CUNY projects has been less than diligent because of the small staff assigned to this work and by the failure to use the lists of questionable contractors developed by other government agencies.

Since the arrival of John Buono as executive director of the Dormitory Authority, according to *Newsday*, there have been some improvements, but much more needs to be done.

EPISTLES OF VERITAS

Topic: The sacrament of Baptism examined



Within the boundaries of Christianity, a person was baptized one way or another. Whether you're a Catholic, Baptist, or Lutheran, you are either sprinkled, immersed, or water poured over your head. Also, you were baptized whether you were an infant, child, or an adult. But, are all these types of baptism valid?

What is the significance of water baptism? How is it part of our daily walk with God?

The sacrament of baptism was first instituted by John, the cousin of Jesus. John was known for being the forerunner of Jesus Christ. Also, he was known for his baptisms concerning repentance.

He baptized people if they wanted to repent. Thus, he was coined John the Baptist.

Jesus Christ reaffirmed the importance of baptism during his discussion with Nicodemus (John 3:3-5). He spoke to him about being born again of water and of spirit. The correct interpretation is that being born of water refers to water baptism. In Acts 8:36, the word "water" is synonymous with baptism. Also, Jesus practiced baptizing people during his ministry (John 3:21-22; John 4:1-2).

The mode or type of baptism used was immersion or dipping. Baptism is from the Greek verb "baptize", which means fundamentally "to dip, plunge, immerse". It is clearly expressed that the proper mode of baptism is immersion, not sprinkling or pouring water over your head. Romans 6:3-4 describes baptism as a type of burial with Jesus Christ. It is clearly evident that baptism in the proper mode fulfills the gospel of Jesus Christ, which is the death, burial, and resurrection of Christ.

Baptism must also be accompanied by an effectual faith (Acts 8:37; Galatians 3:16; Colossians 2:12; James 2:17). When faith is activated during baptism, the person's commitment and identification with Jesus Christ becomes fully realized as grace reigns through him/her (Romans 5:21; Galatians 3:27).


With the proper mode of baptism being immersion and the proper understanding that an effectual faith must be accompanied during bap-

tism, there must be a proper invocation to validate baptism. The proper invocation to validate it is invoking or saying the name "Jesus Christ" during the initiation. Matthew 28:19 describes Jesus giving a commandment for his disciples to baptize people in the "name" of the Father, and of the Son, and of the Holy Ghost. The "name" is not Father, Son, and Holy Ghost. English grammar dictates that the word "name", in relation to the verse, is singular and that it describes to a generic term. Father, Son, and Holy Ghost are titles that gives emphasis to the singular name. The name "Jesus Christ" is the proper name fulfilling the titles "Father, Son, and Holy Ghost. Peter, the Apostle, understood the commandment given by Jesus as Peter was delivering his sermon during the day of Pentecost. In Acts 2:38, Peter said, "Repent, and be baptized in the name of JESUS CHRIST......". This correct interpretation was reiterated in Acts 8:16, Acts 10:48, and Acts 19:5. Also, the name of Jesus Christ is important in the salvation process (Acts 4:10-12).

With the Holy Scripture as the measuring rod of Truth (II Timothy 3:16-17), it is clearly evident that the correct way of being baptized is a person being immersed, accompanied by an effectual faith, in the name of Jesus Christ. One may question, what happens to those types of baptism a person has gone through? As Aquila, Priscilla, and John's disciples from Ephesus were expounded by the word of God more perfectly, you, the reader, are expounded more perfectly (Acts 18:26; Acts 19:3-4).

With the biblical analysis of the sacrament of baptism, it is shown that throughout the centuries baptism has been altered to satisfy the convenience of the person. One example would be Emperor Constantine of the Roman Empire. Though he was credited of establishing Christianity as the official religion of Rome, he was never a believer until the moment of his death. He requested that he be baptized through pouring water over his head because he was to ill to move. A man of the cloth would not dare to refuse the emperor of Rome. His refusal would be political and literal suicide. Thus, one would see the beginnings of politics between the ancient Catholic Church and the empire of Rome.

In conclusion, the sacrament of baptism is important to every believer in Christ and should strive to be rebaptized if he/she has not been baptized the correct way. It is only logical as an ambassador of Christ, for those who believe they are, to represent Jesus Christ the correct and proper way.

Judy Chicago: Women in Art Paul McCartney's "Flaming History


Hey, Judy Chicago is really cool. She is cool because she created art with the purpose of educating it's viewers on the role of women in history, and the fine arts. I think that's pretty cool.

I learned about Judy Chicago in Art 104, which I took this past semester with Prof. Wacks. In that class I learned about an interesting experience that Ms. Chicago had in an art class she was taking. She was wondering why she was only being taught about male artists. When she asked her art teacher why she was never taught about female artists he told her that it was because there were no good female artists throughout history. Ms. Chicago refused to accept this statement as being true. She did some research and found that there were many accomplished women throughout history who should be given credit for the things they have done.

Judy Chicago set out on a mission to give at least some of these women the credit they deserved. In 1979 she created a work of art called The Dinner Party. It is a triangle, 48 feet long on each side, with place settings for 39 historical women. The original concept behind The Dinner Party was a feminist version of the "Last Supper" which was attended by thirteen women who were the "honored guests." However, Chicago found that thirteen was too small a number to represent the many woman that her researchers found.

Some of the women with

place settings Georgia O'Keeffe, the Egyptian pharaoh Hatchepsut, Virginia Woolf, Susan B. Anthony, and the Native American guide Sacajawea. Each woman has a place setting that was created to reflect significant facts about their lives. The plates were painted to symbolize these women and their experiences. The table runners were created with a com-

bination of different techniques including embroidery, crochet, beading, patchwork, and applique.

The names of 999 other accomplished woman are inscribed on a white tile floor that The Dinner Party rests on. This symbolizes how the accomplishments of these 999 woman worked as a foundation for the 39 "honored guests."

It took a lot of work, but the result was well worth it. It was pretty cool of Judy Chicago to do

about a lot of new music, both for new artists and old ones. One older artist who had a great success is Paul McCartney with his new album entitled "Flaming Pie."

This album has a very unusual title. However, a lot of the music and lyrics are mainstream, offering nothing unusual and LSD induced like the "old days." McCartney explains how he got the title as, "John (Lennon) joked that the name Beatles came in a vision from a man on a flaming pie, coming unto us.... You are a Beetles with an A. Another "big name," appearing on the tracks entitled "Used to be Bad," "Young Boy" and "If You Wanna." The track "Used to be Bad" brings together two truly excellent musicians. It was recorded while Miller and McCartney were having a casual jam session and decided to put it on tape. "Used to Be Bad" is an up tempo Blues song combining "kick ass" Blues riffs by Miller and McCartney playing bass, drums and singing. It is performed as a duet by the two.

Miller is also featured on "Young Boy," here singing backup vocals and playing the guitar. Once again, a good Rock'n Roll song. It was also on the soundtrack for the movie "Father's Day," starring Billy Crystal and Robin Williams. I recommend this album to anyone two separate jobs on this album.... that of musician and Producer, adding that hard-hitting heavy sound on songs such as "The World Tonight", "Flaming Pie", "Really Love You", and "Beautiful Night".

"Flaming Pie" is a sort of a combination of a '50's Rock'n Roll rhythm with a Ragtime feel in the piano solo; with the bridge turning into more of a Hard Rock feel. Then with "Heaven on a Sunday" he gives us more of a slow Caribbean feel, similar to John Lennon's "Beautiful Boy (Darling Boy)."

If I had to grade this album like an exam, I would rate it an A+. You take five of the best Rock'n Roll musicians of all time and put them together in a studio together the product is going to be outstanding. It also breaks away from the current artist who have a #1 album, but all of the songs sound exactly the same. It's a relief to know that the EXPERIENCED musicians are still making great music, as well as not being under any type of contract. To be doing an album because they want to, and to just have fun. Paul McCartney says "I came off the back of the Beatles Anthology with an urge to do some new music. It reminded me of the Beatles' standards, that we reached the songs." He also says, "You've got to have a laugh, because it's just an album, and we had fun making it. Hopefully you'll hear it in the songs."

Wellness Column: Quit Smoking Now!

The Wellness Program extends a warm welcome back to students for the fall term. There are many exciting programs scheduled for this semester which cover a wide variety of topics, ranging from HIV/AIDS education to stress reduction techniques. One of the programs addresses the difficult task of quitting smoking. Joanne Hollan, an addictions specialist, will give an introductory seminar on quitting smoking. The program is being presented on Wednesday, Sept. 24, at 2:30 in the Campus Center, Bijou Room (211). It is a Personal Growth CLUE. Participants will then be offered the option to sign-up for follow-up support groups.

Many people find quitting smoking extremely difficult. This is due to the body's addiction to nicotine which is found in smoke. It occurs naturally in the tobacco leaf, the only plant known to contain it. Nicotine has a powerful effect on the brain and central nervous system. Within 7 seconds of inhalation, a significant portion of nicotine has traveled through the bloodstream directly to the brain. The nicotine affects the 'receptor' cells in the brain. This sensitivity to nicotine produces a 'hit' when reaching the brain. The impact is seen in the chemicals that regulate mood, alertness and learning. There is also seen an increase in heartbeat and breathing rate. As in other addictive drugs, nicotine may act as either a stimulant or sedative depending on the person's metabolism, time of day and amount of stress the person is under. In the morning, nicotine appears to act as a stimulant, not just to the brain but to the digestive tract as well. Later in the day, it seems to be more

Nicotine's highly nature is what keeps people smoking. In several studies, when people were given nicotine- free cigarettes, they almost always abandoned them. Nicotine is usually cleared from the body after a few days, however cravings for cigarettes can continue longer. This makes staying with the decision to quit hard. The highest rates of relapse are seen within the first two weeks. However relapse is often part of the long term quitting process. It should not be seen as a failure if the person learns from it and tries again - immediately.

The benefits to quitting smoking are great. Aside from the expense, the list of health concerns range from the wellknown lung cancer and heart disease to more esthetic concerns such as teeth staining and facial wrinkles. There is also risks to unborn babies of low birth weight and premature delivery in woman who smoke during pregnancy.

Deciding to quit is a very personal choice. There are many methods to choose. There is hypnosis, nicotine patches, which slowly reduce the need for nicotine and 'cold turkey'. Support groups help in addition to these methods. Remember whichever method you choose — You Can Do It!

Since that time "Spawn" has become the undeniable flagship of Image comics.

NEW ENGLAND PATRIOTS

Last year they went to the Super Bowl under Bill Parcells. This year if they go there they will go under new coach Pete Carroll. Drew Bledsoe is a good quarterback in this league. His main target is Terry Glenn who had a solid rookie campaign.(1,132 yards). Another favorite target of his is Ben Coates. Curtis Martin is one of the premier backs in this league.(1,152 yards and 14 touchdowns) Their defense is led by Willie McGinest who led the team in sacks. They have two solid defensive backs in Lawyer Milloy and Ty Law. Overall they had an average defense. I feel this team is the most talented team in their division and should win it. It will be interesting to see how much of a motivator Caroll is. If the team struggles everyone will think it is because Parcells is gone.

MIAMI DOLPHINS

Sean Dawkins is an average wide-out. Tight end Ken Dilger seems to be a clutch receiver and will get the ball in pressure situations. Marshall Faulk had a terrible season last year, (587 yards 7 touchdowns) but was also a little banged up. He did have 56 receptions last season. Their defense is not good at all, with exception being Tony Bennet and Quentin Coryatt. They lost Ray Buchanan to free agency. The often injured linebacker Trev Alberts retired. I feel this team will finish last in this division and win 6 games.

AFC CENTRAL

JACKSONVILLE JAGUARS

Mark Brunnel will be out for the first 6 games of the regular season due to the preseason injury against the Giants. Rob Johson is a more than capable backup. Look at the courage he showed coming back in the game against Baltimore with a severely sprained ankle and leading them to victory. The main targets will be Pro Bowler Kennan McCardell and Jimmy Smith, both thousand yard receivers last season. Until Brunell returns, running backs Natrone Means and James Stewart will be utilized more frequently. The defense is led by defensive ends Clyde Simmons, Tony Brackens and linebacker Kevin Hardy who combined for 20 of the teams 37 sacks. CAROLINA PANTHERS


